OBJECTIVE

The purpose of this memorandum is to transmit information to the City Council regarding the preparation of conceptual site plans, construction cost estimates and recommendations regarding the CEQA environmental review process to replace Fire Station No. 6, located on the northeast corner of Chapman Avenue and Debbie Lane.

BACKGROUND

At the March 13, 2015, City Council Retreat, there was discussion regarding the continued need for a new Fire Department Headquarters, previously planned for the east side of Euclid Street (previous Black Angus Restaurant site.) At the retreat, the City Council concurred with staff's recommendation that plans for a new Fire Department Headquarters be abandoned, and that staff concentrate their efforts on relocating and reconstructing Fire Station No. 6.

In an effort to accomplish this task, a sub-committee was established, to analyze the project by exploring various development site options for the replacement station. A contract was awarded to WLC Architects, after they were selected by public bid, and the City has held three public meetings to obtain input from the public.

DISCUSSION

To date the City has solicited comments from the public during three public meetings. The first two meetings solicited response concerning the possible locations for the replacement of Station No. 6. The sites were chosen based upon the Fire Department's analysis of several factors, including developed response time standards; consideration of reasonable travel time; the size of the area to be serviced; the resources available, and the level of acceptable risk.

The proposed relocation sites are:

- 1) *Harbor Boulevard (west side of Harbor Blvd., north of Lampson Ave.);
- A one-acre portion of Westhaven Park, located on the east side of West Street, north of Lampson (would include replacement of park land and/or improved park amenities equivalent to the value of the park space being removed);
- 3) *12111 Chapman Avenue (northeast corner of Chapman Avenue and Debbie Lane), existing site of Station No. 6.

*Both sites 1 & 3 require additional land acquisition.

During the first two meetings, the majority of the public comments identified the Westhaven Park site as the most desirable location for the fire station.

During the third meeting, this information was shared with the public in attendance. This meeting also displayed some site layout and frontal elevation options. This allowed the public to make comments on their preferences. The sub-committee is awaiting additional details from WLC Architects, regarding costs and CEQA requirements. This item will then be forwarded to the Planning Commission where the public will again have an opportunity for comments.

SUMMARY

The sub-committee continues to move this project along as fast as possible due to the Fire Departments need for the new replacement station, while allowing the public to participate in the site selection and station design options. The next steps will be to forward this to the Planning Commission where the public will again have the opportunity to provide comments.

The goal is to have this station constructed by the end of 2017, which means construction would need to start in early 2017.

Garden Grove: Water park, hotel openings this week put city on track for tourist, resort dollars

This is part of an occasional series on every city in Orange County.

Step aside, Anaheim. Move over, Buena Park. There's another city in Orange County ramping up to compete for hotel bed taxes and tourist sales revenue.

OK, it's not exactly on the scale of Disneyland or Knott's Berry Farm. But for Garden Grove, which has struggled financially for decades, getting resort dollars marks a sea change.

On Friday, a \$250 million water park and hotel will open. But that is only

the beginning.

City Manager Scott Stiles stands between two enormous vacant lots on either side of Harbor Boulevard. Just down the boulevard, the Great Wolf Lodge with its huge indoor water park prepares for opening day. Up the boulevard, and only about a mile away, lies Disneyland like a pot of gold at the end of the rainbow.

On one of the empty lots will rise a 700-room hotel with an undisclosed occupant. On the opposite lot, plans are being firmed up for a 200-room boutique hotel.

The astonishing thing is that between the empty lots and Disneyland, there's a collection of relatively new hotels that quietly sprung up when most of us were focused elsewhere.

With the city changing in November from at-large to by-district City Council elections, it's an understatement when the city manager remarks, "The whole future of Garden Grove is really going to be interesting."

CHALLENGES TO OVERCOME

Like Westminster, Garden Grove lays claim to Little Saigon. Signs on the 22 freeway make it official and are intended to draw tourists.

It's a remarkable turn of events considering that less than two decades ago, many longtime county residents who lived outside the area considered it a bold and brave move to visit Little Saigon. That was silly then, just as it is silly now.

Shopping and dining in Little Saigon, regardless of the city, is a treasured treat. Check out Lee's Sandwiches on the northwest corner of Brookhurst Street and Westminster Avenue – yes, that's Garden Grove – for the sliced barbecue Chinese pork.

Still, Stiles is quick to admit crime remains a problem. The city ranks in the lower 38 percentile of the nation's cities when it comes to safety. He adds the city's police force is working to turn things around.

"Everybody's learning to come together," says Stiles. "We're developing our own identity."

That identity is a stew and includes residents who have lived in the city since before the fall of Saigon in 1975 as well as the city's more recent Korean immigrants. It also takes in some 7,000 worshipers who attend the Islamic Center of Orange County mosque.

Along with reinventing Garden Grove's Harbor Boulevard, the city is tackling dilapidated areas.

On Brookhurst just north of Garden Grove Boulevard, developers Ronnie Lam and the Kam Sang Co. are building 180 residential units that will be above restaurants and retail. In time, the seven-acre development is expected to grow to 600 units.

Just a few blocks away, there's a massive steel structure, appropriately dubbed the Rusty Skeleton, that has failed to develop anything more than rust for more than a half-decade. But now the city has given the owner a May deadline to stand up or give up.

"Garden Grove," Stiles says, "is changing fast."

THE PLAY'S THE THING

For years, one of my favorite things about Orange County is Garden Grove's commitment to theater. This is not simply community theater – which would be fine. This is theater that can rise to national quality at half the cost, with a fraction of the commute.

Under former director Tom Bradac, Shakespeare Orange County (now just SOC) blossomed in the 1990s. It continues to grow today at the city's outdoor Festival Amphitheatre under the stewardship of artistic director John Walcutt, now entering his third year.

Walcutt, whom you might recognize from "Lost" and "Little Miss Sunshine," this summer will play King Claudius in "Hamlet."

The 158-seat Gem Theater is a short walk away. While the city owns the facility, One More Productions stages and produces. Seven years ago, at a cost of \$150,000, the company renovated what was an old vaudeville house. The new season opened Friday with "Funny Girl."

But the city's historic downtown continues to struggle. Some shops are shuttered. Others are, well, less than ideal. Black Umbrella Tattoo and Art Gallery, however, is ultra-cool and ultra-hip with well-reviewed ink artists and wall hangings.

In office less than six months after arriving from Cincinnati, Stiles hopes to reinvigorate Main Street. But there are other priorities.

Two years ago, the city faced a \$7 million deficit; last year it was \$4 million. "We've got big budget challenges," Stiles says, "and keeping up with infrastructure."

Stiles explains part of the reason to become a resort destination and recruit new hotels is to bring in more revenue for the city. "These are projects that help me build up the neighborhoods."

Many of the newer hotels such as Hyatt Regency, Marriott Suites, Wyndham and Sheraton claim Anaheim in their name. But change is afoot.

Great Wolf Lodge will open with a 105,000-square-foot water park, a 600-room hotel and an address true to its location -- Garden Grove.



Great Wolf Lodge Southern California, a \$250 million indoor water park and 603suite hotel, will begin to find out Friday, when it will welcome its first swimwearclad visitors.

The Wisconsin-based chain, with 14 resort properties nationwide and in Canada. is betting it can penetrate Southern California and put Garden Grove - perpetually in the shadow of Anaheim - on the map for vacationers.

Its entry into a highly competitive tourism market poses unique challenges for a business that has thrived elsewhere in the U.S., experts say.

"There's a reason why the Great Wolf does well in the Midwest and East Coast.

When the weather is bad, it's nice to have that indoor water park," said Robert Niles, editor of ThemePark Insidencom, which covers the theme park industry. "They lose a bit of that unique selling point here. ... You can go outdoors nine or 10 months out of the year."

But others predict that the Garden Grove resort, which will be the largest Great Wolf property, is immune to roadblocks other resorts might face.

"We went to other Great Wolfs and studied what it is about this water park, this resort," said Matt Fertal, a former Garden Grove city manager who worked to bring the resort to town. "We realized it didn't matter where it was. Families are drawn to it."

The first visitors to cross the resort's threshold and meet its Wiley the Wolf mascot will mark the end of a nearly decadelong effort to bring the attraction to Orange County.

Among the obstacles that Garden Grove and resort officials had to overcome: the \$250 million construction price tag, concerns about the drought and the economic sludge caused by the Great Recession.

"Since day one we have remained committed to opening here in Garden Grove;" said Tim Black, chief operating officer of Great Wolf Resorts. "At long last the resort is about to open, and we know that

patience will pay off as families begin to experience our brand for the first time."

The 105,000-square-foot indoor water park is exclusively for hotel guests; they can invite outside friends and relatives, for \$40 each, up to the room's capacity.

Inside the dome, the temperature is set at 84 degrees, with water to stay steady at 82 degrees. Twisting water slides and rides jut out from the building and into a pool inside.

There's a water-basketball pool, a place to bodyboard or surf and a lazy river. In the hotel are seven eateries, an arcade, a spa for girls and women, miniature golf, and an interactive scavenger hunt for kids.


Rooms go for \$250 to \$600 a night. The average daily hotel rate in the Anaheim-Garden Grove area is \$162.

City officials envision a Great Wolf that can draw more hotels, restaurants and shops to a stretch of Harbor Boulevard once considered blighted.

Greg Blodgett, Garden Grove's economic development director, attended a developer's conference in Los Angeles a couple of weeks ago at which Great Wolf was a popular topic.

"We were all the buzz," Blodgett said. "People who saw me came up and asked about building other things on Harbor. The resort is important for growth of the entire area."

The city already has a hotel and convention center

lined up across the street, where the old Joe's Italian Ice operated for years.

Gary Sherwin, CEO of Newport Beach and Co., the tourism and marketing agency for Newport Beach, sees Great Wolf as helping "solidify the Anaheim-Garden Grove area as a familyfriendly destination. The Great Wolf gives people another reason to stay an extra day or two."

A record 47.3 million people visited Orange County last year, a 2.6 percent uptick from 2014. Of that, Anaheim saw 22.5 million visitors, up 3.5 percent, according to resort district promoter Visit Anaheim.

"It's something unique to the area," said Jay Burress, CEO of Visit Anaheim. "This just adds to the attraction of the area. The stronger economy and the increasing tourism is something we've seen across the country." Register Feb. 18, 2016 3 of 3

Great Wolf arrives as the local theme park arms race is heating up.

The Wizarding World of Harry Potter, based on author J.K. Rowling's magical literary hero, opens at Universal Studios Hollywood in April. Knott's Berry Farm, with its Snoopytheme kids park, is celebrating its 75th anniversary this summer by turning Ghost Town into an interactive experience - letting visitors play poker with the sheriff or arrest family members. The once-bumpy GhostRider wooden roller coaster is getting new tracks and sleek cars.

And, as always, there is Disneyland, which has seen record attendance and where construction just began on a "Star Wars" land. A new ride, Luigi's Rollick-in' Roadsters, and a "Frozen"-inspired musical will debut soon at Disney California Adventure.

In addition, Legoland, Magic Mountain, Raging Waters and Knott's have water parks.

Also in the mix for a family that can afford a stay at the Great Wolf are the swanky hotels that dot Orange County's coast.

"There is nothing around most of the other (Great Wolf) locations," said Susan Emery, Garden Grove's former community development director who now holds the same position in Irvine. "There is stuff here. (Staffers) did have those conversations. It went back and forth: Will it be successful? ...

"Hopefully, it's a shot in the arm for the city," she said.

Some entertainment experts predict Great Wolf will be a success.

"You'd be surprised how popular that place is with families with children," said Dennis Speigel, president of International Theme Park Services, a leisure-industry consulting firm that has tracked Great Wolf since it opened the Sandusky, Ohio, location 15 years ago.

"I think this is right where they want to be – in the thick of that market," Speigel added. "Every kid loves to swim."

But there is debate over who will splash about in Great Wolf's water park: locals seeking mini-vacations or those out-of-town visitors?

Rick West, a writer for Rethink Leisure & Entertainment, said Great Wolf is aimed at families already aware of the brand – out-oftowners or transplants from areas with their own Great Wolfs.

"What they're going after is the resort guest who is going to spend \$300 or more per night near Disneyland anyway," West said. "Why not stay just minutes away from both Knott's and Disney, where you have exclusive use of a water attraction when it's time to relax away from the controlled chaos of the theme parks for an afternoon?"

McWhinney Enterprises CEO Chad McWhinney, the developer who helped bring Great Wolf to town, sees Garden Grove's new resort as offering more than that – namely, a variety of attractions that will lure locals and visitors alike.

"There is not another resort like this in California," he said.

A BIG BET ON GREAT WOLF LODGE

Garden Grove's \$100 million-plus investment in the resort may take years to pay off.

GARDEN GROVE • The Great Wolf Lodge Southern California is opening this week with the help of a \$100 mil-

lion-plus infusion of taxpayer funds, an investment that city leaders say should be recouped within a decade, in large part because of the hotel's

projected generation of \$8 million in annual bed tax.

In addition, the 105,000-square-foot water park and 603-suite resort is expected to help spur growth along Harbor Boulevard and boost Garden Grove's appeal as an entertainment destination.


"The \$8 million is probably a conservative estimate because the market keeps getting better," said Greg Blodgett, the city's economic development director, referring to bed tax revenue. "Once we get these additional resources, it will definitely help (the budget). That's why we've been so aggressive with development."

Not everyone agrees with the strategy.

Handing over a large subsidy is unfair to tax-payers, especially when that money is going to a private company with no guarantee of a return on investment, said Carolyn Cavecche, a former Orange mayor and president of the Orange County Taxpayers Association.

"The taxpayers should not have to roll the dice," Cavecche said. "If they have to pay, they should be getting services. That's what taxpayer money is for, not to be used to invest in a business."

The resort's opening is the culmination of nearly a decade of negotiations among Garden Grove officials, developer McWhinney Enterprises and Great

Wolf Resorts.

In 2009, Garden Grove and McWhinney inked an agreement to bring a water park to Harbor Boulevard. The deal, amended several times, required the city to help the development financially.

Five years later, after McWhinney brought Great Wolf into the mix, Garden Grove gave the developer IS acres on Harbor, just south of Lampson Avenue, for free.

At the time, the land was worth more than \$30 million, said Mike Hannah, a manager at the Orange County Assessor's Office, which appraised the property after McWhinney took control of it.

A few months later, when construction began, the city gave the developer \$5 million. McWhinney also required Garden Grove to invest in renovating Harbor Boulevard. In 2015, the city finished a \$5.2 million renovation of Harbor, upgrading the rundown roadway and sidewalks, adding landscaping to the medians and putting up a traffic signal at the entrance to Great Wolf.

And within 30 days of Great Wolf opening, the city must give McWhinney \$42 million. The city will raise that by issuing bonds. Over 18 years, interest will raise the cost by an estimated \$23 million.

That \$65 million or so will come from property taxes in the area that includes the Great Wolf – money that otherwise would have some to public agencies

Some of that \$65 million will be paid off by Great Wolf itself, from the increased property tax from the resort because of the building improvements. Based on city and county projections, the resort will start off paying \$2.8 million annually in property tax.

"If you look nationally," said Chad McWhinney, the CEO of the developer, "really complex projects almost always involve public-private partnerships. Their goal is to recoup their investment."

Public-private partnerships "have to be beneficial for both parties," he said.

Over the years, some Garden Grove residents have voiced concerns about the aesthetics of the resort – a large funnel, part of a ride, is on the exterior of the park – the anticipated increased congestion on Harbor, the wisdom of opening a water park during a yearslong drought and whether it's the best use of taxpayer funds.

If Great Wolf does as well as city and resort officials predict, the city should see the hotel bed tax top \$10.5 million annually by 2024, according to estimates in city documents. Guests pay the bed tax, also known as a transient occupancy tax, with the amount based on the room charge.

The city also could take in a total of \$8.5 million in sales tax by 2024.

Garden Grove's coffers could use some help. In recent years, the city has had to go into its savings to balance the general fund bud-

get; it is taking an estimated \$6 million for the current fiscal year.

"Great Wolf presented an amazing opportunity," said Matt Fertal, Garden Grove's former city manager, who retired in December 2014 after spearheading the effort to bring in the resort. "For as long as I can remember, we've had the same (financial) struggle year after year."

With Great Wolf, Fertal said, "Maybe we can get over that hump once and for all. That's what made Great Wolf, from a financial aspect, different from anything else."

Woman testifies she wasn't attracted to man accused of kidnapping her

Garden Grove resident says she was raped as a teenager by man she later lived with for a decade.

FULLERTON • A Garden Grove woman who authorities say was raped and kidnapped by her mother's exboyfriend testified on Wednesday that she never found the man attractive – despite marrying him and living together for a decade.

The 26-year-old woman testified that Isidro Garcia began courting her shortly after she arrived in Santa Ana from Mexico at the age of 14, saying Garcia forced her to have sex with him and destroyed her relationship with her mother.

The woman denied that she pursued Garcia or used him to escape her mother, as Garcia's attorney has contended. She was composed on the witness stand as she told, with the help of a Spanish-language interpreter, how she had no

forcing her to live with him.

"Did you find him attractive?" Deputy District Attorney Whitney Bokosky asked about the time the woman met Garcia.

"No," the woman replied.
"In fact, have you ever found him attractive?" the prosecutor asked.

"No," the woman said.

The Register is not naming the woman or her family to avoid identifying a potential sexual-assault victim.

The woman said that shortly after she moved into an apartment with Garcia and her mother, Garcia began favoring her with clothes and a computer.

During a trip to pick up recyclables in Irvine, the woman said Garcia touched her bottom inappropriately.

"I kept insisting on telling my mom," the woman said. "He said I couldn't, because he would call immigration."

Shortly after her 15th birthday, the woman said, Garcia forced her into her mother's room, took off her clothes and pushed her onto a bed, ignoring her pleas to stop.

"He just told me not to yell," the woman said. "I knew that something bad was going to happen."

The woman testified that another half-dozen sexual assaults followed, and her relationship with her mother deteriorated: "I felt that what was happening with Isidro was her fault because it was her boyfriend."


Her mother and Garcia began getting into physical fights, the woman said, leaving her to find solace in a nearby park.

"Every time they would fight I would leave," the woman said. "I would just sit under a tree."

The woman is scheduled to resume her Superior Court testimony this afternoon, when she is expected to be questioned about the fight that led to her alleged abduction, as well as her decade living with Garcia, marrying him and raising a child. In 2014, she reunited with her mother and other family members.

The 58th annual Grammy Awards took place at Staples Center in Los Angeles on Monday, and as far as Brainiac can tell, our fair cities of Garden Grove, Westminster, Stanton and Midway City got shut out this year.


Not, mind you, that we haven't seen our share of winners in years past. For instance, can any of you name the Garden Grovebred winner of five Grammys in years past?

If you guessed the Offspring, that's not a bad try - the popular long-running punk band formed out of Pacifica High School some three decades ago but they've never even earned a Grammy nomination, a slight that's at least partly due to the fact that their biggest hits came before the Grammys started nominating and honoring more modern-sounding acts.

The answer we're looking for here is **Steve Martin**, who grew up in Garden Grove, and won twice for best comedy album in the late '70s – for the classic records "Let's Get Small" and "Wild and Crazy Guy" – before winning three times this century for his work as a bluegrass banjo player.

Martin's our biggest winner, though you'd think the late Westminster resident **Danny Flores** would have gotten an honorary Grammy along the way for writing the greatest boozethemed bar song of all time—"Tequila," by the Champs.

Even our local hair metal hero, **Mick Mars**, guitarist for Mötley Crüe, who grew up in Stanton, was nominated three times for best hard rock performance and probably had his best shot a

win for that band's 1990 single "Doctor Feelgood."

For instance, any idea how much the city pays to keep the streets striped, curbs painted and signs posted? We didn't either – but now we do.

The council unanimously approved a contract with Orange County Striping

ED CRISOSTOMO, FILE PHOTO Service Inc. to do all of those services for \$351,767 per year, which if renewed annually for the full five-year term of the deal adds up to \$1,758,837.

That's a lot of paint, but still the lowest of five bids submitted. Brainiac's not sure what priciest bidder Sterndahl Enterprises Inc. included in its rejected bid, but for \$804,675 a year, it probably ought to be striping the streets with gold-leaf paint.

The council also heard a report from city staff on possible changes to animal control in Garden Grove. The city has contracted with the county for 34 years for animal control and shelter services, but the cost has been going up steadily, from \$730,000 five years ago to \$13 million during the current fiscal year.

Add to that the county's plans to build a new shelter on 10 acres at the old Marine Corps base in Tustin — which is needed, by all accounts—and the city's costs would go even higher.

According to the staff report, the county is asking its 18 contract cities including Garden Grove to pitch in for the \$35 million cost to build the modern shelter, with Garden Grove's share an estimated \$3.5 million to \$4 million.

Put all that together and the city's costs are looking to go up substantially, so **Mayor Bao Nguyen** and the council asked staff to check out options for partnerships with other cities, private providers and nonprofits and report back before the county needs to know whether Garden Grove is in or out.

A soft deadline is set April 1.

Man shot by police sues Garden Grove

BY SEAN EMERY STAFF WRITER

GARDEN GROVE • A man who was shot and injured by Garden Grove police has filed a federal lawsuit against the city, alleging that he was unarmed when an officer opened fire.

Andrew Garcia acknowledged having a toy pellet gun but dropped it before the June 29 shooting, according to a lawsuit filed in U.S. District Court late last month.

In the lawsuit, Garcia's attorneys say the city of Garden Grove, along with the officer who shot Garcia, should pay damages for excessive force and illegal detention and arrest.

Police officials declined to comment on the lawsuit, citing a policy not to discuss open litigation.

Police have released few details about the shooting. According to police, an officer was responding to reports of a man carrying a black automatic handgun when the officer encountered a man near Chapman Avenue and Jacalene Lane.

Police said the man pointed what appeared to be a handgun at the officer, and the officer shot him. Police haven't identified Garcia as the man who was shot.

In his lawsuit, Garcia contends that he was "lawfully resting by a sidewalk when an officer approached him, gun in hand," "yelling profanities" and acting in a "violent and aggressive manner."

The lawsuit alleges that "in immediate fear for his life," Garcia ran. It also contends that the officer fired multiple gunshots into Garcia's back "in a cold, calculating manner."

The lawsuit says Garcia tossed a pellet gun before the shooting, claiming he didn't want to give the officer a reason to shoot him.

- Cannot be claimed as a qualifying child
- Cannot file Form 2555 or 2555-EZ (relating to foreign earned income)
