COMPLEMENTING 'RE: IMAGINE

ART IN THE PARK' EVENT

OBJECTIVE

To inform the City Council of temporary and permanent art installations occurring over the next four weeks in the Downtown area, to complement and promote the inaugural 'Re:Imagine Art in the Park' event, being held in collaboration with the Garden Grove Unified School District (GGUSD) on Saturday, March 16, 2019, at Village Green Park, from 11 a.m. to 3 p.m.

BACKGROUND

The 'Art in the Park' event is part of the City's continuing efforts to brand and identify Garden Grove's iconic Downtown, while promoting the Re:Imagine Garden Grove mission of bringing more art to the community; the GGUSD shares a similar goal, which is to continue to elevate its arts presence and distinction within Orange County, by showcasing the award-winning artistic talents of K-12th grade art students.

DISCUSSION

This event partnership benefits both agencies: attendance will increase at the GGUSD's week-long 'First Impressions' art gallery exhibit, and the Downtown area will see increased foot traffic and interest from attendees.

Because this is a first-time collaboration, focusing solely on visual arts, heightening interest is important, and will be achieved through pre-event, and day-of temporary and permanent art installations. These include:

- The permanent addition of a nature-themed, stenciled mural, on the east-facing wall of the Courtyard Center (CYC) building, to be live-painted by the artist, on the day of the 'Art in the Park' event;
- The permanent transformation of a decades-old, steel-and-wood park bench into a mural depicting a colorful snail family in a flower garden, featuring a color palette complementing the CYC mural, and live-painted by the artist;

- The permanent stenciling of one-to-three words from song titles containing the word, 'brick,' painted onto individual bricks of the wall surrounding the Gem Theater parking lot, to highlight the musical arts presence in the downtown from Gem Theater productions and musical performances at The Garden Amp;
- The temporary installation of 10, 5-foot individual letters in Village Green Park, facing southbound Euclid Street, spelling out the word, 'Re:Imagine,' with each letter uniquely decorated by GGUSD high school art students;
- The temporary placement of two art installations from Los Amigos and Santiago High Schools' art classes, depicting themes of cultural harmony and ecological preservation, throughout a grove of trees at the northeast corner of Euclid Street and Stanford Avenue;
- The temporary placement of 48 aluminum pails containing miniature fairy gardens, designed and planted by GGUSD elementary schools, to encourage event attendees to walk a pathway in Civic Center Park connecting the Community Meeting Center to the Courtyard Center.

FINANCIAL

Funding for implementation of the General Plan measures including RE:Imagine Garden Grove Campaign is obtained from three sources: the General Plan cost recovery fee, the Cultural Arts fee, and the Art in Public Places fee, all of which are taken from a portion of building permit costs. No additional funding is required. There is no impact to the City's General Fund.

SUMMARY

Additional Re:Imagine Garden Grove art enhancements planned for the Downtown include: a red car-themed mural on the paved Pacific Electric right-of-way leg at Nelson Street and Acacia Parkway; implementation of phases 2 and 3 of the CYC mural project, set for the southern and northern walls; installation of custom, laser-cut metal Garden Grove identifiers to be placed on seven banner pole locations; and the debut of a 'Mobile Museum,' consisting of seven colorful Adirondack benches, placed in key locations as part of a social media hashtag program highlighting historical points of interest.

Dear Mayor Jones:

This letter provides an update on flood hazard mapping activities by the Department of Homeland Security's Federal Emergency Management Agency (FEMA) and notifies your community of the engineering model being used. Providing accurate and useful data on flood hazards is one of FEMA's goals and is essential to helping communities make informed decisions on building safely.

FEMA's contractor, STARR II, is developing flood hazard information for the East Garden Grove Channel, Ocean View Channel, and Westminster Channel using HEC-RAS 5.0.5 for one dimensional, steady state hydraulic analyses. The hydrologic analyses will be based on the Orange County Hydrology Manual and the HEC-HMS model will be used. The HEC-RAS and HEC-HMS models will be based on recently acquired LiDAR data and surveyed channel data.

The engineering models may form the basis for proposed Special Flood Hazard Areas (SFHAs) on preliminary Flood Insurance Rate Map (FIRM) panels 0119K, 0138K, 0139K, 0141K, 0142K, 0143K, 0144K, 0231L, 0232K, 0233L, 0234K, 0251K, 0252K, 0253K, 0254K, and 0256K for Orange County, including portions of the City of Garden Grove. A SFHA is the mapped area subject to inundation by the 1-percent-annual-chance flood. Since the likelihood of flooding in certain areas may have increased or decreased and our ability to map flood hazards has improved over time, SFHA changes are expected in the City of Garden Grove.

Your community has 30 days from the date of the letter to consult with the FEMA Region IX staff identified in the last paragraph of this letter regarding the appropriateness of the models selected for the mapping project. Your community and citizens will have additional opportunities to comment on and provide feedback about the models and other draft flood hazard information throughout the project. A formal appeals process and period will be available to help resolve any remaining questions before updated flood hazard information becomes effective for flood insurance purposes.

FEMA wants to ensure that the most up-to-date and accurate technical data are used to develop flood hazard products. FEMA relies on community feedback. Partnerships and local knowledge, during this important project to determine flood hazards in the City of Garden Grove, are critical to reduce flood risk. We look forward to working with local officials and

other stakeholders in the City of Garden Grove to increase flood awareness and reduce risks to life and property. Whether a community elects to submit feedback in response to this letter does not affect its ability to provide feedback at a later stage of the flood study process, or to formally appeal preliminary flood hazard information during a future comment period.

Please provide any questions or comments related to the models selected for the East Garden Grove Channel, Ocean View Channel, and Westminster Channel flood study project by March 15, 2019. 

Monthly Water Usage Data, Tier 2 Projection & Water Supply Information

The attached figures show the recent trend of water consumption in Orange County (OC), an estimate of Imported Water Sales for MWDOC, and selected water supply information.

- OC Water Usage, Monthly by Supply OCWD Groundwater was the main supply in December.
- OC Water Usage, Monthly, Comparison to Previous Years Water usage in
 December 2018 was below average compared to the last 5 years.
 We are continuing to see slight increases in overall water usage compared to the previous three Fiscal Years. It has been 22 months since all mandatory water restrictions were lifted by the California State Water Resources Control Board.
- Historical OC Water Consumption Orange County M & I water consumption is projected to be 551,000 AF in FY 2018-19 (this includes ~15 TAF of agricultural usage and non-retail water agency usage). This is about 11,000 AF more than FY 2017-18 and is about 31,000 AF more than FY 2016-17. Water usage per person is projected to be slightly higher in FY 2018-19 for Orange County at 152 gallons per day (This includes recycled water). Although OC population has increased 20% over the past two decades, water usage has not increased, on average. A long-term decrease in per-capita water usage is attributed mostly to Water Use Efficiency (water conservation) efforts. O.C. Water Usage for the last three Fiscal Years is the lowest since the 1982-83 Fiscal Year (FY 1982-83 was the third wettest year on record).

<u>Water Supply Information</u> Includes data on Rainfall in OC; the OCWD Basin overdraft; Northern California and Colorado River Basin hydrologic data; the State Water Project (SWP) Allocation, and regional storage volumes. The data have implications for the magnitude of supplies from the three watersheds that are the principal sources of water for OC. Note that a hydrologic year is Oct. 1st through Sept. 30th.

- Orange County's accumulated rainfall through early February was above average for this period. Water year to date rainfall in Orange County is 11.90 inches, which is 164% of normal.
- Northern California accumulated precipitation through early February was 108% of normal for this period. Water Year 2018 was 82% of normal while water year 2017 was 187% of normal. The Northern California snowpack was 112% of normal as of February 5th. As of late January, 23.66% of California is experiencing moderate to severe drought conditions while 76.07% of the state is experiencing abnormally dry conditions. The State Water Project Contractors Table A Allocation was increased to 15% in early January 2019.
- Colorado River Basin accumulated precipitation through early February was 104% of normal for this period. The Upper Colorado Basin snowpack was 106% of normal as of February 4th. Lake Mead and Lake Powell combined have about 57% of their average storage volume for this time of year and are at 40.0% of their total capacity. If Lake Mead's level falls below a "trigger" limit 1,075 ft. at the end of a calendar year, then a shortage will be declared by the US Bureau of Reclamation (USBR), impacting Colorado River water deliveries to the Lower Basin states. As of late December, Lake Mead levels were 10.85' above the "trigger" limit. The USBR predicts that the start of 2019 will not hit the "trigger" level but there is a 57% chance that the trigger level will be hit in 2020 and a 68% chance in 2021.




Accumulated Precipitation

"Spring Ahead" Means Extended Hours for El Toro Memorial Park

Don't forget to set your clocks ahead one hour, as March 10th marks the beginning of Daylight Saving Time. For El Toro Memorial Park that means the beginning of extended visitation hours. Starting on Sunday, March 10th, the grounds at El Toro Memorial Park will be open for visitation at 8 a.m. with the gates closing promptly at 7:00 p.m. Extended hours continue until Daylight Saving Time ends on Nov. 3, 2019.

Visitation hours at Santa Ana Cemetery and Anaheim Cemetery are from 8:00 a.m. to 5:00 p.m. year-round. All three cemetery offices including the District Office are open Monday through Friday from 8:00 a.m. to 5:00 p.m. Offices are closed on the weekends.

PLEASE RESPECT CLOSING TIMES AND PLAN VISITS ACCORDINGLY

District staff and our gatekeepers respectfully ask that you please consider closing times when you visit the grounds. If you wish to stay for any length of time, please don't enter the park five minutes before the gates are to close and expect to be allowed to stay. All visitors to the parks should plan to exit the grounds at or before closing time so the cemeteries can be cleared and the premises locked in an efficient and timely manner.

We greatly appreciate your cooperation in this regard.

Veterans Encouraged by Orange County Land Conveyance

The Orange County Cemetery District Board of Trustees was pleasantly surprised by the unexpected visit of three veterans who came to the Feb. 5th Board Meeting to speak during Public Comments. The veterans included U.S. Army Veteran Mr. Ron Bengochea, and two U.S. Marine Corps Veterans, Mr. Nick Berardino and Mr. Bill Cook. Mr. Cook is the Chairman of the Orange County Veterans Memorial Park Foundation. Mr. Berardino is the President of the Veterans Alliance of Orange County and President of Heroes Hall Veterans Foundation. All three gentlemen expressed their exuberant gratitude to the Board as well as to General Manager, Tim Deutsch for their support and encouragement in the development of a veterans cemetery in Orange County.

At the Dec. 4, 2018 County of Orange Board of Supervisors Meeting, 283.3 acres of land near the junction of the 241 Toll Road and CA State Route 91 were conveyed to the District, with the stipulation that half of the developable land be set aside for a veterans cemetery. Tim Deutsch, in turn, thanked the veterans stating that had it not been for their efforts in raising awareness about the need for an Orange County Veterans Cemetery, the District might not have been considered for the land, which will also be used by the District

to develop a much needed fourth Orange County public cemetery. The District looks forward with great anticipation to working with the veterans and various departments within the County to ensure the best use of the land for all Orange County residents.

On March 14th, the District is saying goodbye to two long-time, dedicated and very experienced employees: Groundskeeper, Sergio Ayala who is retiring after working 30 years for the District; and Administrative Manager, Dianna Torrence who has worked for the District since 1991.

When Sergio Ayala came to the District in 1989, he already had eleven years of cemetery groundskeeping experience with a career that started at Ascension Cemetery. During his thirty years with the Orange County Cemetery District he has worked at all three cemeteries, but spent most of his time at Anaheim and Santa Ana Cemeteries.

Dianna Torrence began with the District as a parttime secretary and was promoted to Office Manager in 2000. As an Administrative Manager, she has seen the District through the transitions from manual paper receipts and typewriters, to DOS computers with WordPerfect, to a fully automated office with windows, internet, websites and emails. Virtually all of the organizational systems and procedures that keep the District running have either been developed or refined through Dianna's efforts. When the General Manager is not available, Dianna Torrence is next in command.

Construction Update: Santa Ana Cemetery and El Toro Memorial Park



Santa Ana Cemetery Restroom Remodel

Work is progressing quickly for Santa Ana Cemetery's restroom renovation (pictured left). The new sewage tank is in place and the roadway in front of the main office will be repaved within days. Tile work is completed in the newly remodeled restroom. Lighting and fixtures will be installed next. We expect the restroom to be open to the public within the next 30 days. Having access to an indoor restroom, even when the office is closed, will be a welcome improvement for visitors to the park.

El Toro Memorial Park Restroom and Niche Project

After some unexpected delays, construction is ramping up again on the new public restroom and niche project at El Toro Memorial Park. Additional rebar was required for the block wall, which has now passed inspection, roofing and stucco work are

commencing on the new restroom facility, and all of the concrete niche castings have finally arrived. Once we receive doors and windows, the interior work on the restroom can be completed. After the niche castings are installed, construction can begin on the covered committal service structure and the placement of pavers will take place. We hope to see completion of this project sometime in May.

Recent Downpours Create Concerns for Visitors and Staff

While all the rain this winter has been a welcome relief for drought-weary Southern California, an unfortunate and often alarming consequence is the sinking of gravesites and markers. Sometimes the damage can be quite significant and the District is aware of how upsetting this can be for families visiting the grounds. When severe weather like this occurs, staff does their very best to make a complete survey of the grounds and complete repairs as quickly as possible.

We appreciate your help in notifying the office when you observe such issues with your loved one's gravesite or marker. We also ask that you please be patient while we work to correct these problems, as staff must also be attentive to interment service needs and some repairs cannot be done until the ground dries out. After heavy rainfall, visitors are advised to please use caution as the lawns can be slippery and tripping hazards are increased.

El Toro Memorial Park Hosts Cemetery Tour for SOKA Students

On January 23rd a group of twenty-four students and two professors from SOKA University were given a tour of the grounds at El Toro Memorial Park by Communications Manager, Mary Funk and Cemetery Manager, Bud Bales. Professor Xiaoxing Liu, who has a PhD in Chinese Language and Culture, organized the group of students who came to learn about different traditions and cultural beliefs concerning death and the operations of the cemetery.

The tour lasted about an hour and a half with information provided on the three public cemeteries operated by the District; the difference between a public and private cemetery, how burials are conducted, and staff's personal experience dealing with grief and death. Our Mission Statement and Core Values

The Orange County Cemetery District manages and maintains Orange County's public cemeteries in a manner that preserves their beauty, dignity, historical and cultural values, and offers affordable interment service for County residents.

Flower Removal and Holiday Schedule

Every Wednesday, groundskeepers remove and discard flowers and decorations throughout all three cemeteries. Families are encouraged to remove their flowers or decorations on Tuesday night; you can then place the flowers back on the space on Wednesday afternoon. Please remember that the District policy only allows for two items to be placed on gravesites. This includes the inground flower vase and one other item. If gravesites exceed the number of allowed items, staff may remove and discard the excess items. Please do not leave items of great monetary or sentimental value on gravesites as the District cannot prevent theft.

The District permits the allowed two items of flowers and/or decorations to be left on gravesites during holidays or for special occasions, such as anniversaries, birthdays and for new interments. Please come to the cemetery office and let us know that you have a special occasion and request that the flowers and decorations be left on the space. We do ask that you empty the vase and place fresh water in the container every four to five days to eliminate mosquito breeding sources, which can cause serious health issues. Your cooperation in this regard is greatly appreciated.

In honor of Persian New Year, flowers At El Toro Memorial Park may be placed on Thursday, March 14th until Tuesday, April 2nd. In honor of Easter, flowers at all three District cemeteries may be placed on gravesites on Thursday, April 11th and should be removed by Tuesday, April 30th.

All in a day's work - On 12/27/2018, a victim filed a fraud report with #GardenGrovePD. The victim is a local business owner in #GardenGrove and advertised her skincare products through Nguoi-Viet. The suspect, NGUYEN, agreed to purchase approximately \$80,000.00 worth of product in exchange for \$2,000.00 for commission.

NGUYEN provided the victim with a total of three fraudulent cashier's checks and took approximately \$1,300.00 worth of skincare product. After the victim deposited the fraudulent cashier's checks into her personal bank account, she provided NGUYEN with a \$2,000.00 cashier's check for his commission. It was later discovered that all three of NGUYEN's cashier's checks were fraudulent. The victim then attempted to contact NGUYEN, but his phone number was no longer in working order.

Today after some solid investigation work, #detectives identified, located and arrested Toan NGUYEN at his home in Santa Ana. He was booked at Orange County Jail for burglary, grand theft and other fraud-related charges.

We believe NGUYEN may have targeted the Vietnamese **#community** and similar businesses. Any victims are asked to contact Detective C. Alarcon at 714-741-5787.

Last night at 8:04 PM, #GardenGrovePD Officers were sent to the intersection of 9th St. and Garden Grove Blvd. for a rollover traffic accident. They arrived to see one of the drivers running from the scene. A foot pursuit ensued. The male suspect, later identified as Robert Gonzales, attempted to discard a large bag of narcotics as he began fighting with officers. After a brief struggle, he was taken into custody.

During the investigation, it was learned Gonzales and a second driver, identified as Eric Benitez, were involved in a high speed street race on Garden Grove Blvd. The vehicles crashed into each other and struck a third vehicle. This car was occupied by a mother and her three young children. The victims complained of pain and were taken to a local hospital for treatment.

Both suspects were arrested for #streetracing. Gonzales was also charged with possession/transportation for sale of narcotics, resisting arrest, and a probation violation.

An officer suffered abrasions and a minor head injury; and three other officers were exposed to the illegal narcotics during the altercation. They were all taken to a local hospital for treatment.

Garden Grove City Hall Have you seen coyotes?

We want to make sure you are prepared if you spot a coyote walking around with some safety and prevention tips:

- o Keep small pets inside, particularly at dawn and dusk when coyotes are most active.
- o Keep pet food and water dishes inside.
- o Secure food and trash at all times and remove all sources of water.
- o Pick up fallen fruit and keep compost piles tightly sealed.
- o Sweep up fallen birdseed, which can attract mice and rats, a common food source for coyotes.
- o Remove brush, wood piles, and debris where coyotes can find cover and where rodents are abundant.
- o Install motion-activated lighting or sprinklers.
- o If a coyote approaches or acts aggressively, throw rocks, make noise, look big, and pick up small children and pets. o Do not turn your back to the animal.

To report coyote sightings, call the City's coyote hotline number at (714) 741-5286, include date, time, and location of sightings.

First step is OKd toward another hotel

AN EXCLUSIVE negotiating agreement for the development of a new four-story hotel was approved by the Garden Grove City Council on Tuesday night (Shutterstock).

A first major step to adding yet another hotel to the Harbor Corridor array of hospitality was taken Tuesday night when the Garden Grove City Council approved an agreement with a developer interested in building a four-story hotel there.

The council voted 7-0 in favor of an exclusive negotiating agreement with SoCal Hotel, LLC for the development of the hotel on a site near the northwest corner of Chapman Avenue and Harbor.

(https://orangecountytribune.files.wordpress.com/2016/07/gg-logo_lg.jpg)SoCal Hotel, LLC, is proposing to construct an "upper upscale" hotel on a three-acre site of landfill property owned by the Garden Grove Sanitary District, a division of the city.

The proposal calls for a AAA Three Diamond nationally-branded hotel with about 225 guest rooms, served by surface parking. It would be built directly to the west of the Embassy Suites hotel.

The ENA period would run through Dec. 31. Potentially, the next step would be a development agreement. The city manager would have the discretion to extend the agreement by six months if he feels that sufficient progress is being made.

Also on Tuesday night, the council heard a presentation on the city's expanded code enforcement efforts and approved replacement of the gymnasium floor at the Garden Grove Sports and Recreation Center in Garden Grove Park.

The next meeting of the council will be on Tuesday, March 12.

Two arrested, five hurt in street race

Two people were arrested and five injured in an incident Sunday night in Garden Grove involving a street race, a collision and a fight with police officers.

According to Lt. Carl Whitney of the GGPD, the suspects arrested were Robert Gonzales, 28, of Anaheim, and Eric Benitez, 24, of Costa Mesa. They are both charged with illegal street racing. Gonzales was also charged with possession/transportation of narcotics for sale, resisting arrest and a probation violation.

Police were sent to the intersection of 9th Street and Garden Grove Boulevard at at 8:04 p.m. There they found a roll-over crash in which three vehicles were involved.

One of the drivers was seen running from the scene and was chased on foot. The man, later identified as Gonzales, allegedly attempted to discard a large bag of narcotics and began fighting with officers. He was taken into custody after a brief struggle with officers.

Witnesses told officers that Gonzales was driving a 2009 black Mercedes and Benitez driving a 2017 black Dodge Charger. The high-speed westbound race resulted in the two vehicles colliding, and a third vehicle was also struck.

That third auto was driven by a woman with three children in the car. The woman and children complained of pain and were taken to a local hospital for

treatment.

One of the police officers sustained minor injuries during the altercation with Gonzales and was treated for abrasions and a minor head injury. Three other officers were exposed to the narcotics that the suspect allegedly sought to discard and destroy.



A paramount requisite in the American system of public education is social equality. It must be open to all children by unified school association regardless of lineage."




situations?

JP: Writing ANYTHING is hard, simply because it's daunting to take on a project, especially one as large as a musical. But writing it with Seth made it exciting and fun, as well. We laughed a lot. We would task each other with scenes to write, and then share it with the other for notes and ideas. We definitely started with the characters and what their journeys would be, literal, and emotional. Our show is a jukebox musical with over 30 hit songs from the decade.

OCN: What did you edit out of the piece?

JP: There's a saying writers have that you have to "kill your babies." Meaning, even if you love a moment you've written, that doesn't mean it is serving the show as a whole. We've had lots of stuff in the early versions of the show that didn't make it to the final version. The show originally opened with the young male lead, "Chad," alone in his apartment singing about his ex-fiance "Marianne" (Boston's "More Than a Feeling"). That's WHY we named her "Marianne"

("...see my Marianne walking away..."), but we realized after the Off-Broadway previews that it wasn't needed. But the name stuck anyway. Some songs (like "Don't Bring Me Down") were in the show, but in the end we weren't able to get the rights. But any song we lost I don't bemoan, because I think in the end we got the perfect songs for every moment.

OCN: What is the first musical that made you laugh? Cry?

JP: The first musical album I got a hold of and listened to repeatedly was "Working." I played the "Newspaper Boy" at my community Theater and fell in love with it. It's not well known, but has so many great songs from Stephen Schwartz, who went on to write "Wicked."

OCN: What's the best part about Disaster?

JP: In order, one: the songs, and the surprising ways they're used; two: the disasters: earthquake, rats, sharks, piranhas, tidal wave, etc.; three: getting to fall in love with the characters, who are all so likable, and finding out who will live and die. Seeing the show is like taking a time machine to the 70's, my favorite decade ever!

OCN:What is it like to see small theater companies like

One More Productions perform your work?

JP: This will be the first production I've ever seen that I haven't directed! And I can't wait!

OCN: Does writing exhaust or energize you?

JP: Exhaust! But once it's done, that's when the real fun begins!

OCN: Will you and Seth collaborate again? If so, when?

JP: I sure hope so! But nothing planned quite yet.

OCN: Aside from Disaster, what is your very favorite musical and why? What musical do you hate?

JP: My favorite musical is probably "Falsettos," by William Finn. It would be a dream to get to act that beautiful show. And yet, I'm not drawn to listen to it very often, because the story is just so heartbreaking. I also can never bring myself to watch "West Side Story" again, because the ending is so tragic. Can't someone please do a production where "Tony" lives?! That I would see.

OCN: What do you hope the audience will remember most about Disaster:

JP: Laughing their butts off, and just having the most fantastic evening at the theater.





Bản tin từ Cảnh sát Garden Grove cho biết ông Toan Huu Nguyen đã bị bắt hôm 21/2/2019 để điều tra về tội lừa gạt.

Vào ngày 27 tháng 12/2018, một nạn nhân nộp đơn tưởng trình với Ty cảnh Sát Garden Grove. Nạn nhân là chủ một công ty địa phương ở gần khu phố 10800 trên đường Westminster Ave. tại thành phố Garden Grove. Nạn nhân quảng cáo sản phẩm da mặt trên báo Người Việt.

Nghi can Nguyen đồng ý mua sản phẩm trị giá 80,000 đôla để sẽ được huê hồng 2,000 đôla.

Nguyen gửi nạn nhân 2 tờ ngân phiếu (cashier's checks) giả riêng biệt, mỗi tờ có ghi trị giá 25,000 đôla.

Nguyen nhận mỹ phẩm trị giá khoảng 1,300 đôla. Sau đó Nguyen quay lại, đưa nạn nhân tờ ngân phiếu mới (cũng giả) ghi trị giá phần còn lại là 50,000 đôla.

Nạn nhân ký thác các tờ ngân phiếu vào tài khoảng ngân hàng cá nhân của bà.

Nạn nhân trao Nguyen tờ ngân phiếu 2,000 đôla cho tiền huê hồng, tín rằng các tờ ngân phiếu đã đưa tiền vào ngân hàng.

Sau đó khám phá ra: cả 3 tời ngân phiếu đều dỏm.

Nạn nhân mới liên lạc với Nguyen, thì số phone nghi can đã cắt.

Cảnh sát đỏ tìm, bắt được Nguyen tại nhà riêng của y ở Santa Ana, và tổng giam vào nhà tù Quận Cam về tội tor65m và các tội lừa gạt liên hệ.



Governor Newsom Talks Partnerships, Collaboration with Cities at League Board Meeting

The Governor met with the League of California Cities Board of Directors for more than an hour in an engaging session that touched on a number of priority issues for California cities and the League, including housing, homelessness, disaster preparedness and pensions.

"We appreciate the Governor traveling to Grass Valley to speak to the board on issues that are affecting all of California's communities," said League President Jan Arbuckle, Council Member, Grass Valley. "By meeting with our Board — a Board that represents the diversity of our State — Governor Newsom showed his belief in the value of strong partnerships with cities."

During the meeting, President Arbuckle, who chaired the League and California State Association of Counties Joint Homelessness Task Force, thanked the Governor for including additional resources in his budget proposal for cities and counties to address homelessness.

He described the enormity of the challenge and his commitment to funding permanent housing and supportive services, which his budget proposal reflected by including \$500 million for emergency homeless funding for cities and counties and another \$100 million for county "whole person care" programs.

He was also receptive to the League's interest in playing a role in the new Commission on Homelessness and Supportive Housing, which Sacramento Mayor Darrell Steinberg will chair.

The Governor also responded to questions about partnering with cities to find solutions to address the housing crisis and the need to increase housing production. While he continues to support holding cities who are not in compliance with state housing laws accountable, he is also committed to ensuring cities are getting resources for local planning and to the idea of rewarding communities who are doing their part.

He also stood by his recent comments about exploring the concept of the California Environmental Quality Act (CEQA) streamlining to accelerate housing production.

In order to strengthen disaster and crisis response, the Governor shared his vision for a standardized approach to how the public is alerted during an emergency and announced a statewide summit with California cities and other stakeholders to share best practices for disaster recovery and emergency planning.

In the area of pensions, with the recent funded status of the CalPERS falling to 65 percent after a 10-year bull market run, board members expressed concerns to the Governor about rising pension costs outstripping revenue growth and reducing cities' ability to maintain service levels.

The Governor acknowledged the concerns and expressed his willingness to convene cities and other stakeholders to focus on solutions that would lead to a sustainable pension system in the state.

The Governor's meeting with the board followed the League Officers meeting with his chief advisors in January.

Throughout last week's conversation with the League board, the Governor expressed his interest in collaborating and

partnering with cities to address key issues that are impacting all of California's communities.

He also expressed interest in furthering the partnership with the League and California cities and hopes that his schedule allows him to attend the League's Legislative Action Day in April in Sacramento.


