BACKGROUND/DISCUSSION

Louis Lake Senior Center, or other city facilities if the Center is not available, will be opened as a cooling center for residents who may need to utilize a facility with air conditioning to offset the extreme heat of summer. 





Christ Cathedral will look the same – except inside

GARDEN GROVE » Outside, in defiance of its serene backdrop, a jackhammer thunders away. Sparks flare from a power saw as it ear-piercingly grinds through steel.

Inside, sounds of construction echo through a cavernous space that is at once familiar and disorienting — with flooring uprooted, seats gone and tall scaffolding everywhere.

The famous glass structure, built four decades ago as the Crystal Cathedral, is undergoing its transformation into Christ Cathedral — center of Catholicism in Orange County.

"I like to think of it as our downtown," said the Rev. Christopher H. Smith, rector. "Cathedrals have always been the center of the city, not just for religious

purposes but for serving the community as a whole."

On Friday, Bishop Kevin Vann led a noon Mass to commemorate the upcoming "year of preparation." The cathedral will not officially be a cathedral until its dedication, scheduled for July 17, 2019.

Meanwhile, services are offered in a less spectacular hall on the 34-acre campus.

In 2012, two years after the Rev. Robert H. Schuller's Crystal Cathedral Ministries filed for bankruptcy, the Roman Catholic Diocese of Orange bought the Garden Grove site for \$57.5 million.

The \$72.3 million renovation project began last summer with seismic retrofitting, installation of air conditioning, fountain repairs and other improvements.

For months, a demolition team has been stripping the 12-story-high, 45,000-square-foot building of its past identity.

As deconstruction comes to a close, the second half of the task begins — reconstruction. At this very moment, marble flooring is crossing the ocean from Italy.

here daily, including weekends, to stay on schedule," said Eric Flynn, construction manager.

Ultimately, the exterior will look the same as it did before, said spokesman Ryan Lilyengren.

"It's an archaeologically acclaimed building," Lilyengren said. "The historic shell of the original Crystal Cathedral will be maintained and restored."

However, Catholic and Protestant facilities have different needs and functions, he said.

A "Bishop's Door," for instance, traditionally provides entrance into a Roman Catholic cathedral. It will consist of two 20-foottall bronze doors, replacing the Crystal Cathedral's glass doors.

Catholic cathedrals also feature baldachins, centerpieces designed to draw attention. At Christ Cathedral, a metallic baldachin and a carved crucifix will hover 30 feet above the altar.

Oak pews surrounding the altar will seat about 2,000 visitors.

One thing that stays: the Crystal Cathedral's 16,000-piece pipe organ, currently under restoration. "It's one of the largest in the world," Lilyengren said. "Organ geeks even have a Facebook page for it."

Most iconic, the "crystal" that formed the Crystal Cathedral lives on — albeit in appearance only.

Each of the 12,000 panes of glass has been painstakingly replaced with 5-foot squares consisting of "petals" — shaded triangles individually angled to allow



in just the right amount of light.

Anyone who sat sweltering through a Crystal Cathedral service on a summer day can remember how the flat glass panels invited relentless sunbeams.

Appointed as Christ Cathedral's rector in 2012. Smith has overseen every step of the remodel starting with raising funds to accomplish it.

"People have been so generous," he said. "I'm in awe for two reasons - first because of what we're doing, and second because we're able to do it."



Construction on the former Crystal, now Christ Cathedral, in Garden Grove will continue for another year. Its dedication is not scheduled until July 17, 2019.

It might be July 5, but the Fourth of July war zone continues

If it's the first week of July, well, you don't have to be Brainiac to know what that means: It's time for the annual war zone in Westminster and Garden Grove of illegal fire-



Peter Larsen Brainiac works blasting off all day and all night for a good 10 days on either side of the holiday.

At our home on the western side of Westminster, it started slowly more than a week ago. A pop-pop-pop here, a huge boom there. And judging from the neighbors on

hyperlocal social media sites such as Facebook and Nextdoor.com, it's been like that everywhere.

"To the jerk who, year after year, sets off illegal aerial mortars in our neighborhood ... the police will find you!" wrote one Nextdoor user who pinpointed his particular nemesis as living in an apartment complex near Trask Avenue and Descanso Drive opposite the Walmart on Beach Boulevard in Westminster. "Your neighbors will report you. They can do it anonymously at (714) 548-3212."

That comment landed on a thread below a post left by Westminster Police Department Commander Cameron Knauerhaze, letting residents know that the department has been working in recent weeks to bust anyone with illegal fireworks.

"As promised, detectives have been involved in numerous sting operations this week and have made several arrests," Knauerhaze wrote. "Although I can't go into much detail on the stings, I can report we have seized well over 2,000 illegal fireworks. In one case, several mortar type explosives were seized. Thank you for your patience and we will keep up the 'good fight.'"

The Westminster Police Department's Facebook page also features photos of suspects arrested in connection with illegal fireworks in the city, with the alleged bad guys' faces obscured or cropped out but their handcuffs visible, as were their illegal if colorful explosives.

In Garden Grove, the Police Department has also been running a PR campaign to remind people not to break the law with the dangerous and outlawed fireworks, emphasizing the danger in particular with information on the kinds of things that can happen to you when you light off these bad boys.

A poster from the U.S. Consumer Product Safety Commission of the Garden Grove Police Department Facebook page states that every day during the month of July an average of 250 people a day end up in the emergency room for treatment of fireworks-related injuries. More

than two-thirds of those are there for burns caused by fireworks. The most commonly in-

jured part of the body is pretty easy to guess. Hands and fingers, come on down! You count for a third of the injured body parts.

Second place isn't difficult to figure out either: Heads, faces

and ears count for 28 percent of injuries, and eyes get their own category and make up 9 percent of injuries. Then it gets random, with 18 percent of injuries happening to legs — low-flying mortars? — 8 per-

cent to arms and 12 percent to trunks and "other." And no, we don't even want to contemplate what "other" might include.

After the bubble burst: How homebuying fared in Huntington Beach, Fountain Valley, Garden Grove, Westminster

Homebuying in what we'll call the "Beach Blvd. Corridor" — in and around Huntington Beach, Fountain Valley, Garden Grove and Westminster — rose 34 percent in 2008's first quarter vs. 2018

In the first quarter of 2008, housing's bubble was bursting and it was just months before the global financial collapse that led to the Great Recession. This three-month period still stands as Orange County's slowest-selling start to any year in CoreLogic's database that dates to 1988.

We decided to see how neighborhood housing markets fared since, comparing homebuying's start of 2008 vs. this year's first three months.

CoreLogic found these 19 trends in 13 ZIP codes covered by the Orange County Register's The Wave weekly, ...

1. Purchases: Home sales in this period totaled 984 vs. 735 a decade ago, a gain of 33.9 percent.

- 2. Who's up: Prices increased in 13 of the 13 ZIPs as sales rose in 12 ZIPs.
- **3. Countywide:** \$710,000 median selling price, up 38.4 percent. Orange County sales totaled 7,800 residences, existing and new, vs. 4,419 a decade ago, a gain of 76.5 percent. Prices rose in 79 out of 83 Orange County ZIPs and sales were up in 76 out of 83 ZIPs.

Here is how prices and sales moved at the community level ...

- **4. Fountain Valley 92708:** \$760,000 median, up 32.8 percent. Price rank? 31st of 83. Sales of 119 vs. 70 a decade ago, a gain of 70.0 percent.
- **5. Garden Grove 92840:** \$560,000 median, up 38.3 percent. Price rank? No. 67 of 83. Sales of 89 vs. 69 a decade ago, a gain of 29.0 percent.

Christ Cathedral will look the same – except inside

GARDEN GROVE » Outside, in defiance of its serene backdrop, a jackhammer thunders away. Sparks flare from a power saw as it ear-piercingly grinds through steel.


Inside, sounds of construction echo through a cavernous space that is at once familiar and disorienting — with flooring uprooted, seats gone and tall scaffolding everywhere.

The famous glass structure, built four decades ago as the Crystal Cathedral, is undergoing its transformation into Christ Cathedral — center of Catholicism in Orange County.

"I like to think of it as our downtown," said the Rev. Christopher H. Smith, rector. "Cathedrals have always been the center of the city, not just for religious purposes but for serving the community as a whole."

On Friday, Bishop Kevin Vann led a noon mass to commemorate the upcoming "year of preparation." The cathedral will not officially be a cathedral until its dedication, scheduled for July 17, 2019.

Meanwhile, services are held in a less spec-CATHEDRAL » PAGE 10

tacular hall on the 34-acre campus.

In 2012, two years after the Rev. Robert H. Schuller's Crystal Cathedral Ministries filed for bankruptcy, the Diocese of Orange purchased the Garden Grove site for \$57.5 million.

The \$72.3 million renovation project began last summer with seismic retrofitting, installation of air conditioning, fountain repairs and other improvements.

For months, a demolition team has been stripping the 12-story-high, 45,000-square-foot building of its past identity.

As deconstruction comes to a close, the second half of the task begins - reconstruction. At this very moment, marble flooring is crossing the ocean from Italy.

"We have about 125 workers here daily, including weekends, to stay on schedule," said Eric Flynn, construction manager.

Ultimately, the exterior will look the same as it did before, said spokesman Ryan Lilyengren.

"It's an archaeologicallyacclaimed building," Lilyengren said. "The historic shell of the original Crystal Cathedral will be maintained and restored."



Graduation is a first for Vietnamese family after so much tragedy

She carried roses and a giant smile. Her parents put their arms around her, posing for pictures on graduation day at the University of California, Irvine. She wore the traditional black robe and square, tasseled cap. The strands of blue and gold cords dangling from her neck signified that she was graduating summa cum laude. She had never received a grade lower than an A with a bachelor's degree in psychology.

And yet that graduation in June was just a small part of the story of Skyler Phamle, 25. The fact that she was in America and alive, that's what made her family proud. "This is only one chapter," Skyler said.

Loan Le, Skyler's mother, was raised with seven brothers and sisters in Vietnam during the war-torn 1960s and '70s. The poverty was overwhelming in those days. The Le family, like most everyone else in Saigon, had to line up for rice rations. "My mom never went into depth about her story," Skyler said. "Every time she started to tell me, she would cry."

If the Le family was known for anything in Saigon, it was for trying to escape. Two of Loan Le's sisters left their home one morning, headed for the shoreline, boarded a boat bound for America and were never seen again. The boat never made it to its destination. The lives of the sisters, the Le family believed, were claimed by the sea.

The tragedy, however, didn't deter other Le siblings. It wasn't too long before two other of Loan Le's sisters and a brother left home for the promise of America. Their boat and their lives were lost as well.

Then, another Le brother set out on the same journey. After three weeks at sea, old people on his small boat started dying. As bigger boats passed them in the Pacific Ocean, they screamed for help. Finally, a tourist vessel from France rescued the passengers on the tiny boat. A year and a half later, the Le family received a letter from France. Skyler's uncle had survived.

Back in Vietnam, the dream of escape was still strong. In 1980, Loan Le decided to risk her life and leave home just as her six siblings had done. But her mother stopped her on the way out the door. "My grandmother was crying," Skyler said. "She said, 'I don't want to lose another child." Loan Le agreed to stay. She was 21 years old when she made the decision that saved her life.

Loan Le's parents arranged for her first date with Phuong Pham, a military man who had fought in the jungles of Cambodia. Phuong had two sisters who had successfully made the trip to America. His dream to come to the United States was strong too. But he was determined to do it the legal way. Loan and Phuong were married in 1988. They made their living selling ice cream from a street cart. Eventually, they

bought a store that they called "Phuong Loan Ice Cream." Their son Alex was born in 1989.

When you wanted to leave Vietnam, and you didn't want to risk your life, you needed to apply through official government channels. You needed a sponsor in the United States (remember, Phuong had two sisters in America). And you needed to wait 12 years for approval. So the Phamle family began waiting.

Skyler was born in 1993. Her given name was Han (more on her name later). She and her brother were raised in a house with a small corner of their living room dedicated to the relatives that were lost at sea. Every year, the Phamles were determined to celebrate the lives of those who were lost. "We didn't know what day they died," Alex Phamle said. "So we had a day for them every summer."

There was a major glitch in the Phamles' plan to come to the United States. Phuong's sister, fearing a financial burden, pulled her support. So the Phamles had to start the 12-year process over again.

Skyler participated in a student exchange program in France, where she got to know her uncle and the French language. When she returned to Vietnam, she began to think about expanding her horizons. By 2011, Skyler and her brother started to get excited. That's when the potential of moving started to feel real. They started filling out paperwork to make the move to America official. "Mom used to talk about freedom," Skyler said. "In Saigon, the government controls everything you do."

The Phamles finally came to Southern California on May 29, 2014. The citizenship process will take them five years.

Skyler expected America to be "fancy." The first difference she noticed? "Everybody has cars," she said. Skyler noticed that all the people she met seemed to be addicted to coffee. Americans, she said, wear shoes indoors. In restrooms, she saw girls putting liquid soap on their hands BEFORE the water. What a strange place.

The Phamles rented a one-room apartment in Garden Grove. They only had two beds so they took turns sleeping on the floor. Skyler and Alex enrolled in college. She wanted to make a name for herself, literally. "If I have an English name," she said, "people will remember it." First, she considered Hannah. "Too girly," she said. Then Haley. "I didn't vibe with Haley." She saw a television character named Skyler. "Skyler is cool," she said. "I liked that. There are very few people named Skyler."

Skyler will start working on her master's degree at Cal State Long Beach this fall. She wants to be a psychologist. "I worked my (expletive) off," she said. "I'm going to

show what I can do. I used to think that I'm doing this for myself. But I want to make my family proud. I know the sacrifices they made. I want to honor them."

The person she has impressed the most? Her brother. "She is the first one who graduated in our family history," said Alex, who hopes to graduate from Cal State Fullerton next year. "She's the one who carries the family name. My parents are very proud of her and I am too. I know how hard graduating is to do. "She's really amazing. She's my idol."

The next most important date in their lives will come next year. On May 28, 2019, the Phamles will become eligible to take the test to become U.S. citizens. "This is the way my family sees it," Skyler said. "Are you going to make it count?"

While most Orange County communities still ban residents from setting off fireworks – many warn of hefty fines if you do – 10 cities allow the sale and use of safe and sane fireworks.

Here's the information on when fireworks can be bought and used in those towns:

Anaheim

Residents may purchase the approved fireworks from June 28 to July 4 at 16 stands, here is where you can find the nearest stand. Fireworks may only be used from 10 a.m. to 10 p.m. on July 4. Sales end at 9 p.m. on the holiday.

Fireworks use is not allowed in the hilly eastern side of Anaheim where wildfires are a risk. The ban runs east of the 55 and east and southeast of the 91 freeway.

Buena Park

There will be safe and sane fireworks sold at about booths throughout the city from 10 a.m. to 10 p.m. on June 30 to July 3 and 10 a.m. and 9 p.m. on July 4. Fireworks may be discharged from 10 a.m. to 10 p.m. on the Fourth.

Costa Mesa

Fireworks will be on sale from 10 a.m. to 10 p.m. from June 30 to July 3 and 9 a..m. to 9 p.m. on July 4. Fireworks may be discharged from 4 to 10 p.m. on July 2-4.

Fullerton

Stands open in the city from noon to 10 p.m. July 1 to 3 and from 10 a.m. to 9 p.m. on July 4. Fireworks may be discharged from 10 a.m. to 10 p.m. on July 4.

Garden Grove

Fireworks sales will be open in the city 10 a.m. to 11 p.m. July 1 through 3 and 10 a.m. to 10 p.m. on July 4. Use of safe and sane fireworks is allowed on private property only.

Huntington Beach

There will be 15 school, youth and community groups selling safe and sane fireworks at city-approved booths from noon to 10 p.m. on July 1-3 and 10 a.m. to 9 p.m. on July 4. Fireworks may be used in the city only on July 4 – from noon to 10 p.m. No fireworks at the beach or public places.

Santa Ana

The city allows booths hosted by community groups to sell safe and sane fireworks starting at noon on July 1. Hours are noon to 10 p.m. on July 1; 10 a.m. to 10 p.m. on July 2 and 3; and 10 a.m. to 9 p.m. on July 4. Fireworks may be discharged from July 1 to 4.

Stanton

Sales of safe and sane fireworks in the city are allowed from noon to 10 p.m. on July 1 and from 9 a.m. to 10 p.m. on July 2 to 4. Approved fireworks may only be used on private residential properties and only from 10 a.m. to 11 p.m. on July 4.



Legislative Deals Struck Prior to Deadline to Pull Ballot Measures July 2, 2018

A flurry of legislative deals were made last week to keep certain ballot measures from appearing on the November ballot.

Additional items were also placed on the ballot by legislative action. These agreements came together just before the June 28 deadline for proponents to pull measures from the ballot. Several of these compromises directly impact cities. Also read "Governor Signs His Final State Budget and Numerous Trailer Bills," and "Legislature Passes FY 2018–19 State Budget with Funding for Homelessness Programs, Disaster Response, Transportation Projects and Rainy Day Fund" for the League's detailed analysis of the state budget and subsequent trailer bills.

Legislative Deals That Removed Ballot Measures

The following bills were passed by the Legislature and signed into law by Gov. Jerry Brown on Thursday, June 28.

Tax Fairness, Transparency and Accountability Act of 2018, AB 1838 (Budget)

The Tax Fairness, Transparency and Accountability Act, which was labeled by the League and other opponents as "The Corporate Tax Trick," was slated to appear on the November 2018 ballot. The ballot measure would have drastically limited the ability of local agencies to fund services by requiring all local taxes to be subject to a two-thirds vote, retroactively repealing 25 measures approved in June by local voters and placing onerous conditions on the imposition of local fees.

AB 1838 contains the comprise trailer bill deal supported by major soda corporations which had spent over \$7 million to qualify the ballot measure. This measure pre-empts the ability of cities and other local agencies from levying any new tax, fee or assessment on groceries and soda for 12 years.

The League submitted an <u>oppose letter</u> on AB 1838 because of a provision that would withhold all sales taxes if a charter city, or their voters, validly exercise their existing constitutional right to address local municipal affairs, which includes the decision of whether or not to levy a soda tax. Charter city authority would be quickly eroded if other interest groups used this precedent in the effort to undermine a constitutional right.

Following the Governor's signature of AB 1838, the Corporate Tax Trick was removed from the November ballot.

California Consumer Privacy Act of 2018, AB 375 (Chau)

The <u>California Consumer Privacy Act of 2018</u> ballot measure qualified to be on the November 2018 ballot but was pulled by proponents following the passage of AB 375 (Chau). The ballot measure would have given consumers the right to control their personal information or data collected by companies using or providing internet services. Customers would have been able to stop a company's collection of their data and hold a company accountable for information that is compromised due to a data breach.

AB 375 (Chau) is a narrower version of the ballot measure. Opponents to the initiative expressed their concerns over the compromise bill, but preferred it to the ballot measure. This was, in part, because AB 375 narrowed the circumstances under which consumers could sue companies. The League did not have an official position on either the trailer bill or the ballot measure.

Healthy Homes and Schools Act 2018

The lead paint measure was removed from the November ballot. Last minute negotiations involving a proposed ballot measure sponsored by paint companied titled the <u>Healthy Homes and Schools Act</u>, addressing liability for lead paint remediation, took place on Thursday. The proponents agreed to drop the ballot measure in exchange for other bills not moving through the legislature.

Other Legislative Measures Placed on the Ballot

The Legislature placed two other measures on the ballot that were unrelated to pending ballot measures.

No Place Like Home Act of 2018, AB 1827 (Budget)

The original No Place Like Home program was signed into law on July 1, 2016. This program authorized the distribution \$2 billion dollars among counties as deferred payment loans to finance capital costs of permanent supportive housing for persons who are eligible for services under Proposition 63 (2004) and are homeless, chronically homeless, or at risk of chronic homelessness. Although this program is currently law, it has not allocated funds due to legal challenges, thus the Legislature opted to seek ratification of this program by the voters.

Under AB 1827, now Prop. 2, the voters are being asked to ratify the No Place Like Home program, which proposes to fund the construction of 10,000 housing units available for the homeless and mentally ill, as being consistent with and in furtherance of the Mental Health Services Act. The League supported the original No Place Like Home bill, supported AB 1827, and now supports Prop. 2.

Elimination of Daylight Savings Time AB 807 (Chu)

After several prior unsuccessful attempts, Assembly Member Kansen Chu (D-San Jose), succeeded in his quest to pass AB 807 (Chu), which will give California voters the choice to ratify the repeal of daylight savings time via Prop. 7. The League does not have a position on this ballot measure.

Governor Signs His Final State Budget and Numerous Trailer Bills July 2, 2018

Over the last two weeks, the Legislature approved a second package of budget trailer bills following the initial adoption of the budget on June 14.

Gov. Jerry Brown signed the budget into law on Wednesday, June 27 and finished activity on all trailer bills by Thursday, June 28. Details on the major budget appropriations and initial round of trailer bills were published in CA Cities Advocate on June 15.

Of interest to cities, this package contains several housing and economic development-related measures, including AB 1827, which places the No Place Like Home Act of 2018 on the November 2018 ballot, SB 856, which appropriates the state's Greenhouse Gas Reduction Fund revenues, SB 871, which extends the existing \$300 million film tax credit by five years, and AB 1838, which would pre-empt the ability of cities and other local agencies from levying any new tax, fee or assessment on groceries and soda for 12 years.

Significant activity also occurred related to several deals negotiated in order to pull measures from the ballot. Please see the League's legislative trailer bills deal story "Legislative Deals Struck Prior to Deadline to Pull Ballot Measures."

Trailer Bills of Significant Interest to Cities

These bills enact statutory changes to implement budget appropriations. Each of these bills have been passed by the Legislature and signed by the Governor. Detailed descriptions of the key provisions for cities are outlined below.

AB 1827 (Budget) - No Place Like Home

This trailer bill enacts the No Place Like Home Act of 2018 and provides for submission of the act to the voters at the Nov. 6, 2018 statewide general election. The voters are being asked to ratify the No Place Like Home program, which proposes to fund the construction of 10,000 housing units available for the homeless and mentally ill, as being consistent with and in furtherance of the Mental Health Services Act.

AB 1838 (Budget) — Local Governments Prohibition of Taxation on Groceries

AB 1838 is a comprise trailer bill deal that was supported by major soda corporations to remove the Tax Fairness and Accountability Act measure from the ballot. This proposal preempts the ability of cities and other local agencies from levying any new tax, fee or assessment on groceries and soda for twelve years.

The League submitted an <u>oppose letter</u> on AB 1838 because of a provision that would withhold all sales taxes if a charter city, or their voters, exercise their existing constitutional right to address their municipal affairs.

On June 28, the Governor signed AB 1838 and subsequently the Tax Fairness and Accountability Act measure was removed from the ballot.

<u>SB 856</u> (Committee on Budget and Fiscal Review) — Greenhouse Gas Reduction Fund and Proposition 56 Revenue Allocations

SB 856 appropriates a \$1.4 billion GGRF expenditure plan for FY 2018-19.

As with previous expenditure plans, 60 percent of the Cap-and-Trade revenues in the Greenhouse Gas Reduction Fund (GGRF) will automatically be spent on continuous appropriations for High Speed Rail, the Affordable Housing and Sustainable Communities program, the Transit and Intercity Rail Capital program, and Low Carbon Transit Operations. The remaining 40 percent of GGRF funds are appropriated annually each year to numerous state agencies and grant programs.

Cities and other local governments are eligible for a number of GGRF-funded programs. In fact, the League has worked all year to secure additional GGRF funding for local fire prepositioning, waste diversion, the Transformative Climate Communities program, and the Beacon Program operated by the Institute for Local Government (ILG).

Some of the highlights for local governments of the \$1.4 billion expenditure plan include:

- <u>Local Fire Response</u> \$25 million to the Governor's Office of Emergency Services (CalOES) for local fire response to be used for procurement and maintenance of fire engines and support of the California Fire and Rescue Mutual Aid System.
- Waste Diversion \$25 million to CalRecycle for waste diversion, which fund infrastructure
 grants to help meet new organic waste diversion rules and address declining recycling markets.
- <u>Transformative Climate Communities</u> \$40 million to the Strategic Growth Council for the Transformative Climate Communities program, which fund grants for neighborhood-level innovative projects that reduce GHG emissions in the most disadvantaged communities.
- <u>Urban Greening</u> \$20 million to the Natural Resources Agency for urban greening grant program.
- <u>Urban Forestry</u> \$5 million to CAL FIRE for urban forestry grant program.
- <u>Beacon</u> \$2 million to the Strategic Growth Council for technical assistance to disadvantaged communities, including \$1 million for which ILG is eligible for the Beacon Program.
- <u>Healthy Forests</u> \$160 million to CAL FIRE for healthy and resilient forests programs and projects primarily in or adjacent to state responsibility areas.

- Of this, \$155 million may be used for grants to local governments, Fire Safe Councils, certified local conservation corps, qualified nonprofits for programs and projects primarily in or adjacent to state responsibility areas. It also includes funding for inspections by CAL FIRE and local fire departments for compliance with defensible space requirements around habitable structures in or near state responsibility areas and in Very High Fire Severity Zones. At least 10 percent of these funds must be granted to cities, counties, or special districts.
- Forest Carbon Plan \$50 million to begin implementing the Administration's Forest Carbon Plan
 - \$30 million to CAL FIRE for prescribed fire and other fuel reduction projects.
 - \$20 million to the Natural Resources Agency for grants to expand the Sierra Nevada Conservancy's Watershed Improvement Program model to additional regions for vegetation management, healthy forests, prescribed burns, or other fuel treatment and forested watershed projects.
- <u>Low-Income Energy Efficiency</u> \$10 million to the Department of Community Services and Development for low-income solar and multi-family weatherization programs, including at least \$2 million for farmworker housing.

SB 871 (Committee on Budget and Fiscal Review) Film Production Tax Credit

This bill extends the existing film production tax credit at \$330 million annually for five years from Jan. 1, 2020, through the end of FY 2024-2025. Tax credits of 20 percent or 25 percent of qualified expenditures are offered for the production of a qualified motion picture in this state, with additional credit amounts allowed for productions that return to California, and for original photography occurring outside the Los Angeles zone, as specified.

SB 855 (Committee on Budget and Fiscal Review) Tax Credits: CalCompetes, Hiring, EITC

This bill extends and expands various state tax credit programs, as follows:

- Extends the California Competes Tax Credit Program, which provides incentives for employers to grow and retain high-wage jobs, until Jan. 1, 2030, and authorizes annual allocations of \$180 million in credits until FY 2022-23. Contains additional modifications to the program.
- Extends the existing state Hiring Tax Credit program, which offers tax credits to employers hiring individuals facing hiring challenges in various census tracts, until Jan. 1, 2026.
- Increases the amount of the state's Earned Income Tax Credit (EITC) and expands its application to additional individuals.
- Removes the sunset date of Jan. 1, 2019, for the program which authorizes the Franchise Tax Board (FTB) and local governments to enter into data exchange agreements with the object of improving collection of applicable state and local taxes.

Other Trailer Bills

Each of these bills have passed and been signed by the Governor.

AB 1808 (Budget) Education

This omnibus trailer bill makes changes to early childhood education and K-12 education administration.

AB 1809 (Budget) Higher Education

This higher education trailer bill makes changes to the University of California, California State University and California Community College systems. It also includes a one-time \$10 million allocation to expand mental health services and training to community colleges.

AB 1810 (Budget) Health

This omnibus health trailer bill makes technical and clarifying statutory changes to the administration of health care and health care services. Several provisions, however, were included in this measure of particular interest to cities:

- Eliminating the sunset extension for needle exchange programs;
- Setting an application fee for certification to perform lead-related construction work in public and residential buildings; and
- Authorizes pre-trial diversion program for individuals with certain mental disorders alleged to have committed a misdemeanor or felony offense.

AB 1811 (Budget) Human Services

This omnibus human services trailer bill makes a number of changes to the CalWORKs program, Home Safe Program, and child welfare systems, and includes the following provisions:

- Increases the daily rate for CalWORKs temporary homeless assistance from \$65 to \$85 per day
 for shelter for families up to four members. With additional family members at \$15 each, the
 maximum allowable rate will be \$145. County welfare departments have authority to increase
 these amounts to secure additional bed space needed by the family.
- Increases CalWORKs grants by 10 percent commencing April 1, 2019.
- Requires group homes to develop protocols designed to limit the frequency of law enforcement involvement arising out of incidents at group homes and other licensed residential facilities providing care for dependent children.

AB 1812 (Budget) Public Safety

This public safety omnibus trailer bill that makes technical changes to Department of Corrections and Rehabilitation administration processes and the juvenile justice reform system, which include:

- Allowing youths committed to the Division of Juvenile Justice on or after July 1, 2018, who would
 previously have been sentenced for up to seven years, to be released from custody in two years, or
 at age 23, whichever is later, unless an order for further detention has been made by a committing
 court.
- Establishing an innovation grant program to develop law enforcement trainings to reduce officerinvolved shootings.

SB 847 (Budget) — Courts

This court related omnibus trailer bill that makes technical and clarifying changes to the court system.

SB 849 (Budget) — Proposition 56 Medi-Cal Physicians and Dentists Loan Repayment Act Program

This bill makes technical and clarifying changes to heath related programs including:

- providing loan assistance payments to qualifying, recent graduate physicians and dentists that serve beneficiaries of existing health care programs; and
- authorizing a medical-dental integration pilot program for Medi-Cal beneficiaries in San Mateo County as part of the Medi-Cal 2020 demonstration project.

SB 866 (Budget) — General Government (Civil Service)

This bill authorizes the Department of Human Resources to provide training programs to any public employee or officer so that the quality of service rendered by those persons may be continually improved.

Other Ballot Related Legislation

The Governor signed the following bills into law on June 28 as part of legislative deals related to ballot

measures.

AB 375 (Chau) Internet Privacy and Collection of Personal Information

This bill will give consumers the right to control their personal information or data collected by companies using or providing internet services and allow them to hold a company accountable for information that is compromised due to a data breach.

AB 807 (Chu) — Elimination of Daylight Savings Time

AB 807 (Chu) will give California voters the choice to ratify the repeal of daylight savings time on the November ballot.

Trailer Bills Still to be Acted On

When the Legislature adjourned on Thursday, there were two remaining trailer bills to be acted on. Action on these trailer bills could take place over the next several weeks.

AB 1823/SB 857 (Budget) — In-home Supportive Services

This bill makes technical and clarifying changes to the In-Home Supportive Services program.

AB 1836/SB 870 (Budget) — 911 Fee

This trailer bill has necessary statutory and technical changes related to public safety. This bill also requires a monthly surcharge of between \$0.20 to \$0.80 per phone line to fund current 911 system operations.

- In the involvement of all stakeholders in establishing goals and solving problems.
- In conducting the business of government with openness, transparency, respect and civility.
- The spirit of honest public service is what builds communities.
- Open decision-making that is of the highest ethical standards honors the public trust.
- The vitality of cities is dependent on their fiscal stability and local autonomy.
- The active participation of all city officials increases the League's effectiveness.
- Partnerships and collaborations are essential elements of focused advocacy and lobbying.
- Ethical and well-informed city officials are essential for responsive, visionary leadership and effective and efficient city operations.

The plan features six clear, powerful goals that will guide our actions and ensure progress in the years ahead:

• Goal 1: **ADVOCACY**. Strengthen California cities through proactive advocacy on common priority issues.

- Goal 2: **EDUCATION AND TRAINING**. Increase the capacity of city officials and staff in California to provide the highest level of service to their communities.
- Goal 3: MEMBERSHIP. Maintain high relevance and facilitate meaningful member engagement.
- Goal 4: VISIBILITY. Raise the League's visibility as the preeminent voice for cities in California.
- Goal 5: **GOVERNANCE**. Enhance the League's governance to achieve even higher levels of engagement and effectiveness.
- Goal 6: **ORGANIZATIONAL EFFECTIVENESS**. Expand the League's organizational capacity to fulfill its mission and implement its strategic priorities.

"This three-year strategic plan is designed to help chart our course as we move forward. However, an approved plan with clear, powerful goals is just the beginning. Our focus now shifts to implementing the plan with bold actions. We look forward to the months and years ahead as we take steps towards achieving these goals that I'm confident will deliver even greater value to cities across the state," said Carolyn Coleman, League executive director.
