RE: Response to the 2017-18 Orange County Grand Jury Report re: Housing Orange County's Chronically Homeless

Dear Judge Margines,

In accordance with Penal Code 933.05(a) and (b), the City of Garden Grove submits the following response to the report, findings, and recommendations of the 2017-18 Orange County Grand Jury report entitled, "Where There's Will, There's A Way: Housing Orange County's Chronically Homeless".

#### **FINDINGS**

F1. Homelessness in Orange County is a regional problem requiring regional approaches and solutions.

Response: The City of Garden Grove agrees with the above finding.

F2. The lack of a regional plan designating specific development goals for Permanent Supportive Housing contributes to an insufficient number of available units to house the chronically homeless.

Response: The City of Garden Grove agrees with the above finding.

## F4. Cities' reluctance to provide sites for Permanent Supportive Housing development has contributed to the overcrowded emergency shelters and an increased unsheltered homeless population.

Response: The City of Garden Grove disagrees partially with the above finding. The City of Garden Grove is fully committed to partnering with the County and its fellow municipalities to produce Permanent Supportive Housing units. The City of Garden Grove is a member of the Association of California Cities – Orange County (ACCOC) and, as such, is a member of the ACCOC Homelessness Task Force. On May 8, 2018, the Garden Grove City Council adopted Resolution No. 9504-18 (Attachment 1) authorizing City Staff to participate in the ACCOC's planning efforts regarding County-wide permanent supportive housing. The Orange County Board of Supervisors has published its "Affordable Housing Strategic Plan", which provides a comprehensive, regional housing business plan that identifies both the number of Permanent Supportive Housing units needed as well as the associated costs of renovating existing units or building new ones. The City of Garden Grove anticipates (upon City Council approval) pledging its support of the "Affordable Housing Strategic Plan" and working with the County to implement its recommendations.

## F6. Service Planning Area meetings have successfully brought together city, county and non-profit entities to share information on homeless issues, but have not fostered decision-making or action.

Response: The City of Garden Grove agrees with the above finding.

## F7. NIMBYism has impeded the creation of housing for the homeless, including Permanent Supportive Housing, in the County of Orange.

Response: The City of Garden Grove agrees with the above finding.

## F8. Orange County cities and the County have engaged in blaming and finger-pointing, hampering the collaborative efforts needed to site, finance, and maintain Permanent Supportive Housing.

Response: The City of Garden Grove disagrees partially with the above finding. The City of Garden Grove is fully committed to partnering with the County and its fellow municipalities to produce Permanent Supportive Housing units. The City of Garden Grove is a member of the Association of California Cities – Orange County (ACCOC) and, as such, is a member of the ACCOC Homelessness Task Force. On May 8, 2018, the Garden Grove City Council adopted Resolution No. 9504-18 (Attachment 1) authorizing City Staff to participate in the ACCOC's planning efforts regarding County-wide permanent supportive housing. The Orange County Board of Supervisors has published its "Affordable Housing Strategic Plan", which provides a comprehensive,

regional housing business plan that identifies both the number of Permanent Supportive Housing units needed as well as the associated costs of renovating existing units or building new ones. The City of Garden Grove anticipates (upon City Council approval) pledging its support of the "Affordable Housing Strategic Plan" and working with the County to implement its recommendations.

## F9. Cities have taken a silo approach to developing Permanent Supportive Housing, resulting in inefficient leveraging and pooling of funds across municipal borders.

Response: The City of Garden Grove disagrees partially with the above finding. Although state law requires Cities to enable the development of shelters and lowincome housing by removing local regulatory barriers, the law does not require cities to acquire real property nor fund development of new housing or shelters. Except for Cities like Garden Grove who have chosen to enact its own Housing Authority and directly manage Federal CDBG, HOME, and ESG grants as an entitlement city, most other cities in the County must apply to the County for pass-through funding for social and housing programs as subrecipients. Welfare and Institutions Code 17000 makes it a County responsibility to provide public assistance to the indigent, and funding for social and housing programs is almost exclusively directed to the County. Consequently, the lack of funding available directly to cities minimizes their ability to take on a direct role in the development of housing and shelters. The City of Garden Grove is fully committed to partnering with the County and its fellow municipalities to produce Permanent Supportive Housing units. The City of Garden Grove is a member of the Association of California Cities - Orange County (ACCOC) and, as such, is a member of the ACCOC Homelessness Task Force. On May 8, 2018, the Garden Grove City Council adopted Resolution No. 9504-18 (Attachment 1) authorizing City Staff to participate in the ACCOC's planning efforts regarding Countywide permanent supportive housing. The Orange County Board of Supervisors has published its "Affordable Housing Strategic Plan", which provides a comprehensive, regional housing business plan that identifies both the number of Permanent Supportive Housing units needed as well as the associated costs of renovating existing units or building new ones. The City of Garden Grove anticipates (upon City Council approval) pledging its support of the "Affordable Housing Strategic Plan" and working with the County to implement its recommendations.

## F10. There is no established, independent leadership body in the County empowered to address regional homeless issues in an effective manner.

Response: The City of Garden Grove disagrees partially with the above finding. The City recognizes the County's efforts in exploring solutions, including the creation of the Homeless Czar and Service Planning Areas.

#### **RECOMMENDATIONS**

R1. Orange County cities and the County should develop a Permanent Supportive Housing development plan, and should consider a plan structure similar to the proposal put forth by Association of California Cities – Orange County, that proportionally allocates sites among the cities. (F1, F2, F4, F7, F8)

Response: The recommendation has not yet been implemented, but will be implemented in the future. The City of Garden Grove is a member of the Association of California Cities – Orange County (ACCOC) and, as such, is a member of the ACCOC Homelessness Task Force. On May 8, 2018, the Garden Grove City Council adopted Resolution No. 9504-18 (Attachment 1) authorizing City Staff to participate in the ACCOC's planning efforts regarding County-wide permanent supportive housing. The Orange County Board of Supervisors has published its "Affordable Housing Strategic Plan", which provides a comprehensive, regional housing business plan that identifies both the number of Permanent Supportive Housing units needed as well as the associated costs of renovating existing units or building new ones. The City of Garden Grove anticipates (upon City Council approval) pledging its support of the "Affordable Housing Strategic Plan" and working with the County to implement its recommendations.

## R2. Each Service Planning Area should identify sites for Permanent Supportive Housing proportional to the allocation suggested in the Association of California Cities – Orange County proposal. (F1, F4)

Response: The recommendation has not yet been implemented, but will be implemented in the future. The City of Garden Grove is a member of the Association of California Cities – Orange County (ACCOC) and, as such, is a member of the ACCOC Homelessness Task Force. On May 8, 2018, the Garden Grove City Council adopted Resolution No. 9504-18 (Attachment 1) authorizing City Staff to participate in the ACCOC's planning efforts regarding County-wide permanent supportive housing. The City of Garden Grove is in the process of producing a list of sites for potential Permanent Supportive Housing developments.

## R4. Cities should ensure decision-makers fully participate in their region's Service Planning Area meetings. (F1, F6, F8, F9)

Response: The recommendation has been implemented. The City of Garden Grove is fully committed to participating in the region's Service Planning Area meetings. Additionally, Garden Grove City Manager, Scott Stiles, is a member of the Orange County City Manager's Association (OCCMA) who is currently working with U.S. District Court Judge Carter to inventory available housing and supportive services in the Central SPA.

## R6. Cities should collaborate with, and leverage the work done by, United Way on their "United to End Homelessness" public awareness campaign. (F7)

Response: The recommendation has been implemented. The City of Garden Grove is collaborating with the United Way in their public awareness campaign, "United to End Homelessness". Additionally, I (Steven R. Jones, Mayor of Garden Grove) am a member of the United Way's "United to End Homelessness" Leadership Council.

# R7. To streamline shelter and Permanent Supportive housing development, the County and its cities should establish a decision-making body, such as a Joint Powers Authority, that is empowered to identify and allocate sites and pool funding associated with housing and supportive services for the homeless. (F1, F3, F4, F7, F8, F9, F10)

Response: The recommendation has not yet been implemented, but will be implemented in the future. The City of Garden Grove is committed to partnering with the County and its fellow municipalities in forming a decision-making body to identify and allocate potential Permanent Supportive Housing sites, and to explore funding options associated with housing and supportive services for the homeless. The County of Orange is in the process of forming a Joint Powers Authority (JPA) known as the Orange County Housing Trust (OCHT) that would act as a regional entity to address homelessness and housing issues through the pooling of public and private funding. The City of Garden Grove anticipates (upon City Council approval) participating in the OCHT.

## R8. Such a decision-making body should develop a comprehensive, regional housing business plan that identifies both the number of Permanent Supportive Housing units needed as well as the associated costs of renovating existing units or building new ones. (F1, F2, F3, F4, F8, F9, F10)

Response: The recommendation has not yet been implemented, but will be implemented in the future. The Orange County Board of Supervisors has published its "Affordable Housing Strategic Plan", which provides a comprehensive, regional housing business plan that identifies both the number of Permanent Supportive Housing units needed as well as the associated costs of renovating existing units or building new ones. The City of Garden Grove anticipates (upon City Council approval) pledging its support of the "Affordable Housing Strategic Plan" and working with the County to implement its recommendations.

## R9. Such a decision-making body should propose a plan for securing local, supplemental sources of funding for both Permanent Supportive housing development and associated support services. (F1, F3, F8, F9, F10)

The County of Orange has published its "Affordable Housing Strategic Plan", which proposes a plan for securing local, supplemental sources of funding for both Permanent Supportive Housing development and associated support services. The City of Garden Grove anticipates (upon City Council approval) pledging its support of the "Affordable Housing Strategic Plan" and working with the County to implement its recommendations.








Estimated average household cost of California WaterFix within the MWD Service Area

## **SUMMARY OF RECENT HIGHLIGHTS**

#### California WaterFix

Metropolitan's board made a historic decision to invest \$10.8 billion, nearly 65 percent of the project cost, to allow for the construction of the fully envisioned California WaterFix project. California WaterFix is a comprehensive solution proposed by state and federal agencies to ensure our state has a reliable water supply for many years to come. It will improve the state's water transportation infrastructure by constructing new, state-of-the art facilities that can secure more reliable water supplies, improve water quality, respond to climate change risks and protect ecosystem health.

Participating public agencies, including Metropolitan, have formed a joint powers authority to manage, design and construct the project, while the State of California maintains a strong and important oversight role. This partnership is the most suitable structure to manage risk and ensure WaterFix is built on time and on budget, meeting all design and construction standards.

#### **Budget**

Metropolitan's newly adopted biennial budget for fiscal years 2018/19 and 2019/20 will improve the reliability of local and imported water supplies, ensure public health and safety, and plan for the future while managing costs through relatively modest rate increases of 4% a year that reflect the cost of service. Metropolitan maintains some of the nation's highest credit ratings among government agencies. This was reaffirmed by S&P Global Ratings in June 2018.

#### **Budget Highlights**

- Plans capital spending of \$500 million to maintain the region's water infrastructure
- Increases investments in conservation programs
- Provides funding for California WaterFix
- Decreases annual debt service costs by \$13 million
- Offsets increases in operations and maintenance costs with lower State Water Project charges

#### Conservation

To help make conservation a California Way of Life, Metropolitan has increased its annual conservation budget to \$75 million. In addition to rebates for high efficiency toilets and washers, Southern Californians interested in transforming their lawns into more water-efficient gardens with native plants and smart irrigation will once again have an added incentive to do so with a new landscape transformation rebate program to promote outdoor water savings.

The district is offering a rebate of \$1 per square foot of turf removed. The program will accept up to \$50 million in applications each year. Some Metropolitan's member agencies also may add additional incentives. Information about the landscape transformation program and many other rebates is available at bewaterwise.com.



### **LOOKING FORWARD**

#### **Colorado River Programs**

After years of drought in the Colorado River basin, forecasters say there are better-thaneven odds that low storage levels in the nation's largest reservoir system will trigger shortage conditions by 2020. Managing through those conditions will be critical for Metropolitan to stay reliable. Last year, the U.S. and Mexico agreed on a new strategy that will help conserve more water. Arizona, California and Nevada are negotiating to finalize drought contingency plans. Metropolitan continues to work with desert water agencies to create more storage opportunities, and with agricultural districts on new partnerships that benefit urban areas and farmers, such as water transfers and fallowing agreements.

#### **Investing in Regional Recycling**

Metropolitan is making a major investment in a water recycling project to clean and reuse treated wastewater currently sent to the ocean. Construction on the new water recycling demonstration plant in Carson will be completed by the end of 2018. A partnership with the Sanitation Districts of Los Angeles County, the demonstration project will evaluate an innovative alternative recycling process to meet water quality requirements. Depending on the outcomes of the demonstration plant and an additional investment from Metropolitan, the project could eventually become one of the largest advanced water treatment plants in the world.

#### **Fostering Innovation**

Metropolitan is supporting innovation to produce and test the next generation of water-saving devices and technologies. A dozen innovative water-saving technologies were awarded funding through the Innovative Conservation Program, a competitive program in collaboration with the U.S. Bureau of Reclamation and other Colorado River water contractor agencies that evaluates innovative devices, technologies and strategies. Other forward-thinking programs include the Water Savings Incentive Program that encourages technical advances for improving water efficiency with upgraded equipment or services.

#### **Commitment to Stewardship**

As part of an ongoing commitment to stewardship of our water and other resources, Metropolitan is making major investments to protect open spaces for native species and their habitats, address climate change risks, preserve cultural treasures and promote sustainable business practices. Expanding scientific studies and research that can benefit ecosystem health in the Delta also is a priority for Metropolitan. This includes supporting California EcoRestore, a multi-agency effort to restore 30,000 acres of Delta habitat, protect water supplies and assure the stewardship of natural resources.



## Gem says 'Hello' to dynamic 'Dolly'

espite the considerable efforts of Carol Channing and Barbra
Streisand, "Hello, Dolly!" would not normally be ranked in the upper echelon of American musical theater — its success being largely dependent on a flashy production and an

semble.

That would be Adriana Sanchez, whose track record encompasses most of the divalicious characters in the musical theater genre and whose voice rivals today's professional pop princesses.

And the window dressing (the ensemble cast) is abundant, at times overabundant, as director Damien Lorton throws everything but the kitchen sink onto the Gem stage, lest playgoers be reminded of the structural limitations of the Jerry Herman musical.

Splendidly drilled by choreographers Heather Smith and Alan Collins, the waiters in particular comprise a showstopping entity with highly accelerated movement and midair somersaults.

Overmuch? Perhaps, but quite entertaining nonetheless

As for Dolly herself, Sanchez injects a sneakily predatory spirit into her widowed Yonkers matchmaker as she pursues her own match with wealthy mer-

chant Horace Vandergelder.

This role is captured with bluster and gusto by Tim Klega, who wields total power over his spirited young clerks, energetically interpreted by Josh Curtis-Switzer and Jacob Wayne.

These two go on their own goofy matchmaking mission with milliners Erika Baldwin and Kelly Rosales.

Baldwin's vocal prowess is exceptional while the youthful Rosales reflects traffic-stopping beauty.

Musically, the Gem show is distinguished by the broadly choreographed title number and the first act's curtain closer, "Before the Parade Passes By," both a personal anthem from Sanchez's Dolly and an admonition for viewers to get on with their lives.

There are some memorable cameo appearances by Hannah Gomez and Carmen Tunis as Horace's other romantic options and John Michell as an over-ebullient headwaiter.

Lorton also serves as musical director, and his unseen orchestra provides a fine upbeat accompaniment.

A special treat is offered by costumers Ramzi Jneid and Larry Watts, who've gone beyond the call on their early-20th century creations. Sanchez's first-act bonnet, however, often casts a shadow on her face.

To make "Hello, Dolly" palatable, to borrow a Sondheim line, "You've gotta have a gimmick," and the Gem production of this vintage musical, dusted off for a new generation, is loaded with them.

The show runs through Aug. 5.





### Council puts sales tax on Nov. 6 ballot

PUTTING a 1-cent local sales tax on the Nov. 6 ballot was approved by the Garden Grove City Council on Tuesday night on a 5-2 vote.

Now it's up to the voters.

After lengthy presentations on the municipal budget crisis, the Garden Grove City Council voted 5-2 on Tuesday night in favor of placing a measure on the June 6 general election ballot to levy a 1-cent sales tax.

Casting "no" votes were council members Phat Bui and Stephanie Klopfenstein, with Mayor Steve Jones and council members Kris Beard, John O'Neill, Thu Ha Nguyen and Kim Nguyen in favor.

Before the voting, the council heard reports from the police and fire chiefs and assistant city manager Maria Stipes. Police chief Todd Anglin told the council that with rising crime and homelessness, "we're barely hanging on" in terms of meeting community needs.

(https://orangecountytribune.files.wordpress.com/2016/07/gg-logo\_lg.jpg)Fire chief Tom Schultz worried that the fire department was unable to meet the standard of six minutes for paramedic response time. Both chiefs said the departments were understaffed, the GGPD perhaps by as many as 59 patrolmen.

The city is facing a multi-million dollar "structural deficit" caused by state "takebacks" of previously local money, rising pension costs and aging infrastructure.

Even the city's success in attracting hotels and other business has contributed to the financial crisis. "We're becoming a big city," said Anglin. "And we're getting big city problems."

The tax, if approved by a majority of voters, would raise an estimated \$19 million annually for the city. The ballot measure is worded to emphasize the need to fund public safety needs, but a general tax increase cannot be dedicated to a specific use. However, about 71 percent of the city's general fund goes to police and fire services.



"It's important that we let the people's voices be heard," said Jones, advocating for placing the issue before voters.

"Tough times call for tough measures," said Beard. Comparing the situation to her own finances Thu Ha Nguyen said, "Money in has to equal money out." Kim Nguyen said, "This is something we can't solve by managing our money better."

Klopfenstein made no comment on her "no" vote. Bui cast his vote against the motion despite saying earlier in the meeting that "a fact is a fact" and that the city was "facing very difficult times." However, he had expressed a desire to word the ballot measure to confine spending to public safety.

## Karaoke permit denied by city council

Reversing a controversial action of two weeks ago, the Garden Grove City Council voted unanimously Tuesday night to reject the appeal of a problem-plagued restaurant seeking approval to have karaoke entertainment on the premises.

The council voted 7-0 to back an earlier decision by the city's planning commission to refuse a conditional use permit for the Pho Hoa An restaurant, located at 14291 Euclid St., an act which had been supported by police.

(https://orangecountytribune.files.wordpress.com/2016/07/gg-logo\_lg.jpg)Before the council voted Tuesday night, it heard a report from the police department listing new violations by the operator of the eatery, despite a promise on July 10 to comply with all state and city laws and ordinances.

"I thought I had conditional approval that night" for the karaoke, said Kimberly Lo, the restaurant's operator. "I ask for forgiveness. I will comply 100 percent of the time from now on."

What the council had actually done was continue the matter to July 24. Councilman Phat Bui said, "You speak English very well," and added that he had carefully explained to her what was expected. "I am very disappointed."

The original vote was 5-2 to continue the matter and perhaps offer an accommodation with a six-month probationary period, but public complaints – including an opinion piece from The Tribune – along with police reports of additional violations such as smoking and karaoke on the premises shifted the votes of Mayor Steve Jones and councilmembers John O'Neill, Phat Bui, Thu Ha Nguyen and Kim Nguyen.



The original advocates of denying the permit were Kris Beard and Stephanie Klopfenstein.

"We got a lot of backlash from the community," said Jones. Kim Nguyen said "I stuck my neck out" in support of Lo, despite a long list of violations by the restaurant. O'Neill, speaking remotely via teleconferencing from Fish Camp, California, said he had "wanted to give you the benefit of the doubt" in agreeing originally to continue the matter.







According to Eric Carpenter of the Orange County Transportation Authority, passengers going from or to the "depot" – really an enhanced stop – will be able to use this facility to connect with two of the most heavily-used OCTA bus lines – Route 43 and Brave Route 543.

All the stops along the 4.1-mile path will feature a raised platform for level boarding, a shade structure and seating area for passengers and a stationary route map, along with digital messaging to update passengers about streetcar scheduling and other information.

So what's different about the Garden Grove location? Will it be anything like Union Station in L.A.?

The stop will have dedicated parking for 46 vehicles so you can park your Toyota or Chevy and take the streetcar to any of the station stops eastward past the Willowick Golf Course — itself the subject of considerable development speculation — through Santa Ana's downtown commercial district and on to the Santa Ana Regional Transportation Center, where you can jump on the Metrolink/Pacific Surfliner north to Los Angeles or south to San Diego.





Expansion of the cemetery area on the grounds of the Christ Cathedral campus won approval from the Garden Grove Planning Commission last Thursday.

Planners voted to approve the completion – with certain changes – of a previously approved enlargement of the Memorial Gardens at Lewis Street and Chapman Avenue.

Approved were an enlargement of the interment area and the construction of three new buildings: an administrative office, a cremation niche building and a maintenance building. The site plan also calls for modification of the maximum building height requirements for those structures.

A request for a conditional use permit to demolish an existing 50-foot tall pole sign and to replace it with a new 59-foot tall V-shaped, freeway-oriented electronic reader board sign for Next Sports was also approved. That's an indoor sports facility located at 12821 Knott St. The sign will face the Garden Grover (22) Freeway.

## Buses, not streetcar for Harbor Blvd.

The onset of the OC Streetcar linking Santa Ana and Garden Grove inspired speculation that the route – with a western terminus on Harbor Boulevard – could lead to an expansion of that rail line northward on that busy street.

Well, no. Not yet, anyway.

According to Eric Carpenter, media relations specialist for the Orange County Transit Authority, the OCTA board voted on June 25 to instead emphasize enhancing the bus service that runs down Harbor.

(https://orangecountytribune.files.wordpress.com/2016/08/octa-logo.jpg)The lengthy Central Harbor Boulevard Transit Corridor Study examined possible future transportation uses for that street, ranging from doing nothing all the way to a rapid streetcar. The area examined included Santa Ana, Garden Grove, Anaheim and Fullerton.

A draft report ranked the various options with the rapid streetcar (a rail vehicle which operates in its own lane) at the top, with streetcar (partial sharing of lanes with cars) and bus rapid transit (larger buses using a dedicated lane) close behind.



But "Both Anaheim and Fullerton city leaders expressed general opposition to the streetcar and bus rapid transit options," according to Carpenter, concerned about losing existing street right-of-way.

The result is that proposed enhancements will center on bus transit. Potential changes may include:

- Collecting bus fares before passengers board the bus to speed up the boarding process
- Allowing passengers to board through any of the bus doors.
- Transit signal priority so OCTA buses would be given priority at intersections, holding a green light longer or getting a quicker green light to reduce delays.
- Queue jumps (for example, using right-turn-only lanes as bypass lanes).

Construction on the OC Streetcar is expected to begin later this year, with testing and operation in 2021. It will run west from central Santa Ana along streets and the old Pacific Electric right-of-way to a station stop on Harbor in Garden Grove, just north of Westminster Boulevard.

## 1-cent sales tax plan going to voters?

The placement of a 1-cent sales tax on the Nov. 6 ballot goes before the Garden Grove City Council on Tuesday.

Citing a "structural deficit" brought on by multiple factors including "take-backs" of revenue by the state government and rising pension obligations, city staff is proposing asking voters to levy the tax on themselves which could raise as much as \$19 million annually.

(https://orangecountytribune.files.wordpress.com/2016/07/gg-logo\_lg-e1446082015536.jpg)If approved by the voters by a simple majority, the tax would remain in place until ended by voters. In wooing citizens, the city has warned that unless new revenue is found, drastic cuts will have to be made, with a potentially significant impact on public safety as well as other areas.

A poll conducted on behalf of the city in October 2017 showed that a majority of those polled (400) were in favor of such an increase. Support was strongest among those dwelling on the east side of the city (70 percent) and among Democrats and independents (67 percent each).

Support was lower among Republicans (60 percent) and those living in the central and western parts of Garden Grove (61 and 66 percent).

A follow-up survey asking residents to list their priorities was mailed citywide.



Also on the agenda for Tuesday is a proposal to approve the appeal of a planning commission decision rejecting a conditional use permit for a restaurant for a hard liquor license. That business had been cited for numerous violations.

After the council voted earlier this month to continue the matter, the new recommended action is to uphold the appeal and grant the request with a six-month probationary period, and to allow karaoke entertainment.

The council will meet in its chambers at 11300 Stanford Ave. at 6:30 p.m.

## Three youths hurt in crosswalk crash

THREE boys were seriously injured in Garden Grove Thursday evening when struck while walking in a crosswalk.

A sports utility vehicle striking pedestrians in a crosswalk in Garden Grove sent three teenage boys to the hospital with serious injuries Thursday evening.

According to Lt. Carl Whitney of the Garden Grove Police Department, the incident took place shortly before 6 p.m. at the intersection of Kerry Street and Westminster Avenue.

A group of teen boys were walking south across Westminster in a marked crosswalk at the intersection when a tan SUV moving westbound struck them. Police say a witness told them the vehicle ran a red light, and then hit the pedestrians.

The three suffered serious injuries and were taken by ambulance to a local trauma center. The male driver of the SUV remained at the scene and cooperated with investigators. Driving under the influence of alcohol or drugs does not appear to be a factor.

## League-Sponsored Bond Agency Issues \$46 Million in Tax-Excemt Bonds for Affordable Housing in Palmdale and Transportation Revenue Certificates of Participation in Salinas

July 20, 2018

Some of the most significant benefits of League membership for cities since 1988 have flowed from the League's co-sponsorship of the California Statewide Communities Development Authority (CSCDA).

CSCDA recently issued \$9,200,000 in tax-exempt multi-family affordable housing bonds for Palmdale Park Apartments in Palmdale and \$37,500,000 in Transportation Revenue Certificates of Participation (COPs) under its Total Road Improvement Program (TRIP) to benefit the City of Salinas.

#### About Palmdale Park Apartments

Palmdale Park Apartments is the acquisition and rehabilitation of 58 multi-family affordable housing apartments by Palmdale Park Apartments, LP. Sponsored by Community Development Partners (CDP), the project will continue to be 100 percent affordable and provide apartments to low-income residents in Palmdale.

CSCDA and CDP partnered with JLL Capital Markets and Orrick, Herrington & Sutcliffe, LLP to provide the \$9,200,000 in tax-exempt multi-family affordable housing bonds for the project. The apartments will undergo an extensive interior and exterior renovation ensuring that residents have an updated, safe, and affordable community to call home for years to come. The financing will maintain the affordability of units for low-income tenants for 55 years.

#### About the Transportation Revenue Certificates of Participation

The financing will be secured by Measure X revenues the City of Salinas receives from the Transportation Agency for Monterey County. Monterey County Voters in the county passed Measure X in November 2016 to proactively fund and plan a transportation system that enhances mobility, safety, access, environmental quality and economic activities. Collection began for the three-eighths cent sales tax measure in spring 2017 with a 30-year authorization. Measure X allocates 60 percent of annual revenues to the county's cities for local road transportation projects such as capital street improvements, pothole mitigation and safety upgrades.

CSCDA partnered with Stifel, Urban Futures, Inc. and Orrick, Herrington & Sutcliffe, LLP to provide the COPs for Salinas. The COPs will fund the construction of various improvements within the city including traffic and safety improvement along Boronda Road, a major east/west arterial and gateway to future

growth in the city. The improvements will include widening and resurfacing the existing roadway, installing roundabouts for additional safety and updating accommodations for bike lanes and pedestrian rights of way.

#### Background

CSCDA is a joint powers authority created in 1988 and is sponsored by the League of California Cities® and the California State Association of Counties. It was created by cities and counties for cities and counties. More than 530 cities, counties and special districts are program participants in CSCDA, which serves as their conduit issuer and provides access to efficiently finance locally-approved projects. CSCDA has issued more than \$60 billion in tax exempt bonds for projects that provide a public benefit by creating jobs, affordable housing, healthcare, infrastructure, schools and other fundamental services.
