<u>Objective</u>

The purpose of this memorandum is to highlight milestones completed to date and identified Next Steps for the Willowick Golf Course.

Background

In December 2017, the Cities of Garden Grove and Santa Ana held a Joint Study Session to discuss the potential reuse of the Willowick Golf Course ("Property"). At the meeting, both City Councils directed staff that further due diligence was needed in the areas of visioning and economic valuation of the Property.

In April 2018, the Garden Grove City Council approved an Agreement with the City of Santa Ana that provided for the Cities of Garden Grove and Santa Ana to further implement the exploration of the redevelopment of the property by retaining independent consultants to help create a vision of future development, work with community outreach to determine community needs, and determine the economic framework for the value of the property.

Requests for Proposals were circulated in May 2018 to solicit consultant services for visioning and economic analysis. Ten (10) proposals were received from economic analysis consultants and six (6) proposals for visioning consultants. For the interview process, the top three proposals for economic analysis and the top one for visioning were invited to present their proposals to the Garden Grove and Santa Ana team. The top three proposals for economic analysis included: AECOM, HATCH, and HR&A along with one visioning consultant, the firm of SWA. At the conclusion of the interview process on June 28, 2018, the Selection Committee has recommended HATCH and SWA as the preferred consultants.

Discussion

The Next Steps for both Cities will be consultant coordination, a kick-off meeting, and community outreach/engagement as detailed in the following:

1. Professional Services Agreement(s)

At the April 2018 meeting, the City Council authorized each respective City Manager to approve the appropriate Agreements for Visioning and Economic Analysis. It should be noted the Scope of Work has been modified to accommodate collaboration of both consultants during the Visioning and Economic Analysis process.

- The Professional Services Agreement with HATCH shall not exceed \$50,000 of which the costs will be shared between the Garden Grove and Santa Ana.
- The Professional Services Agreement SWA shall not exceed \$50,000 of which the costs will be shared between the Garden Grove and Santa Ana.
- It is anticipated that both Agreements shall be fully executed by the week of August 6, 2018.

2. Willowick Site Tour

On Monday, August 6, 2018, the Garden Grove and Santa Ana staff will conduct a site tour of the Property with SWA, the Visioning Consultant.

3. Consultant(s) Kick-off Meeting

On Friday, August 10, 2018, the Garden Grove and Santa Ana staff will hold a Kick-off meeting with HATCH and SWA to discuss consultant coordination and community engagement.

4. Tentative Dates for future Community Workshops

The following dates are tentative (August 30, 2018, September 27, 2018 and October 25, 2018) for the three Community Workshops that will be facilitated by the Visioning Consultant. Details of meeting locations will be provided shortly.

The Next Steps described above is envisioned to be completed by December 2018. Staff will continue to apprise the City Council of ongoing Project milestone(s).

UPDATE

OBJECTIVE

The purpose of this memorandum is to highlight activities in the Building & Safety Division.

BACKGROUND

The Building & Safety Division encompasses four units: Permit Services, Building Inspection Services, Building Abatement and Code Enforcement. Provided below are details of recent activities for each respective unit.

DISCUSSION

The year continues to be very active for the Building Permit Center and provided are results of certain streamline initiatives that have been deployed to enhance the dayto-day operations.

1. Lobby Kiosk and Queuing System

In March 2018, an electronic Kiosk was added to the lobby area. The goal to streamline lobby activity was inclusive of services requested in Building, Planning, Code Enforcement, Building Abatement, and Engineering. To date, the lobby activity has been steady with approximately 120 – 200 customers served daily at the public counter. Implementation of the new Kiosk and deployment of the queuing system has assisted with prioritizing customer needs and minimizing lobby wait time.

2. Plan Check Services

To date, Plan Check Services continues to meet review deadlines. Currently, the new Title 24 standards for energy compliance are being integrated into the newly submitted projects with no issues. Examples of Title 24 changes include the requirement for more insulation in the walls and ceiling, and the closer review of equipment that meets the state requirements for energy efficiency. Previously, these items was not checked at this level.

3. Building Inspections

In August 2017, the Daily Inspection Link was an added feature to the Building & Safety Division website that provided an online resource for daily inspection inquiries. In addition, the Building Inspection scheduling has been reduced from 7 days out to 4 days out. The priority is to achieve a reduction in wait time to 2 days by the end of August.

4. Interdepartmental Meetings

Building & Safety Division will be organizing monthly interdepartmental meetings with Police, Fire, Public Works (Street Division/Animal Control), Building, and Code Enforcement. The purpose of the meetings is to harmonize efforts to address issues and have collaborative enforcement efforts throughout the City. The initial meeting will occur in August.

5. Code Enforcement Program

A follow-up to the recent City Council presentation summarizing the City's Code Enforcement Program contemplated community engagement and public outreach as part of the program changes. To that end, the Code Enforcement team participated at the National Night Out held at Village Green Park on August 7, 2018. A Meet on Main community discussion about Code Enforcement is scheduled on Thursday, August 9, 2018 at the Lions Club.

6. Accessory Dwelling Units (ADU) Update

The statistics below reflect ADU activity at the Permit Services Counter as of August 6, 2018.

7. Village Center and Code Enforcement Collaboration

A discussion of code enforcement collaboration with the cities of Stanton and Garden Grove has been initiated. The joint meeting has taken place with the Stanton Code Division to discuss how cooperation and communication would occur with common enforcement issues. Discussions will continue as redevelopment of the Village Center is underway.

8. Christ Cathedral Site Visit

A walk-through of the project site with the City of Orange Building Official and his team took place last week. It provided an opportunity to share Best Practices for the scope and size of the project during construction. Additional site visit(s) will be planned with City Council in the upcoming months in coordination with the City Manager's Office.



Questions concerning eligibility to serve as the Director of Division 4 should be directed to the County of Orange Registration and Elections Department at 714-567-7600.

A public officer, whether elected or appointed, may be elected or appointed to serve as a member of the board of directors of the District. However, a local municipal charter provision or ordinance may restrict a councilmember or city officer from serving in another elective capacity; persons who currently serve as councilmembers or other city officers and are interested in appointment as Director of Division 4 of the Orange County Water District should review their city charter and municipal code and confer with their city attorney



According to the California Department of Fish and Wildlife:

- o Keep small pets inside, particularly at dawn and dusk when coyotes are most active.
- o Keep pet food and water dishes inside. o Secure food and trash at all times and
- remove all sources of water.
 o Pick up fallen fruit and keep compost
- piles tightly sealed.
- o Sweep up fallen birdseed, which can attract mice and rats, a common food source for coyotes.
- o Remove brush, wood piles, and debris where coyotes can find cover and where rodents are abundant.
- o Install motion-activated lighting or sprinklers.
- o If a coyote approaches or acts aggressively, throw rocks, make noise, look big, and pick up small children and pets. Do not turn your back to the animal.

To report coyote sightings, call the City's coyote hotline number at (714) 741-5286, include date, time, and location of sightings.

If the coyote is acting aggressively, call Garden Grove Animal Care Services at (714)741-5565, or the Garden Grove Police Department at (714) 741-5704.



Orange County man's arrest stirs

anxiety in Little Saigon

His family said he had been missing for a month in Vietnam before news of his imprisonment 'without cause or charges.'

The family of a man missing for a month in Vietnam announced Thursday that he has been detained by the government and imprisoned in Ho Chi Minh City "without cause or charges."

Michael Phuong Minh Nguyen had been found alive with no "visible signs of abuse," according to U.S. Embassy officials who notified family members Wednesday.

The father of four daughters had left his home in Orange County on June 27, intending to tour central Vietnam with friends before stopping to visit relatives in

the southern part of the country.

When he did not fly home as expected on July 16, his wife frantically tried to locate her 54-year-old husband. Using social media and tapping into Vietnamese-language media, she spread news of his case.

His disappearance stoked fears in the Vietnamese community in Southern California of the dangers of traveling to a country where human rights and basic freedoms are restricted.

"He was making a personal trip. He has done nothing wrong. More than anything, we just want him back safely," said his wife, Helen Nguyen, an operating room nurse. She was accompanied by her daughters at a news conference near their Orange home.

Authorities in Vietnam detained her husband on July 7, as the print shop owner left Da Nang for Ho Chi Minh City, formerly known as Saigon. He carried just his clothes and more than \$1,200 for expenses.

An agreement between the U.S. and Vietnam requires that the Vietnamese government notify their U.S. counterparts within four days if an American citizen has been arrested and jailed. But in Nguyen's case, no information was exchanged, reportedly as a result of a 1994 privacy act—also signed between the two countries—that does

not allow details about a person to be shared unless that person signs a release form.

"We were in a catch-22. We couldn't get any information about Michael because he hadn't signed anything. But no one would say where he was to get him to sign," said Mark Roberts, Nguyen's brother-in-law. Nguyen is being held at the Phan Dang Luu Detention Center in Ho Chi Minh City, he said.

On July 17, Vietnamese authorities finally notified the U.S. Embassy of Nguyen's arrest. By Tuesday, U.S. Consul General Franc Shelton spoke face to face with Nguyen for the first time — while in Southern California, his extended family met with U.S. Rep. Mimi Walters (R-Laguna Beach) to plead for her

help.

Walters said Nguyen's case is her "highest priority."

"I am working to secure Mr. Nguyen's freedom and to ensure his safety," she said.

"The Vietnamese government needs to know there will be consequences if they don't treat American citizens with respect."

In Orange County's Little Saigon, the arrest has led to widespread worry, with immigrants saying they will rethink or cancel travel plans to Vietnam.

If the Vietnamese government "can target an ordinary person like this, who knows what might happen if we go back and are at the wrong place at the wrong time?" said Mickie Mai, a math graduate student from Fountain Valley who

hoped to tour the birthplace of her ancestors during school holidays.

Dat Hoang, an auto repairman from Santa Ana, said he would look into Thailand as a vacation destination rather than Vietnam.

"Imagine a middle-aged guy like me taking my kids back to my homeland to see their grandparents. If something crazy occurs, if all of a sudden they take me, what can my kids do?" the father of two teenagers said.

"They don't understand how the system works over there. We have to think twice about taking these risks when we can just as easily go somewhere else in Europe or Asia."

In June, Will Nguyen, a

Vietnamese American man from Houston, was arrested after participating in a prodemocracy rally in Vietnam. Video captured his beating, which prompted supporters worldwide to demand his release.

"This is becoming a pattern. These are two high-profile cases of citizens arrested without charges, and people are noticing how randomly the government acts," Roberts said, adding that no formal charges have been filed against his brother-in-law.

"Yet we're prevented from seeing him," he said.

"It is a huge violation of human rights and international law."

Nelly the goat's fate lies with City Council

More than a month after a June 29 deadline to relocate a Nigerian dwarf goat from the backyard of the Tower family's Garden Grove home, Nelly is still playing and living in her little makeshift barn.

The goat's owner, Sharon Tower, and her Los Angeles-based attorney, Patrick Blood, are hoping to instead collaborate with city officials to amend city law, making the pet legal.

Tower and her daughter, Jenna, have made pleas directly to City Council members at their meeting, and Blood sent a letter to the council July 8.

They have received no response, but neither has a member of the city's Anto demand again that the goat be removed.

Council members could not be reached for comment, and a city spokeswoman said she is unable to confirm if the city will reach out.

The Towers have "deep roots" in Garden Grove, Blood said, and they want to show that although Nelly is a goat, she is not a nuisance to the community.

The family's requests "are reasonable," he wrote, "but more importantly necessary for my clients' well being emotionally."

The Nigerian dwarf goat is a licensed therapy animal and an emotional support animal for Sharon Tower. The Americans with Disabilities Act, which deals only with service dogs, does not protect Nelly under federal or state law.

Garden Grove law prohibits possession of livestock and outlines what kinds of animals are considered livestock, but the city does not explicitly state that goats are a prohibited species.

The Towers are not raisimal Control unit returned ing Nelly for commercial purposes. Blood said he feels city code is "unclear" in regards to Nelly, who is a domesticated pet.



Owner of multigenerational Garden Grove market dies

Leo and Virginia Zlaket sold their Garden Grove market — one of Orange County's oldest familyowned businesses — in late 2014.

But they did not get to enjoy a carefree retirement for long. Just a few months later, Leo Zlaket learned he had multiple myeloma, a bone marrow cancer. He died in his Anaheim home at age 77 on Tuesday.

Still, Leo Zlaket's son David said, his father never lost sight of the fact that he had enjoyed "a too-short but wonderful life."

"He was at peace," the younger Zlaket said.

Leo Zlaket grew up in an apartment above Zlaket's Market, founded in 1927 by his father, Leo Zlaket Sr. For 87 years, the venerable store remained at that location—on a part of Euclid Street that later would be designated Historic Main Street.

He and his two siblings shared their childhood with

· Over the years, the shop and its merchandise evolved with the times.

Leo Zlaket's older brother George took ownership in the '50s and added a popular butcher shop. After Leo Jr. came on board in the '60s, the family continued to find ways to "stay ahead of the curve," expanding the deli and catering services, David Zlaket said.

"They turned it into a gourmet food market before Bristol Farms and what have you existed," he said, adding tongue-in-cheek, "Bristol Farms completely ripped us off."

Leo and Virginia Zlaket bought the partnership in 1988 after George retired. David Zlaket pitched in.

"People would enter the store not knowing what they wanted for dinner," David Zlaket said. "My father would direct them finding the perfect cut, preparing and seasoning it, and writing cooking directions on the package."

Leo Zlaket also was well-known in the community for his volunteerism with the Chamber of Commerce, Boys & Girls Clubs and other organizations.

As foot traffic slowed and competition grew over the next two decades, sales floundered. Eventually, the family decided to close shop.

David Zlaket appreciates that he had the opportunity to grow up in in the family business.

"You learn to properly sweep a floor at 10 years old," he said. "I wish my own children had more of that. We were so proud to be Zlakets."

Leo Zlaket is survived by his wife, son, daughterin-law and two grandchildren.

American from Orange County detained in Vietnam prison; congresswoman threatens 'consequences'

An American citizen who went missing last month in Vietnam has been found: He's in a Vietnamese prison, accused of conspiring against the government. No charges have been filed against Michael Nguyen, also known as Michael Phuong Minh Nguyen, of Orange, but he's being detained without the ability to see his family or lawyers, his family said during a press conference Thursday morning outside Orange City Hall.

While relieved to hear he's alive, his brother-in-law, Mark Roberts, called his detainment a violation of human rights and international law.

Congresswoman Mimi Walters, R-Irvine, standing with Nguyen's family, including his four daughters, said she is working to secure his release.

"It's unacceptable to detain an American citizen in Vietnam," Walters said, warning the Vietnamese government that if it doesn't release Nguyen, "there will be consequences for their action."

Asked what she could do to seek his release, Walters said: "I will go as high as I have to. If I have to go to the president of the United States, I will go to the president."

Nguyen, 54, is being held at a detention facility in Ho Chi Minh City. He is under investigation for violating Article 109 of Vietnam's penal code for allegedly conspiring against the government in a country that doesn't tolerate dissent.

"We hope this absence of any formal charges clears any suspicion that Michael was involved in any form of anti-government activities," Roberts said.

The investigation could last as long as three to five months, and possibly longer, Franc Shelton, of the Consulate General office in Ho Chi Minh City, told the family in a phone conversation late Tuesday, Roberts said, adding that the family was told Nguyen is in good health.

In the meantime, Nguyen is not allowed any visitors save a once-a-month meeting with a representative from the American Consulate. He also is not allowed any letters or other written communication.

"He's not even allowed to receive drawings and notes from his children," Roberts said.

Nguyen, who owns a printing company in Garden Grove, takes an active role in caring for his daughters, ages 8 to 15. He makes them breakfast every morning, takes them to and from school as well as their sports and dance activities, and at least twice a week goes with them to church, Helen Nguyen said.

The girls "are so worried now," she said. "They can't sleep at night."

While in detention, Nguyen is provided one meal a day and allowed to purchase additional food from the detention center's canteen but the most he can spend in one month is about \$80, which Roberts said equals an extra bowl of soup, mostly broth, each day.

Nguyen went to Vietnam on June 27 to visit elderly family he visits at least once a year and to meet up with friends for some travel, according to his family. The last time they heard from him was on July 6, Vietnam time.

RELATED: Family fears American citizen from Orange is imprisoned in Vietnam: The BBC reported Thursday that Nguyen was arrested July 7 (July 6 in the United States,) with a small group of dissidents while on a bus on their way to Saigon. Roberts said he could not address that report. Roberts and other family members said they are not aware of any political activities that could have gotten the Orange County man in trouble with the Vietnam government.

Vietnamese officials in the United States did not reply to requests for information from the Southern California News Group.

Helen Nguyen, a surgical nurse at UC Irvine Medical Center and a Kaiser Permanente hospital, thought there might be some communication glitches when she first lost contact with her husband. But she worried. And two days after he failed to return aboard a July 16 flight that was supposed to bring him home, she filed a missing persons report with the State Department and the U.S. Consulate in Saigon. When she later called various police offices in Saigon, she said she was told to come in person to inquire about him.

"They told me, 'You need to be here to file a missing person's report.' But we don't live in Vietnam," she said.

The family notes that recently there's been unrest in Vietnam over land leases to China and a new cybersecurity law set to take effect next year, which will clamp down on tech firms and tighten control of the internet.

An American citizen from Houston, <u>Will Nguyen</u>, was freed July 20 after he was beaten by Vietnamese police and detained for participating in a protest. His release came after pressure from the U.S. government, including a coalition of legislators. Similarly, Nguyen's family said it has found support from Walters, the Orange County congresswoman, and Rep. Alan Lowenthal, D-Long Beach, Rep. Lou Correa, D-Santa Ana, and Rep. Ed Royce, R-Yorba Linda.

A <u>change.org</u> petition calling for his release garnered some 7,000 signatures as of Thursday afternoon.

Veterans and civilians in Garden Grove, named the first Purple Heart City in Orange County in 2012, took notice of Purple Heart Day on Tuesday. Garden Grove lost more troops in the Vietnam War - 41 - than any city in Orange County.

Purple Heart Day is observed on Aug. 7 each year and is a time for Americans to pause to remember and honor the brave men and women who were either wounded on the battlefield or paid the ultimate sacrifice with their lives.

The Purple Heart began as something called the Badge of Military Merit, an honor created by General George Washington in 1782. The honor was only presented to enlisted soldiers who had performed a "singularly meritorious action." Only a handful of these were awarded, and following the American Revolution, the Badge of Military Merit didn't become a permanent fixture among the various other awards and decorations given to those who serve.

But the spirit of the Badge of Military Merit would be honored again in 1932, when the Purple Heart award was created to honor the bicentennial of George Washington's birthday.

Purple Heart Day is observed in different ways:

-Major League Baseball teams pay homage to their local Purple Heart recipients during special pre-game and 7th inning ceremonies:

-Veteran and military organizations hold remembrance meetings for fallen heroes and special events to thank soldiers, veterans, and Purple Heart recipients;

-The Purple Heart Foundation, the fundraising arm of the Military Order of the Purple Heart, recommends donating time and money to the foundation or to other organizations working with Purple Heart recipients.

And, last but not least, American flags are flown at homes and businesses. Some folks fly them all week long. It's not too late.



They are on the median at Garden Grove Boulevard and Knott.

They're in the parking lot of the Motel 6 that I pass on Golden West Street.

And they try to use the restrooms at the Starbucks next to the Motel 6.

Some are down on their luck. Some are mentally ill. Some are addicted to drugs and alcohol. Some are really nice, and some are dangerous.

So what do we do? A federal court judge was expected to rule it's also a humanitarian crisis.

A friend and I lunched at Brodard Chateau in Garden Grove, and it lived up to its reputation as one of the finest restaurants in Orange County.

It is — no doubt about it — upscale. It's Vietnamese, with wonderful touches of French and Asian fusion influences. The interior is sleek, amber, quiet. The staff is formal but warm.

The menu is impressive. Bro-

Leo Zlaket, 77, a local icon and leader

As one local businessman put it, Garden Grove has lost an icon. Leo Zlaket, husband, father, grandfather, businessman, and community leader ended his battle with cancer early Tuesday morning.

Zlaket, 77, was owner and operator of the historic Garden Grove business Zlaket's Market. The market was the oldest family owned business in Orange County, in business for 87 years.

He was born at St. Joseph's Hospital in 1941 to Leo and Mary Zlaket. As the youngest of three children, Leo grew up in the apartment above the store. Customers referred to him as "Poncho" as they rubbed his full head of curly locks. He attended Blessed Sacrament grade school, Mater Dei High School, Fullerton College and was an altar boy at St. Columban's Church until he was 18. Lifelong friends often joked, they felt bad for Leo as a kid. As they were "goofing off" or going to movies at the Gem Theater, Leo was working in the store. They would also say he had the last laugh, as the fruits of his labor were bountiful.

Leo served in the Army National Guard from 1963 to 1969. He would say his greatest military accomplishment was serving in the "War of Watts" with no bullets.

In 1966, Leo met the love of his life, Virginia Roman. Virginia was visiting California from Pittsburgh and met Leo through relatives. Those relatives were longtime Zlaket's Market customers and friends. It was a match made in heaven ... or at least a match made in Mary's kitchen. As their affection for each other grew, Virginia made the choice to remain in California.

They married in 1967 and began their extraordinary 51-year love affair.

Leo and Virginia were inseparable. As newlyweds, they lived above the store, steps away from his mom and dad and the family... Think "My Big Fat Lebanese Wedding."

It was all family, all the time! Leo and Virginia had their son David in 1971 and two years later moved to Anaheim, two miles from the store.

Zlaket's Market provided a wonderful life for their family, as the Zlaket's provided wonderful service to the community. Many kids would claim to have their first job at Zlaket's Market. George and Leo were butchers, known for providing the finest quality meats. When George retired in 1988, Leo and Virginia bought the partnership and carried on the legacy for decades more. They expanded the deli, grew their catering services, and brought gourmet fare to Garden Groven, often traveling to New York and San Francisco for trade shows and inspiration,

Leo and Virginia were trend-setters. One of Leo's greatest strengths was his ability to adapt and change to fulfill his customer's needs. He wasn't just selling his products but offering his expertise. So many would say they would enter the store not knowing what they wanted for dinner. Leo would direct them, finding the perfect cut, preparing and seasoning it, and writing cooking directions on the package.

Over the counter, you would get great conversation. Leo loved a good story, both listening and telling. Customers loved his smile as much as his sense of humor.

He loved baseball and was a life-long Pittsburgh Pirates fan. As a youth, he attended games of the Pirates farm club the Hollywood Stars from the Pacific Coast League. Marrying Virginia from Pittsburgh sealed the deal.

Leo's volunteerism reached many organizations. He was a quiet leader, never looking for accolades, but always willing to help. He served as Chairman of the Board for the Garden Grove Chamber of Commerce, Associate Board Member for Acacia Adult Day Care, Advisory Board Member for Boys and Girls Clubs of Garden Grove, Finance Director for St. Columban's Church and Main Street Parking Commissioner.

Leo was a man who never said no to those in need of assistance. His fundraising gifts were wide spread and supported a multitude of service clubs, children's organizations, community foundations and churches. Whether it was through financial contributions or personally preparing food for events, Leo led through his actions.

Leo would say his greatest accomplishment was his family. His love and devotion to them was immeasurable. His son David felt blessed to work side by side with his dad for over 20 years.

He is survived by his wife Virginia, son David, daughter-in-law Tina, grandkids Gabi and Roman, and sister Yvonne.



He's already won a fan in Maureen Blackmun, the president of the Garden Grove Neighborhood Association organization.

"Nothing affects people's quality of life in the community more than than code enforcement. Pride in our neighborhoods and neighbors can't happen

when lawns are brown, junk is piled up in yards, or cars are parked on lawns," said Blackmun.

"The code enforcement department has needed modernization and a fresh vision for a while. I think David Dent is just the man to do it. I'm impressed and anxious to hear and see the changes and expertise he will bring to the team."

Dent, 38, a resident of Long Beach, is moving the city's code enforcement efforts into overdrive, after years of relative inactivity. He's prepared to set a new bar for residents and property owners for a better-maintained community.

"If you want to live in Garden Grove, you're going to have to follow the rules," he said. "That's why code enforcement is going to shock a lot of people." Dent said that he expects the City Hall will get a lot of calls when the program rolls out, but he has the backing of the city council, planning commission and top city management.

Dent comes to the city from service in San Diego and Compton. His first major initiative was to tackle the marijuana dispensaries that dotted the community.

"The big issue isn't so much the marijuana itself, it's the improvements that were made to the building to accommodate either the dispensary or the growth facility," according to Dent. "Chances are, since they are illegal businesses, they tend not to get permits, so they fall under substandard dangerous building standards."

(https://orangecountytribune.files.wordpress.com/2018/08/code-enforcement-box.jpg)As a chief building official, Dent has the power to "red-tag" (declare unfit for occupancy) a building on the spot. Backed by a half-dozen or so Garden Grove police officers and perhaps another code enforcement officer, Dent politely shut down "50-plus" such "pot shops." The remaining green signs visible around town are vestiges of the original problem.

Another major issue in the city is front lawns – dead grass, paved-over surfaces and even debris. That will bring a new approach to code enforcement.

"Normally, we have been reactive in the sense that when a complaint comes in," a code enforcement officer would go out, but might bypass other problems seen "because we weren't built on being proactive," said Dent.

"That's going to be the biggest thing. There's going to be a shift in their work assignments. There's going to be a priority list," he said. The next step is to "get the public ready."

Code Enforcement meeting on Aug. 9

Garden Grove Neighborhood Association is hosting a "Meet on Main" event on Thursday, Aug. 9 on code enforcement.

It will be held from 6-7:30 p.m. at the Lions Club building at 9860 Larson Ave. in Garden Grove.

The team behind code enforcement will be on hand to explain activities and plans and answer questions.

Top items include short-term rentals (STR), dead lawns and landscaping. "We're going to be a little bit more aggressive in those areas," said Dent, "We're going to start citing. That's something that hasn't been practiced here that much. Before they would just tell them to do something and hope they did it. Or just send them a letter and hope that they did it."

Under the policy, someone in violation of the code would be cited, giving them 30 days to fix the problem. Then a seven-day warning and then fines starting at \$100 and ranging all the way up to \$1000.

According to Dent, the city code – for example – requires that a front lawn be at least 50 percent vegetation, typically grass. But some people have covered their lawn area with concrete, or rock.

"It's got to be something green or growing," he said. "If you can park on it, it doesn't meet the standard." Paved-over lawn areas will have to be de-paved, but the city will work with residents and property owners about how to best restore their front yards.

Before that crackdown occurs, an extensive outreach program is planned, using information in the water bill mailings, meetings with community groups and more. A problem area would be targeted with doorknob hangers, written in different languages.

"Basically, they'll say you'd better water your lawn. If you have any questions about what you need, please come down to the planning department and we can give you pamphlets about that," said Dent.

But after 30 days, enforcement will kick in. "We're going to treat everyone the same way. We can't customize it. It's going to hurt some people in some cases, and that's why there's going to be the outreach."

The top priority right now is the STR problem, in which single-family homes are rented – illegally – to tourists for a few days. Most of those are located in the northeast area of the city near the Anaheim Resort. Dent is looking at ways to approach the problem. He noted that in some cities, utilities are simply shut off to violators.

Dent and the code enforcement staff of four – one supervisor and three officers – are ramping up for a strong effort in that field. "There's going to be enforcement which will exceed and bypass the times we normally operate to deal with them."

"I'm excited about the direction code enforcement is headed. The officers are adjusting and I'm going out with them," he said. "I'm never going to ask them to do anything I haven't tried out myself."

New Regional Data Shows Local Impacts of Transportation Projects Threatened by Prop. 6

August 2, 2018

New regional reports released on July 31 by the American Road & Transportation Builders Association (ARTBA) quantify the monumental regional economic impact of crucial local transportation projects endangered by Proposition 6.

Prop. 6 would eliminate more than \$5 billion annually in existing transportation funds and would jeopardize funding supporting more than 6,500 bridge and road safety, transportation and public transit improvement projects currently underway throughout California. Prop. 6 threatens nearly \$183 billion in economic activity and user benefits throughout all sectors of the state's economy over 10 years. It also puts at risk over 68,200 jobs annually, adding up to over 682,000 job-years over the next decade.

ARTBA is a national non-partisan federation whose primary goal is to grow and protect transportation infrastructure to meet the public and business demand for safe and efficient travel. The regional analyses, conducted by ARTBA Chief Economist Dr. Alison Premo Black, highlight the economic impact of transportation projects on six major California regions: the San Francisco Bay Area, Los Angeles County, the San Joaquin Valley, the Inland Empire, and San Diego and Imperial Counties.

These regional reports build upon a statewide analysis of the impacts of statewide transportation funding, released by <u>ARTBA in February</u>. Below is a snapshot of the economic interests for each region:

In the San Francisco Bay Area, Prop. 6 threatens:

- \$34.5 billion in economic activity and user benefits over 10 years.
 - Including jeopardizing \$9.8 billion in savings for drivers, transit riders and businesses and \$19.3 billion in economic output.

Apply for \$500 Million in Grants to Address Homelessness Crisis at Local Level

Applications Accepted Starting Sept. 5

Cities are eligible to apply for a <u>Homeless Emergency Aid Program (HEAP)</u> grant through the California Homeless Coordinating and Financing Council (HCFC).

HEAP is the \$500 million block grant program designed to provide direct assistance to cities and counties to address the homelessness crisis throughout California <u>authorized by this year's budget</u>.

Important Dates

Wildfire Conference Committee to Hold Two Hearings this Week

August 6, 2018

The recently-appointed <u>Wildfire Preparedness and Response Legislative</u> <u>Conference Committee</u> will continue its work this week with two scheduled hearings.

On Tuesday, the conference committee will hear from experts about ensuring a safe and reliable electric grid. The Thursday hearing will focus on the standard of liability known as "inverse condemnation." The League will testify at both hearings.

The League has taken a <u>position supporting the current liability rules</u> for investor-owned utilities and opposing any changes that would pass on liability to cities or make it more difficult to recover damages in the event of a utility-caused wildfire.

The conference committee held its first hearing on July 26 during the legislative recess to frame the issues for legislative consideration. <u>Yountville Mayor John Dunbar testified</u> in that committee to urge members to carefully consider any policy that would shift new liability to cities or make it more difficult for cities to collect damages caused by wildfires.

With the Legislature's return today for the final weeks of the session, the committee is expected to work quickly. Any agreements made by this conference committee must be heard and voted on by Aug. 31.

Housing and Wildfires Top League Priorities in Final Weeks of Legislative Session

The Legislature reconvenes today from its summer recess and lawmakers must finish debating and passing all bills by Aug. 31.
