Executive Summary

Ten Orange County cities permitted the sale of safe and sane fireworks in 2018, for a total of 229 stands throughout the County. A total of 25 public fireworks displays provided safe celebration options for the communities within Orange County.

In 2018, the injuries associated with fireworks increased to 38 total reported injuries. Last year, Orange County reported 29 injuries that were related to fireworks. In comparison to the Consumer Product Safety Commission's (CPSC) 2017 fireworks injury statistics, Orange County's total fireworks injuries are less than expected for our population. While last year, there were no reported Safe and Sane fireworks-related injuries, this year, Safe and Sane injuries accounted for 13% of reported county-wide injuries. 19% of fireworks-related injuries were due to illegal fireworks while the outstanding 68% of injuries remain unknown. As in previous years, a majority of the reported injuries within Orange County were burns to the eyes, hands and fingers.

Firework injuries reported by hospital emergency rooms and urgent care facilities were mapped and compared to areas where the sale of Safe and Sane fireworks has been permitted. Results are a clear indication that hospitals near the cities where Safe and Sane firework sales are permitted, did not necessarily report more injuries than those hospitals that are not near those same cities.

Orange County experienced a slight decrease in estimated property loss this year. The acreage lost due to fireworks-related fires was also lower than it was last year. Additionally, the amount of both consumer and illegal fireworks that were confiscated (by local fire departments) this year has gone down over 2,300 pounds compared to 2017.

With devastating wildfires forcing evacuations and destroying thousands of homes, wildfires have become a major concern for many Southern California citizens. Fireworks have become a wildfire liability and there is deliberation about the possibility of an outright ban on fireworks in fire-prone California. There have been more than 2,350 wildfires in California within the first half of 2018. This year, many wildfire-plagued cities across America have turned to drones as an alternative to fireworks. While this has not yet become the norm for California, it could very well be on the horizon as the future for holiday festivities. Orange County has yet to see a drone show, but it would be no surprise if one were to take place in the near future.

We would like to take this opportunity to thank all of the fire departments and medical providers in Orange County who contributed data to the analysis in this report.

Background and Methodology

Each year following the Independence Day holiday, the Orange County Fire Authority gathers data in order to analyze the overall impact of fireworks throughout Orange County. The information included in this report was contributed by hospital emergency rooms, urgent care facilities and Orange County Fire Departments to supplement OCFA's own fireworks data.

Injury data was solicited from a total of 25 hospital emergency rooms and 103 urgent care facilities throughout Orange County for the study period of June 30th-July 5, 2018. This year, we received responses from 3 urgent care facilities and 11 hospital emergency rooms, for an overall response rate of 9%. OCFA's own Emergency Medical Services data was also analyzed for injuries related to fireworks. The fireworks injuries contained in this report are only those that were reported to us; it is likely many more injuries occurred that were either not treated or not reported. National statistics extracted from the most recent 2017 CPSC Fireworks Report were also used for a comparison study.

Fireworks-related fire incident and property loss information was gathered from 10 out of 11 Orange County municipal fire departments, for a response rate of 90%. Narratives from the 69 fireworks-related fire incidents that OCFA responded to were analyzed for qualitative information regarding the impact of these incidents within Orange County communities. Local newspaper and social media sources were also utilized for information regarding fireworks-related injuries and various fire-related incidents that were caused by fireworks.

Fireworks Policy in Orange County

In 2018, 10 Orange County cities permitted the sale of safe and sane fireworks for a total of 229 retail consumer fireworks stands throughout the County.

Anaheim Fire and Rescue experienced a 16% increase in firework related calls this year. Also, citations increased from 2 in 2017 to 17 in 2018. There was a garage fire in Anaheim that is still under investigation but most likely caused by illegal fireworks. Although no injuries were reported, the fire did displace a family.

Garden Grove had an OCSD Bomb Squad response call involving a man on a mini-bike pulling a trailer that was assembled to set off illegal fireworks as he rode up the street. There were over 200 calls received regarding illegal fireworks. Garden Grove had 37 officers deployed on fireworks watch this year. Additionally, there were a total of 71 citations (each for \$1000) issued for illegal fireworks.

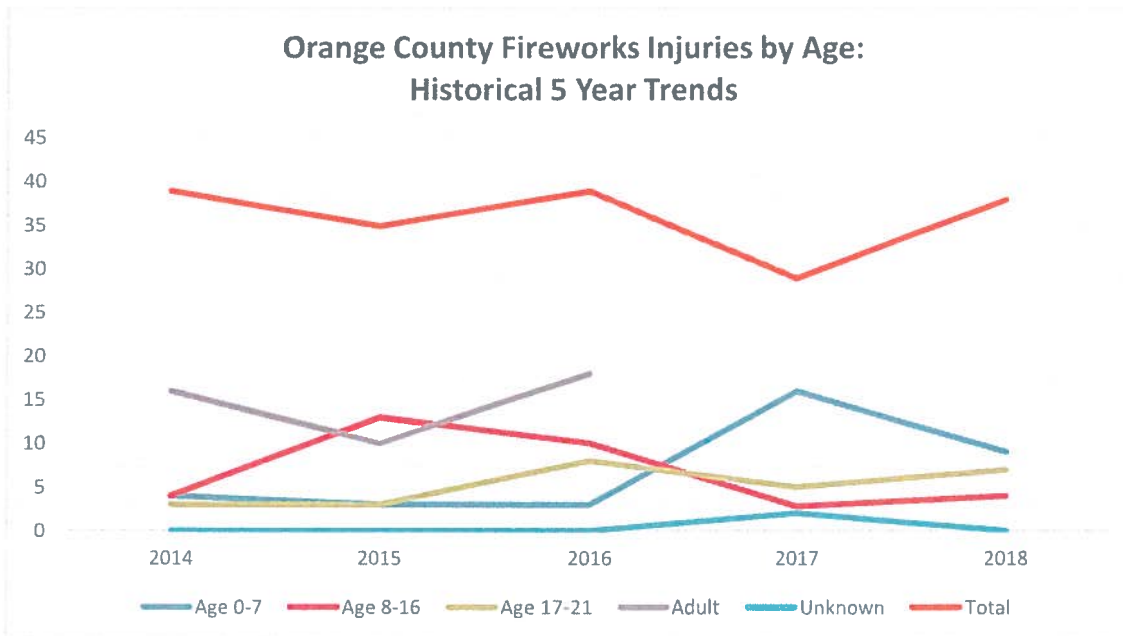
Stanton's Police Department received 34 calls for services for fireworks this year, which is a 28% decrease in calls from 2017. Overall, the City of Stanton found that there was less firework debris on the streets this year. For 2019, the City of Stanton is considering options to decrease response times, alter deployment models and utilize undercover enforcement to assist with future firework enforcement efforts.

Historical Fireworks Injury Trends

In 2018, Orange County hospital emergency and urgent care rooms reported 38 injuries that were directly caused by fireworks. This is an increase in comparison to 2017, when 29 injuries were reported. Over the past 5 years, Orange County averaged close to 34 fireworks-related injuries around the Independence Day holiday (June 30th-July 5th).

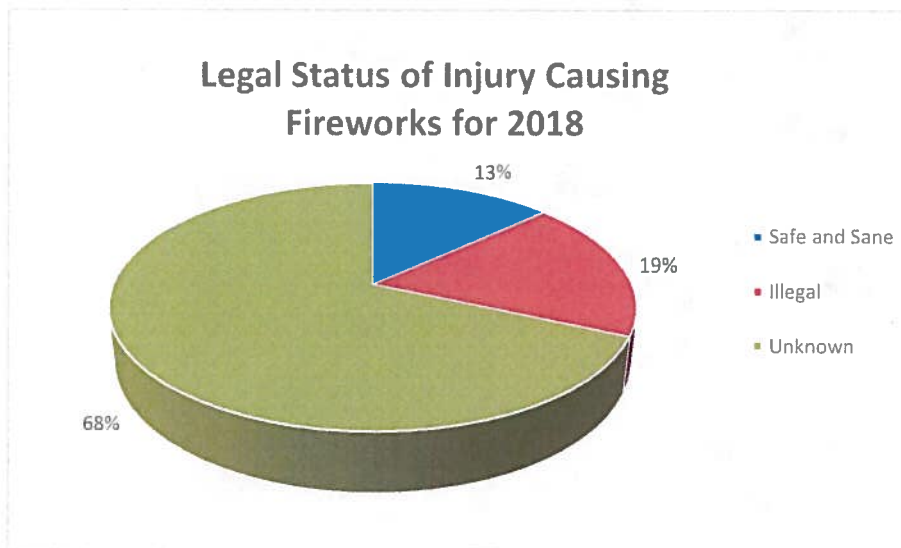
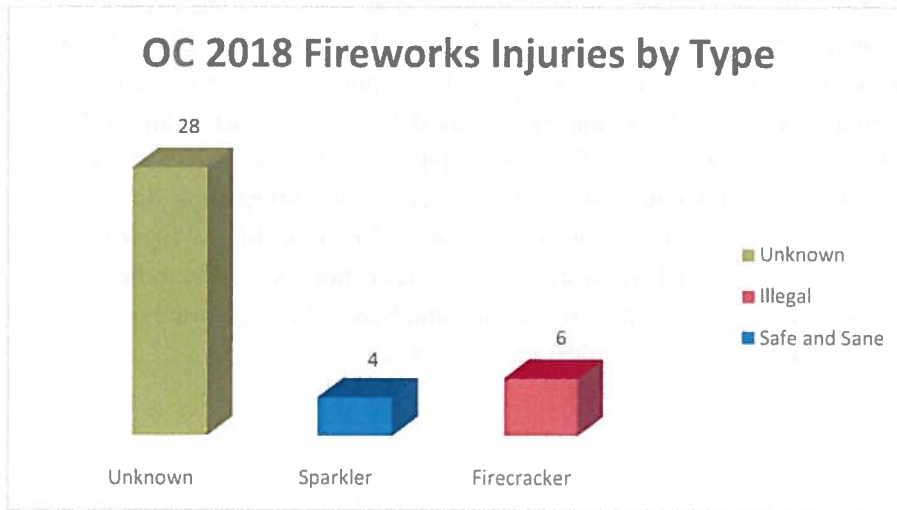

The number of fireworks-related injuries for adult patients was the highest this year. Most years, the adult category seems to yield the highest number of injuries. Reported injuries for patients under the age of 21 (age brackets 0-7, 8-16 and 17-21) increased from 12 to 20 this year.

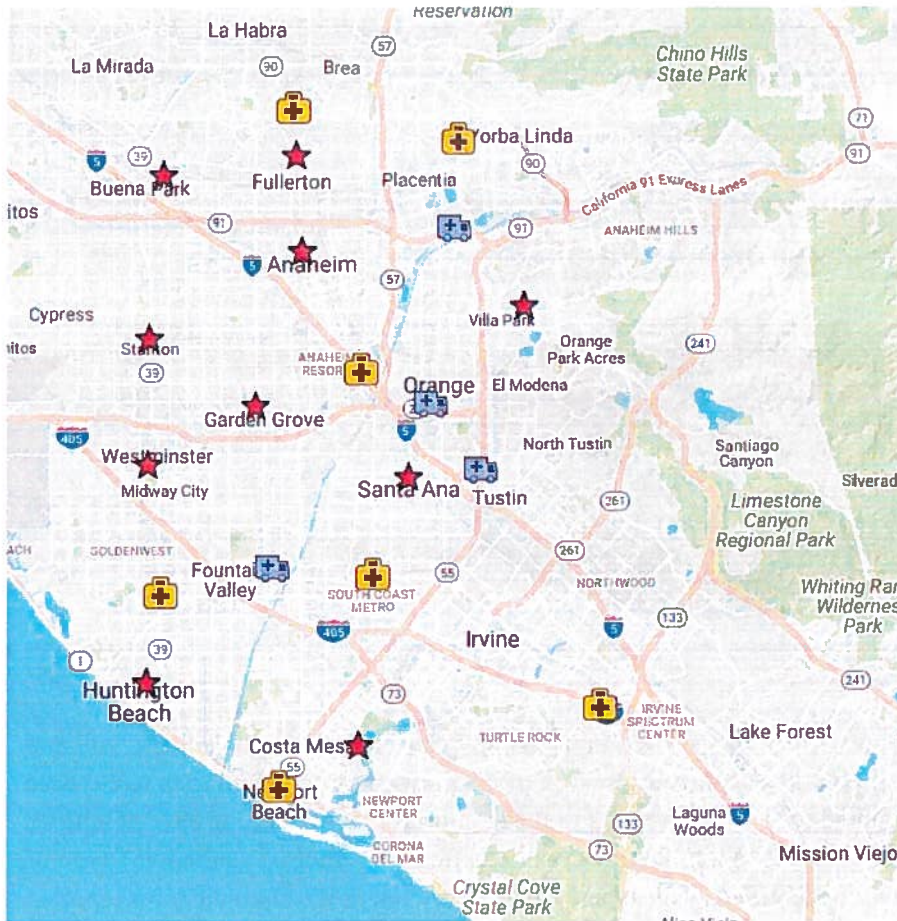
Types of Fireworks Involved in Injuries



This year in Orange County, fireworks-related injuries were caused by both illegal and Safe and Sane fireworks. Illegal fireworks accounted for 19% of all fireworks-related injuries while Safe and Sane fireworks accounted for 13% of fireworks-related injuries. The remaining 68% of injuries were caused by an unknown type. While there were a significant number of “unknown” type of fireworks, Firecrackers were identified as the type of illegal firework that caused the most reported injuries this year and Sparklers were the type of Safe and Sane firework that caused the most reported injuries this year.

Spatial Analysis of Fireworks Injuries

This map displays the locations of the Orange County hospitals that have reported fireworks-related injuries in 2018. The red stars indicate the cities that allowed the sale of Safe and Sane fireworks. The mustard hospital bag marker indicates hospitals that reported between 1-4 injuries and the purple ambulance marker indicates hospitals that reported 5 or more injuries during the study period of June 30, 2018 through July 5, 2018. There were 4 hospitals that reported 5 or more injuries this year (compared to 1 hospital with 5 injuries last year). This information does not conclude that the sale of fireworks caused more injuries. The spatial relationship of fireworks-related injuries that were treated in and around the Safe and Sane cities is not necessarily indicative of an on-going trend that injuries are happening near to the Safe and Sane cities. Reported injuries seem to be spread out throughout the county, regardless of firework sales.

In comparison to 2017, reported fireworks-related property loss decreased slightly in Orange County for 2018. Additionally, reported acreage that was lost due to fireworks-related fires, was significantly lower than in 2017. Illegal fireworks ignited a building fire in Aliso Viejo which resulted in an estimated \$10,000 in damages. Fireworks caused a vehicle fire in Santa Ana which caused \$21,500 in property loss. There was a \$37,000 loss in Tustin for 4 vehicles (in a single incident) that burned due to illegal fireworks. One building and one vehicle sustained minor damage due to rubbish fires that caused an estimated \$4,000 worth of damage in Huntington Beach. This year, Laguna Beach had an incident count of 17 while in 2017, the incident count was only 1. There were 757 incident counts reported for Anaheim alone this year (includes police department calls).

In Orange County Fire Authority’s jurisdiction, 69 fireworks-related incidents were reported this year.

As California continues to face another season of drought and wildfires, fireworks safety is critical to prevent dangerous fires and injuries. Dry brush combined with the continued use of illegal fireworks has elevated wildfire and fire danger within Orange County, which was evident in the 878 incident counts that were reported by Orange County fire departments.

Public Display Incidents

There were 25 public displays in Orange County this year. OCFA took part in 22 of those public displays. Of the 22 public displays, there were no injuries reported. At the Monarch Beach Resort in Dana Point, there was 1 ornamental vegetation fire that was extinguished by the pyro crew. There was 1 violation issued for the Dana Point Barge where the mortars were not buried correctly.

Orange County shows outside of OCFA areas included: 1 in Orange, 1 in Costa Mesa and 1 in Huntington Beach.

Confiscated Fireworks and Citations

Each year, Orange County Fire Authority measures the amount of fireworks confiscated over the Independence Day holiday. In 2018, the amount of reported confiscated fireworks (to local fire departments) was significantly lower than the past couple of years, however, there was no shortage of confiscation activity for local law enforcement. In Stanton, deputies confiscated over 30 pounds of illegal fireworks which resulted in an arrest and several citations. Westminster Police reported several arrests and the confiscation of hundreds of pounds of illegal fireworks. Costa Mesa Police Department seized 1,300 pounds of illegal fireworks in the two weeks leading up to the Independence Day holiday. Newport Beach Police Department confiscated more than 631 pounds of illegal fireworks. The following tables represents the information provided by Orange County fire departments.

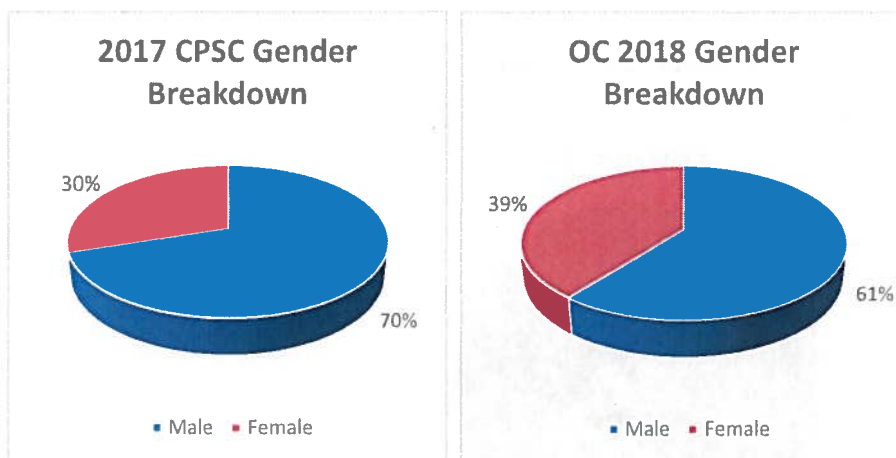

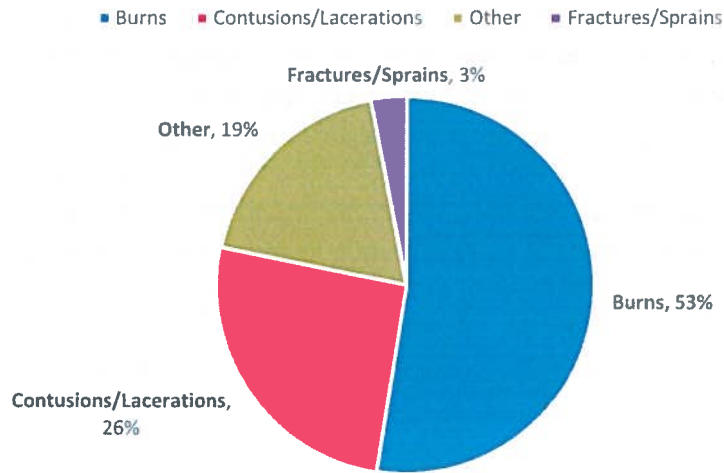
National Statistics Comparison

According to the 2017 CPSC Annual Fireworks Report, fireworks were involved in an estimated 12,900 injuries treated in US hospital emergency departments during calendar year 2017. Compared to the 11,100 injuries treated during calendar year 2016, there were 1800 more injuries treated in calendar year 2017. Orange County's average number of reported fireworks injuries was 38 in 2018 which is an increase from the 29 injuries reported in 2017. The same 10 cities allowed for the sale of Safe and Sane fireworks in 2018 as they did in 2017. In comparison to the national average of injuries reported, Orange County seems to be significantly lower in average injuries. This difference could be attributed to the fact that the sale of Safe and Sane fireworks is limited to 10 Orange County cities, while 47 US states allow the sale of consumer and/or Safe and Sane fireworks (with various local restrictions). Another contributing factor is that not all injuries may have been reported to hospitals and not all hospitals may have provided us with their reported injuries.

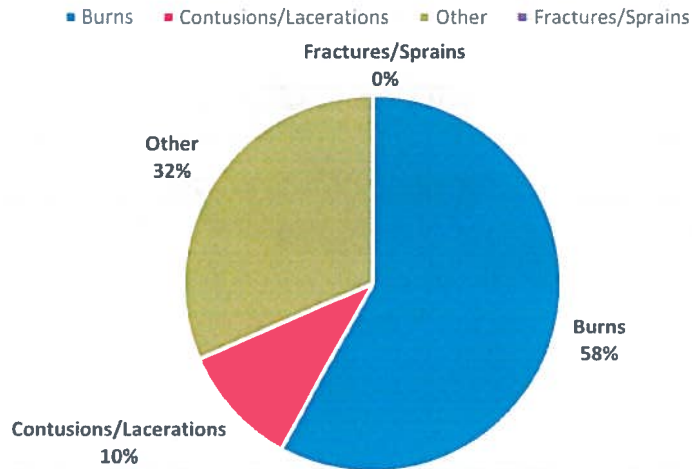


Nationally, 70% of fireworks injuries were experienced by males and 30% of fireworks injuries were experienced by females. This year in Orange County, the gender breakdown was very closely aligned with the national average, with 61% of fireworks injuries experienced by males and 39% of fireworks injuries experienced by females.

CPSC 2017 TYPE OF INJURIES

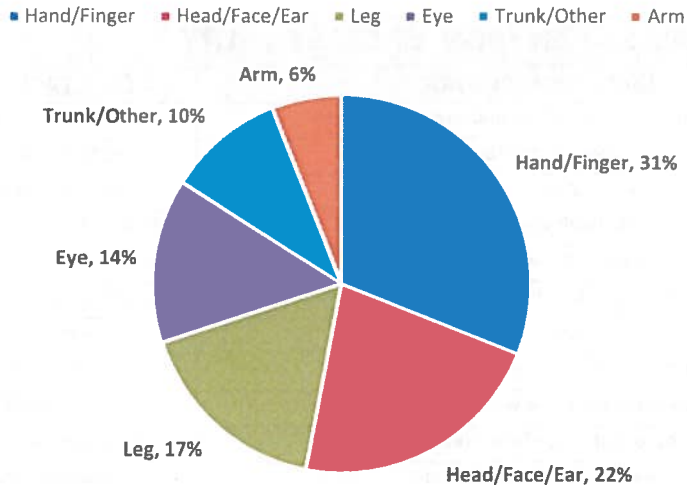


OC 2018 Type of Injuries

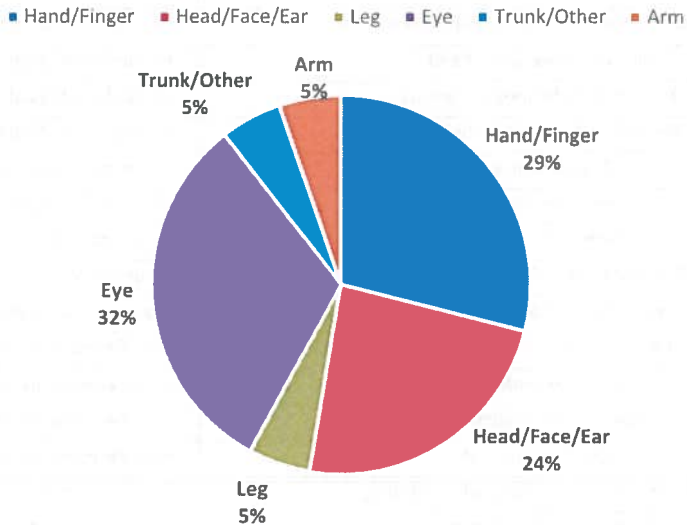


The type of injuries reported within Orange County this year very closely aligns with the national average. As with previous years, burns make up the majority of fireworks-related injuries in Orange County, at 58% this year. This year, the percentage is slightly higher than the national rate of 53% for burns. Orange County experienced no reported fractures and sprains this year, which aligns with the national average of 3%.

In Orange County this year, eye injuries were quite high. At 32%, this is more than double the national average of 14%. While hand/finger, head/face/ear and arm percentages for Orange County were on par with the national averages, the trunk/other and leg categories came in lower than the national percentages reported by CPSC for 2017.

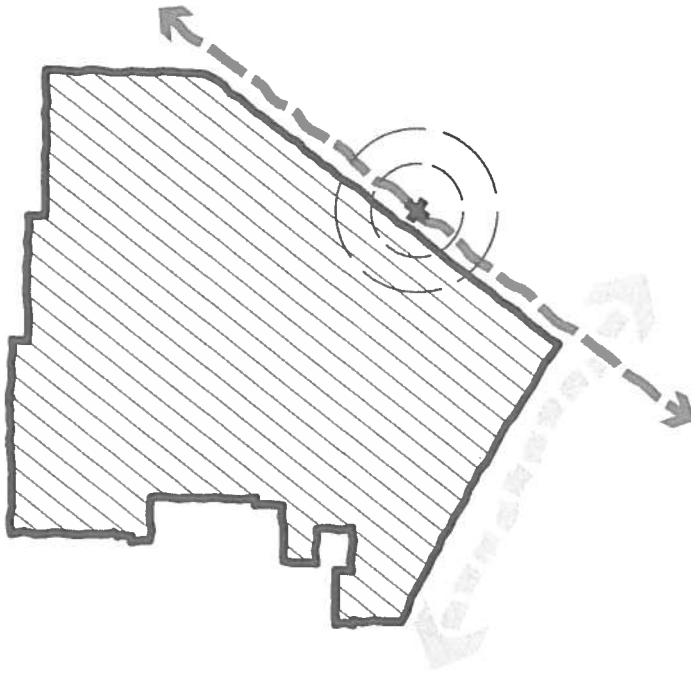

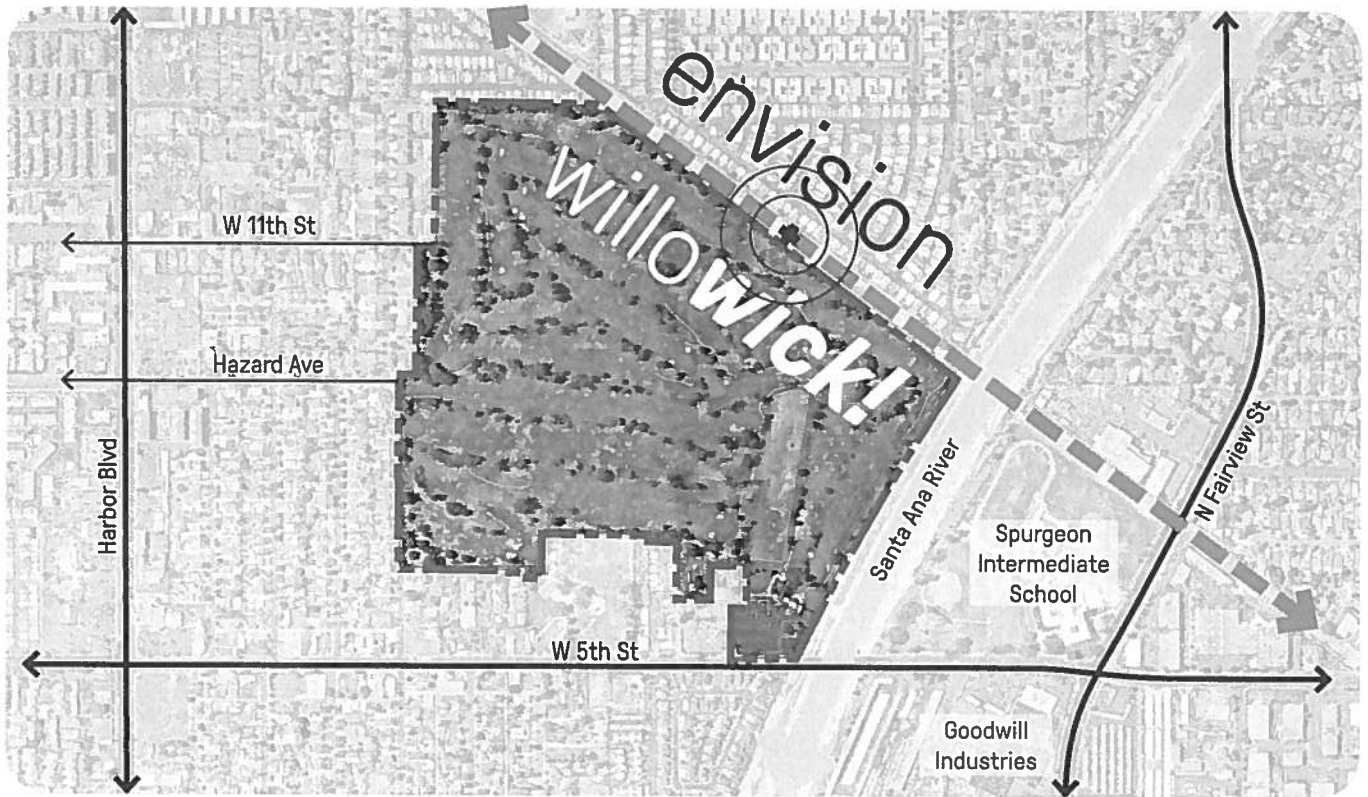

SUBJECT: Monthly Water Usage Data, Tier 2 Projection & Water Supply Information

The attached figures show the recent trend of water consumption in Orange County (OC), an estimate of Imported Water Sales for MWDOC, and selected water supply information.

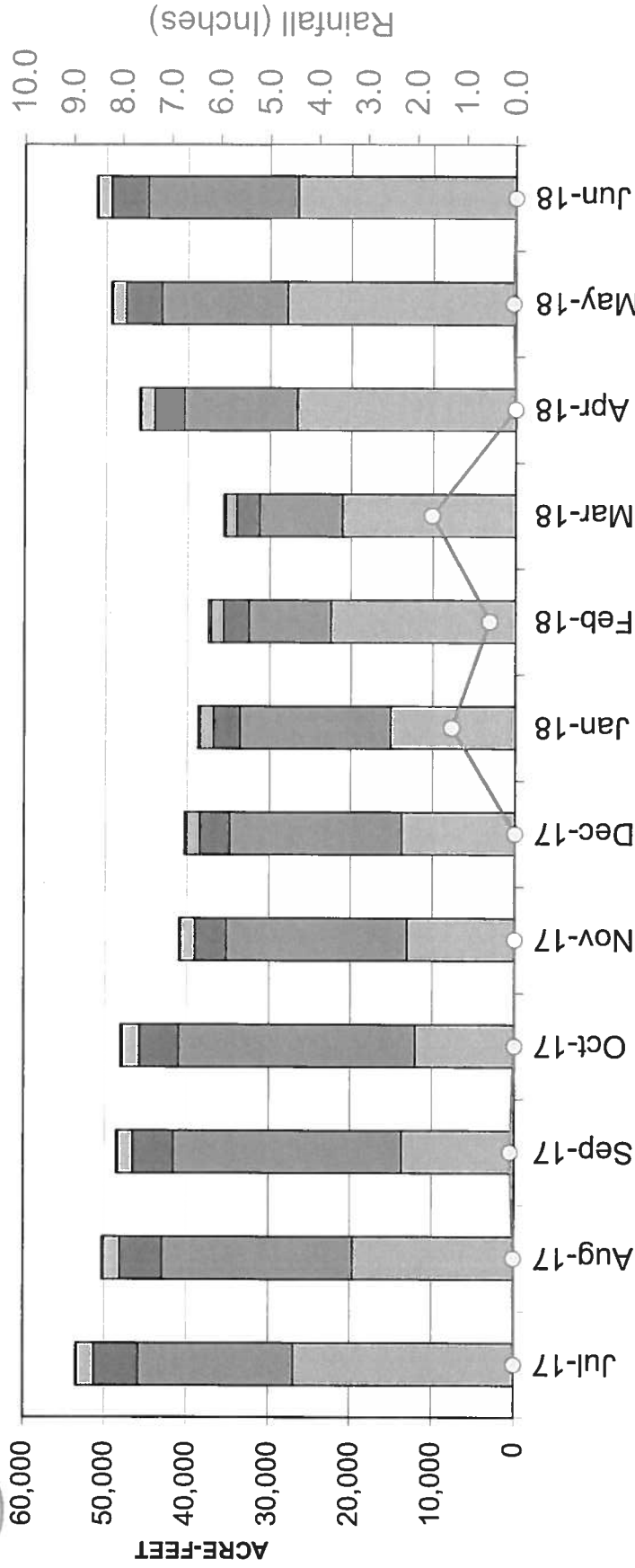
- OC Water Usage, Monthly by Supply OCWD Groundwater was the main supply in June.
- OC Water Usage, Monthly, Comparison to Previous Years Water usage in June 2018 was average compared to the last 5 years. We are seeing a slight increase in overall water usage compared to the previous two Fiscal Years. In June 2016, all water conservation became voluntary for MWDOC agencies and the Great California Drought was declared over by the Governor in April 2017.
- Historical OC Water Consumption Orange County M & I water consumption is estimated to be 540,000 AF in FY 2017-18 (*this includes ~15 TAF of agricultural usage and non-retail water agency usage*). This is about 21,000 AF more than FY 2016-17 and is about 48,000 AF more than FY 2015-16 (During the SWRCB mandatory water restrictions). Water usage per person is projected to be slightly higher than in FY 2017-18 for Orange County at 151 gallons per day (This includes recycled water). Although OC population has increased 20% over the past two decades, water usage has not increased, on average. A long-term decrease in per-capita water usage is attributed mostly to Water Use Efficiency (water conservation) efforts. O.C. Water Usage for the last three Fiscal Years is the lowest since the 1982-83 Fiscal Year (FY1982-83 was the third wettest year on record).

Water Supply Information Includes data on Rainfall in OC; the OCWD Basin overdraft; Northern California and Colorado River Basin hydrologic data; the State Water Project (SWP) Allocation, and regional storage volumes. The data have implications for the magnitude of supplies from the three watersheds that are the principal sources of water for OC. Note that a hydrologic year is Oct. 1st through Sept. 30th.

- Orange County's accumulated rainfall through late July was well below average for this period. Water year to date rainfall in Orange County is 3.66 inches which is 29% of normal.
- Northern California accumulated precipitation through late June was around 84% of normal for this period. Water Year 2017 was the wettest water year on record. The Northern California snowpack was 43% of normal as of April 1st. The State of California was in a declared Drought Emergency that started January 2014 and ended in April of 2017. As of late July, 44.73% of California is experiencing moderate or severe drought conditions while 86.18% of the state is experiencing abnormally dry conditions. The State Water Project Contractors Table A Allocation has increased to 35% as of late May.
- Colorado River Basin accumulated precipitation through late June was 70% average for this period. The Upper Colorado Basin snowpack was 71% of normal as of April 3. Lake Mead and Lake Powell combined have about 58% of their average storage volume for this time of year and are at 43.7% of their total capacity. If Lake Mead's level falls below a "trigger" limit 1,075 ft. at the end of a calendar year, then a shortage will be declared by the US Bureau of Reclamation (USBR), impacting Colorado River water deliveries to the Lower Basin states. As of late July, Lake Mead levels were 2.5' above the "trigger" limit. The USBR predicts that the start of 2019 will not hit the "trigger" level but there is a 52% chance that the trigger level will be hit in 2020 and a 64% chance in 2021.



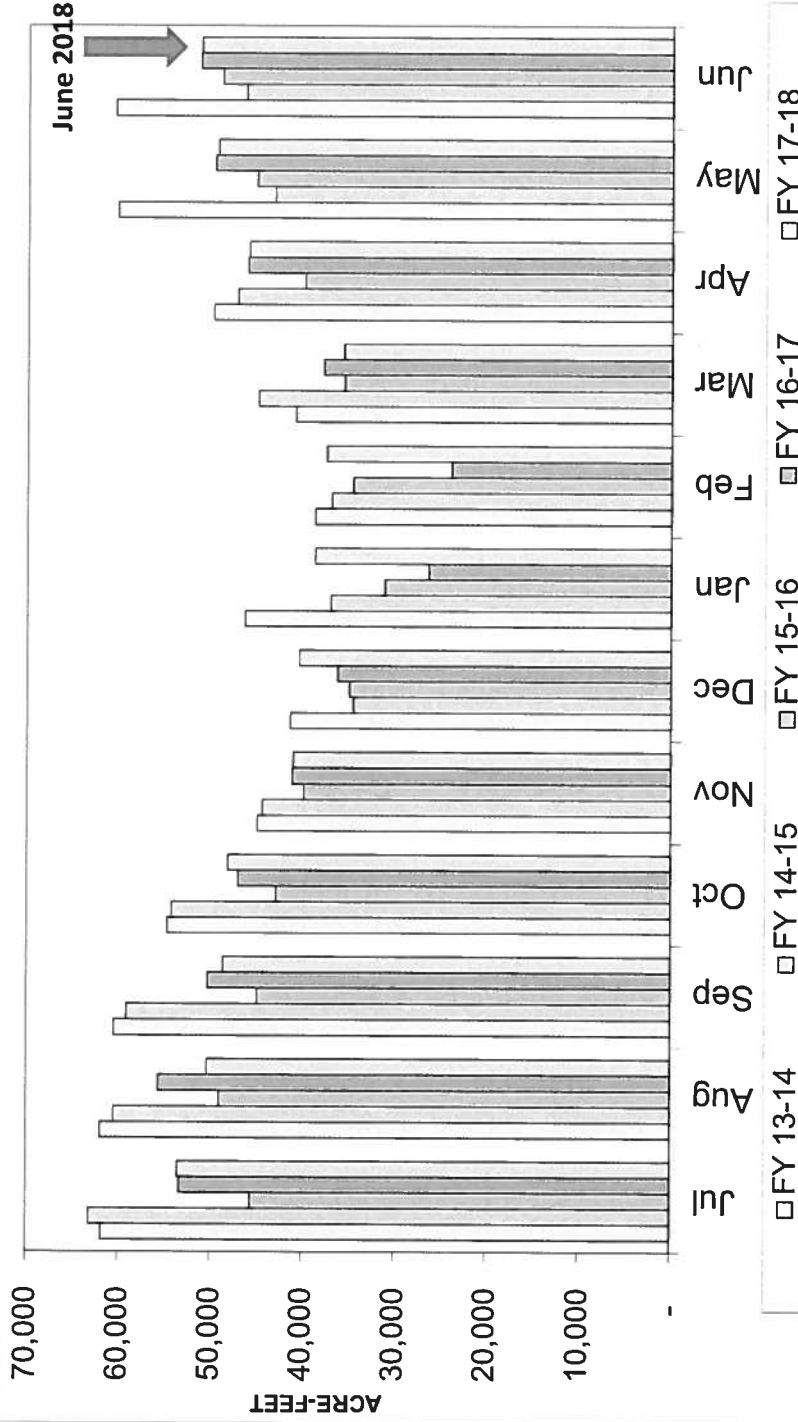
Fig. 1 OC Water Usage, Monthly by Supply with projection to end of fiscal year



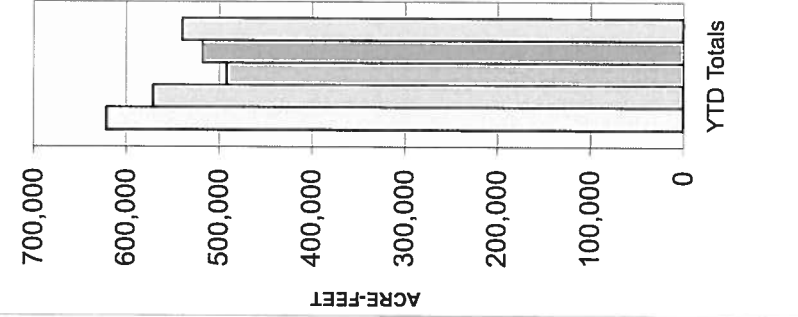

Fig. 2 OC Monthly Water Usage [1]: Comparison to Last 4 Fiscal Years

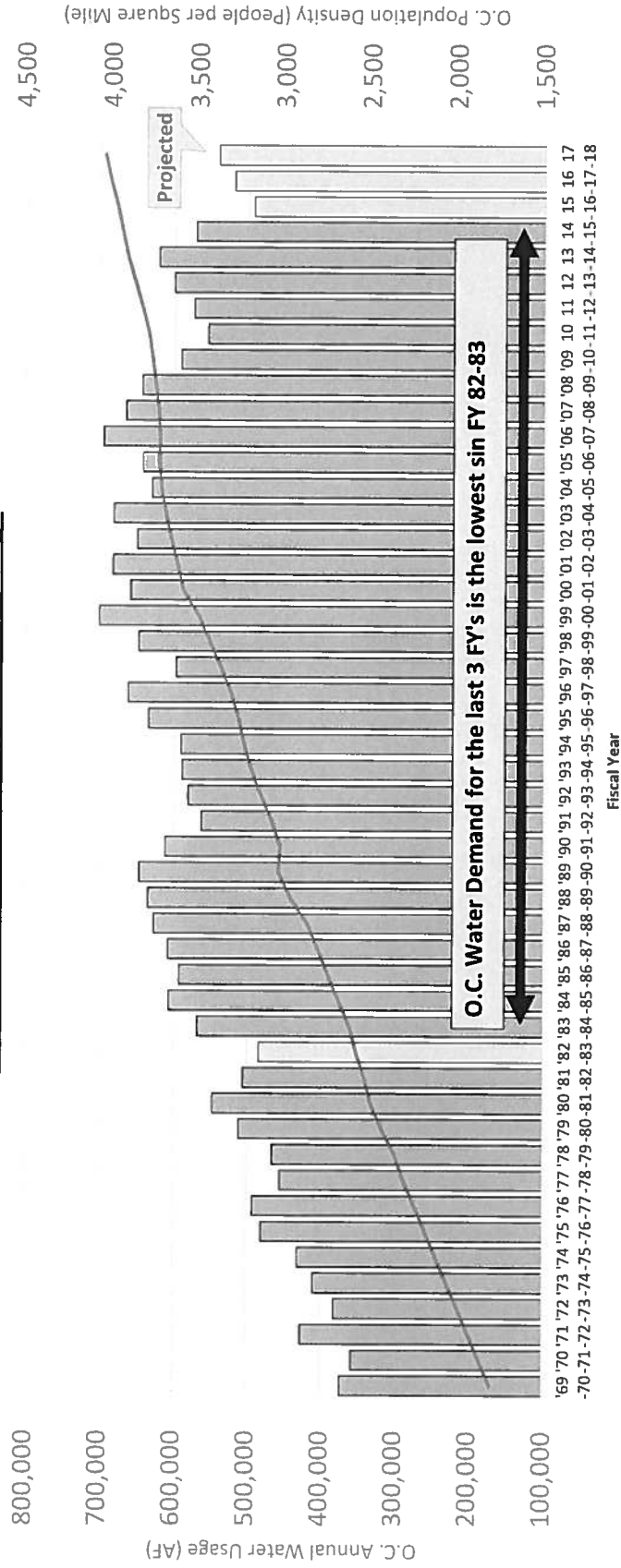

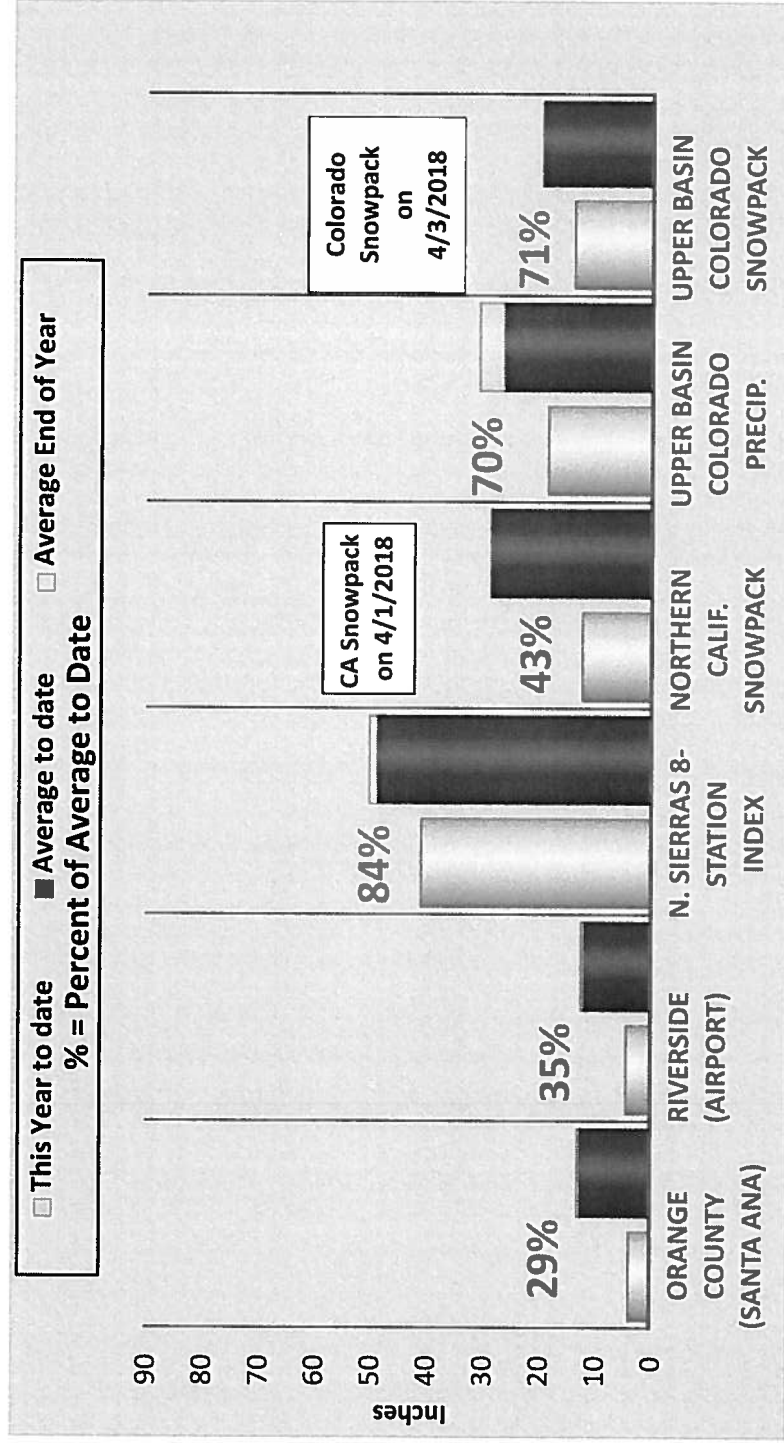

Orange County Annual M & I Water Usage



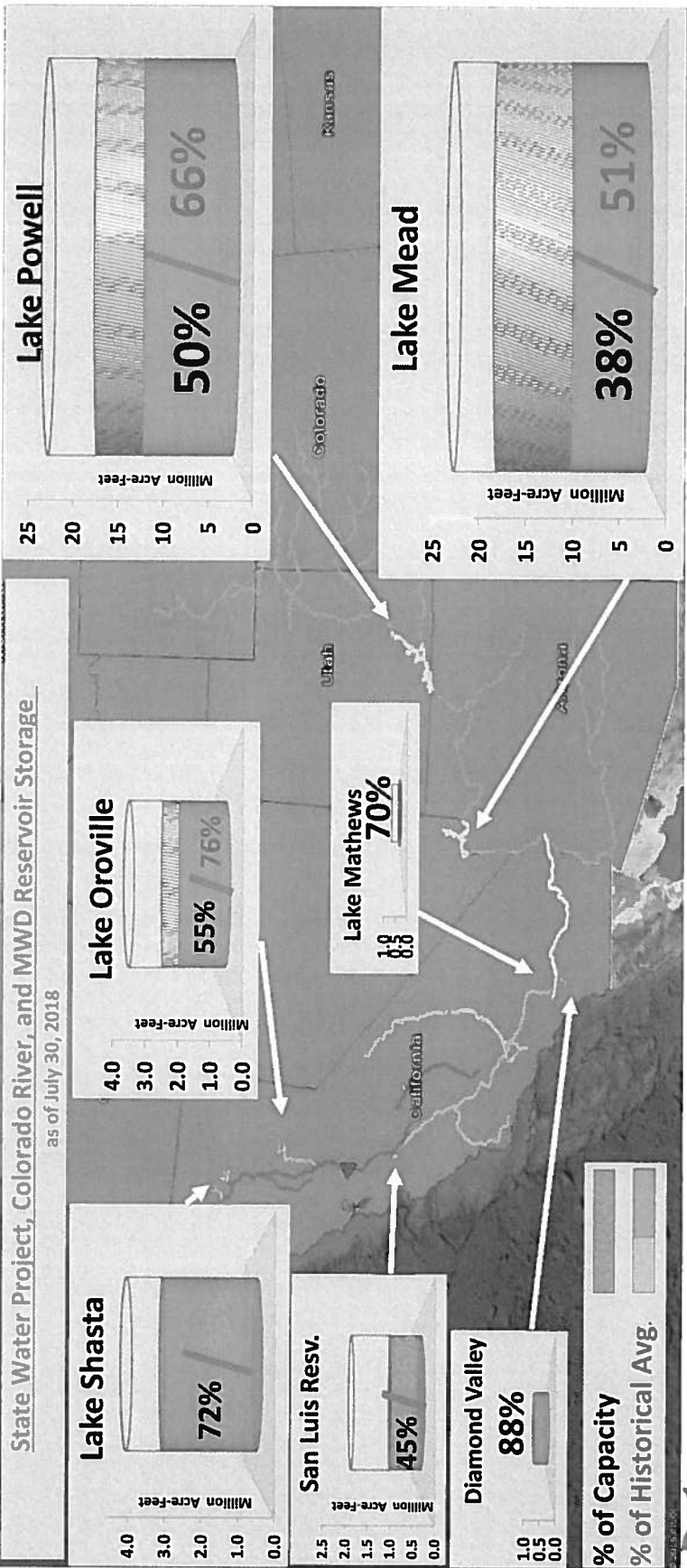
Accumulated Precipitation

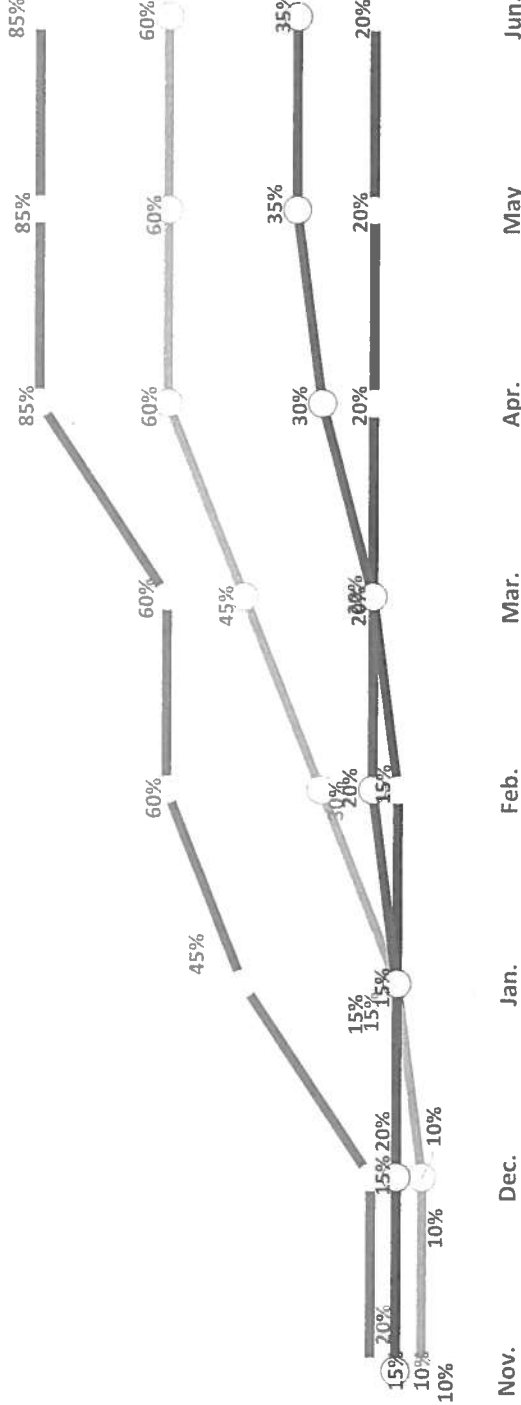

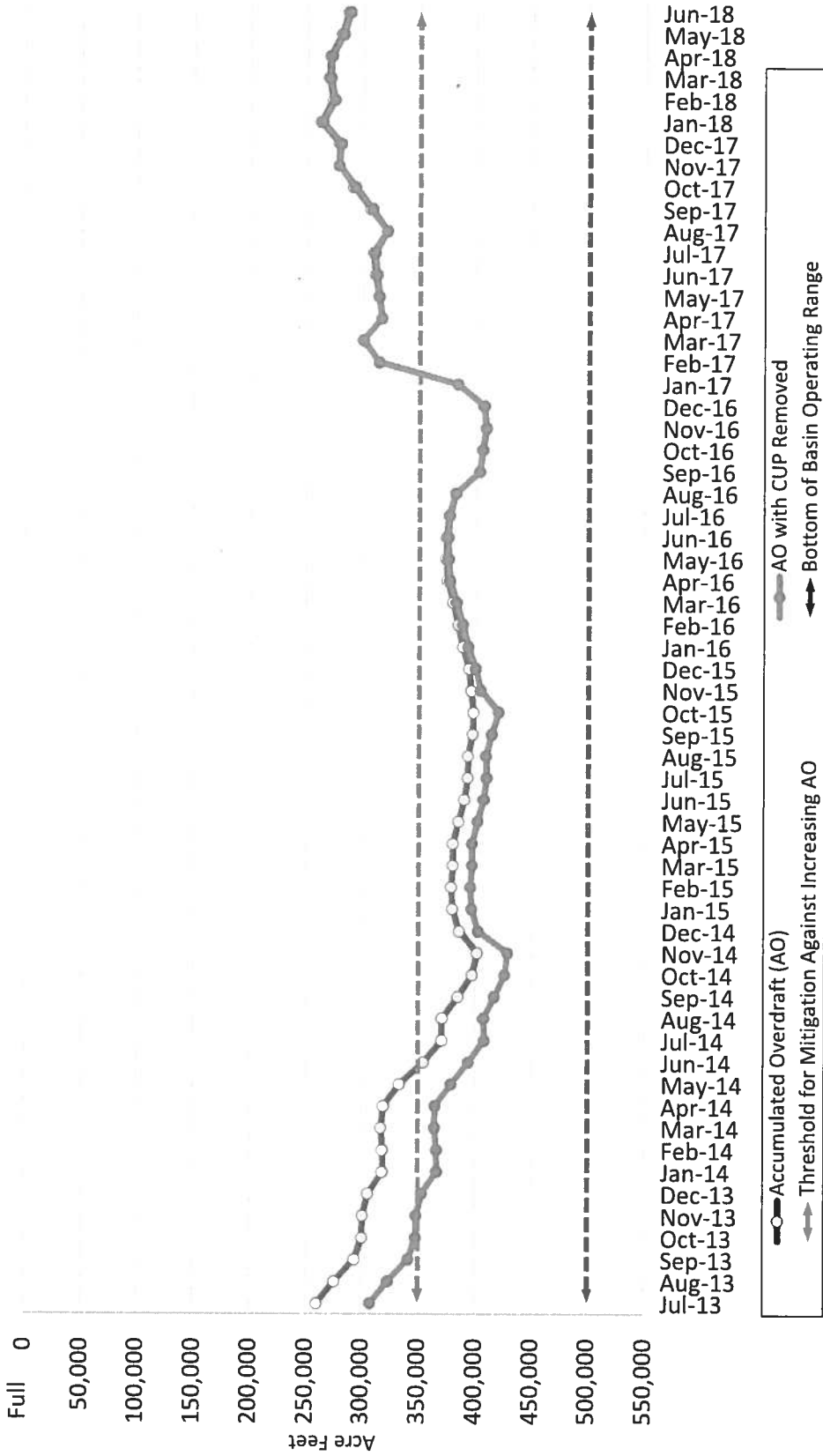

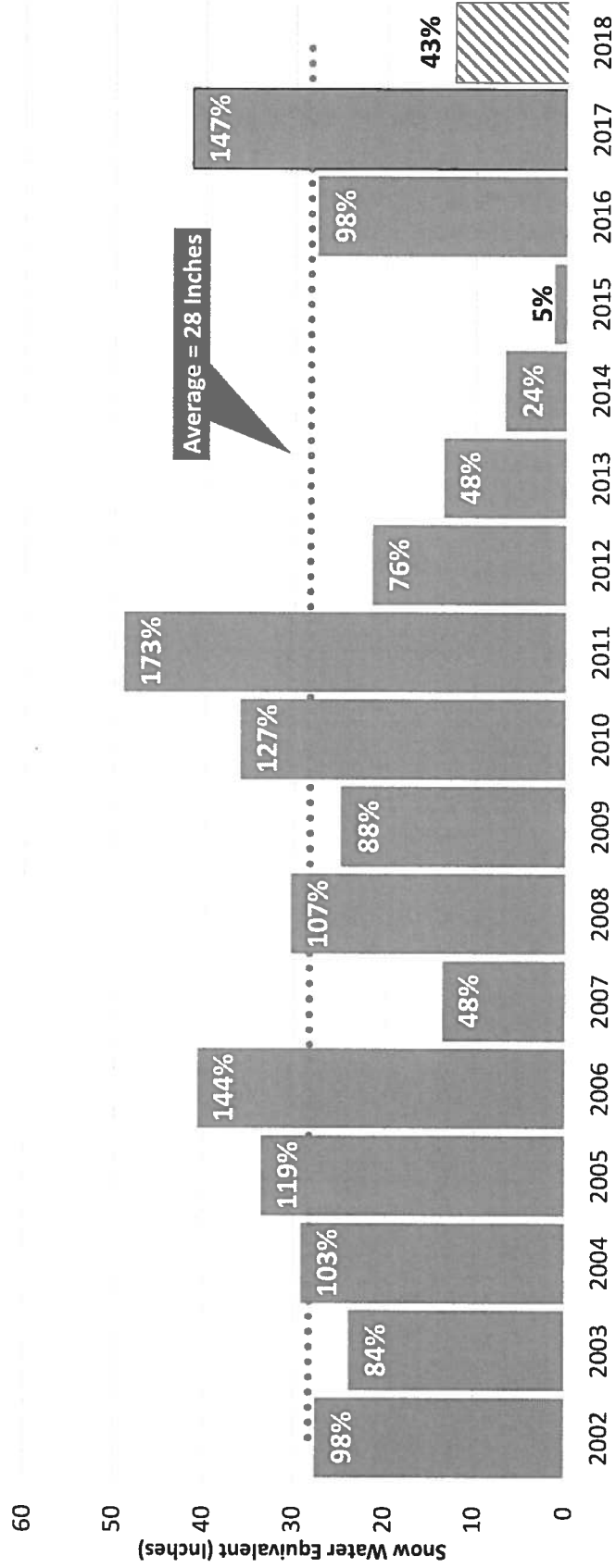
Accumulated Overdraft of the OCWD Groundwater Basin as of June 2018

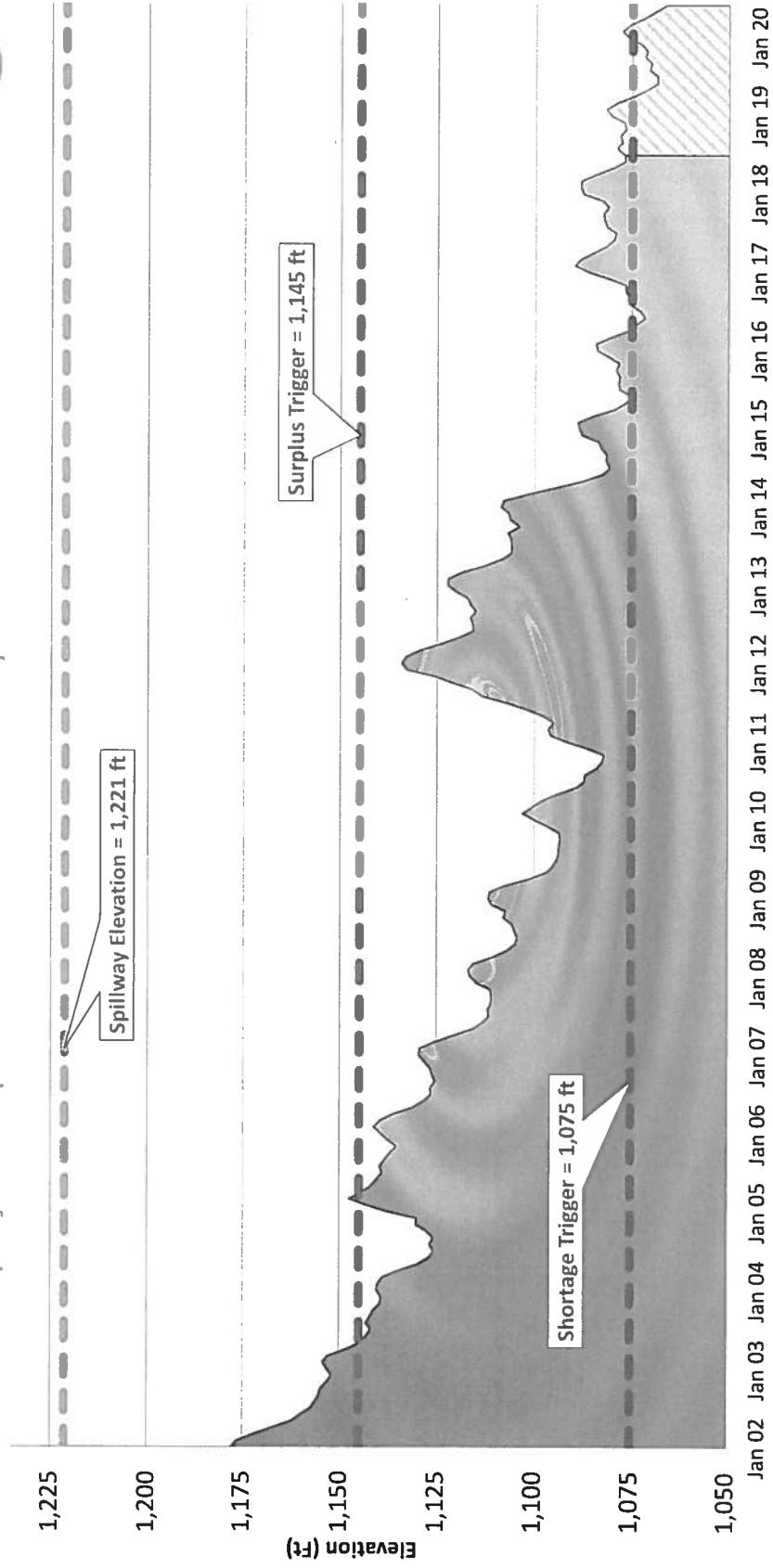
Historical Northern California April 1st Peak Snow Water Equivalent



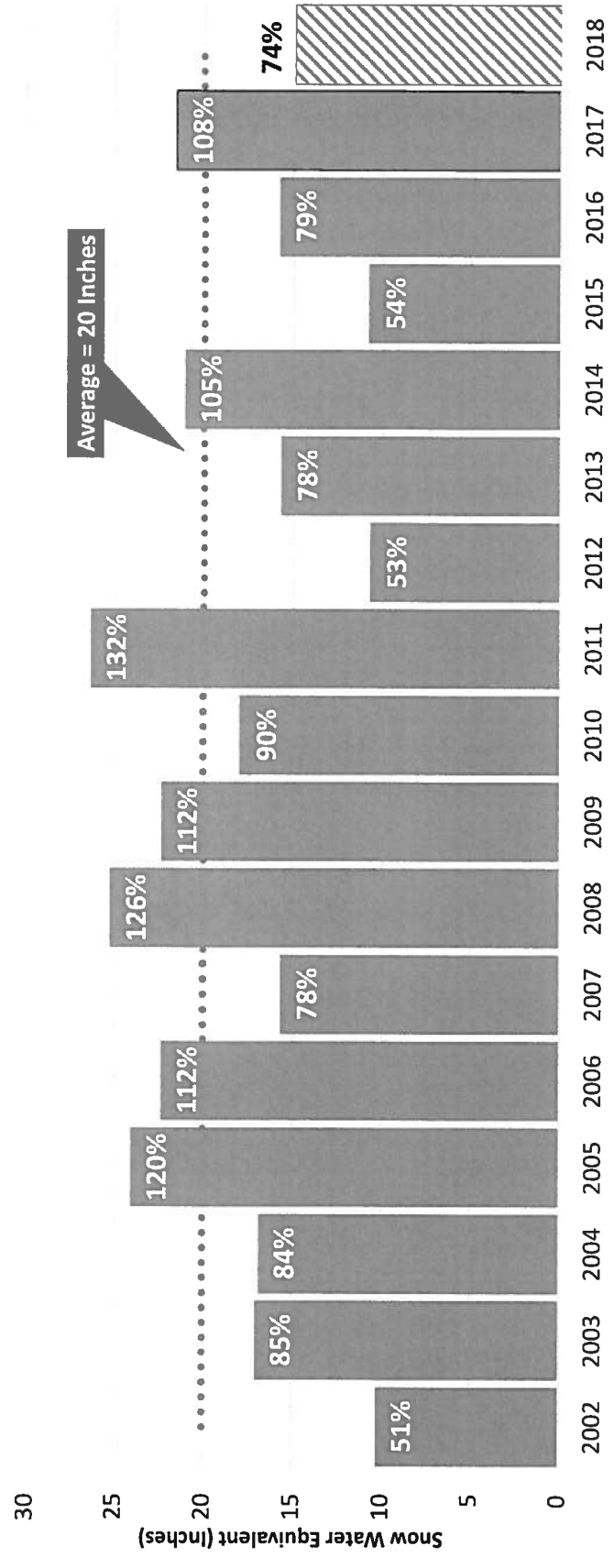


Lake Mead Levels: Historical and Projected projection per USBR 24-Month Study

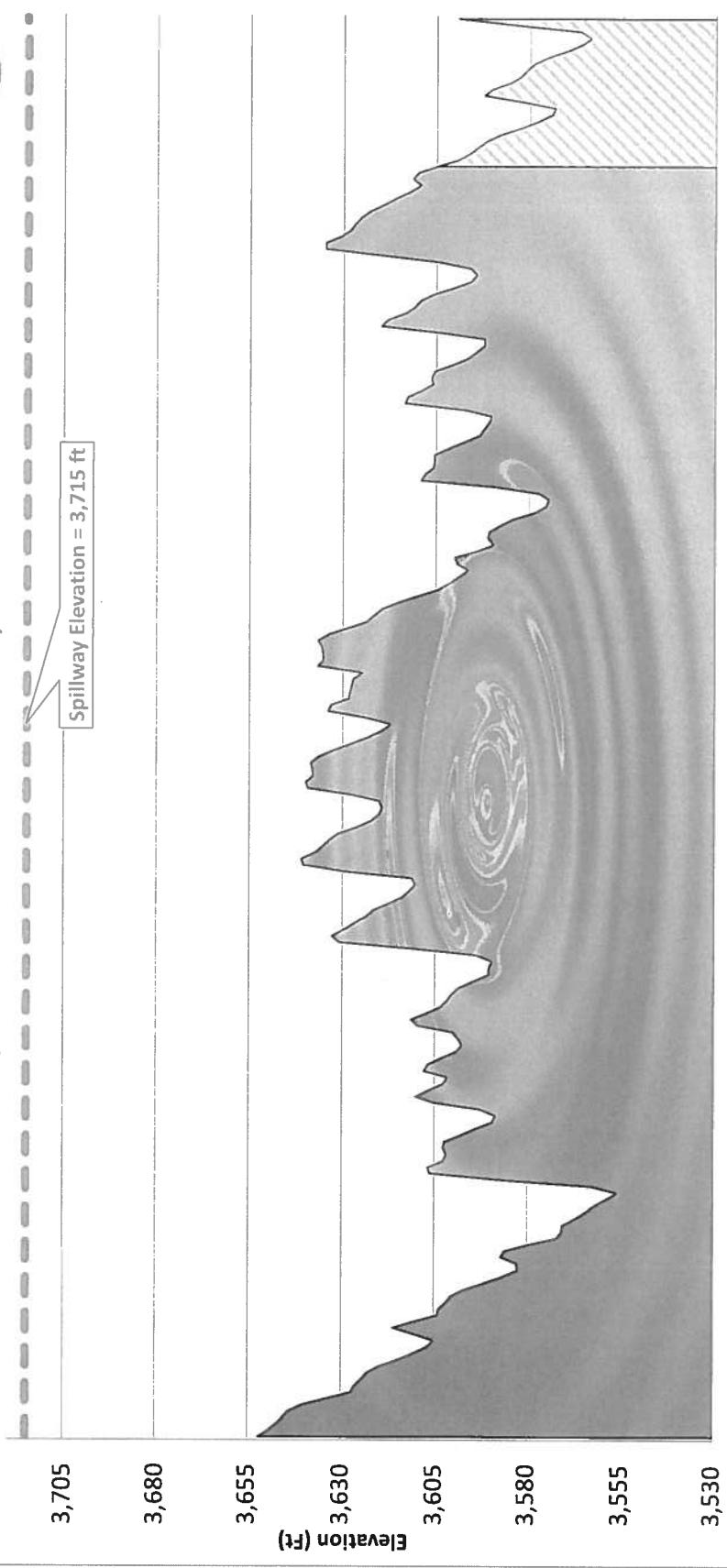
Historical Colorado Basin April 15th Peak Snow Water Equivalent

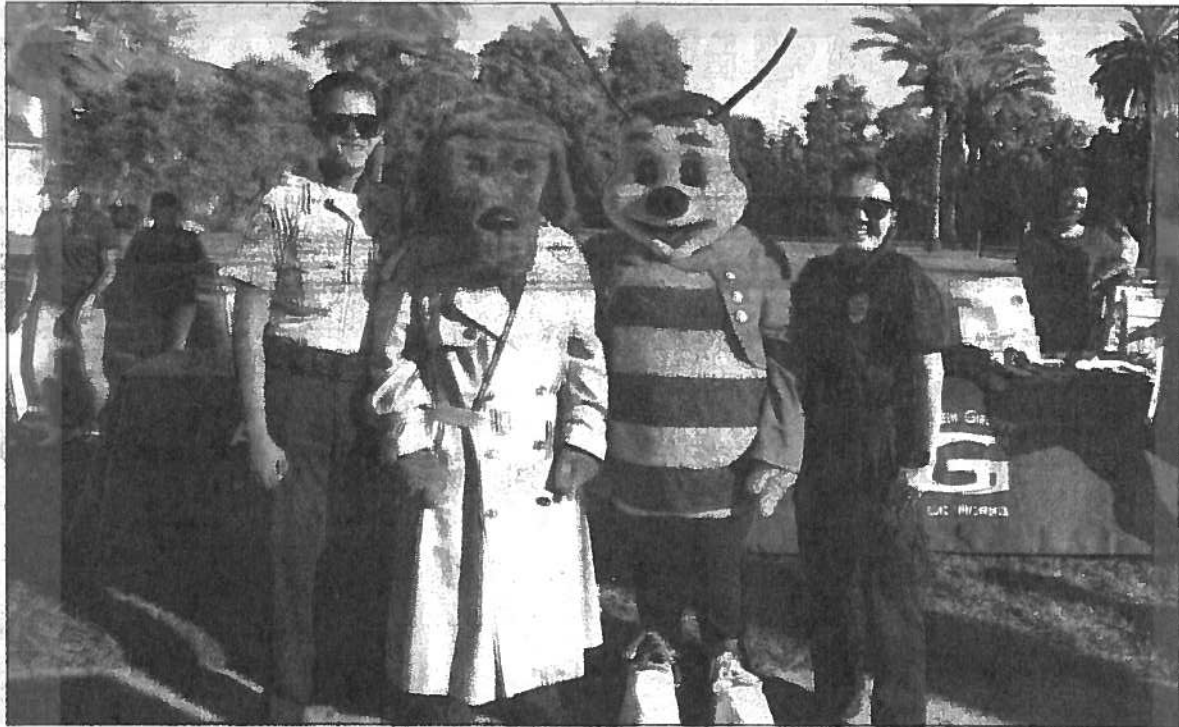

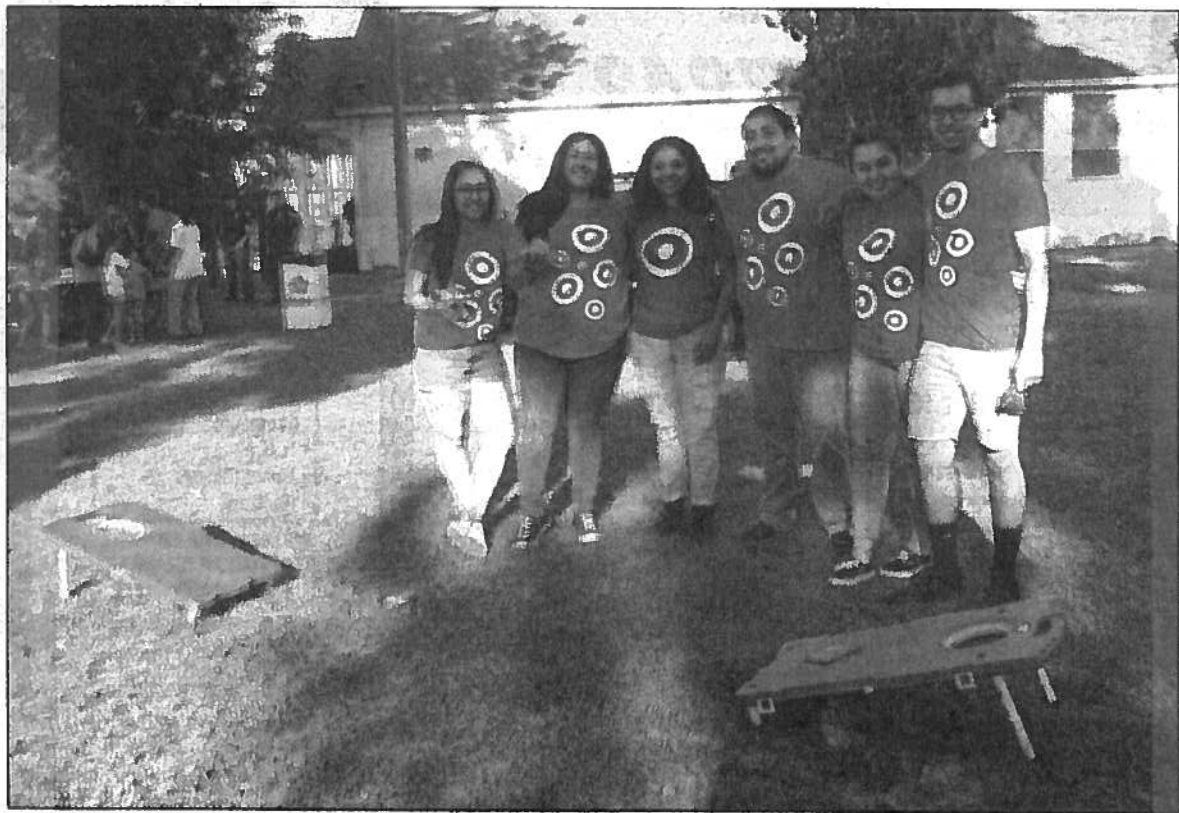

Elvis Tribute Artists including Kirk Wall of Anaheim, the Elvis Festival's longstanding ambassador, will perform the king's favorite songs Sunday, Aug. 26, on Historic Main Street in Garden Grove.

The Elvis Festival founder and organizer Jill Lloyd said Wall has been part of the festival since its inception.

"I knew him previously, as he came to my rescue when an Elvis I had booked for opening ceremonies at the Orange County Fair, where I formerly did PR for them, bailed on me the night before the opening," she said. "Having Elvis there was a special part of the opening ceremonies where Elvis would perform 'Blue Hawaii' with two hula dancers who rose from a cherry picker, or hydraulic crane, so I hired Kirk over the phone and took a chance on him and when he showed up the next morning and saved the day, looking like he'd rehearsed the act many times with the dancers, I knew I had a true artist."

Lloyd said when she started the Elvis Festival, there was no question who she wanted for Elvis and he has been with her ever since, and the festival has continued to grow.

"During the first years Kirk was the only Elvis perform I enlisted," Lloyd shared.

"I was around at the right time when Jill Lloyd needed an Elvis Tribute Artist," said Wall, explaining how he got involved with the Elvis Festival, which is celebrating its 19th year in 2018.

"The festival started out very small," said Lloyd. "It was just a car show at the Orange County Marketplace, the weekend swap meet at the O.C. Fair and Event Center in Costa Mesa. There were Cadillacs and other cars that were Elvis Presley's favorites."

Wall said he would do Elvis sets of music at the car shows and had singalongs, with many different musical twists to keep people entertained and coming back.

"I grew up in a classically-trained

musical family, playing the violin, and my dad sang opera," Wall chuckled. "My dad said, 'That boy can sing,' and so I got away with playing Elvis' 'It's Now or Never' music and I started to also appreciate the Beatles music and when I was in college I did German music and participated in boxing. At fraternity parties I performed with a rock and roll band in the auditorium and started thinking that drums were pretty neat."

Wall currently performs at Knott's Berry Farm in a Hillbilly Band. "I'm honored to have such a great musical opportunity," he said. "Knott's is good to us."

Wall is described as a "jack of many personas."

As a singer from his earliest years, he attended college on an opera scholarship. He has appeared in scores of professional musical theater productions, has led bands ranging from rockabilly to swing ensembles, and has created several colorful alter-egos blending his years of experience as a comic-tinged singer and actor.

Two of Wall's roles include Tony Fabulous, the pink-clad singer of the swing band The Big Shots, and the prosthetic teeth-wearing fiddle player of Billy and the Hillbillies. The latter was a gig he held for 25 years at Disneyland and as mentioned he now performs at Knott's Berry Farm under the persona of Crazy Kirk with his band The Hillbillies.

However, Wall has been performing as Elvis longer than anything, which is nearly 40 years.

His admonition to other musicians? "Keep your mind open to everything that comes along and around your way and keep your interest going in everything you can; that way, your music will be better and improve."

The Elvis Festival is set for Saturday, Aug. 26 on Historic Main Street in Garden Grove from 10 a.m. to 6 p.m.

League-Sponsored Bond Agency Issues \$5 Million in Tax-Exempt Bonds for Monte Vista Christian School

August 9, 2018

Some of the most significant benefits of League membership for cities since 1988 have flowed from the League's co-sponsorship of the California Statewide Communities Development Authority (CSCDA).

The California Statewide Communities Development Authority (CSCDA) announced the issuance of \$5,000,000 in tax-exempt bonds for Monte Vista Christian School (MVCS) located in Watsonville.

About Monte Vista Christian School

Founded in 1926, MVCS is dedicated to being a premier Christian college preparatory school, empowering students to impact their world. MVCS embraces the future, was the first school in the world to adopt iPad technology, and is continually seeking to meet students where they are through impactful curriculum and innovative use of spaces. MVCS offers dedicated, caring, professional educators and a first-class, college-like campus experience

CSCDA partnered with Stifel, Santa Cruz County Bank and Squire Patton Boggs to provide the \$5,000,000 in tax-exempt bonds for MVCS. The bonds will be used to finance an approximately 16,600 square feet multi-purpose building that will include a main performance/assembly space with a stage and retractable seating to accommodate a variety of layouts and events. It will also include separate large classrooms for group vocal and instrumental arts instruction, as well as smaller spaces for individual vocal/instrumental practice.

Background

CSCDA is a joint powers authority created in 1988 and is sponsored by the League of California Cities® and the California State Association of Counties. It was created by cities and counties for cities and counties. More than 530 cities, counties and special districts are program participants in CSCDA, which serves as their conduit issuer and provides access to efficiently finance locally-approved projects. CSCDA has issued more than \$60 billion in tax exempt bonds for projects that provide a public benefit by creating jobs, affordable housing, healthcare, infrastructure, schools and other fundamental services. Proposed Cannabis Regulations Thwart Intent of Voters Who Passed Prop. 64 with Strong Protections for Local Control

August 9, 2018

The Bureau of Cannabis Control (BCC) on Aug. 7 held the first of three public hearings in Oakland to discuss the recently released proposed regulations.

The League served as the only local government advocate in a series of testimony where most of the speakers expressed their support for the regulations or voiced no concerns.

The League's objections to the proposal focus on two main areas: the forced authorization of cannabis deliveries and establishing a 10-day "shot clock" to verify cannabis licenses. These provisions go against Proposition 64, which gives local governments the authority to determine whether or not they want to allow cannabis deliveries in their jurisdictions.

If approved, these proposed regulations could have serious consequences for cities. By removing the ability of local jurisdictions to reasonably regulate commercial cannabis, the BCC will be overturning the local control provisions crafted by proponents and supporters of Prop. 64.

Voice Your City's Opposition

BCC is taking comments on the proposed regulations until Aug. 27. Cities should review the proposal and join the League in voicing opposition.

The League has formally submitted a letter in opposition to both the forced authorization of cannabis delivery and 10-day shot clock provisions, and created a sample opposition letter.

BCC will hold two more public hearings before the comment period closes. The League urges cities to attend and make oral comments opposing these regulations.

Yountville Mayor Cautions Proposed Changes to Utilities Liability for Wildfires are Likely Unconstitutional

Cities Should Join the League and Oppose Changes to Inverse Condemnation

August 10, 2018

Yountville Mayor John Dunbar testified for a second time before the Wildfire Preparedness and Response Conference Committee in just two weeks.

His testimony on Aug. 9 called attention to cities' opposition to a proposal that would place new liability on cities and make it harder for local governments to recover from wildfire disasters.

Sen. Bill Dodd (D-Napa), committee co-chair, started by stating that the issue of inverse condemnation and electric utilities will likely receive the most attention of any of the thousands of bills introduced this year in the last weeks of session.

Committee members continued the discussion on inverse condemnation that they began in their first hearing on July 25. The League opposes reducing the inverse condemnation standard for incidents caused by a utility, whether retroactive or otherwise, and supports ensuring that local governments can recover applicable damages. Local agencies cannot recover all costs from disasters and this method (inverse condemnation) is the method that allows local governments to recoup losses and rebuild communities.

After sharing what happened in Yountville in 2017 when a wildfire forced the evacuation of the 1,000 residents of the California Veterans Home, Mayor Dunbar stressed how local governments are on the forefront of wildfire disaster preparedness and response. He echoed a number of the other experts and questioned the legality of the proposed changes.

"The Governor's proposal to the liability rules may be unconstitutional because it violates an individual's right to receive just compensation and should be evaluated in a court of law," said Mayor Dunbar.

Utilities should be equally prepared and responsive in such dangerous conditions. Proposals to change inverse condemnation rules open the door to allow utilities to pass off liability to other entities and reduce damage recovery that victims would receive. Victims of fires, including local agencies, should continue to receive just compensation for damage incurred.

Next Steps

The committee will continue its work in the coming final weeks of the legislative session. Cities should

oppose the proposed changes to inverse condemnation.

HCD Now Has Authority to Revoke Housing Elements

Non-Certified Housing Elements Put Cities at Risk of Funding Loss Explains HCD Director

August 15, 2018

The California Department of Housing and Community Development (HCD) gained new authority after Gov. Jerry Brown signed last year's 15-bill housing package.

The package included AB 72 (Chapter 370, Statutes of 2017), which provides HCD with broad authority to review any action or inaction by a city or county that it determines is inconsistent with an adopted housing element. This includes failure to implement specified program actions included in the housing element.

HCD now has the authority to revoke a state certified housing element and notify the California Office of the Attorney General if a local jurisdiction is in violation of state law for non-compliance with housing element law, the Housing Accountability Act, "no net loss" law, density bonus law or anti-discrimination law.

The agency has recently released [a 5-minute video](#) to explain its process for monitoring cities and counties and how HCD is implementing its new authority. It is important to note that cities with noncompliant or revoked housing elements are ineligible for many state and federal funding opportunities.

New Report Finds Lack of Safety Features on Roads Costs California Drivers \$61 Billion Annually

Annually Data Shows Urgency of Transportation Safety Projects Jeopardized by Prop. 6



August 16, 2018

Data released on Aug. 15 shows the lack of safety features on roads and bridges costs California drivers \$61 billion each year – as much as \$2,995 per driver in some areas.

According to TRIP, the national transportation research organization that conducted the study, more than two-thirds of major roads in California are in poor or mediocre condition and that 1,603 locally and state-maintained bridges are structurally deficient.

From the report:

“Driving on California roads that are deteriorated, congested, and that lack some desirable safety features costs California drivers a total of \$61 billion each year. TRIP has calculated the cost to the average motorist in the state’s largest urban areas in the form of additional vehicle operating costs (VOC) as a result of driving on rough roads, the cost of lost time and wasted fuel due to congestion, and the financial cost of traffic crashes.”

“Maintaining this higher level of transportation funding will be critical in allowing the state to improve road and bridge conditions, relieve traffic congestion and improve traffic safety. If California is unable to maintain its current level of transportation investment, the cost to the public of deficient roads, traffic congestion, and a lack of adequate roadway safety will increase and economic development opportunities and quality of life in the Golden State will be diminished.”

The findings in the [TRIP report](#) underscore what is at stake in November with Proposition 6, the attack on bridge and road safety.

“The last thing in the world we should be doing is eliminating road safety and infrastructure projects. But that’s exactly what Prop. 6 will do,” said Skip Carter, former Deputy Commissioner of the California

Highway Patrol. “It will have a hugely negative and local impact — making our roads and bridges less safe, more deteriorated and more congested.”

Prop. 6 jeopardizes funding for more than 6,500 bridge and road safety, transportation and public transit improvement projects currently underway throughout California by eliminating more than \$5 billion annually in existing transportation funds.

TRIP is a Washington, D.C. based national transportation research organization that researches, evaluates and distributes economic and technical data on surface transportation issues. TRIP promotes transportation policies that help relieve traffic congestion and its impact on air quality, improve road and bridge conditions, make surface travel safer, and enhance economic productivity.
