Enclosed is the July 2017 Investment Report which shows the financial institutions, types of investment instruments, monthly transactions, current month interest received, and the par and fair market value of investments held. The month-end cash in the bank and petty cash balances are also listed on the Cash and Investment Report. The pie chart (please see chart on attachment A) reflects the investment instruments as a percentage of the total portfolio.

This investment portfolio meets State guidelines and adheres to the City's investment policy. As of July 2017, the City's total portfolio is invested in:

The cash with fiscal agents is restricted as they are funds held and invested by an outside fiscal agent. The restrictions were set forth in the related bond indentures. As of July 2017, 10.439% of the portfolio is restricted.

In summary, the investment portfolio is secured and the City has the necessary cash to pay its bis for six months in a timely manner. Please call me at extension #5060 if you have any questions.



# Garden Grove church provides land for affordable housing, community services

At the ribbon-cutting ceremony this month for the Wesley Village affordable housing complex in Garden Grove, Laura Archuleta couldn't resist referencing Joni Mitchell's 1970 environmental protest "Big Yellow Taxi."

Built on underused land that's part of the Garden Grove United Methodist Church campus on Main Street, Wesley Village offered Archuleta, president of the nonprofit community organization Jamboree Housing Corp., a chance to riff on one of Mitchell's most famous lyrics.

Where Mitchell sang "They paved

paradise/And put up a parking lot," Archuleta told about 300 people packed into the steamy church sanctuary on a hot afternoon that "Today we are going to learn how a group of dedicated organizations and individuals repurposed a parking lot and put up a paradise."

Then she and others who spoke, including a single mom with six children who now reside at Wesley Village, told how the project became reality through a unique collaboration that involved the church, Jamboree and other nonprofit groups, the city and government agencies, private financiers and ordinary people wanting to give someone in need a place to call home.

Those involved see Wesley Village as a model for similar projects in Orange County and other housingchallenged areas — and for longtime churches facing uncertain futures with congregations that become less vibrant as members grow older or move away.

"We had an aging congregation," said Sue Spangler, who has attended Garden Grove United Methodist since the late 1960s and heads the church council. "We felt that in the future we would need to have a plan for doing things differently. So this was part of that plan."

Under a 75-year ground lease with Jamboree, Garden Grove United Methodist received an advance payment of \$200,000 and will be paid \$50,000 annually for the next six years. After that six-year period, the church will share in the rent revenue — minus operating expenses for the property — with the city and Jamboree.

Along with an annual \$36,000 payment from Head Start for the space it uses, Wesley Village is set up to provide a reliable stream of revenue to the church.

The concept of using church land to host affordable housing is not new. Similar efforts have been undertaken by churches across the country in New York City, Portland, Oregon, and Baltimore, where the Schaefer Center for Public Policy at the University of Baltimore holds a sixmonth training course for faith-based organizations that want to develop affordable housing and community services.

One of the larger such projects is a recently approved \$3.5 million land deal between the city of Lafayette, Colorado, and a local church, calling for up to 500 affordable housing units with rents to be no more than 30 percent of household income. In the San Francisco Bay Area, one of the nation's most housingchallenged areas, city officials and an East Oakland church struck a deal earlier this year to build 59 affordable apartments for low-income residents. It is unclear how common a practice it is in Southern California.

While churches long have initiated social engagement for the poor that might include running soup kitchens, holding clothing drives or offering limited shelter to the downtrodden, Wesley Village may well represent the beginning of an emerging response to a growing need to address homelessness and the region's lack of affordable housing, said sociologist Richard Flory, senior director of research and evaluation at USC's Center for Religion and Civic Culture.

"I wouldn't be surprised if this kind of thing starts happening more," said Flory, whose recently deceased father was a pastor at small churches in Los Angeles and taught for decades at Biola University, the Evangelical faith-based institution in La Mirada.

But, he said, congregations considering a project like Wesley Village face challenges.

"Churches tend to want to sort of proselytize," Flory said of faith-based outreach that might focus more on spreading the faith and growing membership than serving the general needs of people in their communities. What's key is "getting them to figure out that if that stuff comes, great. But if not, they are still a presence in the community."

There's also government bureaucracy and neighborhood concerns to deal with: "The other side of it is always zoning and permit issues from the cities, and the neighbors don't tend to like it."

The multigenerational Wesley Village incorporates 47 apartment units — 31 for working families and 16 for senior citizens — and on-site services for its residents and the surrounding community from such organizations as Lestonnac Free Clinic, Alzheimer's Orange County, homeless services provider Project Hope Alliance and the local Boys & Girls Club.

The project, on 2.2 acres, includes a new home for a Head Start program that had rented space in the Sunday school building constructed decades ago but in need of repairs. The playground for the church's own preschool also was reconfigured.

Jamboree secured a mix of public and private funding for the \$18.9 million development.

Wesley Village is named after John Wesley, the 18th century Anglican cleric who, with his brother Charles, stirred the revival movement that led to the founding of Methodism. Residents began moving into the pair of three-story apartment buildings in July.

"To have a future possible income from it and not have to sell it and also to do something that would be of benefit to the community," Spangler said of the underused church property, "was a pretty good match."

### From flood to paradise

Tenants at Wesley Village earn from 50 percent

to 59 percent of the area's median family income and pay monthly rent for the one-, two- and threebedroom units that ranges from \$818 to \$1,338, based on family size and income. That is several hundred dollars below the average rent of \$1,799 landlords sought at the end of 2016 for a vacant apartment in Orange County. Huge demand and short supply has continued to propel the upward trend here and across Southern California in 2017, in some places hitting all-time high rents.

Jamboree got 626 applicants for the 47 units; the waiting list today is at 459.

For someone like Mersidaranny Yin, who works as a tempura fry cook at a nearby restaurant, and her six children, ages 24 to 15, Wesley Village truly is the paradise from Archuleta's frame of reference. At the Aug. 10 grand opening, Yin related the series of setbacks the family endured over the past two years before settling in at Wesley Village a few weeks ago.

Their story brought tears to the eyes of the people fanning themselves in the pews of the church. When Yin finished, many jumped from their seats to applaud.

Yin emigrated from Cambodia in 1981 at the age of 6, living with family in Louisiana and Orange County, where there is a sizable population of Cambodian refugees. Because of the cost of living here, Yin moved back to Louisiana with her children about six years ago. The family managed to get by on her \$2.25 an hour wage as a food server, living in a small town near the capital of Baton Rouge.

Catastrophic rainfall in August 2016 upended them. Yin recalled how one of her daughters asked, "Mommy are we going to die here?" as floodwater swallowed the vehicles in the streets. They lost their car and their apartment, staying with a friend until Yin saved enough for a new place. But during the move, someone burglarized what possessions they had left. That broke Yin's heart.

She drove her children back to Orange County, where they all packed into a living room they rented in Garden Grove. The Yins were desperate for better living

conditions. They weren't allowed to use the bathroom where they were staying and had to visit Target or Walmart to relieve themselves, Yin said. They got some help with social services and medical needs from her children's high school and the Boys & Girls Clubs of Garden Grove. But affording another place to live seemed impossible. Then Wesley Village rose before their eyes: In November, daughter Maryanna Kim, 18, walked past stakes in the ground for the construction of one of the apartment buildings on her way to the library. She told her mother she had found their new home.

Months later, their application nearly fell through because of a false eviction charge by their last landlord in Louisiana. Yin, 42, credits the diligence and patience of Patricia Huerta of FPI Management Inc., the property manager at Wesley Village, for helping straighten it all out.

The Yins got the last available unit — a threebedroom apartment on the third floor in the family building — when someone else canceled during construction delays. The family's excitement over moving in was tempered by the recent death of Yin's mother, but not their gratitude.

"Thank you for being an angel," Yin told Huerta as the two women hugged on the family's way back to their apartment after the grand-opening celebration.

They don't have much furniture yet, and they all share bedrooms. But they can make the rent, \$1,262, between Yin's job and her oldest daughter Cynthia Leang's position as a pharmacy technician. From her balcony, Yin can look into the courtyard below and see children romping on a play set or gaze across the tops of houses in the surrounding neighborhood, where trees and the steeple of another church nearby offer a placid skyscape.

She sweeps her arm across the view with a smile on her face as wide as her gesture.

"I never had this before."

# From an idea to reality

Jamboree has had multiple discussions before with other churches about dedicating unused property for affordable housing.

Such failed efforts date back to 2001: talks with Shepherd of the Hills in Laguna Niguel about building senior housing and with a Long Beach Methodist church regarding affordable family housing. Since 2012, other faith communities in Orange County that have approached Jamboree's business development team include Lutheran and Presbyterian congregations.

Typically the churches have been a presence in their respective communities for decades but are seeing membership decline. Their locations — near transit

lines, schools, and other amenities — can be ideal for housing.

Some want to sell their land at full market value, "which could mean affordable housing wouldn't be all that affordable," Archuleta said. Others inquire about restricting occupancy to church members, but use of public financing wouldn't allow such exclusivity.

The notion of an affordable housing project at Garden Grove United Methodist percolated about five years ago during an ad hoc brainstorming session on the future of the church.

The congregation has worshiped since 1880 in three different buildings on the same corner of Main Street and Stanford Avenue where its current distinctive sanctuary has stood since 1967.

But with a population that peaked at 1,500 in the mid-1950s and now numbers about 275, Garden Grove United Methodist faces the same uncertainty as many other mainline churches with aging congregations.

The church holds services for a more youthful Vietnamese- speaking membership and a longtime group of Samoan congregants, along with offering space to Korean-language and east Indian faith groups. But its core Caucasian membership is declining. The church didn't want to sell its land, said Spangler, the church council chair. Instead, its members embraced what she called a "wild idea."

They saw the answer in the vacant lot where neighborhood children sometimes kicked around a soccer ball or a local Boy Scouts troop held some outdoor activity — a forlorn area that Jim Spangler, chairman of the church board of trustees, described as dominated by mowed weeds — and in a parking lot on a distant corner of the church property, rarely used except by parents dropping off children at the Head Start.

Curt Pringle, a former two-term Anaheim mayor and state assemblyman whose parents still attend Garden Grove United Methodist, proposed the idea of hosting affordable housing at the church. Pringle runs a consulting firm that deals with land use, public relations and government affairs; Jamboree is a client of his firm, Curt Pringle & Associates.

The church approached Jamboree in 2013 and the "wild idea" took shape as pastoral leadership changed hands and plans moved through the city government process. There were delays, and concerns raised from the surrounding neighborhood over density, upkeep and just what "affordable housing" might look like.

At one community meeting, Spangler recalled, "a man stood up and said I don't want to live in the projects.' Well, these buildings are nice."


The church's community services over the years have included feeding the homeless, tutoring local schoolkids, and hosting Scout troops. It already had established relationships with groups like Alzheimer's Orange County, founding the Acacia Adult Day services that is now located nearby, and provided space a few days a week to the Lestonnac free health clinic for several years.

Affordable housing on the premises seemed like a logical next step.

"I was all excited about this right from the beginning," said a joyous June Stokoe, 71, who has attended Garden Grove United Methodist for four decades and met husband Charley there 33 years ago. Both came to the Wesley Village celebration.

With the model that the collaboration represents, Wesley Village has the chance to be transformative beyond its own boundaries, Archuleta told the people in the pews.

"If you didn't think you were changing lives before, you are now."

# **Background**

In March 2017, the Board heard public testimony on the South Coast Air Quality Management District's (SCAQMD's) Plan and CARB's Mobile Source Strategy for the State Implementation Plan (SIP). The Board adopted Resolutions 17-7 and 17-8, as well as an addendum that provided additional direction to staff, including:

Within 12 months, "...staff shall return to the Board with concepts for an indirect source rule to control pollution from large freight facilities including ports, railyards, warehouses, and distribution centers, as well as any identified alternatives capable of achieving similar levels of emission reductions..."

This process will involve stakeholder outreach, including formal workshops and informal meetings, to identify potential options for reducing emissions from freight facilities and to understand the relative pros and cons. CARB staff will present concepts to the Board in March 2018.

# Anaheim man gets 4 years in Garden Grove burglary spree

An Anaheim man was sentenced to more than four years in prison and his accomplice 90 days in jail for a burglary spree in Garden Grove that netted them at least \$150,000, according to court records obtained Monday.

In a plea deal struck with prosecutors Aug. 21, Julio Pachas, 45, was given four years and four months behind bars for multiple vehicle burglaries. He was given credit for 374 days behind bars, according to court records.

His girlfriend, Michella Fuquay, 24, also of Anaheim, was sentenced to home confinement or electronic monitoring and placed on probation for three years, according to court records. On Feb. 16, police served a search warrant at two places, one in Anaheim and the other in Garden Grove, according to Lt. Carl Whitney. The search warrants stemmed from multiple vehicle burglaries in Garden Grove and neighboring cities in Orange and Los Angeles counties, Whitney said.

Police allege Pachas targeted vehicles in parking lots of busy shopping centers and would rifle through them while the owners were shopping, Whitney said. In some cases, vehicle windows were smashed in, the lieutenant added.

Purses, wallets, luggage, computers, cell phones, and sunglasses were among the items taken, Whitney said.

Police also found a "garage full" of stolen loot in Fuquay and Pachas' residence, Whitney said. In 2013, the couple pleaded guilty to similar charges stemming from burglaries in Garden Grove, while Pachas also admitting having sex with an underage girl. Pachas was sentenced then to three years in Orange County jail for three counts of underage sex, four counts of second-degree burglary, a count of possession of a gun by a felon and a count of receiving stolen property, all felonies.

Fuquay pleaded guilty in 2013 to receiving stolen property and fraudulent use of a credit card, both misdemeanors, and was sentenced to 14 days in jail, 80 hours of community service and placed on three years of probation.

They were arrested in January 2013 following an investigation of vehicle burglaries in Garden Grove and neighboring cities, which dated back to two years earlier, police said. When police were led to Pachas' home they found "wall-to-wall stolen property," said police Lt. Jeff Nightengale. A public viewing of the stolen goods drew 200 people with 44 victims claiming 120 stolen items, Nightengale said.

Thanks to the \$76 million bond measure voters approved last year construction of a gymnasium and multi-purpose room at Stacey Middle School is now underway, with completion expected later in the school year.

Some of that money is also earmarked for adding air-conditioning to schools in the district, with Superintendent Cyndi Paik noting in her back-to-school press release that the district is currently conducting "an internal heat survey" at every campus in the district.

It's good to have data. but alas, it's all too easy this week to figure out what the survey is going to show: It's hot, hot, hot, so good luck students, teachers, and everyone else on campus until this late-summer heat wave breaks.

# Garden Grove district to offer Vietnamese immersion program

The program aims to strengthen cultural ties

Garden Grove Unified School District will be the second in Orange County to offer a Vietnamese dual language immersion program, when the school year starts today.

"We want students to be bilingual, bicultural and biliterate," said Sara Wescott, the district's assistant superintendent of elementary education.

Students in the pre-kindergarten program will be taught a half-day in English and the other half in Vietnamese. The program is meant to strengthen students' ties to the Vietnamese culture. It's arrival comes after a yearslong lobbying effort from members of the Vietnamese community who have said the program also would increase students' cognitive ability.

cient in the diversity of our community," said Luisa Rogers, the district's director of English-learner programs.

Wescott estimates that 25 to 50 transitional kindergarten students - those who turn 5 between Saturday and Dec. 2 — at John Murdy Elementary School will be enrolled.

The program aims to align its Vietnamese instruction with its English education, creating a comparable track, said Natalie Tran, director of the National Resource Center for Asian Languages at Cal State Fullerton who has been helping the district develop the curriculum.

Tran said the center has gathered resources from the Vietnamese community and produced children's books, which Wescott said have been reviewed by community members.

Rogers said she hopes poetry, songs, literature, visual arts and family events will enhance the students' understanding of the Vietnamese culture.

"We want students to be profi- munity started lobbying for a program in 2013, with then-GGUSD trustee Bao Nguyen's petition gathering more than 1,200 signatures. The petition sought to create the county's and the state's first Vietnamese dual immersion program by fall 2014.

Wescott said the district started conducting its feasibility study for such a program in 2013, but began' its work in earnest by the 2015 16 school year. California Association for Bilingual Education recommended that the district first build a Spanish dual immersion program. The district did so in fall 2016 through Monroe Elementary Language Academy, which Wescott said now has about 300 students.

Meanwhile, in fall 2015, Westminster School District's DeMille Elementary School started a Vietnamese dual immersion program, which now has more than 150 students, said district spokeswoman Trish Montgomery.

Wescott said GGUSD is planning to expand its Vietnamese immersion program for kindergarten stu<sup>33</sup> dents next year.

# City leaders vote to regulate parking

Recreation vehicles will be required to have city-issued permits

In response to community concerns regarding public safety, neighborhood aesthetics, and curbing the parking of non-Garden Grove recreational vehicles on residential streets, the Garden Grove City Council has approved an ordinance that will require recreational vehicles parked on public and private streets to have a valid city-issued permit, at no cost.

The ordinance takes effect in late September, 2017.

Pay attention, because there are strict rules.

And strict fines who those who don't follow the law.

Under the new ordinance, residents may request up to 12 non-consecutive, 72-hour recreational vehicle parking permits for the sole purpose of loading or unloading before and after travel. Residents will be able to request both loading and unloading permits at the same time.

# GG, WM representatives outline plans for future

Alan Lowenthal, Janet Nguyen attend Legislative Networking Mixer

Elected officials from West Orange County cities — including from Westminster and Garden Grove — gathered to meet with the public on Aug. 25 at the Cypress Senior Center for the annual Legislative Networking Mixer. Representatives from local, state and federal offices shared their updates and answered questions.

Congressman Alan Lowenthal, 47th District, which represents Westminster, Garden Grove and surrounding areas, shared updates on water recycling, the Joint Forces Training Base, veterans and homelessness. Additionally, he announced that his new office is opening on Main Street in Garden Grove.

"I am on the Transportation and Infrastructure Committee," said Lowenthal, who went on to discuss the expansion of the 405 Freeway. "A \$630 million TIFIA loan was signed in late June. When the work is completed, it will improve the national freight network and access to ports."

The Department of Transportation loan provides up to \$628 million in a Transportation Infrastructure Finance and Innovation Act (TI-FIA) loan to the Orange County Transportation Authority (OCTA) at 2.91 percent with a term of 35 years after substantial completion of the I-405 Improvement Project. The TIFIA loan represents 33 percent of eligible project costs totaling \$1.91 billion.

Regarding water, Lowenthal touted the current success and future plans for the Orange County Water

District's water recycling program. He said the \$124 million loan in the 2017/2018 budget for the district is one of only 12 projects selected, and it will allow the water agency to expand water recycling from 100 million gallons/day to 130 million per day.

"Orange County is the nation's model on water recycling," said Lowenthal. "Thanks to water recycling, Orange County is almost self-sufficient and should be in a good position when there are future droughts. Orange County is always looking to the future."

Lowenthal announced the renaming of the Long Beach Veterans Affairs Hospital. It is now named for an Orange County hero and Medal of Honor recipient, Tibor Rubin. In May of 2017, the facility was renamed Tibor Rubin VA Medical Center.

Lowenthal's other areas of local interest are the Prado Dam embankment work and the problem of homeless people living on the Santa Ana River Trail.

"Residents are concerned about the Prado Dam, fixing the Santa Ana River and flood basin," said Lowenthal. Concerns for the growing homeless problem are the subject of discussion at all levels of government. No easy solution has been found, but many agencies are working on it.

His final topic was a happy one. He was one of the people present for a recent event for Pastor Nguyen Cong Chinh who, as a Lutheran minister, had been arrested by the government in Vietnam. Pastor Chinh was sentenced to 11 years.

"I adopted Pastor Chinh as a personal project to help him get back to the U.S.," said Lowenthal. "There was a big reception in Westminster, and Mayor Tri Ta, Bishop Van Tran and others were at the event at the Lutheran Church... The people of Orange County feel that they want people to have human rights and religious rights in Vietnam."

In addition to Lowenthal, local State Senator Janet Nguyen, 34th District, was present for a short time, but had to leave early for another event, and did not have the opportunity to speak before the audience of 100 people.

Other officials included Congressman Lou Correa, 46th District, Assemblywoman Sharon Quirk-Silva, 65th District, and Colin Edwards, an aide from Assemblyman Travis Allen's 72nd District office.

Representatives from the cities and chambers of commerce in Westminster, Stanton, Cypress, Los Alamitos, Seal Beach and Rossmoor, along with representatives of the Legislative Affairs Committee of West Orange County, were present.





#### **ORDINANCE NO. 2885**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GARDEN GROVE ADDING SECTION 10.56.115 TO CHAPTER 10.56 OF TITLE 10 OF THE GARDEN GROVE MUNICIPAL CODE RELATING TO RECREATIONAL VEHICLE PARKING RESTRICTIONS

City Attorney Summary
This Ordinance establishes parking restrictions applicable to recreational vehicles.

WHEREAS, the parking of recreational vehicles on rights-of-way raise a number of public safety concerns, including the obstruction of access to roadways during emergency response, reduction of visibility at intersections, increased opportunities for vehicular thefts and the creation of unsafe environments for persons dwelling within and around them; and

WHEREAS, the City would like to mitigate the public safety concerns associated with the parking of recreational vehicles on the City's rights-of-way.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GARDEN GROVE HEREBY ORDAINS AS

SECTION 1: Section 10.56.115 is hereby added to Chapter 10.56 of Title 10 of the Garden Grove Municipal Code to read as follows:

Section 10.56.115 Recreational Vehicle Parking

A. No person shall park and leave standing on any public or private street, alley or public property any recreational vehicle, except pursuant to a permit issued by the City Manager or his/her designee as provided for in this section. For purposes of this section a "recreational vehicle" means a vehicle for the conveyance and/or shelter of persons or goods for purposes of leisure-time activities, including a motor home, travel trailer, van, truck camper, camping trailer, boat, or off-the-road vehicle.

B. The City Manager or his/her designee may is-

B. The City Manager or his/her designee may issue 72-hour recreational vehicle parking permits to City residents for the sole purpose of loading and unloading before and after travel, and not to exceed 12 non-consecutive permits in any calendar year per residential address. The permit shall only allow the parking of a recreational vehicle in front of the address of the resident applying for the permit with at least one day in between applying for the permit, with at least one day in between each of the 12 permits allowed per calendar year per address. No more than one permit per address shall be

dress. No more than one permit per address shall be issued at any given time.

C. The City Manager or his/her designee may issue weekly recreational vehicle parking permits not to exceed 7 days per permit to City residents, and not to exceed 6 non-consecutive permits in any calendar year per residential address. The permit shall only allow the parking of a recreational vehicle in front of the address of the resident applying for the permit, with at least one day in between each of the 6 permits allowed per calendar year per address. No more than one permit per address shall be issued at any given time.

D. The City Manager or his/her designee shall have the authority to promulgate administrative regulations and an application process for the issuance of per-

tions and an application process for the issuance of permits authorized by this section.

The City Council may, by resolution, establish

fees to defray the costs of processing permits.

SECTION 2: If any section, subsection, subdivision, sentence, clause, phrase, word, or portion of this Ordinance is, for any reason, held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance and each section, subsection, subdivision, sentence, clause, phrase, word, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, words or portions thereof be declared invalid or unconstitutional.

SECTION 3: The Mayor shall sign and the City Clerk shall certify to the passage and adoption of this Ordinance and shall cause the same, or the summary thereof. to be published and posted pursuant to the provisions of law and this Ordinance shall take effect thirty (30) days after adoption.

The foregoing Ordinance was passed by the City Council of the City of Garden Grove on the 22nd day of August 2017.



# Growing homeless population in Garden Grove has led to increased frustration among Korean business owners



Paul Brady is "home-free," not homeless.

"You can live on the street and be happy," said Brady, 26, after riding his bike in the abandoned Garden Grove Galleria in Little Seoul, the city's Korean business district.

Brady, a construction worker, said his mother has a home nearby, but that he's not comfortable living with her and that the house — a group home — is packed with others seeking help. Brady is a part of Garden Grove's growing homeless population — police estimate that about 300 transients live in the city — many of whom have flowed into Little Seoul.

Korean business owners and community leaders said the rising number of homeless people has created a problem for the district, including a rise in vandalism and property crimes. According to the city police crime map, between January and August, 2017, vandalism increased by 50 percent and other property crimes — such as burglary and theft — rose by 45 percent over the same period last year.

"They are not only roaming around the district but also sleeping and living in alleys and corners," said Wendy Yoo, president of the Orange County Korean American Health Information and Education Center, when she and other Korean community leaders met with city officials in Juné.

Brady served jail time for residential burglary, but he wants people to understand that those who are homeless, or "home-free," are not necessarily troublemakers.

"When you are homeless, it just depends on your morals as a person," Brady said. "Even as a knuckleheaded person, I am learning."

### Growing homeless population

Little Seoul, a 2-mile stretch of Garden Grove Boulevard between Beach Boulevard and Brookhurst Street, is filled with Korean restaurants and shops, attracting Koreans and non-Koreans day and night.

But police officers, community leaders and homeless people said the district's unlit alleyways, stretches of hidden parking lots and abandoned buildings such as the Garden Grove Galleria provide plenty of places to sleep relatively hidden.

Dana Youlin and Jennifer Pifher often sleep in parking garages around the district, waiting until Youlin starts receiving a \$1,700 monthly social security check.

Youlin said he had to quit his nearly three-decade job as a building manager because of a heart ailment and back injuries. He emptied his 401k and sold his truck, but could not afford to stay off the street. He struggles to bike to a nearby hospital where he receives treatment, he said.

"I don't like to be here," Youlin said. "(But) things kept coming."

Daryl Hoffman has often slept in the back of the industrial parks around the

intersection of Beach and Garden Grove boulevards.

Hoffman became homeless after suffering seizures and getting laid off from a Walmart in Westminster, he said. He is biding his time, he said, until his body fully recovers.

"I gotta go back 100 percent;" he said.

Éric Ortiz, 23, said he has been homeless since he was 13, when his parents abandoned him. He moved recently to Garden Grove from Santa Ana, following a homeless acquaintance.

He said he often panhandles and asks for food in the district. He also finds abandoned cars — in and around the district — where he can sleep. But he said he wants to get a construction job and get off the street that he called home for a decade.

"I am not letting go," he said.

### Frustrated business, community leaders

Min Sook Cho, who manages a Korean restaurant in the district, said she is often busy sweeping her storefront in the morning to deal with the litter that accumulates overnight.

About a month ago, Cho said, her restaurant's donation jar was stolen while she was working the counter.

"I had my eyes open but still got my nose chopped," she said, using a Korean idiom

Joseph Kim, director of the Korean Social Ministry of Orange County in St. Anselm of Canterbury Episcopal Church of Garden Grove, said the church had to reduce how often it donated food to those who are homeless.

"They needed to follow some semblance of a rule," Kim said.

Korean business owners and community leaders said they understand that the growing homeless population is a complex regional, not local, issue. Many also said they are learning to live and work together with the homeless population.

But they are also frustrated, saying they think

some of the homeless population find shelter and commit vandalism on their private properties.

Yoo said she thinks the city isn't taking the problem seriously.

"Who is going to take care of it if the city doesn't?" she said.

### Lack of reporting

Cultural and language barriers have complicated the issue in Little Seoul

"The Korean population doesn't tend to talk," You said.

The retirement of longtime Korean community liaison Yoo Tae-Kyung in 2015 left a year-long gap in that role. This led to greater reluctance among Korean business owners and stan to report to the police what they see as problems caused by the homeless population

"They think, 'It's going to be bothersome. There's no use,' "said Sharon Baek, the newly hired Korean community liaison for the police department.

Back said when business owners and staff do report, they often don't file the necessary paperwork that would allow the police to act.

"Rarely you have someone sign the paperwork," Baek said.

Back is reaching out to members of the Korean community, urging them to call the police whenever they have a problem. She said most calls she has gotten have been taken care of by the police.

"If I can help you, I will try it for you," Baek said.

Meanwhile, Officer Brian Hatfield, who heads the homeless outreach team for the Garden Grove Police Department, urged business owners to secure their businesses and add lighting to the surrounding area. He also encouraged businesses to redirect those who are homeless in support services.

Hatfield said he wants the community to understand there are limitations on the actions that the police can take.

"We can't tell the homless to go away," Hatfield said. "Simply existing is not a crime." Register Aug. 27, 2017 3 of 3



Để đáp ứng mối quan tâm của cộng đồng về an toàn công cộng và mỹ quan khu phố, Hội đồng Thành phố Garden Grove đã phê duyệt một quy định đòi hỏi các xe giải trí (xe RV) đậu trên các đường phố công cộng và tư nhân phái có giấy phép thành phố cấp, hoàn toàn miễn phí. Pháp lệnh có hiệu lực vào cuối tháng 9 năm 2017.

Theo quy định mới, cư dân có thể yêu cầu 12 giấy phép đậu xe không liên tiếp trong 72 giờ với mục đích duy nhất là sắp xép đồ đạc (loading/unloading) trước và sau chuyển đi. Cư dân có thể yêu cầu cả giấy phép loading và unloading cùng một lúc.

Cư dân nếu cần đậu xe RV lâu hơn có thể xin giấy phép đậu xe hàng tuần không quá bảy ngày cho mỗi giấy phép. Không được xin trên sáu giấy phép hàng tuần cho mỗi địa chỉ nhà ở mỗi năm, với lì nhất nghĩ một ngày giữa sáu giấy phép.

Một giấy phép hợp lệ sẽ chỉ cho phép các xe RV đậu trước địa chỉ của người cư trú nộp đơn xin giấy phép. Quy định sẽ không ảnh hưởng đến tài sản cá nhân.

Thành phố đang phát triển một hệ thống tự động để sắp xếp quá trình xin giấy phép. Hệ thống sẽ có trên trang web của Thành phố, tại www.garden-grove.org, vào cuối tháng 9 năm 2017. Từ bây giờ đến thời điểm cuối tháng Chín, Thành phố sẽ không phạt những xe RV đậu trên đường phố công cộng và tư nhân.



### Little Saigon sắp có khu thương mại xây bằng vỏ thùng 'container'

**GARDEN GROVE, California (NV)** – Garden Grove, một trong những thành phố vùng Little Saigon, sắp có khu thương mại đặc trưng, dùng vật liệu xây dựng là vỏ thùng thép 'container,' trên lô đất rộng 1.86 mẫu, nơi từng là địa điểm nhà hàng Black Angus, chuyên món thịt bò steak nổi tiếng, hoạt động từ năm 1988 đến 2005, ở thành phố này.

"SteelCraft Garden Grove là một dự án đầy sáng kiến, đặc biệt với các nhà hàng nổi tiếng và các dịch vụ phục vụ đời sống cư dân, đồng thời sẽ đem lại nguồn lợi tức giúp cho kinh tế thành phố Garden Grove," ông Phát Bùi, phó thị trưởng Garden Grove, nói với nhật báo Người Việt, sau buổi họp cộng đồng của thành phố cùng với công ty SteelCraft vào tối Thứ Hai, 21 Tháng Tám vừa qua.

"Dù được ủng hộ, hiện nay dự án trị giá trên \$5 triệu này vẫn còn trong thời gian thiết kế và thu thập phản ứng của cộng đồng," cô Jennifer Lê, giám đốc tiếp thị và phát triển công ty Howard CDM, nói với nhật báo Người Việt.

"Chúng tôi chưa nhận được đơn xin giấy phép xây dựng," cô Mary Medrano, nhân viên ban thiết kế thành phố, xác nhận với nhật báo Người Việt.











MATTERS FROM COMMISSIONERS: Vice Chair Brietigam stated that the City was possibly looking into hiring six police officers and one sergeant, however, because of the great need for officers due to the homeless out of prison and more criminal

activity in general, he challenged the Garden Grove City Council and staff to increase the number of officers to 200 by the year 2020.

Chair Kanzler agreed and commented that the City should also have more community programs to give criminals something to do other than commit crimes. Kanzler then asked staff if there were strategies for a walkable connection from Main Street to the Cottage Industries area. Staff responded that the parking lots near Main Street were controlled by the schools; that Main Street's street parking supported the businesses and included the parking lot near Bar Code and the large lot on Grove Avenue; that the lot across from Doug's Downtown Grill was a private lot that the City used to rent; that connecting the two sides of Euclid Street for the downtown area was the biggest problem; and that the Steelcraft developer would also like to see a connection with Main Street as the project would be centered between the Cottage Industries and Main Street areas.

MATTERS FROM STAFF: Staff noted that the July 20<sup>th</sup> meeting would be cancelled and gave a brief description of agenda items for the August 3<sup>rd</sup> meeting.

This program provides a variety of public agencies and developers access to low-cost, tax-exempt financing and economic development tools. CSCDA recently issued a total of \$12,250,000 in tax-exempt multi-family affordable housing bonds for Meadows Court/Holly Lane Apartments in Vacaville.

### **About Meadows Court/Holly Lane Apartments**

Meadows Court/Holly Lane Apartments is the acquisition and rehabilitation of 82 multi-family affordable housing apartments by Meadows Holly Partners, L.P. Community Development Partners (CDP) is the project sponsor. The project will continue to be 100 percent affordable and provide apartments to low-income residents in Vacaville.

CSCDA and CDP partnered with Citibank and Orrick, Herrington & Sutcliffe, LLP to provide the \$12,250,000 in tax-exempt multi-family affordable housing bonds for the project. It will undergo an extensive interior and exterior renovation ensuring that residents have an updated, safe, and affordable community to call home for years to come. The financing will maintain the affordability of units for low-income tenants for 55 years.

# Understanding "Bowenwork" When Regulating Massage

Over the past several years, significant changes have occurred in massage regulation and local officials have faced challenges keeping up with the laws and understanding the various massage-related disciplines. <u>BowenUSA</u>, a small bodywork association representing Bowenwork practitioners, recently approached the League of California Cities® to provide background information for local officials on "Bowenwork" and explain why they believe that their businesses should be regulated differently than massage practitioners by cities and counties.

#### **Certification Process for Bowenwork Practitioners**

Practitioners of Bowenwork maintain that their bodywork modality is fundamentally different from massage and, therefore, should not be regulated by cities and counties in the same manner.

The American Bowen Academy (ABA) certifies Bowenwork practitioners, who must complete 340 hours of training in order to become certified, including 212 hours in the theory and practice of Bowenwork, 100 hours of anatomy and physiology, 24 hours of business and ethics and 4 hours CPR certification. Once certified, Bowenwork practitioners are required to complete 32 hours of continuing education units every two years to maintain professional registration with ABA.

Bowenwork can be defined as a gentle, relaxation technique that uses minimal touch over specific and targeted parts of the body in order to reset the autonomic nervous system and promote the body's innate healing systems. In Bowenwork, the movements are minimal and the practitioner's contact on the client's body lasts a few seconds, followed by several hands-off rest periods ranging from two to four minutes, or longer. The work is performed on fully clothed clients and no heat, oils or lotions are applied to the body. Bowenwork sessions can be, and have been done in public.

The Oregon and New Hampshire legislatures have exempted Bowenwork practitioners from state massage licensing requirements. In Colorado, Arizona and Texas, non-massage therapists may practice their bodywork technique if trained by a recognized training organization that monitors and manages any complaints about a practitioner's professional conduct.

Representatives of ABA, maintain that, to date, the Academy has never had any complaints nor cases of practitioners involved in human-trafficking, prostitution, or otherwise causing public harm.

#### Most Bowenwork Practitioners do not have CAMTC Certificates

Since Bowenwork practitioners have their own certification process, most do not also pursue a separate voluntary certification from California Massage Therapy Council (CAMTC), because they prefer to practice Bowenwork rather than massage.

## **Local Regulation of Bowenwork**

Challenges have occurred for Bowenwork practitioners when some local agencies require them to present CAMTC certification. Representatives of ABA maintain that CAMTC does not recognize Bowenwork training (as described above) as "massage" training. This has led to some Bowenwork certified practitioners needing to spend thousands of additional dollars enrolling in CAMTC-approved massage schools in order to become CAMTC certified, despite the fact that they do not intend to practice massage.

BowenUSA representatives share that Bowenwork practitioners are willing to obtain a local business license as well as present Bowenwork certification from ABA. They have no issues with regulatory oversight from municipalities that might extend beyond what is permissible to impose on massage therapists licensed by CAMTC. This could include provisional business licenses, enhanced background checks, site visits, etc. BowenUSA practitioners are willing to comply with this level of regulation if it means they are able to practice this modality unhindered.

BowenUSA representatives encourage cities to learn more about Bowenwork from the <u>American Bowen Academy</u> and other resources on this modality, and consider licensing Bowenwork practitioners separately from CAMTC-certified and other massage therapists.

# Guest Piece: Vetting the Public Finance Team, Has Your Municipal Advisor Passed the Test?

When managing their personal finances, many people turn to financial advisors to help them make informed decisions about complex financial products and investment options. For state and local government officials responsible for managing the public's finances, specialized financial advisors called municipal advisors may be hired to provide advice regarding the issuance of municipal bonds or use of municipal financial products.

If a municipal advisor is part of your public finance team, you should know that the Municipal Securities Rulemaking Board (MSRB) — the national regulator responsible for protecting the public interest by promoting a fair and efficient municipal securities market — has established baseline standards of professional qualification for municipal advisors. Municipal advisors must pass the MSRB's Municipal Advisor Representative Qualification Examination, or Series 50 exam, no later than Sept. 12 to continue engaging in municipal advisor activities.

If you are currently working with a municipal advisor or planning to start a new engagement, it would be prudent to confirm that the municipal advisor has passed the Series 50 exam or is planning to do so by the Sept. 12 deadline. Municipal advisors were granted a grace period of one full year from the launch of the exam on Sept. 12, 2016 to prepare for and pass the exam. Yet with less than one month remaining until the deadline, more than 100 municipal advisor firms registered with MSRB did not have at least one person qualified with the Series 50 exam or enrolled to take the exam.

<u>Find the names of individuals who have passed the Series 50 exam on the MSRB's website</u>. It is in your constituents' best interest to make sure that all members of your public finance team are duly qualified in accordance with federal regulations. Doing this due diligence can help avoid a disruption in the municipal advisory services you receive, including preventing a negative impact to the bond issuance process.

MSRB creates and maintains rules for municipal advisors and municipal securities dealers that underwrite and trade municipal bonds. The Series 50 exam is one element of a comprehensive regulatory framework for municipal advisors that includes rules addressing core duties to clients, disclosures and conflicts of interest. Access more information about what to expect from your municipal advisor and how to research the background of your municipal finance professionals on the MSRB's website.

# Local Elected Leaders, Business Leaders and Community Groups Unite in Long Beach to Stop the Big Telecom Power Grab

Leaders from Long Beach, Cities in Los Angeles County and Others Urge Lawmakers to Reject SB 649

Long Beach Council Member Al Austin and representatives from the Downtown Long Beach Alliance, the Belmont Heights Community Association and the American Public Works Association of Southern California today urged the Legislature to reject SB 649 (Hueso). Opposed by more than 215 cities and dozens of counties, this legislation would virtually eliminate cities and counties' authority to negotiate with telecommunications companies on the siting of wireless equipment in the public right of way and on public infrastructure. SB 649 would also cap the lease rates far below market rate, on public infrastructure. The group held a press conference this morning in Long Beach at Pierpoint Landing. For more, see Page 2.

Cities support advances in technology, unique and diverse neighborhoods, businesses and closing the digital divide. Cities also have the authority to work with telecommunication companies to advance modern technology through an established discretionary permitting process, and many are doing so. Cities are responsible for updating local zoning codes to reflect land use changes, based on the evolution of local neighborhoods and residents' needs. Discretionary control of local land use decisions is critical to preserving and supporting the unique identities of California's diverse communities. The bill has widespread opposition because it erodes local land use control, and subsidizes the telecommunications industry at the expense of local neighborhoods.

SB 649 would give the wireless giants virtually limitless ability to install antennas, wireless boosters, and other equipment. The bill would shortchange taxpayers by capping lease rates of public infrastructure statewide. Meanwhile, Californians would still pay the same high prices for their wireless services.

Each of the speakers urged the Legislature to listen to the opposition and reject SB 649.

Long Beach Council Member Al Austin: "SB 649 would nearly eliminate Long Beach's, and every other local government's ability to manage the way in which telecommunications equipment is deployed in neighborhoods and around businesses, just so the telecommunications industry can have their equipment permitted more rapidly throughout California," said Council Member Al Austin. "Our unequivocal opposition to SB 649 is 100 percent consistent with our support for diverse communities, well designed urban spaces, and modern technologies."

Austin Metoyer, a policy and research manager with the Downtown Long Beach Alliance raised concerns on the legislation's impact: "The Downtown Long Beach community has spent over two decades working with the city to redevelop the area into the vibrant destination it has become. Our community is includes tourist attractions, such as hotels, restaurants and entertainment venues and a wide range of businesses and industry. We have worked hard to transform this area and our efforts have created a unique asset to Long Beach. SB 649 would leave communities like ours, and the elected officials who represent us, without any ability to determine how wireless technology equipment is integrated into our public infrastructure.

"We support new technology, increased bandwidth and connectivity — these are key building blocks of successful businesses. However, we must also recognize local land use decisions, such as design standards of infrastructure in the public right-of-way, on street lights, or hanging off of, or rather not hanging off of telephone wires, is equally key to the success of businesses."

Sydney Simon, Belmont Height Community Association board member, says that this bill is a "giveaway" to the telecommunications industry at the expense of Long Beach residents. "If this bill passes, we could potentially see cell antennas and associated equipment of up to 21 cubic feet on our utility poles."

James Biery, legislative chair of the American Public Works Association of Southern California, spoke about the impact this equipment would have on municipal infrastructure.
