OBJECTIVE

To report on the performance rating for the Garden Grove Housing Authority.

BACKGROUND

The SEMAP (Section 8 Management Assessment Program) Certification represents the Housing Authority's performance for the fiscal year 2015-2016. Garden Grove Sales Tax *Update*

Third Quarter Receipts for Second Quarter Sales (April - June 2016)

Garden Grove In Brief


Garden Grove's receipts from April through June sales increased 5.9% compared to the same quarter of 2015. Actual sales activity reported by the City's retailers slipped 1.8% when accounting aberrations were excluded.

A multi-year adjustment that hiked the allocation from the county use tax pool was the primary reason for the difference between cash receipts and actual sales. Accounting events that affected one or both periods exaggerated the impact of lower fuel prices on service station returns and depressed comparisons for petroleum products/equipment. An adjustment pared current quarter postings from auto leases while a shift to pool reporting hurt light industrial/ printer receipts. A onetime year-ago use tax allocation and lower sales cut business and industry group comparisons.

A recent addition, combined with the reclassification of an eatery from casual dining, boosted hotel/liquor returns. Sales increased from grocery stores and the building and construction sector. Receipt of taxes due from prior periods masked a 1.2% decline in sales of consumer goods due, in part, to a business closeout.

Adjusted for anomalies, taxable sales for all of Orange County grew 1.0% over the same period; the Southern California region as a whole was up 1.6%.

Statewide local sales and use tax receipts were up 1.9% over last year's spring quarter after adjusting for payment aberrations.

The largest gains were for building supplies, restaurants, utility/energy projects and countywide use tax pool allocations. Tax revenues from general consumer goods and business investment categories rose slightly while auto sales leveled off.

Interest In Tax Reform Grows

With modest growth in sales and use taxes, agencies are increasingly reliant on local transaction tax initiatives to cover growing infrastructure and employee retirement costs. As of October 1, there are 210 active add-on tax districts with dozens more proposed for the upcoming November and April ballots.

The Bradley-Burns 1% local sales tax structure has not kept pace with social and economic changes occurring since the tax was first implemented in 1933. Technology and globalization are reducing the cost of goods while spending is shifting away from taxable merchandise to non-taxed experiences, social networking and services. Growing outlays for housing and health care are also cutting family resources available for discretionary spending. Tax-exempt digital downloads and a growing list of legislative exemptions have compounded the problem.

California has the nation's highest sales tax rate, reaching 10% in some jurisdictions. This rate, however, is applied to the smallest basket of taxable goods. A basic principle of sound tax policy is to have the lowest rate applied to the broadest possible basket of goods. California's opposite approach leads to revenue volatility and causes the state and local governments to be more vulnerable to economic downturns.

The State Controller, several legislators and some newspaper editorials have suggested a fresh look at the state's tax structure and a few ideas for reform have been proposed, including:

Expand the Base / Lower the Rate:

Eliminate much of the \$11.5 billion in exemptions adopted since the tax was first implemented and expand the base to include the digital goods and services commonly taxed in other states. This would allow a lower, less regressive tax that is more competitive nationally and would expand local options for economic development.

Allocate to Place of Consumption:


Converting to destination sourcing, already in use in the state's transactions and use tax districts, would maintain the allocation of local sales tax to the jurisdiction where stores, restaurants and other carryout businesses are located, but return the tax for online and catalog sales to the jurisdiction of the buyer that paid the tax. One outcome of this proposal would be the redirection of tax revenues to local agencies that are currently being shared with business owners and corporations as an inducement to move order desks to their jurisdictions.

Tax reform will not be easy. However, failing to reach agreement on a simpler, less regressive tax structure that adapts this century's economy could make California a long-term "loser" in competing with states with lower overall tax rates.


The attached figures show the recent trend of water consumption in Orange County (OC), an estimate of Tier 2 volume for MWDOC, and selected water supply information.

- Fig. 1 OC Water Usage, Monthly by Supply OCWD Groundwater water was the main supply in August.
- Fig. 2 OC Water Usage, Monthly, Comparison to Previous Years Water usage in August 2016 was low compared to the last 5 years with the exception of August 2015. Lower usage is primarily due to strong conservation efforts and mandatory restrictions set by the Governor for the period of June 2015 to May 2016. In June 2016 all water conservation became voluntary for MWDOC agencies.
- Fig. 3 Historical OC Water Consumption OC water consumption is projected to be 519,000 AF in FY 2016-17 (this includes ~15 TAF of agricultural usage and non-retail water agency usage). This is about 20,000 AF more than FY 2015-16 and is about 53,000 AF less than FY 2014-15. Water usage per person is projected to be slightly higher than in FY 2015-16 for Orange County at 145 gallons per day (This includes recycled water). Although OC population has increased 20% over the past two decades, water usage has not increased, on average. A long-term decrease in per-capita water usage is attributed mostly to Water Use Efficiency (water conservation) efforts.
- Fig. 4 MWDOC "Firm" Water Purchases, 2016 "Firm" water above the Tier 1 limit will be charged at the higher Tier 2 rate. Our current projection of Tier 2 purchases is zero in 2016.

<u>Water Supply Information</u> Includes data on: Rainfall in OC; the OCWD Basin overdraft; Northern California and Colorado River Basin hydrologic data; the State Water Project (SWP) Allocation, and regional storage volumes. The data has implications for the

magnitude of supplies from the three watersheds that are the principal sources of water for OC. Note that a hydrologic year is Oct. 1st through Sept. 30th.


- Orange County's accumulated rainfall through September was well below average
 for this period. This continues the impact of the previous four hydrologic years'
 below-normal rainfall in reducing those local supplies that are derived from local
 runoff. El Nino conditions have diminished and NOAA has shifted its prediction from
 La Nina to a greater chance of neutral conditions for the 2016-17 winter (La Nina is
 generally associated with cool dry winters in Southern California).
- Northern California accumulated precipitation in September was around 115% of normal for this period. The Northern California snowpack is 97% of normal as of April 1st. This follows three below-average hydrologic years. The State of California has been in a declared Drought Emergency since January 2014. The State Water Project Contractors Table A Allocation is at 60% as of the end of June.
- Colorado River Basin accumulated precipitation in September was 96% average for this period. The Upper Colorado Basin snowpack was 85% of normal as of April 15th. This follows two below-average hydrologic years, the Colorado River Basin is in the recovery of a long term drought. Lake Mead and Lake Powell combined have about 61% of their average storage volume for this time of year. If Lake Mead's level falls below a "trigger" limit 1,075 ft. at the end of a calendar year, then a shortage will be declared by the US Bureau of Reclamation (USBR), impacting Colorado River water deliveries for the Lower Basin states. As of late September Lake Mead levels were hovering right at the "trigger" limit but fortunately levels are expecting to increase due to water releases schedule at Lake Powell. The USBR predicts that the "trigger" level will not be hit by the end of 2016.


Accumulated Precipitation



Greyhound rescue Hemopet in Garden Grove fights to stay open after receiving a \$82,000 state tax bill.

GARDEN GROVE • One way California pays the bills is by taxing dog blood.

And officials at Hemopet, a Garden Grove nonprofit known as the Red Cross for canine blood, say that is financially troublesome.

Hemopet, which rescues greyhounds from racetracks and adopts them out after drawing their blood to help all sorts of dogs, owes \$82,000 in back taxes to the state. And the group estimates it is looking at an annual \$30,000 tax bill going forward.

Founded in 1986, Hemopet rescues dogs and supplies about 40 percent of the nation's canine blood. Selling the blood covers the bulk of the bills, with donations filling the gap.

Now the nonprofit has to also cover the sales tax annually, after Gov. Jerry Brown recently vetoed a bill that would have exempted it from collecting and passing along the tax when selling its blood to veterinary hospitals. The news shook Hemopet's leaders.

"Closure of Hemopet will unquestionably result in suffering and even death of thousands of animals, an inadequate supply of life-saving canine blood for veterinary patients, and harm and hardship to pet owners," Jean Dodds, the

founder of Hemopet, wrote to an assemblyman in July when the bill was working its way through the Legislature.

Hemopet saves greyhounds, the famous speedsters, from often-brutal racetrack conditions that can leave them lame and cast off when they stop winning; some once were even put down after they stopped winning. Dog racing is legal in seven states, including Florida, Oklahoma and Texas.

Housed in the Orange County Sheriff's Department's former training facility on Salinaz Avenue in Garden Grove, Hemopet has veterinarians on staff. The organization mends greyhounds' broken legs, helps heal their infected wounds, removes rotten teeth and teaches them to live as family pets.

Once healed, the dogs donate blood twice a month, blood that other dog breeds can use. The greyhounds, which number about 220 at any given time, stay at Hemopet for 12 to 18 months before being put up for adoption. About 120 get new homes each year.

"Veterinary hospitals are desperate for blood," said Karen Stalk, Hemopet's manager. "We provide a need."

The 2.5-acre campus holds color-coded barns where the greyhounds reside. Red is for those recovering from injuries, purple is for the greyhounds learning to live with other dogs. The blue barn holds those ready for adoption.

They sleep in large cages surrounded by toys and stuffed animals. The dogs are usually quiet until spotting a stranger – when one barks, the others join in.

Hemopet bathes the greyhounds in kiddie pools, and on hot days some will mosey over and lounge in them. Staffers and volunteers walk them multiple times a day, let them run on a track, play with the greyhounds in a large, grass yard, teach them to be with others without fighting.

Technicians work in a sterilized lab, separating red blood cells from plasma, both of which Hemopet sells along with whole blood. Red blood cells are for transfusions, and plasma is useful for puppies that didn't get enough milk from their mothers and have poor immune systems.

Often, volunteers become owners.

Long Beach's Kelli Tunnicliff didn't like greyhounds. They looked weird – too tall and skinny. But her husband, Dan, always wanted one.

So, in 2000, Tunnicliff began volunteering at Hemopet to become familiar with greyhounds.

"When I first saw Topaz, he grabbed my sleeve and pulled me into his cage," she recalled. "He was so calm and a great ambassador" for the breed.

They adopted Topaz and a second dog: "Freckles, though, was more neurotic and skittish. She would run in circles."

Tunnicliff, who still volunteers, "fell in love with them."

Hemopet takes about half the legally allowed amount of blood, Stalk said, to ensure the grey-hounds are safe, healthy and comfortable. Hemopet sells out of its blood supply daily.

"It's a win-win," said Dodds, Hemopet's founder. "There is an equal benefit to the donors and all the dogs they save."

But the nonprofit doesn't charge the animal hospitals and the smaller veterinary offices the sales tax – trying to keep the added burden from getting passed on to pet owners. Hemopet often gives the blood for free if a dog's owner is short of money.

The nonprofit's leaders thought for years that a California law exempting blood banks from charging sales tax applied to Hemopet. But the law, according to the California Board of Equalization, applies only to human blood banks.

In 2012, after a Board of Equalization audit, the board determined that Hemopet owed \$81,828 in sales tax from 2008 to 2011. The board hasn't chosen to audit other years.

"The BOE has consistently treated animal blood banks as retailers of tangible personal property subject to sales tax," Dan Elliott, a board spokesman, said in an email.

The Board of Equalization offers payback options for those who can't pay in full.

Hemopet has an annual operating budget of around \$2.8 million, according to IRS tax filings. The nonprofit's officials say it is on an extremely tight budget. Its revenue from the blood bank goes to fund the nonprofit's work rehabbing the greyhounds and running the adoption program.

"Without the blood bank, we wouldn't be able to do all the other amazing things," Stalk said.

At the suggestion of two Board of Equalization members, Hemopet successfully lobbied California legislators for Senate Bill 898. The original bill would have wiped out the back taxes as well as provided an exemption. But the back-taxes provision was ultimately taken out to make it easier to win Brown's approval.

He vetoed the bill anyway, along with six others.

"Each of these bills creates a new tax break or expands an existing tax break," Brown said in his veto message. "Tax breaks are the same as new spending – they both cost the general fund money."

The seven bills, Brown said, would have cost California \$300 million in the 2017-18 fiscal year. The bill that applied to Hemopet would have cost the state \$158,000; there is one other animal blood bank in California, a for-profit.

"If the prior tax assessment is levied and not forgone," Dodds wrote in that July letter to the assemblyman, "Hemopet will be forced to close, since the company cannot obtain more loans or afford more debt."

In his veto message, Brown did say that if legislators were adamant about the tax exemptions, they could put them in next year's budget.

Hemopet's officials plan to work on making that happen. And, in recent days at the Garden Grove facility, officials put on a brave face.

"We don't like to talk about what-ifs," Stalk said.
"We may have to pay the back taxes, but we'll figure out a way. And the fight to get an exemption in the budget is on the way. We know it will be slow, but we're confident."

Correa for Congress

As Loretta Sanchez looks to vacate her seat in the House of Representatives and move to the U.S. Senate, two Democrats, Lou Correa and Bao Nguyen, are vying to replace her in the 46th Congressional District.

We recommend Correa for possessing the necessary experience that will allow him to hit the ground running.

Correa, a former state assemblyman, is a business-friendly Democrat who offers more moderate views on many of the big issues. That is something that will serve him well in Congress, where working across the aisle is a greater requirement than in the Democrat-dominated statehouse.

He told us that the issues he is running on are the same as when he first ran for office: jobs and preserving quality education and the opportunities it provides.

"My job as a policy maker is really to get out of the way and let you do what you do best," he said of job creators.

While we have been supportive of Nguyen's time at the helm of Garden Grove, we thought the move to Congress, after only one term as the city's mayor, was premature.

Correa also has the endorsement of the outgoing Sanchez, who received our endorsement for Senate. The Editorial Board recommends Lou Correa for the 46th Congressional District.

Bock, Klopfenstein for Garden Grove council

The elections for City Council should be interesting this year in Garden Grove, which is moving to elections by district, rather

than at-large, for the first time.

District 3 pits jewelry store owner Clay Bock against research scientist Thu-Ha Nguyen for a two-year term. With crime in the city up about 40 percent, public safety is a big issue for both candidates. Ms. Nguyen's lack of knowledge on the public pension issue, which plagues many cities and is particularly costly for public safety employees, coupled with endorsements from the local police and fire unions, gave us pause, however.

The candidates disagreed over the controversial topic of red light cameras. Garden Grove and Los Alamitos are the only cities in the county to continue operating the intersection cameras – down from at least nine cities a few years ago, according to a July Register report. Ms. Nguyen said that she was fine with the

cameras, and that they are "there for a reason."

But Mr. Bock had a different take. "I am not sure it's effective in helping with traffic accidents," Mr. Bock told us, adding that most of the revenue collected goes to the contractor operating the cameras. And the steep fines are "outrageous" and constitute "harassment" of citizens, he said.

And though we disagree with his zeal for eradicating marijuana dispensaries, we think Clay Bock would be best-suited to improving the city's business climate and public safety while

maintaining fiscal responsibility.

In District 5, marketing consultant Stephanie Klopfenstein and home health nurse Demian Garcia-Monroy vie for a full four-year term on the council. As with the District 3 candidates, crime is the dominant issue. Both candidates also said they

thought city staff were overworked,

While both candidates possess a wealth of experience and strong character, we believe Stephanie Klopfenstein, who has been endorsed by Councilman Chris Phan to fill his seat and currently serves on the Parks, Recreation and Arts Commission, is better equipped to address the city's \$4 million deficit, encourage economic development and tackle complicated issues such as public safety and homelessness without raising taxes. If elected, we urge her to reconsider her support for the red light cameras, however.

The Editorial Board recommends votes for Clay Bock in District 3 and Stephanie Klopfenstein in District 5 on Nov. 8.

And officials at Hemopet, a Garden Grove nonprofit known as the Red Cross for canine blood, say that is financially troublesome.

Hemopet, which rescues greyhounds from racetracks and adopts them out after drawing their blood


to help all sorts of dogs, owes \$82,000 in back taxes to the state. And the group estimates it is looking at an annual \$30,000 tax bill going forward.

Founded in 1986, Hemopet rescues dogs and supplies

ct. 17, 2016 2 of 2 about 40 percent of the nation's canine blood. Selling the blood covers the bulk of the bills, with donations filling the gap.

Now the nonprofit has to also cover the sales tax annually, after Gov. Jerry Brown recently vetoed a bill that would have exempted it from collecting and passing along the tax when selling its blood to veterinary hospitals—news that shook Hemopet's leaders.

"Closure of Hemopet will unquestionably result in suffering and even death of thousands of animals, an inadequate supply of life-saving canine blood for veterinary patients, and harm and hardship to pet owners," Jean Dodds, the founder of Hemopet, wrote to an assemblyman in July when the bill was working its way through the Legislature.

Hemopet saves grey-hounds, the famous speed-sters, from often-brutal racetrack conditions that can leave them lame and cast off when they stop winning; some once were even put down after they stopped winning. Dog racing is legal in seven states, including Florida, Oklahoma and Texas.

Housed in the Orange County Sheriff's Department's former training facility on Salinaz Avenue in Garden Grove, Hemopet has veterinarians on staff. The organization mends greyhounds' broken legs, helps heal their infected wounds, removes rotten teeth and teaches them to live as family pets.

Once healed, the dogs donate blood twice a month, blood that other dog breeds can use. The greyhounds, which number about 220 at any given time, stay at Hemopet for 12 to 18 months before being put up for adoption. About 120 get new homes each year.

"Veterinary hospitals are desperate for blood," said Karen Stalk, Hemopet's manager. "We provide a need."

The 2.5-acre campus holds color-coded barns where the greyhounds reside. Red is for those recovering from injuries, purple is for the greyhounds learning to live with other dogs. The blue barn holds those ready for adoption.

They sleep in large cages surrounded by toys and stuffed animals. The dogs are usually quiet until spotting a stranger – when one barks, the others join in.

Hemopet bathes the greyhounds in kiddie pools, and on hot days some will mosey over and lounge in them. Staffers and volunteers walk them multiple times a day, let them run on a track, play with the greyhounds in a large, grass yard, teach them to be with others without fighting.

Technicians work in a sterilized lab, separating red blood cells from plasma, both of which Hemopet sells along with whole blood. Red blood cells are for transfusions, and plasma is useful for puppies that didn't get enough milk from their mothers and have poor immune systems.

Often, volunteers become owners.

Long Beach's Kelli Tunnicliff didn't like greyhounds. They looked weird - too tall and skinny. But her husband, Dan, always wanted one.

So, in 2000, Tunnicliff began volunteering at Hemopet to become familiar with greyhounds.

"When I first saw Topaz, he grabbed my sleeve and pulled me into his cage," she recalled. "He was so calm and a great ambassador" for the breed.

They adopted Topaz and a second dog: "Freckles, though, was more neurotic and skittish. She would run in circles."

Tunnicliff, who still volunteers, "fell in love with them."

Hemopet takes about half the legally allowed amount of blood, Stalk said, to ensure the greyhounds are safe, healthy

Price of blood

Hemopet sells 250 milliliters of whole blood, about 8 ounces, for \$190; 120 milliliters of plasma and 1,250 milliliters of red blood cells go for \$108. In all, approximately 4,200 bags, at 125 milliliters each, are drawn each year.

and comfortable. Hemopet sells out of its blood supply daily.

"It's a win-win," said Dodds, Hemopet's founder. "There is an equal benefit to the donors and all the dogs they save."

But the nonprofit doesn't charge the animal hospitals and the smaller veterinary offices the sales tax – trying to keep the added burden from getting passed on to pet owners. Hemopet often gives the blood for free if a dog's owner is short of money.

The nonprofit's leaders thought for years that a California law exempting blood banks from charging sales tax applied to Hemopet. But the law, according to the California Board of Equalization, applies only to human blood banks.

In 2012, after a Board of Equalization audit, the board determined that Hemopet owed \$81,828 in sales tax from 2008 to 2011. The board hasn't chosen to audit other years.

"The BOE has consistently treated animal blood banks as retailers of tangible personal property subject to sales tax," Dan Elliott, a board spokesman, said in an email.

The Board of Equalization offers payback options for those who can't pay in full.

Hemopet has an annual operating budget of around \$2.8 million, according to IRS tax filings. The nonprofit's officials say it is on an extremely tight budget. Its revenue from the blood bank goes to fund the nonprofit's work rehabbing the greyhounds and running the adoption program.

"Without the blood bank, we wouldn't be able to do all the other amazing things," Stalk said. At the suggestion of two Board of Equalization members, Hemopet successfully lobbied California legislators for Senate Bill 898. The original bill would have wiped out the back taxes as well as provided an exemption. But the back-taxes provision was ultimately taken out to make it easier to win Brown's approval.

He vetoed the bill anyway, along with six others.

"Each of these bills creates a new tax break or expands an existing tax break," Brown said in his veto message. "Tax breaks are the same as new spending – they both cost the general fund money."

The seven bills, Brown said, would have cost California \$300 million in the 2017-18 fiscal year. The bill that applied to Hemopet would have cost the state \$158,000; there is one other animal blood bank in California, a for-profit.

"If the prior tax assessment is levied and not forgone," Dodds wrote in that July letter to the assemblyman, "Hemopet will be forced to close, since the company cannot obtain more loans or afford more debt."

In his veto message, Brown did say that if legislators were adamant about the tax exemptions, they could put them in next year's budget.

Hemopet's officials plan to work on making that happen. And, in recent days at the Garden Grove facility, officials put on a brave face.

"We don't like to talk about what-ifs," Stalk said. "We may have to pay the back taxes, but we'll figure out a way. And the fight to get an exemption in the budget is on the way. We know it will be slow, but we're confident."

Garden Grove man gets 114 years in murder over drugs

SANTA ANA • A Garden Grove man was sentenced Friday to 114 years to life in prison for shooting one person to death and injuring two others as payback for being ripped off in a drug deal.

A jury convicted Dustin Sean Ross McDonald, 25, of felony murder and two counts of attempted murder for the 2014 killing of

23-year-old Aaron Chavez and the wounding of Chavez's girlfriend, Ashlee Caldwell, and her friend In-

grid Gonzalez.

Prosecutors alleged that McDonald, a drug addict, became enraged after Chavez and Caldwell sold him a "bad bag of dope." Believing he had been cheated,

McDonald set up another meet with the couple, where prosecutors said he planned to shoot them as payback.

On Aug. 12, 2014, McDonald met Chavez and Caldwell, who had brought Gonzalez along, near 12th and Main streets in Santa Ana. Prosecutors believe that McDonald walked up to the front passenger side window of the vehicle the man and two women were sitting in and opened fire.

Chavez was struck once in the face by the gunfire. Caldwell was hit four times and Gonzalez suffered three bullet wounds. A gun matching the bullets and shell casings used was found at McDonald's home.

GG police urge locals to dispose of outdated pills

Take Back Day is planned for Oct. 22


On Saturday, Oct. 22, the Garden Grove Police Department and the Drug Enforcement Administration (DEA) will give the public another opportunity to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused and unwanted prescription drugs.

To dispose of pills safely, drop them off at the Garden Grove Police Department, at 11301 Acacia Parkway, from 10 a.m. to 2 p.m. (The DEA cannot accept liquids or needles or sharps, only pills or patches). The service is free and anonymous, no questions asked.

Last April, Americans turned in 447 tons (more than 893,000 pounds) of prescription drugs at almost 5,400 sites operated by the DEA and more than 4,200 of its state and local law enforcement partners. Overall, in its 11 previous Take Back events, DEA and its partners have taken in over 6.4 million pounds—about 3,200 tons-of pills.

This initiative addresses a vital public safety and public health issue. Medicines that languish in home cabinets are highly susceptible to diversion, misuse and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs.

Studies show that a majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet. In addition, Americans are now advised that their usual methods for hazards.

Police seek to reduce distracted driving, accidents

Eight fatal accidents have occurred in GG in 2016

In response to the nationwide increase of fatal accidents involving distracted drivers, and pedestrians and bicyclists not following traffic rules, the Garden Grove Police Department Accident Reduction Team was organized as part of a city campaign to reduce traffic collisions, and to prevent fatal accidents involving pedestrians and bicyclists.

According to the Accident Reduction Team, more people are using electronic devices while driving and walking. To reduce the number of fatalities in Garden Grove, the Accident Reduction Team began enforcing "zero tolerance" weeks in August, by looking for distracted drivers, pedestrians jaywalking and bicyclists not traveling on the right side of the roadway in the direction of traffic. The enforcement resulted in the issuing and killed for something that of more than 300 citations. This year-round effort focuses on reeducating commuters on traffic safety rules, and the importance of safely sharing roads.

Along with the California Office of Traffic Safety, in September the Garden Grove Police Department joined other law enforcement agencies, pedestrian advocates, and walking clubs in the "California Pedestrian Safety Month," passed by the California State Senate.

Police Chief Todd Elgin stated, "With the growing obsession on texting and social media, distracted driving has become an epidemic, and distracted walking has become an increasingly serious problem, not just in Garden Grove, but nationwide. More and more people are getting injured

According to the Garden Grove Police Department, to date, eight fatal accidents have occurred in Garden Grove for 2016.

To prevent fatalities and lifechanging injuries, the Garden Grove Police Department Accident Reduction Team will be reaching out to commuters through various media outlets, as well as through presentations, and community meetings to educate the public on the dangers of not following traffic laws. The City's website, social media, and other mediums will be used to promote the campaign.

Time to prep for Big One

City to hold drills as part of Great California Shakeout

An earthquake is predicted for Oct. 20 at 10:20 a.m. At 10:20 on 10/20, a pretend earthquake will happen, and schools and government offices will participate in the Great California Shakeout, a drill to test our readiness for the Big One.

The San Andreas Fault line that runs through California is expected to be the location of a huge earthquake in Southern California. For most of our lives, residents have been warned that "The Big One is Coming." Most of us have pack supplies and try not to worry.

Employees from the City of Westminster at City Hall and the police and fire stations will participate in the annual disaster drill.

"Announcements will be made over the loudspeaker system," said Sgt. Jim Kingsmill. "Office workers will get under desks or other safe locations."

"We may do an evacuation drill after the earthquake drill," said Ellen Lopez, Westminster Police Department emergency management coordinator.

"We are waiting for confirmation that the evacuation drill will occur," said Kingsmill. "The 911 operators will stay at their desks; they will handle calls, as usual."

The drill, a statewide event called "Drop, Cover, and Hold On" is expected to be the state's largest earthquake drill ever. Homeowners and local residents are encouraged to participate with their families and coworkers, using the time after the drill concludes to discuss future emergency planning.

The Westminster Police Department has provided the following instructions for the drill: Register your neighborhood, business or organization at ShakeOut.org/California/register; download a drill broadcast recording from the same location; have a drill at 10:20 a.m. on 10/20; discuss what you learned, then make improvements.

Police and fire departments recommend that residents and business owners perform a hazard hunt, looking for items that may fall during an earthquake then secure them; create a personal and family disaster plan; organize or refresh your emergency supply kit; identify and fix

any structural issues; and perform other actions found at www. EarthquakeCountry.org.

FEMA, the Red Cross and ready.gov have created suggested lists of emergency supplies to have on hand. Review the list and get your kit ready before the Shake Out event so you can be prepared in the event of a real earthquake, fire or other serious disaster. Why? Because local police, fire, hospital and other resources can be overwhelmed saving lives and not immediately available to help with food, water and other supplies of daily living. Once your kit is ready, plan to resupply every October before the drill.

A combined list of supplies from the three organizations includes: one gallon of water per person, per day; a three-day supply of non-perishable food, battery-powered or hand-crank radio and NOAA Weather Radio with tone alert and extra batteries for both; flashlight and extra batteries; First Aid kit; whistle to signal for help; dust mask to help filter contaminated air and plastic sheeting and duct tape to shelter-in-place; moist towelettes, garbage bags and plastic ties for personal sanitation; wrench or pliers to turn off utilities; can opener for food; maps of Orange, Los Angeles and San Diego counties; cell phones with chargers.

Recommended food supplies include: foods that will not make you thirsty, salt-free crackers, whole grain cereals and canned

food with high liquid content, protein or fruit bars, peanut butter, dry cereal or granola, dried fruit, nuts, canned juices, non-perishable pasteurized milk, high energy foods, vitamins, food for infants, comfort/stress foods and pet food.

Additional items: medications, multi-purpose tool, copies of personal documents (medication list, medical information, proof of address, deed or lease to home, passports, birth certificates, insurance policies), matches, rain gear, bleach, blankets and/or-sleeping bags, tent, work gloves, latex or vinyl gloves, paper plates,

cutlery and cups.

There are many other items you may want to include such as toys and games for the kids, a deck of cards, and printed information on how to sanitize items and purify water for drinking, a list of phone numbers for friends and relatives, and cash in small bills, since many businesses may not have change for larger bills. Check online for ideas, then decide what makes sense for your family.

Plan ahead for Oct. 20. Gather your emergency supplies and create a kit. Organize your neighborhood, family and co-workers to participate in the drill.

When possible, take a First Aid and CPR class in case you need to save your family or friends after a disaster. If you do each of these tasks, you will feel more empowered and when the real Big One happens, you will be ready.

California City Solutions: San Luis Obispo Creates Unified Approach to Public Engagement

This story is part of an ongoing series featuring Helen Putnam Award entries. The 2016 entries will be available on the League's website as a resource for cities in a searchable database called California City Solutions. San Luis Obispo's Public Engagement and Noticing Manual was submitted in 2016 for the Enhancing Public Trust, Ethics, and Community Involvement award category.

Meaningful public engagement is a core component of how the city of San Luis Obispo provides services to its residents. Keeping up with the multiple ways in which the public receives information and new outreach strategies can be a challenge. Digital tools, in particular, offer ways to transform the public engagement process. San Luis Obispo created the Public Engagement and Noticing (PEN) manual to help the city enhance its efforts following an in internal assessment

identified a need for a consistent approach when engaging the public and created the Public Engagement and Noticing (PEN) manual to support this effort.

Resident groups and other stakeholders all identified the need for greater clarity, noticing and outreach regarding development projects and policy initiatives. Some expressed concern about inconsistency of outreach and tools used between departments, and how that affected early and effective public engagement. Staff decided that it needed a unified approach to public engagement to ensure that the community could receive information and provide feedback on key issues.

The PEN manual was drafted to provide a concise and easy-to-read guide for city staff to use when engaging the community on various types of city projects and policy initiatives. It also serves as a document to help inform city council and community expectations about how and when the city engages the public.

Collaboratively produced with city staff and a local consultant, comprises four major components:

1. The Action Plan Matrix helps identify the level of public engagement staff is expected to use based on the type of project. Levels of public engagement are divided into three communication objectives: inform, consult, and collaborate. These communications objectives were modeled after work done by the International Association of Public Participation. Objectives are listed horizontally across the top of the matrix. Types of projects are divided into four levels of complexity (i.e. decision-making process) and listed vertically on the left hand side of the matrix: staff level, department head/city manager, advisory bodies, and city council.

To use the matrix, the level of complexity of the project is determined, and then staff identifies what communication objectives are expected based on that level. For example:

- Completing a paving project is considered a staff level service delivery, and the expected communication objective is to inform the community about the project.
- Developing a new policy document, like a Climate Action Plan, requires city council approval, and the expected communication objective is to collaborate with the public to develop recommendations.
- 2. Identification of outreach tools makes it clear how staff can achieve effective and meaningful public engagement. Outreach tools are listed for each communication objective in two categories: what is expected, and what can be done to go above and beyond. For example, it is expected that staff will do official noticing, use the website to electronically notify interested parties, post information on the city website and contact key community liaisons when informing the public is the communication objective.

If an issue is designated as needing consultation or collaboration with the public additional tools are required such as surveys, focus groups, workshops, neighborhood meetings and the use of online public comment forum tools like Open Town Hall from Peak Democracy. After a successful pilot, the city began using this program (branded as Open City Hall) as a required part of all projects which require collaboration with the public. This tool has allowed the city to engage with a new segment of the community who were not previously aware of how to be involved or were unable to for a variety of reasons.

- Where and when. This is one of the most important aspects of public The PEN manual includes a sample list of established community organizations and interest groups, media contacts, and venues with capacity and address information.
- 4. Best practices are identified and described for each communication tools, which will help gather meaningful public input and formalize expectations for community members about what will take place.

Templates are included for outreach tools such as e-notification, fact sheets, flyers, advertisements, postcards and signage. This helps to standardize the city's outreach materials.

The city's PEN manual is a tool to help staff determine how to maximize engagement tools at their disposal to achieve meaningful engagement with the public and result in policy informed by a broader section of the community.

Results indicate:

- Over 400 community member participated in a community forum to help identify goals and priorities for the upcoming fiscal year. Another 751 people participated through Open City Hall and mailed surveys.
- The city currently has a 92 percent approval rating from users of the Open City Hall engagement tool with 1,779 individual visitors and 1,281 comments posted. This is the equivalent of 64 hours of public testimony. The use of this tool, through the implementation of the PEN manual, has made the process for collecting feedback much more efficient saving both staff time and resources.

The San Luis Obispo City Council officially endorsed the manual in August 2015 and the Action Plan Matrix has been used during meetings to provide clear direction to staff from the city council as to the desired level of engagement for a given item. The PEN manual has also been featured as a model for other cities to replicate by the National Research Center.
