**UPDATE** 

#### **OBJECTIVE**

To update the City Manager on the Waste Disposal Agreement Amendment and its time extension request.

#### BACKGROUND

On April 14, 1997, the Garden Grove City Council adopted Resolution No. 7959-97, which in part, proposed the establishment of the Garden Grove Sanitary District (District) as a subsidiary district of the City of Garden Grove, in-turn setting forth the adoption of Resolution No. 7960-97 establishing the District Advisory Commission.

#### **DISCUSSION**

The disposal of solid waste at Orange County landfills is governed by a 2009 Waste Disposal Agreement (WDA) in which cities in the County have agreed to deposit their solid waste at the County's three landfill facilities in return for low, stable disposal rates. The term of the current WDA began on July 1, 2010, and runs through June 30, 2020, with importation of waste from outside the County set to expire on June 30, 2016.

With the success of waste diversion and recycling in recent years combined with slow recovery from the Great Recession, the resulting effect has caused in-County waste generation to dramatically decrease, which has reduced revenue. A committee of City Managers representing Orange County cities participated with the County in preparing a framework to address this revenue reduction, and to ensure rate stabilization for local residents and businesses. The proposed Amendment to the WDA sets forth the continuation of future importation to offset the revenue reduction and establishes a fair-share allocation of net importation revenues to cities.

On May 26, 2015, Public Works Department staff submitted to Garden Grove Sanitary Board a review and recommendation package to: 1) Adopt Resolution authorizing amendment to the 2009 Waste Disposal Agreement with the County of Orange and 2) Authorize and execute amendment to the 2009 Waste Disposal Agreement with the County of Orange. The Board approved both recommendations presented. At the Orange County City Managers Association (OCCMA) October meeting, an update was provided on behalf of the Solid Waste Committee about the status of the WDA Agreement. To date, 33 cities have approved the WDA Amendment.

There is a sensitive timeframe issue that may ultimately impact importation and the WDA Amendment. In the current WDA, importation is set to expire by June 2016 unless otherwise extended. L. A. County Sanitation District is the primary and largest importer to the Orange County Disposal System generating 60% of the imported waste. Given the uncertainty of the WDA Amendment to extend importation beyond 2016, L. A. County Sanitation District has issued a Request For Purchase (RFP) to solicit proposals for other disposal options outside of Orange County. These proposals are due October 30, 2015, at which point, the L. A. County Sanitation District will be considering other disposal options.

Orange County Waste and Recycling (OCWR) is currently requesting a time extension from September 30, 2015 to December 31, 2015 to finalize discussions with City of Irvine. The new time extension will be incorporated into a revised WDA Amendment and will require all cities/districts to obtain council or board approval. Please note that the Solid Waste Committee is proceeding cautiously in the event additional time may be necessary beyond the requested December 31, 2015 deadline as the plan is to only return an amendment to the City Council/Board once.

Provided below is additional information that responds to questions raised at the October meeting. The rate numbers noted below were provided by OCWR in December 2014 and they have indicated no changes to the projected rates.

Do all cities have to approve the WDA Amendment?

The Original WDA was approved by all 34 cities. Therefore, all parties have to agree to the amendment(s).

2. What happens if an amendment is not approved?

Rate Increase in landfill tipping fees and the OCWR estimates are provided:

#### Projected Tipping Fee Rates on July 1, 2016

Continue Importation	\$33.66 per ton
Without Importation	\$39.10 per ton
Difference	\$5.44 per ton

3. Will rates to Orange County residents increase?

Depending on language within each specific city franchise agreements, both residential and commercial rates will likely increase.

4. When will the last payment to bankruptcy recovery be made from these funds?

Per the terms of the WDA Amendment, it would be FY 16-17. If the revised WDA Amendment is approved, the final payment in the amount of \$5.9M will be scheduled for FY 16-17.

5. What is the estimated future importation revenues to cities?

See Attachment No. 1 for breakdown of \$30M to cities. An initial disbursement of \$5.4M will be made to cities plus annual allocation of \$25M through 2020. Additional allocation 50/50 of Gross Importation Revenue will be disbursed through 2025.

For your review I have also taken the liberty to attach Orange County's Allocation Projected Importation Revenue dated March 3, 2015. I am available to answer any questions you may have regarding this update.

Just west of the Platinum Triangle in Anaheim, six hotels are under construction, from the 96-room Holiday Inn Express & Suites to the 603-suite Great Wolf Lodge in Garden Grove.

An additional five hotels are in the planning stage, and one is slated for an expansion. The Homewood Suites by Hilton-Anaheim Convention Center at the Disneyland main gate recently opened at 2010 S. Harbor Blvd. with 215 rooms.

All told, that's 3,813 additional rooms in the resort region.

"As Disneyland and the Convention Center continue to grow, there's been a lot of pent-up demand even though no new hotels have been built in a while," said Ajesh Patel, president and CEO of Propera, which is building the JW Marriott Anaheim and two other hotels in the city.

"You see the same set of developers working on multiple projects here," Patel said. "I think we feel the market is strong enough to sustain all of the growth."

The hotel industry in Orange has been booming this year. In October a Chinese construction company bought the Hyatt Regency Orange County in Garden Grove for \$137 million.

SCG America, the U.S. arm of the giant Shanghai Construction Group, acquired the 656-room hotel, built in 1986. The seller, the Xenia Hotels & Resorts real estate trust, paid \$112 million for the hotel in 2008, near the previous real estate peak.

"The market's very hot," said Harry Pflueger, a principal with Maxim Hotel Brokerage, referring to the pace of California hotel deals. "Nobody has a perfect crystal ball, but there's a pretty good three-year landing strip to this cycle."

A record \$4.4 billion was spent to buy 174 California hotels in the first half of the year, according to Atlas Hospitality Group of Irvine.

Two of Orange County's landmark lux-

ury hotels, the 393-room Ritz-Carlton Laguna Niguel and the 250-room Montage Laguna Beach, were sold to Blackstone Group this summer as part of its \$6 billion acquisition of Strategic Hotels & Resorts.

Commercial real estate has drawn big bucks as investors seek alternative bets with interest rates near historic lows. And hotels look relatively cheap, according to Green Street Advisors in Newport Beach. Its lodging industry value index for August was up just 2 percent from its 2007 peak – the smallest gain from pre-

recession highs among seven real estate sectors tracked.

Key to the buying boom is the hotel industry's record profits, derived from a strong tourism rebound out of the Great Recession. Powerful fundamentals – rising rooms rates and falling vacancies – are attracting buyers who are using

low interest rates and plentiful financing to make deals.

And the tourists are noticing – and hopeful the uptick in hotels will benefit them.

"More hotels means more competition, and hopefully lower prices," Denise Strilchvky, a 40-year-old Canadian, said during a recent visit to Disneyland.


In Garden Grove, across from Great Wolf, the spot of the former Joe's Italian Ice also is slated for hotels – though details aren't certain yet.

"We view the Resort District as one entity, including Garden Grove," said Jay Burress, CEO of Visit Anaheim. "The larger Convention Center pushes our room needs into Garden Grove. They are a big part of what we do."




The Orange County Food Bank is short of turkeys to distribute to the needy this Thanksgiving and is seeking last-minute donations.

## COMMUNITY MEETING DATES AVAILABLE FOR PUBLIC INPUT ON VOTING DISTRICT BOUNDARIES

The City of Garden Grove invites members of the community to participate in upcoming community meetings to provide input on the formation of new district voting maps for the city. The meetings, running from the end of November 2015 through March 2016, will be facilitated by David Ely from Compass Demographics, the firm overseeing the formation of five voting districts for the 2016 elections.

The "by-district" City Council elections system process provides several monthly informational meetings for the public to participate in, prior to the preliminary and final district map proposals being presented to the Garden Grove City Council. Both the preliminary and final district proposals will include public hearings as part of the process.

The first round of "Individual Informational Meetings" take place from Monday, November 30 through Friday, December 4. One-hour meetings with Mr. Ely can be scheduled from 10:00 a.m. to 9:00 p.m. on a first-come, first-serve basis. The meetings will take place in Garden Grove City Hall, located at 11222 Acacia Parkway. The goal of these meetings is to educate voters on the process and obtain feedback on an individual or small-group basis.

Reservations for the individual meetings must be made at least three business days in advance by contacting the City Clerk's Office at (714) 741-5035 or by email at districtelections@garden-grove.org.


Following the first round of individual informational meetings will be three "Public Informational Meetings" scheduled for December 9, 12, and 16, held in various sites in the city, soon to be determined. The public meetings will be conducted in a workshop setting with larger groups providing input via interactive opportunities. Times and locations will be announced on the City's website, <a href="https://www.ci.garden-grove.ca.us">www.ci.garden-grove.ca.us</a>, as well as the City's Facebook and Twitter.

Dates, times, and locations for the January, February, and March 2016 individual and public community meetings will be announced by mid-December.

On Tuesday, November 24, 2015, Mr. Ely will hold a study session on the process for establishing the "by-district" election system as part of the regular Garden Grove City Council meeting, held at 6:00 p.m. in the Courtyard Center, 12732 Main Street. The anticipated date for the final report to be presented to the Garden Grove City Council is March 22, 2016.

A district election mapping webpage is now available on the City's website under the Open Government menu item that will provide information and access to all items related to the district-based elections mapping process. These items include: notices of all public meetings, public notices, press releases, agenda reports, maps, and other supporting documents.

The establishment of by-district elections was the result of a settlement between the City of Garden Grove and Rickk Montoya, this past September, involving a lawsuit brought against the City asserting that the City's current "at-large" method of electing City Council members violated the California Voting Rights Act.

## STUDY SESSION - REVIEW OF CALIFORNIA STATE POLYTECHNIC UNIVERSITY, POMONA (CAL POLY) 606 MOBILITY STUDY.

Lee-Anne Milburn presented an overview of the 606 Mobility Study. The Public and Staff then discussed and received input on the subject. A Re:Imagine booklet titled "Garden Grove, a Community in Motion" was handed out and included information on a Non-Motorized Mobility Network, an Open Space Network Enhancement, a 2060 Downtown Concept Plan, and a "Gardens and Groves" Theme.

MATTERS FROM COMMISSIONERS: Commissioner Zamora mentioned that trees near Target, north of Westminster Avenue were gone and replaced with bushes and rocks, and that a large Pine tree at the southwest corner of Westminster Avenue and Euclid Street was removed. Staff explained that if a tree was behind a sidewalk, it would be beyond the City's jurisdiction and that if a tree's roots lifted the sidewalk, they would address the roots, however, if there was the risk of the tree falling over, the tree would be removed. Staff added that trees could be replaced, and if Target was removing trees, Code Enforcement would investigate as there was a ratio of trees to parking spaces. Currently, some centers were using minimal landscaping due to the drought. Staff then mentioned that the City did an alternative landscaping outreach program a few years ago at the Gem Theater.

Commissioner Margolin asked staff for a breakdown of the City's graffiti removal process. Staff explained that Public Works would remove graffiti with paint, sand blasting, or a high-powered washer on right-of-ways in 72 hours or less, however, graffiti on buildings required staff to contact the property owner to remove the graffiti.

Commissioner Paredes asked staff to explain the joint agreements with schools for use of park land, and asked that for organizations such as AYSO and Pop Warner, who would need to be contacted to encourage partnerships. He also mentioned that parks with sports amenities seemed to be more popular than parks with pathways. Staff explained that joint-use facilities have been in place for many years, however, not all schools have them and that in regard to liability, the City would be responsible and would need to provide insurance.

Chair O'Neill thanked Commissioner Pak for his service and wished him well in taking care of his family.

MATTERS FROM STAFF: Staff announced that the next Planning Commission meeting on Thursday, November 19, 2015 would be cancelled and that the next regular meeting would be December 3rd. Also, a new Commissioner would be proposed at the next Council Meeting.

In response to Commissioner Mai's request at the last meeting, staff explained how to obtain street light for a neighborhood street and gave staff member Ana Neal as the contact. First, a formal application would be required, then a survey would be sent to the community, and if approved, the cost at \$1,500 per light, would be distributed evenly to residents on the block or street, in addition, a maintenance fee would be charged to each home on the street at approximately \$70 per month.

Commissioner Mai encouraged that everyone thank a veteran for Veteran's Day to let them know they are appreciated.

Chair O'Neill mentioned that there would be an event at the Orange County Fairgrounds on Veteran's Day at 10:00 a.m.

Staff wished everyone a nice Thanksgiving.

In California, motor vehicle fuel — other than jet fuel — is exempt from sales and use tax. However, proceeds of some taxes on aircraft jet fuel are affected by the FAA rule. The rule does not apply to taxes in effect on Dec. 31, 1987 including the local Bradley Burns 1.25 percent rate or the 4.75 percent state general fund rate in effect at the time. However, several other state rates may be affected, as well as most local transactions and use tax rates.

Local governments with tax revenue from aircraft (jet) fuel may need to provide a spending plan to the FAA by Dec. 8.

This is the third open enrollment period and the group is excited about its successes to date. According to the Centers for Disease Control and Prevention (CDC), California's uninsured rate has dropped from 17 percent in 2013 to 8.6 percent today. These newly insured are Californians who now receive free annual wellness exams and preventive services, make doctor's appointments instead of going to the emergency room, effectively manage their chronic conditions and now have the peace of mind of knowing that they are covered.

Covered California is the only place where residents can access both quality health insurance and the federal financial assistance to help pay for it. Many Californians receive health insurance from their employers or qualify for other programs like Medi-Cal or Medicare. However, Covered California has become a safety net for everyone else who needs private health insurance but could not afford it in the past. Currently, 90 percent of the enrollees receive premium financial assistance which is determined on a sliding scale — the less the consumer makes the more assistance it receives to pay for that coverage.

Individuals can determine what level of financial assistance they qualify for or whether they are eligible for Medi-Cal by using the "Shop and Compare" tool on the Covered California website. By simply entering household income, zip code, age and the number of people that want to purchase insurance, consumers can get a close estimate of the financial assistance they will receive and the cost of each plan.

Open enrollment is the only time when Californians can enroll or change their insurance plan through Covered California, unless they have a qualifying life event. There are many ways to access Covered California's insurance options. Consumers can enroll on their own at <a href="https://www.coveredca.com">www.coveredca.com</a>, or speak with a Service Center Representative by calling 1 (800) 300-1506. They can also receive free, confidential, in-person assistance from a Certified Enrollment Counselor or Certified Insurance Agent.

DWR has \$10 million in Proposition 1 funds immediately available to update or develop local ordinances and groundwater plans to facilitate basin-wide sustainable groundwater management. Eligibility is restricted to stressed, unadjudicated basins. A basin is stressed when it is in critical overdraft, or it exhibits a reduction in groundwater storage, sea water intrusion, degradation of groundwater quality, land subsidence or surface water depletion.

Applications for this grant opportunity are due by 5 p.m. on Dec. 8 and awards will be made in February 2016.

## California City Solutions: Cerritos Library Carves out High-Tech Space for Teen Students

This story is part of an ongoing series featuring Helen Putnam Award entries. The 2015 entries are available on the League's website as a resource for cities in a searchable database called <u>California City Solutions</u>. The city of Cerritos' Library Teen Studio was submitted in 2015 for the Community Services and Economic Development award category.

Due to a strong demand for library services, the city of Cerritos faced the challenge of how to provide teenage students with access to computers and study areas in the Cerritos Library. The solution was to remodel an area within the library into a Teen Studio where teens can access high-tech equipment and participate in activities that encourage educational, creative and personal development. Completed in 2013, local teens contributed design suggestions and the project was made possible through the support of the business community, Friends of the Cerritos Library and teen volunteers. The Teen Studio provides teens with access to computers and study areas.

The Cerritos Library opened in October 1973. The original library was an 18,000-square-foot building with a collection of 45,000 books. The facility also provided the latest technology, including 16-mm films and projectors, record players with headphones and coin-operated electric typewriters.

As the city's population of families with school-age children grew, library use increased significantly. To meet the community's growing demand for library materials, space and resources, the city expanded the Cerritos Library in 1987. The remodeled library featured two microcomputer rooms which were devoted to the computer literacy concept at the time.

With the library open seven days a week and serving students from throughout the seven-city ABC Unified School District, the demand for library services continued to grow. City leaders recognized a need to further expand. The third phase of the Cerritos Library was completed in March 2002. The larger 88,000 square foot space houses 300,000 books, museum-quality exhibits and artwork, and 200 computers for the public's use.

At that time, the computers were located in the Children's Library in an area themed 21st Century, and offered high-speed Internet access, the Microsoft Office suite of programs, and online subscription research databases. Rooms were also available for students to work on group projects.

As more students used the library's services, the computer stations and study areas became increasingly crowded. City leaders decided that the library needed to create a special niche for teens with access to the latest technology, individual and group study areas and college preparation programs.

Library staff cleared a 2,500-square-foot space. The Cerritos City Council asked staff to invite local teens to participate in meetings to help design and develop the new space. The teens provided valuable insights on preferred furnishings, the floorplan, study areas and technological equipment. The Cerritos Library Teen Studio opened in September 2013.

The Teen Studio is a multi-purpose space with seating for up to 66 people, where teens can participate in activities that encourage their educational, creative and personal development. It offers access to state-of-the-art technology, group and individual study areas and the library's young adult collection of approximately 7,000 items. A staff member is always available.

High-tech equipment includes 18 Apple computers, one 40-inch computer surface table, three 65-inch interactive wall-mounted smart displays, two 32-inch e-posters, Wi-Fi access and a multifunction printing device. Internet connectivity is also available for personal laptop and notebook connections through data ports offered at tables throughout the Teen Studio. The computer

surface table makes it possible for teens to share and collaborate together using a large, thin display that recognizes fingers, hands and other objects placed on the screen. The innovative displays combine the touch capabilities of an interactive whiteboard with the crisp visuals of flat-panel display technology to elevate collaborative computing and learning. The e-posters feature artwork created by teens and highlight information about upcoming programs.

By using existing space within the library, the city was able to successfully complete the project while carefully covering its costs. The city's total investment in the construction of the studio was \$290,141. Funding for the majority of the construction cost was allocated from a reimbursement of maintenance and servicing funds the city received from Los Angeles County as part of the Safe Neighborhood Parks Propositions of 1992 and 1996.

The Teen Studio's dedication event was a collaborative effort between the city and Cerritos Library teen volunteers, known as Volunteens. The Volunteens distributed information and dedication buttons and helped visitors use the new high-tech equipment. They also participated in the Teen Studio ribbon cutting and plaque unveiling event with the Cerritos City Council.

Within one year of the dedication, an estimated 25,882 teens had visited the new teen space on a drop-in basis. The Teen Studio successfully met the challenges of providing teens with adequate access to computers to complete their homework and the necessary space to study individually or in groups.

#### 2016 Strategic Goals

- Increase Funding for Critical Transportation and Water infrastructure. Provide
  additional state and federal financial assistance and new local financing tools to help
  meet the critical transportation (streets, bridges, active transportation and transit) and
  water (supply, sewer, storm water, flood control, etc.) infrastructure maintenance and
  construction needs throughout California's cities.
- Improve Housing Affordability. Increase state and federal financial support, reduce
  regulatory barriers, and provide additional incentives and local financial tools to address
  chronic homelessness and improve housing affordability and availability in cities
  throughout the state.
- 3. Update the Local Government Tax Structure to Respond to the New Economy and Stimulate Economic Growth. Consistent with existing constitutional protections for property, sales and local taxes, develop and enact reforms to the local government tax structure to respond to the growth in e-commerce, the shift from the consumption of goods to the consumption of services, changing patterns of commerce and innovations in technology.

In addition to the feasibility report on licensing, the sunset report is supposed to contain information on its compensation guidelines and salary levels; status in revising its school approval process; and performance metrics on certificate suspensions, school inspections and disapprovals, processing of complaints, etc. (see **B & P Code Sec. 4620** for more details).

The California Massage Therapy Act (**B & P Code Secs. 4600 – 4621**) sunsets (or expires) on Jan. 1, 2017 unless extended by the Legislature.
