Subject: Approval of Oversight Board Action

The City of Garden Grove Successor Agency (Agency) notified the California Department of Finance (Finance) of its October 14, 2015 Oversight Board (OB) resolution on October 15, 2015. Pursuant to Health and Safety Code (HSC) section 34179 (h), Finance has completed its review of the OB action.

Based on our review and application of the law, OB Resolution No. 47-15, approving the issuance and sale of Tax Allocation Bonds by the Agency to fund an enforceable obligation and authorizing certain other actions in connection therewith, is approved.

The Agency entered into a Disposition and Development Agreement (DDA) with Garden Grove MXD, LLC (Developer) on April 13, 2010. Section 408 of the DDA allows for the issuance of \$42 million in Tax Allocation Bonds assuming the Agency and Developer have met certain conditions. Finance's approval of OB Resolution No. 47-15 is given specifically with the understanding these conditions have been met.

Following the issuance of the bonds, the Agency debt service payment obligations for the bonds should be placed on a future Recognized Obligation Payment Schedule, subject to Finance review and approval.

OBJECTIVE

To update City Council on FY 2015-16 labor and overtime expenditures in the Fire department along with measures being pursued to maintain fiscal integrity.

BACKGROUND

The FY 15-16 Fire Department labor budget, as adopted, included two parts:

Full-time labor allocation: \$15.59 million

This allocation funds 96 sworn positions, 4 constant manning positions and 5 nonsworn staff. The funded 4 constant manning positions provides an additional overtime cushion or could be filled as deemed necessary to maintain operations. Note: When the budget was approved, 8 of the 96 funded positions were vacant which included 2 captains, 3 engineers, and 3 firefighters.

Overtime allocation: \$2.37 million

The overtime allocation funds required constant manning per contract as well as other ancillary overtime requirements of the department. Note: Constant manning refers to the practice of ensuring that all fire department units are staffed with a minimum level of personnel on a daily basis.

DISCUSSION

As part of the ongoing monitoring of the current year budget, the Finance Department observed an atypical overtime expenditure trend in the Fire Department. The Finance Department immediately initiated discussions with the Fire Department to determine the causes and possible solutions. This trend is, in large part, a result of two issues: an unusually high number of vacant positions over a protracted period and extensive mutual aid assignments over the past six months.

The high number of vacancies has put a strain on the overtime allocation portion of the budget. After the Fire Department opted to cancel the existing firefighter candidate list this Spring and embark on a new recruitment process, it slowed the filling of existing positions. Although we feel this will ultimately garner the most Fire Department Labor Update December 3, 2015

qualified candidates, the protracted vacancies have resulted in higher staff overtime consumption and overall higher overtime usage versus prior years.

We also currently have two firefighters out of service completing paramedic training. Again, this will benefit the department in the end, but it adds to the overtime cost to maintain constant manning.

The other issue causing the expenditure of overtime dollars has been the deployment of staff to assist with firefighting in northern California. The cost of the mutual aid responses so far is estimated in excess of \$500,000. Although the state provides reimbursement, it does not account for the overtime differential here in Garden Grove.

Based on the table below (pay period ending November 6, 2015), if the current trend of overtime usage endures, the Fire department will exceed its allocated overtime budget by about \$4.1 million. Hence, the department is on pace to exceed its overall approved labor budget by about \$2.55 million. A situation that would worsen the general fund structural deficit.

However, it should be noted that these projected Year End numbers reflect a straight line assumption based on pay period #10 numbers, which will most likely change over time. Staff fully expect the actual year-end labor deficit numbers to be less than the projected \$2.55 million as the vacant positions are filled and other mitigating measures are pursued by Fire management.

Further, higher levels of OT are traditionally incurred during the first half of a given fiscal year, which we expect will lead to reduced trends from January-June 2016.

ACTIONS

The City Manager's Office is taking a number of aggressive measures to ensure that this projected OT deficit is reduced even further:

- Immediate bi-weekly meetings between the City Manager, Fire Chief, and Finance Director were scheduled to track and reduce OT spending. All OT spending, other than to cover constant manning in our fire stations, requires joint discussion and approval of the City Manager and Fire Chief.
- ☐ Recruitment for all vacant positions is underway and assigned top priority for Human Resources and Fire.
 - a. The fire engineer recruitment is now complete and the Fire Chief will extend job offers to candidates next week.
 - b. The firefighter list is nearly complete pending background and medical clearance. The Fire Chief and Human Resources staff estimate that appointments can be made by end of January 2016.
 - c. Human Resources and Fire will pursue a continuous recruitment arrangement that will ensure a viable fire engineer and fire fighter list at all times.
- ☐ Fire and Finance have been charged with vigilantly tracking and requesting prompt reimbursement from the State for all eligible expenses incurred from northern California wildfire mutual aid assistance. We are working to recover as much reimbursement as possible during the current fiscal year.

CONCLUSION

Our fire staff continues to work diligently serving the public during this ramp-up period as we fill positions. While many firefighters have had the opportunity to earn more OT compensation, they have been asked to work a greater number of hours, and this is taxing on our staff. For the basic overall health of the department, we need to get to a point where fewer positions remain vacant.

The report is for informational purposes only. No action of the City Council is required. As always, I am available for further discussions and further update reports will be forthcoming.

The purpose of this report is to inform the City Council of the change of process for awarding Federal Emergency Solution Grant (ESG) and Community Development Block Grant (CDBG) Funds to local non-profit service providers.

BACKGROUND

Annually, the City receives a direct allocation of ESG and CDBG funds from the Department of Housing and Urban Development (HUD) to provide services to low-income persons and neighborhoods. Historically, Staff has sent requests for funding/service proposals to service providers who provide eligible services to Garden Grove residents. Staff then reviews the proposals, makes funding recommendations and presents the proposed ESG and CDBG budget to the Neighborhood Improvement and Conservation Commission for review and public comment and then to Council for review, public comment and approval.

DISCUSSION

Recently, the HUD rules for ESG have changed, necessitating a change in our grantee award procedure. Beginning with the FY 2016-17 budget, our award process will be:

- A Super NOFA (Notice of Funding Availability) will be sent out jointly by the cities of Garden Grove, Anaheim, Santa Ana and the County of Orange announcing the availability of ESG funds;
- Staff from those agencies will review the submitted applications for completeness and minimum threshold requirements;
- Applications that meet the minimum threshold requirements will be reviewed jointly by a staff member and a Neighborhood Improvement and Conservation Commissioner (or the equivalent) from each jurisdiction and a resident of the County who is either homeless or has been homeless;

 The recommendations of this group will be included in the FY 2016-17 Action Plan which will be available for public review for 30 days and presented at public hearings before the Neighborhood Improvement and Conservation Commission, and Council.

This new grant award process will keep the City in compliance with HUD's requirement that there be a coordinated, county-wide approach to funding ESG sub-recipients. It will also meet the requirement to have input from a homeless or formerly homeless individual into the award process. While the process of awarding funds to sub-recipients is being done jointly, it should be noted that Garden Grove's entire ESG award will be awarded to service providers who directly service Garden Grove residents.

Due to decreasing funding, a change will also be made to the CDBG award process for FY 2016-17. The limited CDBG funds the City receives prevents awarding CDBG funding to any new service providers. As a result, requests for funding proposals will no longer be issued. Instead, staff will contact our existing service providers to establish a scope of service and budget for the new budget year.

SUMMARY

Changes made to the award process for Federal funds will keep the City in compliance with HUD regulations. All Federal funds awarded to the City will remain in the City and will be awarded to service providers who directly serve our residents.



With a strong likelihood of El Niño driven storms causing flooding in parts of California, and consumers concerned about the availability of homeowners' insurance in areas with a high risk of wildfire, I am writing to ask you to share this important information about insurance coverage with your constituents:

El Niño and Flood Insurance

Meteorologists predict El Nino will likely bring heavy rains and flooding to many areas in the state. Flood damage is not covered by traditional homeowners' insurance. Flood insurance is only available through the National Flood Insurance Program and there is a 30 day waiting period before the policy is effective. Californians living in areas with any risk of flooding should purchase flood insurance through the NFIP immediately. Learn more at https://www.floodsmart.gov/floodsmart/.

Fire Insurance: California FAIR Plan

With increased losses, due to more frequent and more severe fires, some insurance companies are not renewing policies or restricting where they write new policies. Consumers should always shop around for homeowners' insurance. If they cannot find standard coverage they should ask an insurance agent or broker about the non-admitted (surplus lines) market.

The Legislature also established an insurer of last resort for Californians unable to find standard home insurance. Californians unable to find standard home insurance are entitled to purchase fire insurance from the California FAIR Plan. They can contact the FAIR Plan at https://www.cfpnet.com/.

We provide a number of tools on our California Department of Insurance Website to help consumers understand home/residential insurance so that they can make the best decision for their situation, including informational guides, a premium comparison tool, and a new coverage comparison tool that allows consumers to compare differences between insurance policies offered by insurers. Need Assistance Finding Property Insurance?

Shop Around

Whether you are interested in purchasing, reviewing or replacing homeowners, renters, condominium or mobile home insurance, it is important to shop and compare insurance products just like you would when shopping for any other important consumer purchase. Since residential insurance often protects your largest financial investment, plan on spending some time to conduct a search of the insurance marketplace.

The California Department of Insurance (CDI) public web site provides a premium comparison tool (https://interactive.web.insurance.ca.gov/survey/index.jsp) for companies licensed to sell residential insurance. You may wish to contact the insurance companies to see if they are currently accepting new business.

What If I Can't Find Insurance?

If after shopping the market you are still having difficulty obtaining residential insurance, you may want to contact the California FAIR Plan (http://www.cfpnet.com/) to explore your coverage options. As the insurer of last resort, the FAIR Plan should only be considered after a diligent search for coverage in the traditional insurance market. If you are turned down or non-renewed by your current insurance company, or are otherwise in need of coverage, you may apply for coverage under the FAIR Plan through an agent or broker licensed to sell property insurance, or you may contact the FAIR Plan directly at 800-339-4099.

Please note that the FAIR Plan only provides coverage for the perils of Fire or Lightning, Internal Explosion, and Smoke. For an additional premium, Extended Coverage (windstorm, hail, explosion, riot or civil commotion, aircraft, vehicles, and volcanic eruption) and Vandalism or Malicious Mischief may be added to the policy. Since the FAIR Plan policy does not cover all the perils insured under a traditional homeowners' insurance policy such as theft or liability, you may want to consider purchasing a "Differences in Conditions" policy in addition to the FAIR Plan policy that will

cover these additional risks. An agent or broker should be able to locate an insurance company that sells this type of coverage.

GARDEN GROVE UNIFED UNDER THE JACKHAMMER

The school district is in the middle of a \$503 million project to improve all of its campuses.

he Garden Grove Unified School District is about halfway through its \$503 million modernization project.


The yearslong undertaking, funded in large part by a 2010 voter-approved bond, is meant to rid schools in the district of their aging, archaic infrastructure and put in place piping, communication lines and contemporary aesthetics that will, officials say, improve the teacher and student experiences.

The modernization, district officials say, is one of the largest and costliest ever undertaken in Orange County. It is on budget and on schedule – set to wrap up in 2017.

"It's a game changer for us," Dave Fisher, manager of Garden Grove High's theater, said of the changes there. "It's progress."

The district has schools in Garden Grove, Westminster, Stanton, Santa Ana and Fountain Valley, and also serves parts of Cypress and Anaheim.

Among the changes: new plumbing, wheelchair

accessible restrooms and classrooms, new paint, a redesigned foyer at Garden Grove High's theater, air conditioning and wireless infrastructure that will allow the district to invest in newer technology, such as laptops.

The ongoing construction, which began in 2012, has been a logistical challenge.

Some schools are shut down entirely and students get bused to other facilities. At the high schools, where construction is being done in several phases, students spend time in portable classrooms and construction crews must work around midterms and finals to avoid making noise.

to avoid making noise.

"Our overall goal is to minimize the impact to students and teachers," said district spokesman Alan Trudell. "Learning takes precedence over everything."

The removal of large, nearly floor-length windows around the district raised concern from a Lake Elementary School teacher and some of her classroom parents.

At Gilbert Elementary, which construction crews finished in August, the classrooms are enclosed on all sides – with windows at the top of one side, preventing students from looking out. The windows also do not open.

District officials, for their part, say putting the windows higher up keeps students from being distracted by staring out the window, keeps the buildings cooler during summer months and creates a sense of security because people cannot look in.

But others argue that students need the natural light and fresh air that the older windows provided.

"Many of us are saddened at the loss of window views, and at the loss of windows that open," said Claire Bischoff, a eighthgrade science and art teacher at Lake Intermediate. "We are used to being able to look out, and to open the windows when needed. With the new modernized classroom, artificial lighting and ventilation blowers will have to be running 100 percent of the time."

Students at Lake Intermediate, which is slated to go under the jackhammer in 2016, also sent letters to the school district opposing the removal of the windows.

"When the light shines through the trees and through the window, it brings beauty," wrote Deliz Amador, who is in Bischoff's science class. "The warm feeling of the sun brings me much joy."

Trudell, though, said Bischoff is the only person he has heard complain about the upgrades.

Measure A is an infrastructure bond that passed in June 2010 with 59.2 percent of voters supporting it. The measure is for districtwide modernization and has a \$503 million budget. Of that money, \$250 million is in the form of a bond property owners will pay off over 30 years, \$200 million in matching state funds and \$47 million in supplemental grants.

The district is set to pay off the bond by Aug. 1, 2040. Currently, property owners in the district's boundaries pay \$46.56 per \$100,000 of the assessed value of their homes.





Shovels finally dig in at Brookhurst Triangle

The nearly three-decade wait is over: Shovels have gone in the ground at the Brookhurst Triangle in Garden Grove.

Construction crews began excavating the nearly 14-acre site, bounded by Garden Grove Boulevard and Brookhurst Street, in mid-November. Eventually, the Brookhurst Triangle, a patch of dirt for more than 20 years, will become the city's largest mixeduse development, with 674 mid- to higher-end apartment units, about 272,000 square feet of open space and 65,000 square feet of commercial space.

The project will be divided into multiple phases, with phase one calling for 180 residential units to open up within 18 to 21 months, said Phil Wolfgramm, a senior vice president for developer Kam Sang Co. Inc. Phase one will cost the developer about \$40 million.

"The area is beginning to get life again," Wolfgramm said. "It will bring more housing and revenue to the city and revitalization to the area."

Construction was to begin in 2014, but there were delays at the state Finance Department that held up Kam Sang's purchase of the former Redevelopment Agency property from the city. The phase one sale, for \$6.5 million, was finalized Nov. 9.

The city will sell the rest of the property for \$18 million once phase two begins. Not all of that money, though, will go to Garden Grove. With the dissolution of redevelopment agencies statewide, Orange County gets a sizable chunk of that money to distribute to other taxing agencies. Still, the project has the potential to be an economic boon for the city. The residential units alone are expected to bring in about \$550,000 a year in property taxes, said Greg Blodgett of the city's Economic Development Department, who was once a member of the Redevelopment Agency.

It is unclear how much sales tax the city will get because no retailers have been finalized.

Kam Sang has planned the commercial spaces to be part of the final phases of construction and has had only cursory talks with potential business. But Wolfgramm said most of the businesses will be smaller, independent stores and restaurants – some of which may have influences banking off of the nearby Korean Business District and Little Saigon.

The open spaces will include a park inside the residential complex and an urban trail around the Brookhurst Triangle.

A parking garage is also planned.

"Millennials and others want that," Blodgett said of mixed-use developments that combine living spaces with restaurants and stores in compact, walkable urban areas. "Throughout Orange County you see successful (mixed-use) projects going up. It's a positive for the city."

City officials hope that progress at the triangle will also motivate someone to build a development at the so-called rusty skeleton across the way. Negotiations for the property among the landowner, developer and money lender for the proposed Lotus Plaza project – have apparently stalled. The City Council could opt to execute a long-

standing demolition order for the 90-foot structure as early as Tuesday.

The Brookhurst Triangle has a history of false starts and failed projects.

In 1988, the city declared two buildings at the former Ford dealership to be public nuisances, allowing Garden Grove to tear them down. The area became redevelopment property in 2002.

Then, less than five years later, developer Urban Pacific Builders dropped a \$300 million project in the triangle that would have changed the city's skyline with twin high-rises.

Kam Sang came on board in 2009. But it took until early 2014 for the Planning Commission to approve plans for Kam Sang's development.


A groundbreaking ceremony is scheduled Tuesday afternoon, with Kam Sang and Garden Grove officials expected to attend.

"We've taken a property that was hugely blighted and turned it around to create an environment with residential and community spaces, and a lot of great things for the city," Blodgett said. "It's a starting point for the area."

Garden Grove's first round of public meetings to discuss district election maps is set for mid-December.

Ely will host several rounds of meetings. The city plans to announce the dates of subsequent meetings, set for early 2016, by the middle of the month.

This first round will give residents a chance to give input to Ely. Ely also was scheduled to stage private meetings with residents this week.

Subsequent meetings, Ely said, will be more conventional – with Ely presenting the proposed maps and residents commenting on them.

Broken gas line found in roof vent 'definitely an intentional act,' police say

GARDEN GROVE • Authorities cleared a building after a broken gas line was found in a roof vent Wednesday morning, police said.

Employees at Cushman & Wakefield property management smelled gas around 11:40 a.m. in their building in the 7200 block of Eagle Drive, Garden Grove police Lt. Bob Bogue said.

Officers and a Southern California Gas Co. crew found a 2-inch rubber tube attached to the broken gas line on the side of the building that had been put inside a roof vent that led into the management office.

"It was definitely an intentional act," Bogue said.

The Orange County Sheriff's bomb squad searched the building for explosive devices. None were found.

There was no ignition

device inside, Bogue said.

Investigators were trying to determine a motive.

"I asked them, 'Is somebody mad at them?'" Bogue said.

'Rusty skeleton' coming down if no agreement by Dec. 8

Register Nov. 28, 2015 GARDEN GROVE • The 90foot-tall steel structure known as the rusty skeleton that has spent a decade going through several failed projects may be nearing its end.


The City Council set Dec. 8 as a hard deadline for the three parties collaborating on a potential development, known as the Lotus Plaza Project, to come back to the table.

The rusty skeleton has not been touched since 2009. Residents and council members have called the structure – visible from the 22 freeway – an eyesore.

The project has long been mired in financial troubles, litigation and a revolving door of development plans.

"We've given a lot of time," Mayor Bao Nguyen said. "But we should give some more time. We're going into the holiday season. Hopefully that does something for us."

Cathay Bank, the money lender for the project, and developer Brooks Street say they want a mixed-use development to rise up on

Garden Grove Boulevard and Brookhurst Street. But the Hoag Foundation, the property owner and a nonprofit supporting the Boys & Girls Clubs of Garden Grove, says it wants to pull out of the project and demolish the structure.


The City Council, though, does not want to see the development, first approved a decade ago as the Garden Grove Galleria, go to waste.

It decided Tuesday night to have the Hoag Foundation's board reconvene before Dec. 8 and reconsider pulling out. If it does not, each council member said he will vote to enforce a demolition order that has been in place since 2013.

Officials for Hoag seemed reluctant to change positions.

William Grant, the president of the Hoag Foundation's board of directors, said there are many reasons why the board no longer wants to work with Cathay or Brooks Street – but refused to mention any apart from the \$550,000-plus that Cathay owes Hoag for legal fees.

"It's not just about the legal costs," Grant said. "The Hoag board has wrestled with this. But we've run into nothing but roadblocks."

BROOKHURST STREET PROJECT AHEAD OF SCHEDULE FOLLOWING DISCUSSIONS WITH BUSINESS OWNERS

At a press conference today, the City of Garden Grove announced that the Brookhurst Street Rehabilitation project, originally scheduled for completion in mid-December, is expected to be done by the end of next week. The \$2.5 million project raised concerns from area businesses, prompting discussions and immediate actions to be taken by the City.

The Brookhurst Street project is a one-mile major reconstruction project broken into two sections, from Hazard to Westminster, and from Trask to Emerson. The capital project involves replacing the asphalt base paving in all six lanes, north and south, of both segments. This improvement will meet commuter needs for the next 20 years.

During today's press conference, City Council member Phat Bui, Public Works
Director William Murray, and City Manager Scott Stiles, discussed ongoing personal
contact with Garden Grove businesses on Brookhurst to see what the City could do
to lessen the impact and move the project along faster. Immediate actions
included increasing accessibility by creating left turn lanes into the shopping areas
and directing the contractor to extend their work hours to include weekends.



I am writing this letter to ensure that you and your staff are aware of important updates regarding Keep Your Home California, the State's free foreclosure prevention program. Keep Your Home California is a valuable resource that has already helped many homeowners avoid foreclosure. The program offers up to \$100,000 per household. We want to make sure you are aware of recent changes which could be critical to helping many more!

Keep Your Home California was established under the U.S. Treasury Department's Hardest Hit Fund. As part of this federally funded program, California was allocated nearly \$2 billion to help eligible low and moderate income homeowners avoid preventable foreclosures. Since the program's inception in February 2011, Keep Your Home California has provided \$1.2 billion in assistance to more than 58,000 California households, each facing a serious financial hardship.





A recently adopted amendment to a federal regulation by FAA clarifies the rule that the proceeds of state and local taxes on jet fuel at an airport must be used for airport-related purposes, including capital and operations, state aviation programs and airport noise mitigation. The FAA is allowing a three-year period through Dec. 8, 2017, during which FAA will withhold enforcement actions and state and local agencies must develop compliance plans.

In California, motor vehicle fuel — other than jet fuel — is exempt from sales and use tax. However, proceeds of some taxes on jet fuel are affected by the FAA rule. The rule does not apply to taxes in effect on Dec. 31, 1987 including the local Bradley Burns 1.25 percent rate or the 4.75 percent state general fund rate in effect at the time. However, several other state rates may be affected, as well as most local transactions and use tax rates.

CSCDA and WAP partnered with Citibank to provide \$9.1 million in tax-exempt multifamily affordable housing bonds for Duarte Manor, and WAP brought in AEGON as their Tax Credit Investor. Treadstone Companies, in San Diego, serves as the development consultant to WAP. The rehabilitation will include substantial renovation of unit interiors and property including new kitchen cabinets and appliances, tub surrounds & fixtures, Americans with Disabilities Act (ADA) improvements, interior and exterior doors, new roofing, exterior and interior painting, security cameras and controlled access and energy efficient systems. New ENERGY STAR rated and low-water usage products include kitchen hoods, ranges, refrigerators, low-E windows, airconditioning units and low flush water closets.

The financing of Duarte Manor will maintain the affordability of units for low-income tenants for 55 years.

Pasadena: Northwest Manors II Apartments

Northwest Manors II Apartments is an acquisition and rehabilitation of 44 multifamily affordable housing apartments by East Mountain Housing Associates, LP in Pasadena. The project sponsor is Community HousingWorks. Northwest Manors II will continue to be 100 percent affordable and provide eight studio, six one-bedroom, and 30 two-bedroom apartments to low-income families.

CSCDA and Community HousingWorks partnered with Berkeley Point Capital, LLC to provide \$8,428,000 in tax-exempt multifamily affordable housing bonds for Northwest Manors II. The rehabilitation will include new flooring, countertops and cabinets in kitchens and bathrooms, windows, light fixtures, wall furnaces, interior and exterior paint, a new roof, sustainable landscape, and the installation of a new playground at each site. The financing of Northwest Manors II will maintain the affordability of units for low-income tenants for 55 years.

Chino: Vista Park Chino Apartments

Vista Park Chino Apartments is an acquisition and rehabilitation of 40 multifamily affordable housing units, also by Jim Perley of WAP and his nonprofit partner Better Housing Foundation. Vista Park will continue to be 100 percent affordable and provide 21 two-bedroom units and 19 three-bedroom units to low-income families.

CSCDA and WAP partnered with Citibank to provide \$9.3 million in tax-exempt multifamily affordable housing bonds for Vista Park, and WAP brought in AEGON as their Tax Credit

Investor. Treadstone Companies, in San Diego, serves as the development consultant to WAP. The rehabilitation will include substantial renovation of unit interiors and property including new kitchen cabinets and appliances, tub surrounds & fixtures, ADA improvements, interior and exterior doors, new roofing, exterior and interior painting, security cameras and controlled access and energy efficient systems. New ENERGY STAR rated and low-water usage products include kitchen hoods, ranges, refrigerators, low-E windows, air-conditioning units and low flush water closets.

The American Public Works Association (AWPA) recently announced that the public works departments for the cities of Palo Alto and Vallejo have recently been awarded the prestigious APWA Accreditation. The APWA Accreditation program recognizes public works agencies that exceed the requirements of the management practices established nationally for the public works industry, as contained in the <u>APWA Public Works Management Practices Manual</u>.

The cities both submitted an application in February 2013, with Vallejo receiving its APWA Accreditation in August and Palo Alto in October.

The Accreditation award indicates the department has met all applicable Accreditation requirements for documentation and practices.

The Palo Alto Public Works Department comprises four divisions — Engineering Services, Environmental Services, Public Services and Airport Operations. The department provides services that are integral to the overall health, safety and appearance of the city, with commitment, courtesy and pride. In partnership with the Palo Alto community, the staff strives to offer efficient, cost effective and environmentally responsible services that make the city a beautiful, vibrant and appealing place to live and work.
