It was moved and seconded to receive and file the minutes from September 4, 2012.

DISCUSSION ITEMS:

4-a. Pedestrian Access Closure on Fallingleaf Street at Lampson Avenue

The staff report dated March 5, 2013 was introduced. A petition signed by the residents of Fallingleaf Street was submitted for review. Discussion ensued.

It was moved and seconded to accept staff's recommendation to approve the closure of the pedestrian access at the end of Fallingleaf Street just north of Lampson Avenue.

ACTION: (5) AYES - Unanimous

4-b. Traffic Signal – Chapman Avenue and Lamplighter Street

The staff report dated March 5, 2013 was introduced. A petition signed by 89 people in favor of the petition was submitted to staff for review. This intersection satisfied four (4) of the (9) warrants. Only (1) warrant must be satisfied to meet the criteria for a traffic signal.

It was moved and seconded to accept staff's recommendation for installation of a new traffic signal at the intersection of Chapman Avenue and Lamplighter Street.

ACTION: (5) AYES – Unanimous

4- c. Traffic Signal Priority List – Update

The staff report dated March 5, 2013 was introduced. Staff is requesting the intersection of Chapman Avenue and Lamplighter Street be added to the existing Traffic Signal Priority List based on the point system. This intersection has 31 points.

It was moved and seconded to accept staff's recommendation to add the intersection of Chapman Avenue and Lamplighter Street to the Traffic Signal Priority List.

4-d. Request the installation of an audible pedestrian signal at the intersection of Brookhurst Street and Woodbury Avenue/Traylor Way.

The staff report dated March 5, 2013 was introduced. Maria Gerard, Orientation and Mobility Specialist, from the Braille Institute spoke to the Commission in favor of the signal, as it would be beneficial for the visually impaired students.

It was moved and seconded to accept staff's recommendation to approve the installation of an audible pedestrian signal at the intersection of Brookhurst Street and Woodbury Avenue/Traylor Way.
