b. Pedestrian Access Closure on Laurelton Avenue at Springdale Street

The staff report was introduced to consider a request to close the pedestrian access at the end of Laurelton Avenue on the east side of Springdale Street.

The resident provided a signed petition from the residents living along Laurelton Avenue and Wutzke Street, citing their concerns over neighborhood safety and increased criminal activity due to the opening in the existing block wall. The opening provides direct access from Springdale Street on to Laurelton Avenue. Garden Grove Police Department have no objection to this closure.

It was moved and seconded to accept staff's recommendation to receive public input and approve the pedestrian entrance closure to Laurelton Avenue located just east of Springdale Street.
