OBJECTIVE

The purpose of this report is to inform the City Council that the International Council of Shopping Centers (ICSC) 2019 RECON convention will be held at the Las Vegas Convention Center. The convention begins Monday, May 20, 2019 through Wednesday, May 22, 2019. At this time, staff would like to solicit interest of City Council members in attending this convention.

BACKGROUND

Founded in 1957, ICSC is the global convention for the shopping center industry and provides networking, deal making and educational opportunities for retail and real estate professionals from around the world. Its more than 70,000 members in over 100 countries include shopping center owners, developers, managers, investors, retailers, brokers, academics, and public officials. At the ICSC RECON convention, the City will have the opportunity to meet with these members and take advantage of networking, deal making and education opportunities. The convention typically features approximately 1,000 exhibiting companies, and approximately 36,000 attendees.

Attendance at this convention will allow the City's Economic Development team to explore economic, marketing and promotional conditions affecting the shopping center industry. Promoting and marketing the City of Garden Grove to industry retail representatives and developers remains a priority. The City will be exhibiting a booth with display and marketing materials located in an area designated as the Cities of the World Pavilion. As an exhibitor, the City will maximize its opportunity to meet with key players in the shopping center, hospitality and housing development arenas. In addition, by attending the convention, staff will meet with potential developers by canvassing the trade show floor.






Irvine Student Wins Chapman University Sponsored Arts Contest



Garden Grove is poised to join OCFA

Though a couple of cities over the past year have threatened to drop out of the Orange County Fire Authority, Garden Grove is veering the opposite direction - toward membership.

If the final steps unfold as expected, OCFA may absorb the 93-year-old Garden Grove Fire Department as early as August. All full-time employees would stay put.

In return for providing fire and paramedic services, OCFA would bill Garden Grove \$22.1 million annually for the 10-year contract, plus about \$113,600 per year for start-up costs. That's almost \$3 million less than what the city expected to spend this fiscal year to operate its Fire Department.

The transition enjoys broad support. City officials say joining OCFA will cut costs, relieve pension liability and fund necessary equipment updates. At a recent workshop, most if not trucks are more than a decade all of the seven City Council

members appeared amenable to the idea.

And, importantly, the Garden Grove chapter of the International Association of Fire Fighters labor union enthusiastically promotes the move.

"We've been fighting for this for two years," said Eric Thorson, spokesman for Local 2005. "OCFA's service level is second to none. And because it's so big. it can provide resources that small cities can't."

The contract will go before the Orange County Fire Authority's board today and then, most likely, the City Council on April 9.

Under the agreement, all of the Fire Department's 84 sworn employees would be picked up by OCFA, City Manager Scott Stiles said.

Garden Grove would continue to own its seven fire stations and, consequently, foot the bill for building maintenance. But OCFA would take over just about every other expense, including providing updated vehicles and apparatus.

Some of Garden Grove's fireold, Thorson said.

"Equipment has been neglected for years," he said. We can either keep putting Band-Aids on problems or let OCFA fix everything in one fell swoop."

Also, OCFA would bring in more emergency workers. Currently, four of Garden Grove's seven teams are equipped with only one paramedic. OCFA's model would mandate two paramedics for every team.

The marriage of the agencies would benefit both sides, said Lori Zeller, assistant chief of business services for OCFA. "Garden Grove is right in the middle of the county and borders two of our cities," she said.

Already, OCFA frequently serves parts of Garden Grove from its stations in

Cypress and Westminster.

Officials said transitioning to OCFA shouldn't affect response time and could even improve them. The countywide agency arrives in under seven minutes and 20 seconds 80 percent of the time, Zeller said.

For Garden Grove, one of the biggest perks in a merger would be the shift of future pension responsibilities to its firefighters' new employer - although "the obligation we already have doesn't go away," Stiles said.

Like most cities in California, Garden Grove faces burgeoning pension costs. The city owes the California Public Employees' Retirement System \$61 million for its Fire Department staff alone.

"We pay what's required - \$3.5 million a year and not a penny more," said Ann Eifert, risk management analyst for the city. "We haven't been in the

Garden Grove poised to join OCFA

While a couple of cities over the past year have threatened to drop out of the Orange County Fire Authority, Garden Grove is veering the opposite direction — toward membership.

If the final steps unfold as expected, OCFA may absorb the 93-year-old Garden Grove Fire Department as early as August. All full-time employees would stay put.

In return for providing fire and paramedic services, OCFA would bill Garden Grove \$22.1 million annually for the 10-year contract, plus about \$113,600 per year for start-up costs. That's almost \$3 million less than what the city expected to spend this fiscal year to operate its Fire Department.

The transition enjoys broad support. City officials say joining OCFA will cut costs, relieve pension liability and fund necessary equipment updates. At a recent workshop, most if not all of the seven City Council members appeared amenable to the idea.

And, importantly, the Garden Grove chapter of the International Association of Fire Fighters labor union enthusiastically promotes the move.

"We've been fighting for this for two years," said Eric Thorson, spokesman for Local 2005. "OCFA's service level is second to none. And because it's so big, it can provide resources that small cities can't."

The contract will go before the Orange County Fire Authority's board on Thursday and then, most likely, the City Council on April 9.

Under the agreement, all of the Fire Department's 84 sworn employees would be picked up by OCFA, City

Manager Scott Stiles said.



Report: Stronger State-Local Partnerships Needed for Solutions to Housing Crisis in California

March 25, 2019

Across the nation, cities are experiencing a housing crisis on many fronts, from homelessness and poor housing quality to lack of supply and affordability.

This diverse landscape demands that cities and states collaborate and that cities retain a broad set of tools to meet unique local needs. But in many states, the set of tools available to city leaders is limited. The National League of Cities (NLC), in collaboration with all 49 state municipal leagues, has released "Local Tools to Address Housing Affordability: A State-by-State Analysis," to uncover how states interact with cities on key housing policies and the level of authority they provide to cities to implement proven strategies.

This new research finds that depending on their state and home rule authority, the ability of cities to improve housing conditions varies extensively across the country. This assessment of all 50 states and the District of Columbia across the five policy areas — inclusionary housing, rent control, housing vouchers, housing trust funds and states tax incentive programs — finds that the District of Columbia, as well as cities in New York and California have more tools to address housing affordability than other cities. This report is the fifth annual research project developed in collaboration with NLC and state municipal leagues.

No matter their size, level of prosperity or growth pressures, nearly all communities in the United States struggle with housing affordability. Whether the priority is housing supply, affordability, quality or helping households achieve economic mobility, cities need the proper tools and flexibility to meet the unique housing circumstances facing their communities.

Specific findings include that along with cities in California and the District of Columbia:

- Nineteen other states are expressly permitted or face no legal barriers to inclusionary housing;
- Twelve other states are permitted, have some barriers, or have limited control to implement rent control;
- Thirty-four other states have established housing trust funds; and
- Eighteen other states have state-level tax incentives for new construction and/or rehabilitation of existing low-income housing.

For both NLC and the <u>49 state municipal leagues</u>, the topic of housing rose to the forefront as a top advocacy priority. In 2018, League Executive Director Carolyn Coleman and Oakland Mayor Libby Schaaf joined the new <u>NLC housing task force</u>, which seeks to develop a set of best and promising practices at the local level, as well as policy recommendations to federal and state governments.

The League of California Cities is continuing to strongly support legislation and budget proposals that streamline the housing approval process and increase funds for affordable housing, and is collaborating with the Legislature and Gov. Santa Monica Short-Term Rental Ordinance Withstands Legal Challenge

The Ninth Circuit Court of Appeals issued a <u>decision</u> last week rejecting a legal challenge brought by online hosting platforms HomeAway.com and Airbnb to Santa Monica's short-term rental ordinance.

The League filed a friend-of-the-court <u>brief</u> in the case, authored by Christi Hogin of Best, Best and Krieger. The California State Association of Counties and the International Municipal Lawyers Association also joined in the League's brief.

The ordinance at issue in the case authorizes city-licensed and registered "home-sharing" rentals – where resident(s) remain on-site with guest(s) – but prohibits all other forms of short-term rentals for 30 days or less. It also imposes certain obligations on online short-term rental hosting platforms such as HomeAway.com and Airbnb. Specifically, the ordinance requires online hosting platforms to collect and remit transient occupancy taxes and to regularly disclose listings and booking information to the city. It also prohibits them from booking properties that are not licensed and registered with the city and from collecting any fees in connection with such prohibited transactions.

The city adopted the ordinance following a proliferation of short-term rentals in residential zones. Such short-term rentals, the city council reported, "had negatively impacted the quality and character of its neighborhoods by 'bringing commercial activity and removing residential housing stock from the market' at a time when California is already suffering from severe housing shortages."

HomeAway and Airbnb sued, claiming the ordinance violated various laws including the federal Communications Decency Act of 1996 and the First Amendment.

Federal courts have interpreted the Communications Decency Act to immunize "publishers" of third-party content from liability arising out of that content. The purpose of the Act is "to promote the continued development of the Internet and other interactive computer services."

HomeAway and Airbnb argued that Santa Monica's ordinance was inconsistent with the Act because it effectively required them to monitor and remove third-party content "to prevent their website from becoming littered with unbookable listings." The Ninth Circuit Court of Appeals rejected this argument, noting that the ordinance simply prohibited the online platforms from proceeding with unlicensed bookings; it did not seek to impose any liability on the platforms for the contents of the listings. "Like their brick-and-mortar counterparts," the court held, "internet companies must also comply with any number of local regulations concerning, for example, employment, tax, or zoning."

The Ninth Circuit was also unpersuaded by HomeAway and Airbnb's arguments that the ordinance imposed a "content-based financial burden" on their commercial speech in violation of the First Amendment. The Ninth Circuit found no "significant expressive element" associated with processing a short-term rental booking.

Although this ruling may be appealed, it is a positive development for cities in the area of short-term rental regulation. Cities that have questions as to how they may be impacted by this ruling should consult with their city attorney.

Trailer Budget Bill Proposes Statewide Tax on Drinking Water

The League joins the Association of California Water Agencies (ACWA) and a <u>large coalition</u> of nearly 200 local water and public agencies to oppose the proposed water tax unless amended with an alternative funding source.

The budget trailer bill language, based on <u>SB 623 (Monning, 2017)</u>, is intended to establish a stable funding mechanism administered by the State Water Resources Control Board to assist those who do not have access to safe drinking water. This bill is a slightly modified version of Gov. Jerry Brown's 2018 proposed trailer bill, which was ultimately rejected.

The 2019 trailer bill proposes agricultural assessments to address nitrate-related contamination and a tax on drinking water (tap water) that would require approximately 3,000 local water systems to assess on local residents and businesses.

Since 2017, the League has been supportive of the establishment of a safe and clean drinking water fund, but has been advocating for the removal of any tax on tap water as a funding source. This year, the ACWA and the California Municipal Utilities Association (CMUA) are sponsoring <u>SB 669 (Caballero)</u>, which would create the Safe Drinking Water Trust in the State Treasury to fund a Safe Drinking Water Fund at the State Water Board.

Lack of access to safe drinking water in certain disadvantaged communities is a public health issue that the state needs to address. The League will continue to be supportive of ACWA and CMUA's proposal to remove the tax on water from any legislation and is evaluating other related safe drinking water fund legislation.
