Dear Senator Padilla:

I write in support of the Orange County Sanitation District's (OC San) Community Project Assistance Request for the Headworks Rehabilitation Project and to seek your support of \$10,000,000 in federal funding as part of the Interior and Environment Appropriations Bill, Fiscal Year 2022.

As the Mayor of the City of Garden Grove, this request will directly support our shared effort to improve the reliability of our regional wastewater treatment system and deliver high quality water for the Groundwater Replenishment System to drought proof our region. The requested assistance will support the construction of this vital conveyance system that brings in approximately 120 million gallons of wastewater through six major truck sewers that combines, measures and removes debris and grit that otherwise could end up in the ocean.

The Headworks Rehabilitation Project is ideally suited to receive federal assistance. It is my understanding that the Senate recognized the significant importance of water recycling and improved water quality most recently when it passed the Water and Wastewater Infrastructure Assistance Act. This project directly supports the goals of this bill.

For these reasons and the justification provided to your office through the Community Assistance Project Request portal, I wholeheartedly support the requested assistance and look forward to your support. Welcome to the Office of Care Coordination Spring Quarterly Update. We are pleased to share our progress on the County's COVID-19 Homelessness Response System and other key developments in the provision of services for those experiencing homelessness.

# **Project Toolbelt and Project HomeKey**

As of end April 2021, Project Toolbelt, one of the County's COVID-19 Homelessness Response System programs, provided services to 601 program participants. This program provided an opportunity for the contracted service providers to be innovative in engaging individuals that were not previously engaged with the Homeless System of Care. Services provided by Project Toolbelt included emergency shelter in a motel setting, 3 meals a day, weekly case management, weekly COVID-19 testing, access to the COVID-19 vaccine and other resources and wraparound supportive services. One component of service is to provide one on one case management to support participants to create an individualized housing plan with the goal of transitioning to stable and longer-term housing options. Of the total 601 Project Toolbelt participants: 297 participants have obtained permanent housing; 205 have obtained temporary but more stable housing; 73 have transitioned to emergency shelters; and 26 others transitioned to facilities that provide a higher level of care they so greatly needed. In addition, participants are being assessed for eligibility for Orange County Housing Authority Set Aside and Mainstream vouchers, along with Anaheim and Santa Ana Homeless Set Aside Vouchers. Eligible participants are also referred to the HomeKey Program via the Coordinated Entry system, with support and collaboration between Project Toolbelt and HomeKey case managers, participants are then engaged for intake and move in. The HomeKey Program is operated out of two motel sites in Stanton and provides longer term stays, enhanced engagement, and on-site services from the program operator. To date, 90 Project Toolbelt households have successfully transitioned into the HomeKey Program. The HomeKey Program provides housing to 132 program participants that were at higher exposure to COVID-19 due to their vulnerability and/or age.

# Shelter COVID-19 Vaccine Program

The Office of Care Coordination and Public Health Services have been working closely to implement a COVID-19 vaccine distribution plan for people experiencing homelessness within the shelter system. There has been outreach around this effort to 55 different shelters countywide, including domestic violence, transitional aged youth, and pregnant woman programs. All front-line staff at Emergency Shelter Programs have been offered the opportunity to get vaccinated. The Office of Care Coordination coordinated with Public Health Nurses to educate participants regarding the COVID-19 vaccine and distributed the vaccine to County shelter sites. The vaccine drive effort's success is due to the support from the Orange County Fire Authority, City of Anaheim, City of Fullerton, City of Laguna Beach, City of Huntington Beach, City of Newport Beach, Public Health and all the emergency shelter providers. The vaccine distribution began March 19, 2021, and within the next two weeks, around 800 shelter participants received their first dose. The distribution of the second dose began April 19, 2021, and all will be administered before the end of this quarter.

# **Coordinated Entry System Update**

The Coordinated Entry System (CES) is a mechanism for allocating available housing units via a systematic resource targeting process designed to implement localized priorities for program participants via intake assessment. CES covers the geographic area of Orange County and is regionally focused by Service Planning Areas, it is easily accessed by individuals and families seeking housing and services and includes a comprehensive and standardized process used by all service providers in the System of Care.

Following a successful pilot and implementation of Orange County CES for Families with minor children into the Homeless Management Information System (HMIS), the CES for Individuals, Veterans and Transitional Aged Youth, is currently transitioning into HMIS. The Request for Proposals for the Individual CES issued in late 2020 has identified Friendship Shelter as the Operational Coordinator for the Individual CES. The Office of Care Coordination and the Orange County Continuum of Care are excited for the regional coordination and technical support Friendship Shelter will provide to access points. Operations have begun to transition from the Office of Care Coordination over to Friendship Shelter. # **Homeless Data Integration System**

The Homeless Data Integration System (HDIS) is a statewide data warehouse that compiles data from the 44 Continuums of Care (CoC). Each CoC coordinates a comprehensive regional strategy to address homelessness and collects data about the people it serves and the services it offers, according to common federal standards established by the U.S. Department of Housing and Urban Development (HUD). Integration of this data into HDIS establishes California's first statewide repository of common homelessness data.

This centralized repository can assist in identifying statewide patterns of service usage across California's geographic regions, supporting efforts to identify and address racial and other inequalities among people experiencing homelessness. This information will be used to support technical assistance, planning, funding, and coordination decisions more efficiently. We can more readily determine the remaining work needed to prevent, reduce, and ultimately end homelessness across California. HDIS was developed and will be maintained by the State Homeless Coordinating and Finance Council. # **Affordable Housing Developments**

Westminster Crossing is located in the City of Westminster and will provide 65-units of affordable housing for low to extremely-low income individuals and families. The County is providing funding as well as twenty (20) one-bedroom units will receive Project Based Voucher rental subsidies from the Orange County Housing Authority (OCHA) and will house 20 individuals experiencing homelessness referred from Orange County Coordinated Entry System (CES). These twenty units will provide supportive housing for individuals experiencing chronic homelessness, who will receive on-site support from the OC Health Care Agency (HCA).

Buena Esperanza is a 69-unit affordable studio development located in the City of Anaheim, providing supportive housing to three subpopulations - veterans, individuals living with mental illness and individuals formerly experiencing homelessness. The County is providing funding as well as twenty (20) of the studio units will receive Project-Based Veterans Affairs Supportive Housing Voucher rental subsidies from OCHA referred by Veterans Affairs (VA). Buena Esperanza will also be receiving on-site support from the HCA as well as Jamboree and the VA.





# Seeking Applicants for the Lived Experience Advisory Committee

The Orange County Continuum of Care (CoC) Board recently created the Lived Experience Advisory Committee. The Advisory Committee is intended to ensure that the voices and perspectives of individuals with current or past lived experience of homelessness are heard and considered in the decision-making process of the CoC Board. It also provides a way to share recommendations and feedback on the CoC and its programs and services.

To be eligible to serve on the Advisory Committee, interested individuals must identify themselves as having experienced homelessness, past or present, preferably in Orange County.

# Care Plus Program

On December 28, 2020, the Office of Care Coordination launched the Care Plus Program (CPP). CPP is a collaborative care coordination program for those most vulnerable across the County's System of Care. CPP aims to expedite the identification of needs and complete successful linkages to services and resources utilizing a



Multi-Disciplinary Team approach. A data integration platform coordinates and shares data across County departments. The Multi-Disciplinary Team approach provides an opportunity for all programs to work together, using real time data and information to ensure coordinated service delivery. The system allows the County to build a care team around an individual to create a shared Care Plan across all departments. The initial launch is a pilot phase and will be providing coordinated service delivery for a targeted cohort of those experiencing homelessness.

**NEWPORT BEACH, Calif., May 12, 2021** — Officials with Hoag Memorial Hospital Presbyterian and John Wayne Airport today announced the opening of the Fly Well Clinic, making JWA one of just a few airports across the nation to offer travelers onsite COVID-19 vaccinations, urgent care, telehealth consultations and vital screenings. Located post-security in Terminal B across from Gate 10, the new clinic also will offer flu shots during the annual flu season.



Meanwhile, the recently-opened Hoag Rapid COVID-19 Testing Clinic at JWA is available to all airport visitors – travelers and non-travelers alike. Located pre-security in Terminal B on the Departure Level before the TSA Security Checkpoint.

"We are proud to partner with John Wayne Airport to offer convenient access to quality health care for the millions of people who fly to or from the airport every year," said Marcy Brown, Hoag's senior vice president and chief hospital operations officer. "It's so important that people get vaccinated against this deadly virus, and the Fly Well Clinic and the Rapid Testing Clinic are important new resources for helping us reach out to the community in a number of ways to ensure everyone receives care when and where they need it, including vaccinations."

Offering convenient access to Hoag-quality care, the Fly Well Clinic offers travelers the option of walk-in visits or advance appointment scheduling. The clinic's onsite licensed health care provider can treat travelers' minor illnesses and injuries, as well as cold and flu symptoms and travel sickness, as well as write prescriptions. Travelers are also invited to visit the Fly Well Clinic for general health and wellness information. The clinic also offers a free Virtual Reality (VR) experience designed to relax and reduce the stress sometimes associated with travel along with modern aromatherapy with essential oils from CAMPO.

"With everyone over the age of 16 eligible to receive a COVID-19 vaccine, Hoag is working to continuously expand access and reach people in a variety of ways – whether that's at the local senior centers or before your flight to visit a loved one," Brown said. "Hoag's presence at JWA is a great opportunity to remind our community to make their health a prority."

The partnership represents the first airport health clinic in Orange County and comes at a time of heightened health awareness among passengers and Airport employees.

"As we begin to see an increase in air travel once again, we want to ensure that our guests feel safe and healthy. We believe our partnership with Hoag will help achieve that important community health-care goal," Airport Director Barry Rondinella said. "As the highest-ranked health care provider in Orange County, Hoag is uniquely positioned to address our guests' specific health care needs, as well as the needs of the nearly 900 people who work at the Airport. # Free Battery Program Provides Medical Baseline Customers More Resiliency

All Californians need to be prepared for potential outages, especially those who rely on electricity for medical devices and equipment and live in a high fire risk area. Southern California Edison's Medical Baseline customers can now have greater peace of mind with a clean, portable backup battery, with renewable charging from an accompanying solar panel, through the utility's **Critical Care Backup Battery Program**.

"SCE wants to help empower our customers and communities to be as prepared as possible for potential outages caused by unexpected weather and other emergencies," said Jessica Lim, SCE principal manager of Customer Programs and Services. "Programs and services, such as Critical Care Backup Battery, can help provide additional resiliency and support during these critical times."

**Customers who may be eligible for the Critical Care Backup Battery Program must:** 

- Live in a high fire risk area;
- Be enrolled in the Medical Baseline program; and
- Be enrolled in an income-qualified program, such as California Alternate Rates for Energy (CARE) or Family Electric Rate Assistance (FERA).

Eligible customers will receive a letter informing them about the program and providing details on how to work with an SCE-approved contractor to determine the appropriate battery size for their medical devices. Once confirmed, the contractor will then deliver and set up the backup battery and solar panel for customers free of charge.

"We understand the burden the pandemic, which has been compounded by extreme weather events, can have on our customers and we have made it simpler for them to qualify for important programs like Medical Baseline until June 30," said Lim.

## **Customers who may be eligible for the Medical Baseline Program:**

- Rely on medical devices and equipment vital for life or to restore crucial physical function, including mobility.
- Are temperature sensitive and require air conditioning.
- Have a life-threatening illness, compromised immune system or other conditions requiring heating and/or cooling.

Customers who are not enrolled in an income-qualified program and do not meet

the qualifications for the Critical Care Backup Battery Program can still check their eligibility for Medical Baseline online at **sce.com/medicalbaseline**, which is now available in 19 languages, including Spanish, Korean, Chinese, Vietnamese and Tagalog.



# 1 killed, 1 injured after suspected drunk driver slams into stopped car in Garden Grove, police say

A suspected drunk driver slammed into the back of another car stopped at a red light in Garden Grove late Saturday, killing the driver of the stopped vehicle and injuring a passenger, police said.

The crash occurred at Woodbury Road and Libby Lane at around 10:54 p.m., Garden Grove police said in a statement. They said a white Nissan Titan was speeding eastbound on Woodbury when it crashed into the back of the waiting Toyota Camry.

The Toyota was pushed into the intersection by the force of the crash, then smashed into two parked cars and a retaining wall. The Nissan driver got out and fled on foot immediately after the crash, but was arrested nearby.

The Toyota driver, later identified by the Orange County coroner as 27-year-old Pedro Vergara, died at the scene. A woman who was in the passenger seat was taken to UCI Medical Center with minor injuries.

The suspect was later identified as Mario Miguel Hernandez-Lopez of Garden Grove, 38. Police said in the statement that after his arrest, they evaluated him, suspected he was drunk and booked him in Orange County jail. It's not clear if he had any injuries.

# Garden Grove sắp trồng 12,000 cây xanh để chống thay đổi khí hậu

GARDEN GROVE, California (NV) – Tối Thứ Ba, 11 Tháng Năm, Hội Đồng Thành Phố Garden Grove bỏ phiếu với tỷ số 7-0 đồng ý thông qua dự án Urban Forest Management Plan (UFMP) để trồng 12,000 cây xanh tại những nơi công cộng quanh thành phố trong thời gian sắp tới. Kế hoạch này kéo dài 40 năm.

Thành phố Garden Grove được ước tính cứ 100 cư dân có 17 cây xanh, ở mức thấp hơn so với mức trung bình cây xanh ở Orange County là 100 người có 22 cây, theo số liệu của thành phố.

Sau khi nghe ông Omar Sandoval, luật sư thành phố, trình bày, Nghị Viên Stephanie Klopfenstein (Địa Hạt 5) đề xướng việc thống qua dự án và Phó Thị Trưởng Kim Nguyễn (Địa Hạt 6) ủng hộ, rồi năm thành viên còn lại đồng lòng đồng ý.

Trước khi bỏ phiếu, Nghị Viên Phát Bùi (Địa Hạt 4) nhắc lại những kỷ niệm ông còn nhớ với những con đường rợp mát bóng cây từ năm 1975, nhưng cũng nêu lên vài vấn đề như cây có thể rơi nhựa xuống làm dơ bẩn những xe đậu bên dưới và rễ cây có thể làm nghẹt ống dẫn hay ống thoát nước, cả của thành phố lẫn cư dân.

Ông nói: "Tôi chỉ muốn nêu lên vài vấn đề bây giờ để tránh phiền toái cho cư dân trong tương lai thôi chứ tôi hoàn toàn tán đồng ý với dự án này."

Nghị Viên Diedre Thu-Hà Nguyễn (Địa Hạt 3) nói: "Với sự gia tăng nhiệt độ giữa các khu vực, đặc biệt là ở Orange County, cây cối giúp làm mát cái nóng này. Tôi hoàn toàn ủng hộ kế hoạch UFMP này."

Trước khi bỏ phiếu, Phó Thị Trưởng Kim Nguyễn cũng nêu lên vấn đề rằng rễ cây thường nâng mặt đường và lề đường lên cao, vừa phá đường, vừa gây nguy hiểm. "Tôi muốn chúng ta có kế hoạch đề phòng những chuyện này mà thôi," bà giải thích. "Thực sự, tôi thích dự án này từ đầu."

Trả lời việc này, ông Sandoval cho biết là nhóm đảm trách việc trồng cây đã lưu ý đến những chi tiết này nên sẽ chọn loại cây không gây ra vấn đề để giảm thiểu việc chăm sóc lâu dài.

Cuộc bỏ phiếu diễn ra rất nhanh chóng vì tất cả mọi thành viên Hội Đồng Thành Phố đều thấy cái lợi cho thành phố trước hiểm họa ô nhiễm môi trường cũng như khí hậu ngày một nóng dần.

Garden Grove là một trong những thành phố tiên phong trong việc soạn thảo giải pháp dài hạn để giải quyết vấn đề này, qua các khoản tài trợ, sửa chữa, và trồng cây xanh trong thành phố trong 40 năm tới.


Theo hồ sơ thành phố, năm 2018, Garden Grove nhận được ngân sách CAL FIRE Grant là \$574,000.

"Một phần số tiền này được dùng để trồng 363 cây dọc theo đường mòn 'Huân Chương Danh Dự" (Medal of Honor) và hệ thống thoát nước tại đây," bà Diedre Thu-Hà Nguyễn cho biết.

Tác hại của nhiệt độ tăng cao, do biến đổi khí hậu, gây ảnh hưởng nghiêm trọng đối với các khu vực cư dân có thu nhập thấp, người vô gia cư, và người cao niên, nên việc trồng thêm cây xanh là cần thiết, các nhóm bảo vệ môi trường nhắc nhở.

Trồng nhiều cây giúp tạo bóng mát cho khu vực nhiều dân cư.

Thêm vào đó, cây xanh còn hạn chế lũ lụt, và đóng vai trò quan trọng đối với sức khỏe tinh thần của người dân thành thị.

Theo báo mạng Voice of OC, trong một báo cáo năm 2019, Đại Bồi Thẩm Đoàn Orange County cảnh báo việc không đủ cây xanh trong thành phố khiến nhiệt độ tăng cao những ngày nắng nóng và tạo ra khí lạnh ban đêm.

"Các tàn cây tạo bóng mát vào ban ngày sẽ hút khí CO2, lọc bụi, bảo vệ môi trường, và giúp giảm nhiệt," theo đại bồi thẩm đoàn.

Trong khi đó, các cây già bị bứng đi và việc trồng lại thì khó khăn vì thiếu ngân sách nên càng thiếu hơn.

Cũng theo báo cáo của Đại Bồi Thẩm Đoàn, ngân sách trồng cây xanh ở các thành phố vùng Orange County cần từ \$20,000 đến \$1.8 tỷ.

Trở về buổi họp, ông Phát Bùi nói: "Tôi muốn được thấy thêm nhiều cây xanh trồng xen kẽ với những cây đang có sẵn ở Garden Grove trong khu Little Saigon, dọc theo đường lớn như Brookhurst, Euclid hay Westminster cũng như trong khu dân cư." [qd]

# Hundreds of Cal Cities members "Zoom" in on Capitol for Legislative Action Days

City officials urge the State to commit at least \$10 billion for cities in the 2021-22 State Budget

May 12, 2021

Over 300 city officials from throughout the state joined forces for the League of California Cities Legislative Action Days, a two-day virtual advocacy summit – part education, part advocacy – connecting local leaders directly with state lawmakers.

Cal Cities President and El Centro Mayor Cheryl Viegas Walker kicked off the event underscoring what's at stake for cities this year and the importance of all city officials advocating on the common interests of California cities.

"The state legislative session is in full swing, and as lawmakers in Sacramento begin to make decisions and vote on legislation, it's imperative that our voices are heard loud and clear in the Capitol," Viegas Walker said.

Cal Cities Executive Director and CEO Carolyn Coleman provided a broad overview of which bills are the highest priorities for cities this year, "We have our work cut out for us with a healthy package of legislative proposals we support that will help cities recover, as well as proposals that would set our communities back and stall recovery."

Cal Cities legislative representatives then briefed city officials on the details of the priority areas, including COVID-19 relief, housing and land use, broadband infrastructure, public safety, organic landfill waste, and unfunded mandates, before the dozens of legislator meetings began. Over the coming days, city officials are estimated to attend around fifty meetings with legislators.

#### Commit \$10 billion in the State Budget to help cities recover from the pandemic

During the legislator meetings, city officials are advocating for the State to commit at least \$10 billion for cities in the 2021-22 State Budget. Despite the approximately \$8 billion in direct fiscal relief reserved for California cities in the American Rescue Plan, many cities still face dramatic budget shortfalls that continue to grow. City governments have lost more than \$5 billion in revenue since the start of the pandemic; that number will grow to \$6 billion in the coming year. California cities have also expended at least \$5 billion in expenditures related to COVID-19.

Faced with an unexpected, historic surplus of \$75 billion, the state has the opportunity to create an equitable, comprehensive recovery plan that will allow communities to not just survive but thrive. The \$10 billion dollars would go to direct and flexible aid for cities, resources to address homelessness and housing supply, broadband infrastructure, and the implementation of new regulations for organic waste removal.

#### **Priority Housing and Land Use Bills**

Housing affordability and homelessness are among the most critical issues facing California cities. Affordably priced homes are out of reach for many people, and housing is not being built fast enough to meet the current or projected needs of people living in the state. Unfortunately, many of the proposed bills in the Legislature include policies that will not help spur much-needed housing construction in a manner that supports local flexibility and decision-making and community input. State-driven ministerial or by-right housing approval processes fail to recognize the extensive public engagement associated with developing and adopting zoning ordinances and housing elements that are certified by the California Department of Housing and Community Development. As a result, Cal Cities members are asking legislators to vote no on the below proposed legislation:

SB 9 (Atkins) Increased Density in Single-Family Zones. OPPOSE

AB 215 (Chiu) Housing Element. Regional Housing Need. OPPOSE

AB 989 (Gabriel) Housing Appeals Committee. OPPOSE

AB 1401 (Friedman) Residential and Commercial Development. Parking Requirements. OPPOSE

#### **Stop Unfunded Mandates**

Cities continue to face rising pension costs and reduced budgets due to the pandemic. As CalPERS determines the discount rate for the next four years, cities must guard against unreasonable cost increases that could threaten stable funding for essential services. Legislation has been revived, as well, that would require public agencies to pay for disallowed compensation, which further threatens cities' fiscal stability. In addition, proposed costly public meeting requirements with no implementation funding was also introduced this legislative session. Cal Cities members are asking legislators to vote no on:

**SB 278** (Leyva) Public Employees' Retirement System. Disallowed Compensation. Benefit Adjustments. **OPPOSE** 

AB 339 (Lee) Local government: open and public meetings. OPPOSE

#### **Reducing Landfill Waste and Pollution**

The cost of solid waste disposal and recycling is going up. Cities anticipate rates will increase in the next three years due to new organic waste regulations from SB 1383 (Lara, 2016) and the overall cost of recycling. CalRecycle only finalized its regulations in November 2020, leaving only 13 months for cities to comply with many of the requirements before the Jan. 1, 2022 implementation deadline, and without providing funding to implement the regulations. As a result, Cal Cities members are asking legislators to support the proposed legislation, which would delay penalties for local jurisdictions demonstrating a reasonable effort to comply:

SB 619 (Laird) Organic Waste. Reduction Regulations. SUPPORT
SB 54 (Allen) Plastic Pollution Producer Responsibility Act. SUPPORT IN CONCEPT

#### **Broadband: Closing the Digital Divide**

California cities need a comprehensive broadband package that would create sustainable funding sources for cities to deploy broadband infrastructure. Others legislative efforts are underway to streamline broadband permitting and implement existing federal regulations into state law. Cal Cities is negotiating amendments to these bills because they undermine local authority and fail to prioritize communities needing broadband service the most. As a result, Cal Cities members are asking legislators to take positions on the following bills:

**AB 14** (Aguiar-Curry) Communications. California Advanced Services Fund. Deaf and Disabled Telecommunications Program. Surcharges. **SB 4** (Gonzalez) Communications. Wireless Telecommunications and Broadband Facilities. **SUPPORT** 

AB 34 (Muratsuchi) Communications. Broadband for All Act of 2022 SUPPORT IN CONCEPT AB 537 (Quirk) Local Permitting. Broadband Projects. Watch – Requested Amendments SB 378 (Gonzalez) Local Government. Broadband Infrastructure Development Project Permit Processing. Microtrenching Permit Processing Ordinance. Watch – Requested Amendments SB 556 (Dodd) Street Light Poles, Traffic Signal Poles. Small Wireless Facilities Attachments. OPPOSE

#### **Public Safety**

Public safety and police reform policy emerged as major priorities for cities and the Legislature this year in the areas of hiring and training, accountability, and modernizing the approach to delivering public safety services in communities. As city officials engage with the Legislature on public safety and reform measures, it is important that this urgent need for change be met with practical and precise modifications to existing law that are data-driven and focused on improving outcomes for all communities. As a result, Cal Cities members are asking legislators to take the following positions on these bills:

SB 2 (Bradford) Peace Officers. Certification. Civil Rights. OPPOSE

SB 16 (Skinner) Peace Officers. Release of Records. OPPOSE

SB 210 (Wiener) Automated License Plate Recognition Systems. Use of Data. OPPOSE

AB 48 (Gonzalez) Law Enforcement. Kinetic Energy Projectiles and Chemical Agents. OPPOSE

AB 718 (Cunningham) Peace Officers. Investigations of Misconduct. SUPPORT

# Cal Cities urges lawmakers to invest \$3 billion for broadband in the state budget

Broadband just one of many city priorities underscored during Infrastructure Week

May 12, 2021

Protecting and modernizing critical infrastructure is one of the League of California Cities' 2021 Strategic Advocacy Priorities.

The timing for United Infrastructure Week, May 10-14, is especially appropriate as it aligns with Cal Cities Legislative Action Days, where city officials step up their lobbying efforts with state lawmakers, including the need for infrastructure funding.

Cal Cities is advocating for the investment of at least \$3 billion for broadband infrastructure to be included in the state budget. These investments would support the expansion and related infrastructure upgrades needed in unserved and underserved communities to help cities catalyze broadband projects statewide. Granting Cal Cities' budget request, coupled with the investments from the federal government, would make significant headway in achieving the state's broadband goals.

Throughout the COVID-19 pandemic, both state and federal governments have emphasized that infrastructure remained a priority and city officials are pressing hard to ensure those stated priorities translate into funding and resources for city infrastructure projects.

#### **State Infrastructure Resources Update**

A comprehensive broadband package failed to reach the Governor's desk at the end of the 2020 legislative session, disappointing many as COVID-19 drew increased attention to California's digital divide. In response, several broadband bills directly impacting cities have been introduced this year:

- AB 14 (Aguiar-Curry) Communication. Broadband Services. California Advanced Services Fund.
  - SB 4 (Gonzalez) Communications. California Advanced Services Fund. Deaf and Disabled Telecommunications Program. Surcharges.
  - These measures would reform the existing California Advanced Services Fund (CASF) surcharge, retooling it to play a much larger role in closing the digital divide. Specifically,

these measures would continue to fund the CASF beyond its original 2022 sunset date, make it easier for local governments to apply for these grants, expand the definition of "unserved" so more communities are eligible for funding, and raise speed requirements for new networks.

**Action: SUPPORT** 

AB 34 (Muratsuchi) Communications. Broadband for All Act of 2022

This measure would place a \$10 billion general obligation bond measure on the November 8, 2022, ballot. Funding would be allocated to cities, counties, special districts, school districts, and other local government agencies to build their own broadband networks.

**Action: SUPPORT IN CONCEPT** 

AB 537 (Quirk) Communications. Wireless Telecommunications and Broadband Facilities.
This measure would implement the FCC's adopted regulations on broadband permit shot
clocks into state law. Cal Cities has requested amendments to ensure consistency with the
federal requirements.

**Action:** Watch - Requested Amendments

• SB 378 (Gonzalez) Local Government. Broadband Infrastructure Development Project Permit Processing. Microtrenching Permit Processing Ordinance.

This measure would require local governments to allow microtrenching for the installation of underground fiber if the installation in the microtrench is limited to fiber. Cal Cities has requested amendments to ensure consistency with the federal requirements.

**Action:** Watch - Requested Amendments

 SB 556 (Dodd) Street Light Poles, Traffic Signal Poles: Small Wireless Facilities Attachments.

This measure would directly conflict with the FCC's adopted regulations on wireless services deployment. Specifically, it would require local governments to make space available on streetlight poles, traffic signal poles, utility poles, and other public infrastructure to telecommunications providers. SB 556 would also create ambiguity in the fees local governments can charge for access to their infrastructure.

**Action: OPPOSE** 

#### **Federal Infrastructure Resources Update**

The American Jobs Plan, outlined by the White House early this year, is an ambitious proposal to invest approximately \$2 trillion this decade to address infrastructure needs. Cal Cities anticipates the introduction of various proposals in Congress to guide these investments. Cal Cities is currently assessing cities' infrastructure needs to advocate Congress effectively and will continue to provide more information as it becomes available.

In addition to the American Jobs Plan proposal, the recently passed American Rescue Plan

included significant investments in infrastructure. The \$8.3 billion in local recovery funds headed to California cities through the ARP can be used to provide broadband services to unserved and underserved households and businesses.

Additionally, the American Rescue Plan includes \$10 billion for the new Coronavirus Capital Improvements Projects Fund, which will help deliver critical capital projects directly enabling work, education, and health monitoring, including remote options in response to COVID-19.

The plan also includes \$7 billion for the Emergency Connectivity Fund, which will be distributed through the Federal Communications Commission to reimburse schools and libraries for the purchase of remote learning devices and internet connections for students. As the U.S. Department of the Treasury guidance is finalized for the American Rescue Plan, Cal Cities will release more information on the eligible uses of these funds.

Congress continues to work on surface transportation reauthorization, and Cal Cities is working with the National League of Cities on transportation needs for cities. The surface transportation program was up for reauthorization in September 2020 and was renewed for one year. Congress has until September 30 of this year to act on a new bill — or pass another extension.

These are just some of the exciting opportunities in the infrastructure space this year. Looking beyond Infrastructure Week, Cal Cities will continue to advocate for protecting and modernizing critical infrastructure while maintaining local authority.

### Guide to Local Recovery Update: May 12

The portal for local governments that will receive their money directly from the U.S. Department of the Treasury is now live.

This portal is for cities classified as Metropolitan Cities under the American Rescue Plan.

Local governments designated as non-entitlement units are also eligible to receive Coronavirus State and Local Fiscal Recovery Funds, as provided in the American Rescue Plan. However, they will receive this funding from their applicable state government, not through this link.

Jurisdictions must submit a request to receive funding even if they have previously applied for other programs through the Treasury Submission Portal. Eligible jurisdictions will receive further communications regarding the status of their submission via the email address provided in the Treasury Submission Portal.

#### Treasury Guidelines for American Rescue Act now available!

The Treasury Department announced on Monday, May 12 details on how eligible <u>entitlement cities</u> will be able to access funding from the American Rescue Plan Act's \$65 billion in direct and flexible relief for every city in the country, directly from the Treasury Department. For <u>non-entitlement cities</u>, Cal Cities has been in communication with the California Department of Finance, to learn about the process for the distribution of funds and we will provide an update with information as soon as possible.

# Tentative decision on Rule 20 undergrounding program to be considered at upcoming CPUC hearing

Cal Cities encourages cities to provide public comment urging against changes at May 20 hearing

May 12, 2021

On April 7, 2021, California Public Utilities Commission (CPUC) President Marybel Batjer issued <u>a tentative decision</u> on the Rule 20 undergrounding program revisions.

The program provides guidelines and procedures for undergrounding overhead electric facilities such as electric distribution lines. Cal Cities, as a party of the Rule 20 proceeding, <u>submitted</u> <u>comments</u> outlining concerns with the decision.

The tentative decision includes significant changes to the Rule 20 program that would impact cities:

- CPUC would not sunset the Rule 20A program. However, cities will cease to receive work credits through the program on Dec 31, 2022.
- CPUC would prohibit cities from borrowing, selling, or trading work credits from other jurisdictions immediately, unless a county wants to redistribute its work credits to cities within its jurisdiction or if neighboring cities want to pool credits for a common project.
- CPUC will continue to deliberate on whether to make changes to project eligibility criteria for Rule 20A in Phase Two of the proceeding.

As many cities currently have insufficient work credits to carry out Rule 20A undergrounding projects, the decision to cease allocating new work credits beyond 2022 and prohibiting cities from borrowing, selling, or trading credits fundamentally undermines cities ability to conduct new undergrounding projects using the Rule 20A program.

#### How to Engage

Cal Cities is encouraging cities to provide public comment urging against these changes to the Rule 20 program. The tentative decision will be reviewed and voted on May 20, CPUC business meeting beginning at 10 a.m. <u>View the agenda</u> for this meeting, along with information about how to provide public comment. The tentative decision is item number 24 on the agenda.
