I have reviewed the Orange County Grand Jury Report, *Unfunded Retiree Healthcare Obligations-A Problem for Public Agencies?* On behalf of the City of Garden Grove, I am providing responses to Findings F2, F3 and F4 and Recommendations R2, R3 and R4, as requested by the Grand Jury.

#### Response to Findings

**F2:** Twenty one out of the 32 agencies that provided June 30, 2013, data to the Grand Jury had not put aside funds in an irrevocable trust to help pay for the accrued actuarial liability of retiree healthcare costs in the future. This is an imprudent level of contribution.

We disagree partially with this finding. The City of Garden Grove does not provide employees with retiree medical coverage per se. However, the City participates in the PERS retiree health benefit that mandates a city contribution/subsidy of \$119.00 per month per retiree as of June 30, 2014. The City funds this contribution on a pay-as-you-go basis annually. In addition, the City set aside \$1.00 million in an assigned contingency fund for this obligation beginning in FY2009.

F3: Anaheim, Buena Park, County of Orange, Huntington Beach, Lake Forest, and Stanton were in compliance with the requirement to contribute a full 100% or more of their Annual Required Contribution in the FY 2012-13. The remaining 26 agencies were not in compliance.

We disagree partially with this finding. (See response to F2 above.) Moreover, Governmental Accounting Standards Board (GASB) 45 does not mandate agencies to contribute 100% of the Annual Required Contribution.

**F4:** All agencies surveyed (except Anaheim) do not disclose retiree health benefits as part of employee compensation per GAAP standards.

We disagree wholly with this finding. (See F2 response above.) Employees become eligible to receive this benefit if they retire from the City of Garden Grove and are eligible for PERS pension, and enrolled in CalPERS health plan.

#### Response to Recommendations

**R2:** The 21 agencies that have not contributed into an irrevocable trust fund to finance their retiree health obligations should begin to put aside monies to fund this obligation and reduce their unfunded public liabilities. (F.2.)

The recommendation will not be implemented because it is not warranted. (See F2 response above.) The City funds this contribution on a pay-as-you-go basis annually. In addition, the City set aside \$1.00 million in an assigned contingency fund (not irrevocable trust) for this obligation beginning in FY2009.

**R3:** The 26 agencies that are not recognizing the full amount of their Annual Required Contribution as expense in the current period and should comply with the requirement to do so. (F.3.)

The recommendation has been implemented. The City complies with this recommendation consistent with GASB 45 implemented since FY2008

**R4:** All agencies surveyed should recognize retiree health care benefits in employee compensation in conformity with GAAP. (F.4.)

The recommendation will not be implemented because it is not warranted. (See F2 response above.) Employees become eligible to receive this benefit if they retire from the City of Garden Grove and are eligible for PERS pension, and enrolled in CalPERS health plan.

I have reviewed the Orange County Grand Jury Report, *Joint Powers Authorities: Issues of Viability, Control, Transparency, and Solvency.* On behalf of the City of Garden Grove, I am providing responses to Findings F1 and F3, and Recommendations R1 and R2, as requested by the Grand Jury.

#### Response to Findings

**F1:** Orange County has nine "inactive" Joint Powers Authorities that have no viable activity, revenue, expenditure, assets, or liabilities. The Grand Jury determined that these Joint Powers Authorities serve no benefit to the public or the taxpayers and have the potential for misuse or obfuscation of public funds.

The City disagrees partially with this finding. The City agrees that the Orange County Regional Airport Authority, which Garden Grove is a member City, does not have viable activity or revenue; however, we disagree that the JPA has potential for misuse or obfuscation of public funds. We additionally agree that this JPA's purpose has been fulfilled and there is no longer a benefit to the taxpayers.

The Garden Grove Public Finance Authority (GGPFA) is a conduit entity used to facilitate debt financing for the City of Garden Grove and related entities. It provides for the financing of public capital improvements for members through the purchase by the Authority of obligations of a member pursuant to bond purchase agreements, and/or the loan of funds to a member. The GGPFA has enabled the issuance of several outstanding bonds with maturity extending through 2030. As a result, the JPA cannot legally be dissolved. The GGPFA will also be used in the future for other public financing activities.

F3: Orange County has 18 vertical Joint Powers Authorities created by a city along with its redevelopment agency that no longer exists. The Grand Jury determined that these Joint Powers Authorities serve no benefit to the public or the taxpayers and have the potential for misuse or obfuscation of public funds.

The City disagrees wholly with this finding. The members of the GGPFA are the City of Garden Grove, the Garden Grove Sanitary District, and the former Redevelopment Agency whose rights and obligations were assumed by the Successor Redevelopment Agency. Further, the GGPFA still has outstanding bonds and obligations facilitated by the JPA through a maturity date of December 2030.

#### Response to Recommendations

**R1:** All Orange County Joint Powers Authorities that are "inactive" should submit the official paperwork with the State of California requesting termination of their existence or provide at the next public meeting the justification for continuing the Joint Powers Authority. (F.1.)

With regard to the Orange County Regional Airport Authority, the recommendation has not yet been implemented, but will be implemented in FY 2015-16 until complete. The Orange County Regional Airport Authority is inactive and the City of Garden Grove will take the lead to terminate the JPA.

With regard to the GGPFA, the recommendation will not be implemented because it is not warranted. The GGPFA is active as indicated in the response to F1 above.

**R2:** All Vertical Joint Powers Authorities created by a city along with its redevelopment agency should submit the necessary paperwork with the State of California requesting termination of their existence. (F.3.)

The recommendation will not be implemented because it is not warranted. The GGPFA is active as indicated in the response to F3 above.

#### Dear Judge Sanders:

I have reviewed the Orange County Grand Jury Report, Joint Powers Authorities: Issues of Viability, Control, Transparency, and Solvency. On behalf of the City of Garden Grove as a member agency of the Orange County Regional Airport Authority (OCRAA), I am providing responses to Findings F4 and F5, and Recommendation R3, as requested by the Grand Jury.

#### Response to Findings

F4: Vertical Joint Powers Authorities with a single controlling entity, such as a city council, have the potential to use this organizational structure as a shell company to avoid other legal constraints on the controlling entity and to obfuscate taxpayer visibility.

The Orange County Regional Airport Authority is a "horizontal" JPA structural organization made up of multiple Orange County cities; therefore, we do not believe the finding is applicable.

Vertical Joint Powers Authorities in which the controlling entity transfers assets F5: from itself to a Joint Powers Authority for the purpose of obtaining additional funding, or signs a long-term lease to a Joint Powers Authority to obtain assets, are avoiding transparency and are not acting in the best financial interest of the taxpayers.

The Orange County Regional Airport Authority is a "horizontal" JPA structural organization; therefore, we do not believe the finding is applicable.

#### Response to Recommendations

**R3:** All Joint Powers Authorities should take the following actions to insure transparency to the taxpayers: 1) have an annual outside audit, 2) post the complete audit on their city website as a separate Joint Powers Authority entity, 3) send the audit to the County Controller and the State Auditor, and 4) ensure the required reports are filed annually to the County and the State. (F.4., F.5.)

The recommendation will not be implemented because it is not warranted. The Orange County Regional Airport Authority effectively ceased operations in 2004 following the passage of the Orange County Measure W in 2003 which prevents an aviation reuse of the El Toro Station. The last activity in the accounts of OCRAA occurred in Fiscal Year 2004. A small cash balance totaling \$3,836.11 remains in the account and will be applied toward formal dissolution of the JPA.

Due to the lack of activity and limited fund balance, an annual outside audit is not warranted. The City of Garden Grove will take the lead to terminate the JPA's existence during Fiscal Year 2015-16.

I have reviewed the Orange County Grand Jury Report, Joint Powers Authorities: Issues of Viability, Control, Transparency, and Solvency. On behalf of the Garden Grove Public Financing Authority (GGPFA), I am providing responses to Findings F1 and F3 through F6, and Recommendations R1 through R4, as requested by the Grand Jury.

#### Response to Findings

**F1:** Orange County has nine "inactive" Joint Powers Authorities that have no viable activity, revenue, expenditure, assets, or liabilities. The Grand Jury determined that these Joint Powers Authorities serve no benefit to the public or the taxpayers and have the potential for misuse or obfuscation of public funds.

The GGPFA disagrees wholly with this finding. The GGPFA has viable use and benefits to the public and taxpayers, and does not misuse or obfuscate public funds.

The GGPFA is a conduit entity used to facilitate debt financing for the City of Garden Grove and related entities. It provides a mechanism for the financing of public capital improvements for members through the purchase by the Authority of obligations of a member pursuant to bond purchase agreements and/or the loan of funds to a member. The GGPFA has enabled the issuance of several outstanding bonds with maturity extending through 2030; as a result, the JPA cannot legally be dissolved. The GGPFA will also be used in the future for other public financing activities.

F3: Orange County has 18 vertical Joint Powers Authorities created by a city along with its redevelopment agency that no longer exists. The Grand Jury determined that these Joint Powers Authorities serve no benefit to the public or the taxpayers and have the potential for misuse or obfuscation of public funds.

The GGPFA disagrees wholly with this finding. The members of the GGPFA are the City of Garden Grove, the Garden Grove Sanitary District, and former Redevelopment Agency whose rights and obligations were assumed by the Successor Redevelopment Agency. Further, the GGPFA still has outstanding bonds and obligations facilitated by the JPA through a maturity date of December 2030.

**F4:** Vertical Joint Powers Authorities with a single controlling entity, such as a city council, have the potential to use this organizational structure as a shell company to avoid other legal constraints on the controlling entity and to obfuscate taxpayer visibility.

The GGPFA disagrees wholly with this finding. The GGPFA is a legally authorized public entity that provides an effective mechanism to issue debt when needed. Moreover, the GGPFA is administered by a Board of Directors at publically noticed and held meetings.

**F5:** Vertical Joint Powers Authorities in which the controlling entity transfers assets from itself to a Joint Powers Authority for the purpose of obtaining additional funding, or signs a long-term lease to a Joint Powers Authority to obtain assets, are avoiding transparency and are not acting in the best financial interest of the taxpayers.

The GGPFA disagrees wholly with this finding. The use of the JPA is an efficient and cost effective mechanism of capital financing for the City, its related agencies, and taxpayers. The GGPFA has no information that would support the finding of the Grand Jury that vertical Joint Powers Authorities in which the controlling entity transfers assets from itself to a Joint Powers Authority for the purpose of obtaining additional funding, or signs a long-term lease to a Joint Powers Authority to obtain assets, are avoiding transparency and are not acting in the best financial interest of the taxpayers.

**F6:** 32 of the Joint Powers Authorities identified in Orange County are not complying with the California State reporting requirements in code Section 6500 and SB 282 according to the latest information available from the year 2013.

The GGPFA disagrees wholly with this finding. The GGPFA complies with the California State reporting requirements through its reporting in the City of Garden Grove's Comprehensive Annual Financial Report.

The recommendation will not be implemented because it is not warranted. The GGPFA is active as indicated in the response to F3 above.

**R3:** All Joint Powers Authorities should take the following actions to insure transparency to the taxpayers: 1) have an annual outside audit, 2) post the complete audit on their city website as a separate Joint Powers Authority entity, 3) send the audit to the County Controller and the State Auditor, and 4) ensure the required reports are filed annually to the County and the State. (F.4., F.5.)

The recommendation will not be implemented because it is not warranted. The GGPFA financial transactions are included in the annual audit of the City of Garden Grove by an outside auditor and disclosed in the footnotes of the Comprehensive Annual Financial Report (CAFR). The CAFR is posted annually on the City's website and appropriate documentation is sent to the State.

**R4:** The 32 Joint Powers Authorities that are not complying with the California State Law requiring annual reporting should become compliant by submitting their 2014 report by December 31, 2015, and submitting the required reports annually thereafter. (F.6.)

The recommendation has been implemented. The GGPFA believes it is in compliance in the context of submitting its reports through the City's annual CAFR.

Enclosed is the August 2015 Investment Report which shows the financial institutions, types of investment instruments, monthly transactions, current month interest received, and the par and fair market value of investments held. The month-end cash in the bank and petty cash balances are also listed on the Cash and Investment Report. The pie chart reflects the investment instruments as a percentage of the total portfolio.

This investment portfolio meets State guidelines and adheres to the City investment policy. As of August 2015, the City invested 19.485% of its total portfolio in treasury securities and 56.706% in federally backed securities. 18.532% of the portfolio or \$37.093 million is invested in the Local Agency Investment Fund (LAIF) managed by the California State Treasurer. A portion of the investment portfolio is restricted as they are funds held and invested by an outside fiscal agent. The restrictions were set forth in the related bond indentures. As of August 2015, 5.277% of the portfolio is restricted. Please see chart on attachment A.

In summary, the investment portfolio is secured and the City has the necessary cash to pay its bills for six months in a timely manner.









ORANGE · A professional photographer accused of sexually assaulting a girl possessing child pornography was facing multiple felony charges Tuesday.

Andrew Christopher Brown, 42, of Orange has been charged with felony possession and control of child pornography, sexual penetration by a foreign object, oral copulation of a minor and forcible oral copulation, according to the Orange County District Attorney's Office.

Brown is being held in lieu of \$500,000 bail and is scheduled to appear in court for arraignment on Oct. 16.

Between June 2014 and August 2015, Brown is accused of meeting the girl and offering to take photographs of her. During that time, he is accused of taking sexually explicit photos of the girl and sexually assaulting her, prosecutors said.

A relative of the girl contacted the Orange County Sheriff's Department and reported the crime. The case was investigated by the Sheriff's Department with assistance from the Internet Angeles Los Crimes Against Children Task Force.

Brown is also accused of possessing and controlling child pornography on his personal computer and an external hard drive.

If convicted, Brown faces up to nine years in prison and mandatory lifetime sex offender registration.

## **Activists want state to honor South Vietnam**

Group seeks to have Oct. 26 be proclaimed Republic of Vietnam Day.



CHRIS HAIRE STAFF WRITER There is an effort in the Little Saigon community to get officials in Sacramento to follow the lead of Garden Grove, Westmin-

ster and Santa Ana and proclaim Oct. 26 to be Republic of Vietnam Day.

The constitution of the Republic of Vietnam, also

known as South Vietnam, went into effect Oct. 26, 1955, and Garden Grove resident Lac Tan Nguyen is leading the coalition of Orange County activists to get that day memorialized by the California Legislature.

Though these types of resolutions are largely symbolic, Vietnamese American activists say having such a day would show that officials are empathetic to the pain still felt by one of the most prominent ethnic communities in California. After the 20-year Vietnam War ended in 1975, many South Vietnamese fled and settled in California, with the two largest concentrations of Vietnamese residing in Little Saigon and in San Jose.

"We are asking the state to recognize the just cause of the Republic of Vietnam," Nguyen said. "After 40 years, it's time to ask local and state officials to recognize and memorialize the sacrifices of the (Vietnamese) people."

Garden Grove Mayor Bao Nguyen, whose city passed a similar resolution in 2014 about a month before he won his election, said it would be "wonderful" if California made Oct. 26 Republic of Vietnam Day, but he added he would like to see more action to meet the needs of the community.

"I think people would be happy, but it's just another resolution," he said. "If they really wanted to recognize the community, the Legislature would do something real. What about the youth or the discrepancy in health care?"

Leaders of the Steering Committee for the Republic of Vietnam Day Resolution also are asking San Jose and several Orange County cities near Little Saigon, including Anaheim, Stanton, Irvine and Fountain Valley, for similar proclamations.

"As a Vietnamese refugee who fled Vietnam on a wooden boat across the South Asia Sea, I personally understand the struggle that the Vietnamese people have endured since the fall of Saigon," Sen. Janet Nguyen, R-Garden Grove, said in a statement. "Consequently, I will review the proposal once we get an official request."

Business owners are being warned that the Department will never ask for a fee to be paid at the time of the inspection so do not pay for anything on site. Owners and their representatives always have the right to ask for identification or refuse entry if they question the legitimacy of the company or individual.

The Fire Department has paired with the Police Department and neighboring jurisdictions, to educate the community, and to go after these individuals that may leave the pubic exposed to fire dangers.

"Preying on hard-working citizens in our city and anywhere else is morally wrong, and we will not tolerate it," said Fire Chief Tom Schultz.

In its campaign to educate the public, the department is proactively reaching out to businesses with information to avoid falling for these questionable practices that may endanger the public. In addition, the Police Department will be investigating potential fraud cases, and going after these individuals and companies.

## Case of West Nile Virus reported in GG

Vector Control will post warning signs around city as a result

The Orange County Mosquito and Vector Control District (OC-MVCD) has advised Garden Grove city officials that one human infection of West Nile virus has been reported in Garden Grove.

Additionally, 11 mosquito traps set by the OCMVCD in Garden Grove found mosquitoes infected with the West Nile virus.

As a result of these latest findings, the district will be posting signs at the entries, and other prominent locations, of all Garden Grove parks. The signs will warn the public of mosquitoes infected with West Nile virus being found in the location, along with precautions to avoid being infected.

According to the OCMVCD, similar actions are also being taken in Fullerton, La Habra, Yorba Linda, and Anaheim.

OCMVCD makes the following recommendations to avoid being bitten by mosquitoes:

- Eliminate any standing water around your house;
- Make sure all window and door screens are in good condition;
- Wear a repellent containing DEET, Picaridin, Oil of Lemon Eucalyptus or IR 3535;
- Contact the Orange County

Mosquito and Vector Control District to report dead birds or neglected pools.



## \$250 million Garden Grove hotel, water park to open in March

Great Wolf Lodge Southern California, a 603-suite hotel and 105,000-square-foot water park, is now accepting reservations with rooms available starting in March.

Reservations range from \$260 to about \$600, depending on the suite and when customers visit.

The \$250 million Garden Grove resort is on schedule for completion and on budget, said Chad McWhinney, CEO of Great Wolf developer McWhinney.

It will be Southern California's first indoor water park and the largest of Great Wolf's 14 facilities. The resort will bring in an estimated \$8 million annually in tax revenue to the city, which would be the most from any Garden Grove hotel.

Construction began in May 2014. Some rooms are finished and furnished. Fort Mackenzie – a multilevel tree house water fort – is installed in the park.

Resort officials gave an inside look into the seven eateries that will occupy space inside the resort, including Bear Paw Sweets & Eats and Dunkin' Donuts.

"This is a new, flashy property for us," said Ruben Rodriguez, whose second day as Great Wolf CEO was Wednesday, "It makes us a coast-to-coast brand."

Only hotel guests will use the water park and its 565,000 gallons of water that, Arthur pointed out, amount to less than it takes to fill an Olympic-size swimming pool.

Garden Grove officials have said they aren't worried about Great Wolf's water usage, pointing out it will operate a state-of-the-art recycling system with mechanized pumps, filters and tanks to purify the water before circulating it back into the park's common water areas. An estimated 11,000-plus gallons will be lost a day, via dripping bathing suits and evaporation.

## Does sunny Southern California really need an indoor water park?

alifornia's first indoor water park will debut in mid-February when the oftdelayed \$300-million woodsy-themed Great Wolf Lodge finally opens in the Disneyland area.

During a press preview on Wednesday, I walked through the framed and airtight Great Wolf Lodge Southern California hotel and entertainment complex still under construction in Garden Grove about a mile from Disneyland. Crews continue to work on the project, with exposed drywall, plywood, insulation, ductwork and I-beams still present throughout the 328,000-square-foot building. None of the rustic mountain cabin theming was in place yet in the public areas of the hotel. The rooms, which run from \$250 to \$600 depending on the season, have a cozy log cabin design with wilderness and outdoors themes.

The water park remains further from completion, with a water play structure and a few slides already in place. A pile of dirt sits at the center of the 75-foot-tall complex that is about the size of a college or pro football indoor practice facility.

In the works since 2010 when the project was first announced, the 105,000-square-foot indoor water park in Garden Grove will be the largest in Great Wolf's history and among the biggest in the world. Of course, it will be dwarfed by the world's largest indoor water park: Germany's 710,000-square-foot Tropical Island, housed in a former blimp hangar. And at approximately 2 1/2 acres, the Garden Grove indoor water park will be far smaller than a typical 15- to 20-acre outdoor water park.

Although the Los Angeles area boasts a 73% chance of sunshine throughout the year, according to the National Weather Service, none of the local water parks operate very far outside the summer season. Knott's Soak City, Six Flags Hurricane Harbor and Raging Waters San Dimas typically run

a weekends-only schedule in September before closing down for the season.

Great Wolf operates 12 other water park hotels in colder North American climates that promote the year-round destinations as "weatherproof fun." The Wisconsin-based chain has built several hotels near theme parks and water parks, including locations near Cedar Point and Kings Island in Ohio, Busch Gardens Williamsburg in Virginia and Schlitterbahn Kansas City. The first Great Wolf Lodge opened in 1997 in Wisconsin Dells, a tiny Wisconsin town with 18 water parks that rightly proclaims itself the "water park capital of the world."

Like all Great Wolf lodges, the California water park will be for use only by those staying at the hotel, although day passes will be available for visitors of registered guests. A digital wristband will provide access to the water park while also serving as a room key and electronic wallet.

The indoor water park will feature a mat racer slide, tube slides, body slides, wave pool, lazy river, interactive play structure and kiddie water playground. Among the highlights in Garden Grove: A six-story funnel slide, a surfing simulator and a trapdoor-launched 360-degree looping slide. The marquee attraction is expected to be a Slideboard that combines a Guitar Hero-like video game with a water slide.

Unlike the Great Wolf Lodges in Pennsylvania and Ohio, the Garden Grove hotel won't be getting a hydromagnetic water coaster that propels raft riders over whoop-de-do hills and down high-speed drops.

With the continuing drought in California, Great Wolf will undoubtably face questions about water usage when the 565,000-gallon park opens next year. Officials say the indoor park will recirculate up to 90% of its water and experience less evaporation than outdoor parks.

The Garden Grove property expects to use 149,500 gallons of water per day, according to a 2010 report obtained by the OC Weekly. That translates to more than 50 million gallons of water per year.

Billed as a family-friendly resort, the Garden Grove hotel will include several non-water-park-related activities, including a motion simulator ride, miniature golf, video game arcade, miniature bowling alley and kids spa. Wiley the wolf and five other costumed characters will make regular meet-and-greet appearances.

The opening of the new lodge also brings the first MagiQuest live-action role-playing game to California. Using infrared-emitting magic wands, players conduct a dozen interactive scavenger hunts throughout the hotel, including a battle with a dragon. The MagiQuest wands will also

animate small animatronic animals in some hotel suites. Mercifully, there is an override switch for parents with the noise-emitting creatures automatically switching off at 11 p.m.

The 600-room suites-only lodge will also feature seven dining options, including sit-down restaurants, a bakery and a Dunkin' Donuts.

### CITY APPROVES DISTRICT-BASED ELECTIONS FOR 2016

California Voting Rights Act Lawsuit Against City Settled

Following tonight's special meeting of the Garden Grove City Council, the City announced that a settlement had been reached in a lawsuit brought against the City in July asserting that the City's current "at-large" method of electing City Council members violates the California Voting Rights Act. Pursuant to the settlement, a stipulated judgment will be entered requiring the City to replace the current at-large election process with a by-district election process for all five city council seats, commencing in 2016. After 2016, the Mayor will no longer be directly elected, but, instead, will be appointed by the rest of the City Council, similar to the system used in many other Orange County cities.

The lawsuit, filed by Garden Grove resident Rickk Montoya, sought a court order mandating that the City implement district-based elections in accordance with the California Voting Rights Act. The California Voting Rights Act prohibits public agencies from imposing an at-large method of election "that impairs the ability of a protected class to elect candidates of its choice or its ability to influence the outcome of an election."

Montoya's lawsuit claimed that Garden Grove residents of Latino background were denied effective political participation in Garden Grove City Council elections.

Pursuant to the settlement, five, non-overlapping, geographically-defined electoral districts will be drawn, and the City Council will consist of one member who resides within, and is nominated and elected by voters within, each of those five districts. The Electoral District Map will be designed in accordance with the California Government and Elections Codes.

The City will retain a demographics firm to assist in developing the district maps. The City will hold a series of community meetings and public hearings to obtain community input before finalizing the district maps.

In establishing districts, the City Council may take into account topography, geography, cohesiveness, contiguity, integrity, and compactness of areas, as well as community interests of the district. The size of the districts must be as nearly equal in population as is reasonably possible.

In November 2016, three seats of the Garden Grove City Council will be up for election. Another two seats will be up for election in 2018. Which three district seats will be up for election in 2016 will be determined in conjunction with the map drawing process. All five City Council members elected under the new by-district system will serve four-year terms.

Currently within Orange County, the City of Seal Beach employs the most similar 5-district electoral system in which the Mayor is appointed by the City Council. The majority of Orange County cities also have appointed Mayors instead of at-large Mayoral elections.






