1. PUBLIC HEARING ITEM(S):

a. CONDITIONAL USE PERMIT NO. CUP-015-2014

APPLICANT: Tho Thanh Huynh
LOCATION: 13075 Euclid Street

REQUEST: To operate an existing 30,294 square foot supermarket, Dalat Supermarket, with a new original State Alcoholic Beverage Control Type "21" (Off-Sale, General) License. The site is in the CCMU3 (Civic Center Mixed Use 3) zone. The project is exempt pursuant to CEQA Section 15301– Existing Facilities.

b. CONDITIONAL USE PERMIT NO. CUP-016-2014

APPLICANT: Larry Slagle (Yellow Cab Service/WTS)
LOCATION: 13571-13591 Harbor Boulevard

REQUEST: To operate a vehicle fleet storage yard for Western Transit Services that will be used to store passenger vans/mini-buses to transport primarily developmentally disabled and elderly passengers. Western Transit Services vehicle fleet storage operation will occur in conjunction with the operation of Yellow Cab Taxi. The site is in the C-3 (Heavy Commercial) zone. The project is exempt pursuant to CEQA Section 15301- Existing Facilities.

c. CONDITIONAL USE PERMIT NO. CUP-017-2014

APPLICANT: Sarmad Matti
LOCATION: 10664 Garden Grove Boulevard

REQUEST: To operate an existing liquor store, Star Liquor, with a new original State Alcoholic Beverage Control Type "21" (Off-Sale, General) License. A Conditional Use Permit (CUP) is required when there is a change of ownership and no existing CUP for alcoholic beverage sales. The site is in the GGMU3 (Garden Grove Mixed Use 3) zone. The project is exempt pursuant to CEQA Section 15301- Existing Facilities.
