RE: Response to Orange County Grand Jury Report, *OC Recycling: Doing it the Right Way*

Dear Judge Nakamura:

The City of Garden Grove has reviewed the Orange County Grand Jury Report, *OC Recycling: Doing it the Right Way*. In compliance with California Penal Code sections 933 and 933.05, the City has responded to each of the findings and recommendations included in the report. Each finding and recommendation is listed below, followed by the City's response.

### Findings

F1. In nine of the ten cities investigated, the waste hauler has been the sole source provider to their respective city (s) anywhere from 39 to 72 years. Where there is an opportunity for service providers to compete, there is an opportunity for competitive bidding, which may result in improvements in cost and performance.

The City of Garden Grove agrees with this finding.

F2. The labeling on residential bins are not always legible or have comprehensive enough instructions laminated or otherwise made a part of the lid, especially with regards to single use plastic shopping bags. Education and outreach efforts need to be reinforced as often as possible and a visual reminder on the recycle container will help alleviate confusion.

The City of Garden Grove agrees with this finding.

F3. Orange County Waste and Recycling as well as the waste haulers provide helpful recycling education to the public where contractually required to do so. It is the Grand Jury's view that most cities delegate much of the customers/public education efforts to the waste haulers. Contracts indicate both parties are responsible for educating the public.

The City of Garden Grove disagrees partially with this finding. The City and waste hauler have shared recycling education responsibilities. The City of Garden Grove provides recycling educational outreach through the City website, public events, facebook, and at the public counters. The City has also participated in school outreach through the Discovery Cube's Eco Challenge program. The waste hauler provides recycling educational outreach through the hauler website, City related public events, school assemblies and at chamber of commerce meetings.

- F4. Cities are not in compliance with AB 341 mandates with respect to providing recycling containers for multi-family units.

The City of Garden Grove disagrees partially with this finding. The City has an AB 341 modified plan that has been approved by CalRecycle. The City has been progressively providing recycling containers for multifamily units as a result of actively mailing each multifamily unit a survey twice a year. This survey reminds multi-family units of the need to either obtain a recycling bin or adopt a recycling program, and documents third-party, or self-recycling activities performed at the multi-family units. Next year, the City will adopt a local mandatory ordinance for multi-family units to sign up for recycling services.

#### Recommendations

- R1. All cities and county entities that do not have a contract review process in place should establish one to ensure regular reviews of service contracts are performed and that contract terms are still relevant as legislative changes are enacted. Serious consideration should be given to shortening the length of contracts to facilitate opportunities for competitive bidding where feasible. (F1)

The recommendation has been implemented. In regards to a contract review process, the City meets with the waste hauler on a monthly basis to discuss agreement terms and operational concerns. The City has also hired a solid waste consultant expert to assist the City in these monthly reviews with the waste hauler to ensure service contracts are performed and legislative changes are enacted. The recommendation for a shorter length of contract has also been implemented. Over time, the City has reduced contract lengths and currently has a 14 year agreement in place ending in June 2024. Once the current agreement has ended, the City plans to participate in competitive bidding. The City must also be mindful that residential carts and containers and the equipment to collect them varies by hauler. New contracts usually require the purchase of new equipment and distribution of new carts/containers by haulers. Shorter contract terms require haulers to amortize their costs/investments into shorter periods that yield higher costs to residential customers.

- R2. Municipalities should ensure that recycle bins be labeled with comprehensive recycling instructions to facilitate proper sorting of waste (F2 and (F3).

The recommendation has not yet been implemented because the current waste hauler has determined labeling bins is not cost effective in comparison to continuing proactive public education and outreach including posting a detailed list of eligible recycling materials on both the City and waste hauler websites. The City

will consider this type of bin labeling in the future bidding process along with providing ongoing proactive recycling education.

- R3. Cities, that have not already do so, should implement the requirements of AB 341 as they pertain to multi-family recycling programs. Additionally, such programs need to be closely monitored by city contract administrators rather than relying solely on waste haulers to fulfill the mandates (F4).

The recommendation has been implemented. An AB 341 modified plan has been approved by CalRecycle. AB 341 compliance by businesses and multi-family units, that meet the threshold of AB 341, is monitored during monthly meetings by reviewing data submitted by the hauler, and data gathered from aforementioned surveys. The City and solid waste consultant expert closely monitor legislative mandates on an ongoing basis to ensure the City and waste hauler achieve compliance.

OBJECTIVE

To provide City Council with information on the current capital improvement projects underway at City parks.

BACKGROUND/DISCUSSION

During this past year, Community Services and Public Works have collaboratively worked on several capital improvement projects throughout city parks. Staff utilized the 15-year Parks, Recreation and Facilities Master Plan to help develop a list of improvements. The following is a list of projects that have been completed and/or are currently underway.

**Eastgate Park**

In May 2020, staff contracted with USA Shade Company for the purchase and installation of a shade unit that was installed on the south side of Gary Hall pool at Eastgate Park. This new shade unit will provide shade to patrons that participate in pool programming at this site.

**Shelley Kensington Park**

Shelley Kensington Park, between Lampson Ave. and Stanford Ave., off Nutwood St. had improvements completed as part of the Right-of-Way project. The basketball court was removed from its previous location and placed next to the playground area in order to incorporate the newly added bike trail. Landscaping will also be added to this space.

**Faylane Park**

Public Works staff completed several projects at this park site, including revamping the pump house with a new look and design, adding drought tolerant landscaping around the perimeter of the pump house, and an updated color scheme that was applied to the pump house, restrooms, and picnic shelter. This project will serve as a template for future park and facility renovations to give facilities a more uniform look.

**Magnolia Park**

Public Works staff applied the new color scheme for City parks at Magnolia Park, which included painting the building exterior of the Family Resource Center, the picnic shelter, and handball courts.

**Atlantis Play Center**

The replacement of the Atlantis Play Center fence is currently underway. The project includes the removal and disposal of the existing 6-foot tall chain link fence and the installation of a ClearVu fence. The new fence will be 8 feet tall with an additional 1-foot angled top, making

the fence nearly 9 feet tall. The installation is projected to be completed by the end of September 2020.

### **Garden Grove Park**

In April 2020, staff was informed that there were CDBG funds available for a parks and facilities capital improvement project. Staff identified Garden Grove Park as an eligible location for CDBG grant funds. Staff then prepared a scope of work that included the demolition of the large picnic pavilion and the three small picnic shelters, and the construction of ADA accessible sidewalks, slabs, new picnic pavilion, three new picnic shelters, tables, benches, barbeque grills, new playground equipment and surfacing, playground shade canopies, and electrical improvements that will allow for additional security lighting.

Attached is the conceptual plan that was included with the project bid documents. The plan was used as a general outline for bidders, however, the selected bidder will need to develop and submit to the City an engineered plan for review and approval. Bids will open at 11:00 a.m. on Monday, August 31, and publicly read aloud via a scheduled teleconference. Staff intends to bring forth a contract for approval by the City Council in late September or early October.


These capital improvements have been funded by allocated budget of CDBG funds and Park Fee funds. Staff will continue working on additional park improvements as funds and resources become available.

The Community Services Department has provided information for current capital improvements at City parks.

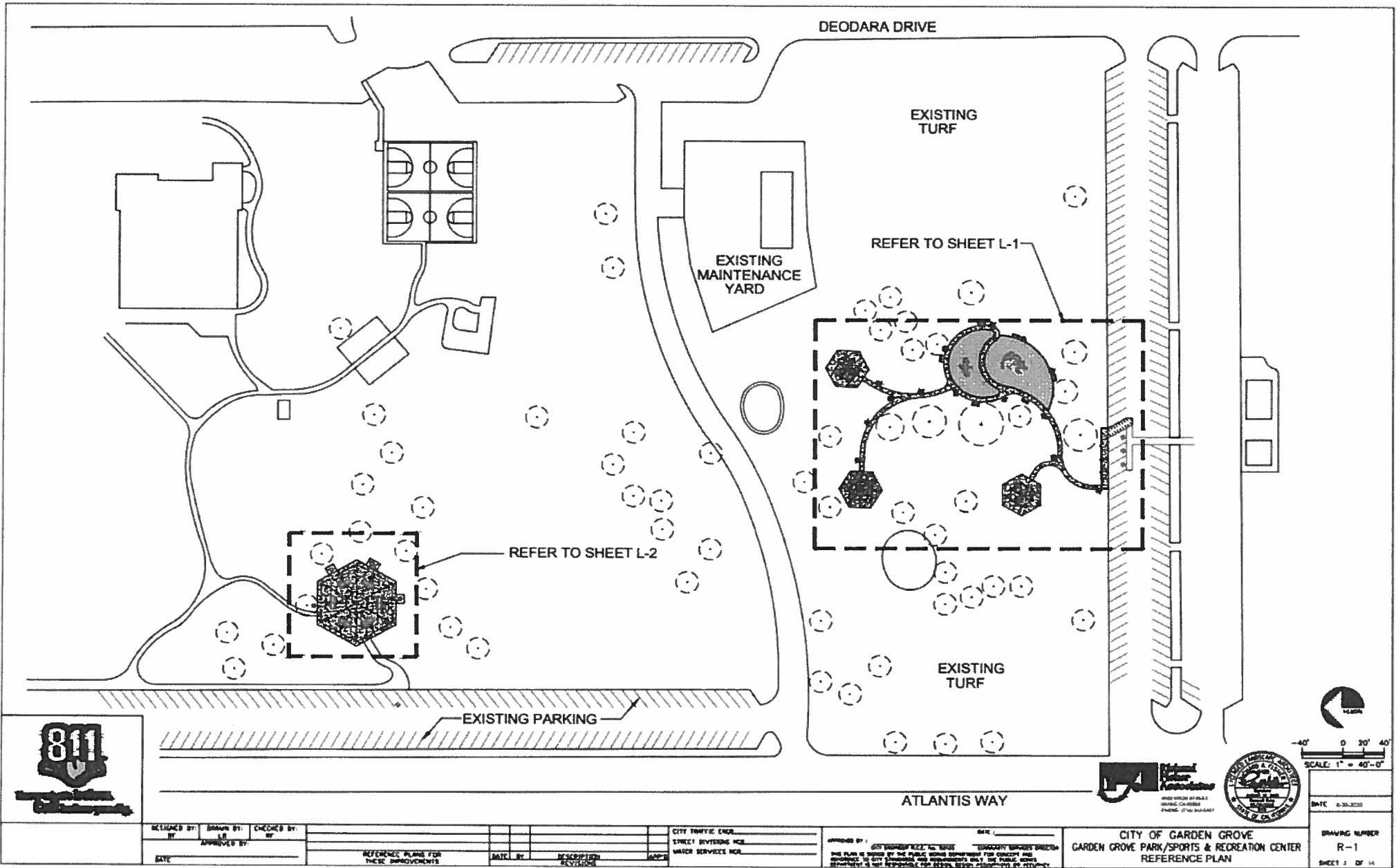

## **County of Orange Adds Second Supersite to its COVID-19 Testing Arsenal** *Large-scale drive-through coronavirus testing opens at OC Fair & Event Center August 26*

**Santa Ana, Calif.** (August 25, 2020) – Just six weeks after opening the Anaheim Supersite, the County of Orange announced today a second supersite opening at the OC Fair & Event Center in Costa Mesa on August 26.

360 Clinic will be conducting no-out-of-pocket cost testing leveraging personal insurance reimbursements and federal government assistance for the uninsured, with additional financial support from the County.

"I'm so pleased that we are opening this new test site to offer additional convenient access to testing for our residents, particularly for those within my district," said **Orange County Board of Supervisors Chairwoman Michelle Steel, Second District**. "Testing is one of the keys to our ability to slow the spread of the virus and still go about our business of getting back to work and enjoying life in our community."

"This new site in Costa Mesa bolsters our local testing capacity, enabling more symptomatic and asymptomatic Orange County residents within priority groups, to access free contactless testing with quick turnaround times on results," said **Vice Chairman Andrew Do, First District**. "To make our testing network better still, the county is establishing a call center and making website registration options accessible in multiple languages to ensure that all residents, no matter their primary language, have equal access to vital testing services."

Tests will be available for individuals prioritized for testing by the California Department of Public Health:

- People with symptoms
- Close contacts with people known to have COVID-19
- Healthcare workers, first responders
- Residents and employees of congregate living facilities
- Essential workers (grocery store, food supply, utility workers, public employees and teachers)

"There are three key messages we want to convey to people who may have been reluctant to get tests – particularly at our supersites," said **Third District Supervisor Donald P. Wagner**. "1. Wait times in your car are generally no more than 30 minutes. 2. The tests are self-administered, safe, easy and pain-free. 3. Results are available in 24 to 48 hours so you can quickly determine whether you test positive for COVID-19 or not and plan accordingly."

"We are committed to continuing to offer testing options to our residents that are easy and convenient for all of Orange County's residents. Tests are just one tool in our arsenal to beat the novel coronavirus, but it's a powerful tool," said **Fourth District Supervisor Doug Chaffee**.

**Fifth District Supervisor Lisa A. Bartlett** added, "Our goal is to do everything we can to slow the spread of COVID-19 including making it as easy and convenient as possible for residents to get tested. The addition of the



Costa Mesa Supersite will hopefully bring us one step closer to achieving that goal. The more options that are available for people to get tested and get results in a timely manner, the quicker we can mitigate the spread of the virus. In addition to the extensive test site locations, we've launched major marketing, advertising and community outreach campaigns centered around the importance of protecting yourself and each other by wearing a face covering, washing hands frequently and staying six feet apart."

**Costa Mesa Mayor Katrina Foley** added, "We know that mass testing with prompt results combined with mask wearing and social distancing is necessary for our kids to return to in-person school and our business community to reopen. This Supersite, the second largest in California, opens up another path on our road to recovery. We are grateful that the City of Costa Mesa and the OC Fair will host and support this important public health program."

"The good news is that our seven day daily case count is going down compared to where we were in July. This is especially encouraging given the additional testing capacity we've added," said **Orange County Director of the OC Health Care Agency and Acting County Health Officer Dr. Clayton Chau**.

Orange County residents who meet the Public Health criteria may register online starting today at <https://360clinic.fulgentgenetics.com/>. Participants will be asked to provide their contact information along with their health insurance information (if they have it) while selecting their appointment date and time. Once a resident has successfully registered, they will receive a confirmation text or email. They will be required to show this confirmation on the date and time of their registration in order to be tested.

Starting on Wednesday, August 26, the Costa Mesa Supersite will operate Mondays – Fridays from 7 a.m. to 3 p.m. Questions can be directed to 360 Clinic representatives at (800) 446-8888. ## **Clayton Chau, M.D., Ph.D. Selected as County Health Officer**

**Santa Ana, Calif. (August 26, 2020)** – In unanimous vote by the Orange County Board of Supervisors yesterday, Clayton Chau, M.D., Ph.D., was selected as County Health Officer.

Dr. Chau will serve as the Director of the OC Health Care Agency (HCA) as well as County Health Officer. He was hired on as the HCA's Director on May 4, 2020 and subsequently assumed the role as Acting County Health Officer on June 9, 2020.

Dr. Chau worked for the HCA's Behavioral Health Services team from 1999-2012 and was most recently Chief Clinical and Strategy Officer for Mind OC, the not-for-profit created to support the advancement of Be Well OC.

In addition to his time at Mind OC, Dr. Chau was previously employed by Providence Health System, the third largest health system in the country, as the Regional Executive Medical Director of the Institute of Mental Health and Wellness, Southern California Region. Dr. Chau was also appointed by the 23rd U.S. Secretary of Health and Human Services serving on the Interdepartmental Serious Mental Illness Coordinating Committee.

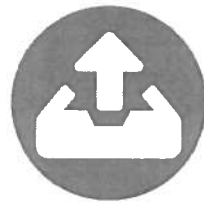
His past positions include Senior Medical Director for Health Services at L.A. Care Health Plan, the largest nonprofit health plan in the nation, responsible for behavioral health, care management, utilization management, and disease management. In that capacity, Dr. Chau was actively involved in the development of the Los Angeles County Whole Person Care Program. He was also the Co-Principal Investigator for a multi-year Center for Medicare & Medicaid Services 'Innovation grant in Transforming Clinical Practice.

Dr. Chau received his PhD in Clinical Psychology from Chelsea University in 2004, and his medical degree from the University of Minnesota in 1994. He completed his psychiatry residency at the University of California, Los Angeles/San Fernando Valley followed by a fellowship with the National Institute of Mental Health in psychoneuroimmunology focusing on substance use disorder and HIV. Additionally, he has served as an Associate Clinical Professor and Lecturer at a variety of renowned academic institutions including the University of California, Los Angeles and the University of California, Irvine. Dr. Chau has conducted international trainings in the areas of health care integration, health care system reform, cultural competency and mental health policy.

The City of Garden Grove is updating the Housing Element, Safety Element, Land Use Element, and adopting a new Environmental Justice Element to the Garden Grove General Plan. The community is invited to participate in an online survey available Monday, August 31, 2020 through Friday, September 25, 2020 to provide input towards creating a community housing strategy for the next eight years as well as a healthier community. The survey, available in multiple languages, can be accessed at [ggcity.org/housing-element](http://ggcity.org/housing-element).

In California, cities are required to develop a general plan, a blueprint for future developments in the city that establishes goals, objectives, and policies. The Housing Element, a component to the general plan, is mandated by the state to be updated every eight years to identify housing needs for all income levels during specific planning periods by meeting its Regional Housing Needs Assessment (RHNA) allocation. The City of Garden Grove's RHNA housing allocation for the 2021-2029 planning period is projected to be 19,124 units. Information about the RHNA methodology and allocation are available at [scag.ca.gov/rhna](http://scag.ca.gov/rhna).

The City is also updating the Safety and Land Use elements and adopting a new Environmental Justice Element to establish policies mandated by the state. The Safety Element establishes policies that will minimize the risk of personal injury, loss of life, property damage, and environmental damage associated with natural and man-made hazards. The Land Use Element reviews the uses of land for housing, businesses, industries, agriculture, open space, public facilities, and other categories. The new Environmental Justice Element will establish policies to reduce pollution, and to provide residents with access to healthy food, physical activity, and safe and sanitary housing.

Updating the elements in the Garden Grove General Plan is a 14-month process. Over the next four months, community surveys will be conducted online, and meetings will be held in compliance with the state and county COVID-19 orders. 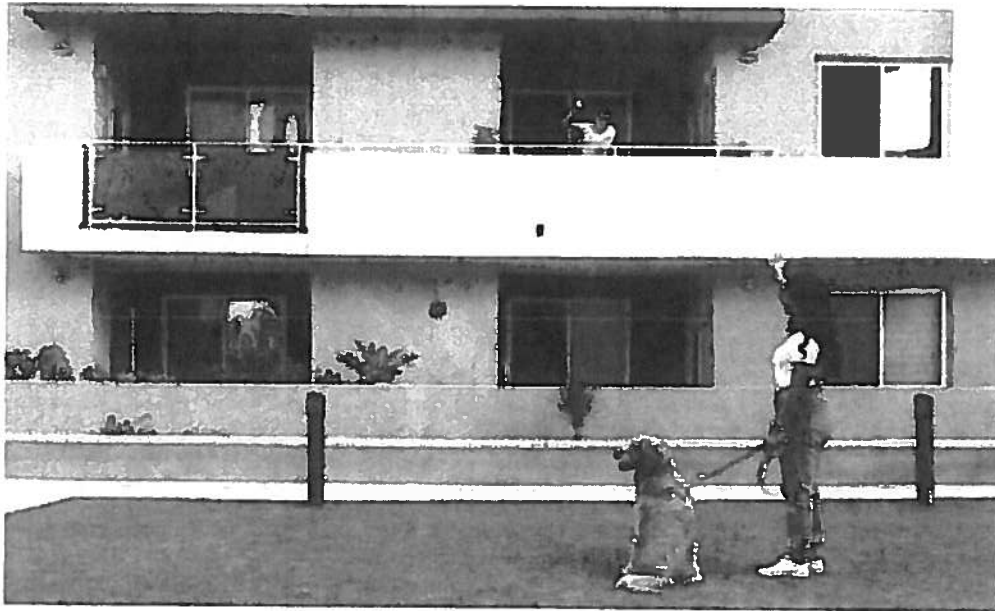

# Senate and Assembly Appropriations Committees Decide Fate of Key Measures; Prepare for Final Floor Votes on Bills of Interest to Cities

Legislature has until Aug. 31 to send bills to Governor's desk

*August 21, 2020*

The Appropriations Committees of both houses met on Thursday, Aug. 20 to decide the fate of hundreds of bills, albeit significantly fewer than usual due to the truncated session schedule impacted by COVID-19 and the health crisis.

Following these committee hearings, the stage is now set for the final days of the legislative session, as the Legislature faces a quickly approaching Aug. 31 deadline to send bills to the Governor.

Below is a complete list of bills on which the League has a position that were pending on the Senate or Assembly Appropriations Committees suspense file. Those that passed, including some with amendments, are listed as "Pass," and those that failed to move are listed as "Held." The held measures were tabled and are ineligible for further action this session.

## **Key Results**

The COVID-19 pandemic shifted the primary focus of the Legislature to the public health response and economic recovery. Nonetheless, several substantive housing measures persisted, some aimed at providing aid for the current emergency, and others focused on the longer looming housing crisis. The Appropriations Committees of both houses narrowed the number of housing-related measures moving forward, while bills that were championed by leadership moved forward, such as [SB 1120 \(Atkins\)](#), which would require a local government to ministerially approve a housing development containing two residential units (duplex) in single-family residential zones.

Cities, of course, need additional, sustainable funding to address and prevent homelessness and spur the construction of affordable housing. Unfortunately, League-sponsored legislation to create such a funding source, [SB 795 \(Beall\)](#), was held by the Assembly Appropriations Committee. The issue remains a key priority for the League in tackling statewide housing supply and affordability challenges.

Over the next two weeks, the Legislature will be particularly focused on preventing an impending "eviction wave" of California renters as evictions may legally resume on Sept. 2, absent further

action by lawmakers and Gov. Gavin Newsom.

In response to the growing transmission of COVID-19 and the proximity of public safety and other frontline workers to the virus, several lawmakers have pushed expanded presumptive eligibility for workers compensation that pose significant fiscal risks to public and private employers. While the safety and well-being of public employees is a priority for local governments, measures such as AB 664 (Cooper) and SB 1159 (Hill) currently violate reasonable standards of fairness under the workers compensation system. Both of these measures were approved and await floor votes.

As COVID-19 public health orders disrupt workplaces and private lives, lawmakers have sought to expand unpaid family leave. While the effort is notable, the construction of the current effort in SB 1383 (Jackson), which was approved by the committee, raises significant costs and liabilities for employers by requiring any employer with five or more employees to provide 12 weeks of protected leave each year with no relation to the current COVID-19 pandemic.

On issues related to taxation, the Assembly Appropriations Committee gave the green light to SB 1441 (McGuire), which is a critical measure that will allow the continued collection of the utility users tax from retail sales of prepaid wireless telecommunication products.

Several measures were introduced late in the session in response to the heightened attention on policing. While the Appropriations Committees largely decided to stall measures until at least next session, a handful were approved, including the League-supported AB 1506 (McCarty), which would require the California Department of Justice to, upon request, conduct independent investigations into officer-involved incidents of deadly force. Meanwhile, SB 776 (Skinner) was also approved, which would unjustifiably expand current law by providing for the disclosure of police personnel records for every incident involving use of force, regardless of whether the officer was exonerated or if a complaint was not sustained.

# Message from League Executive Director Carolyn Coleman on Coronavirus Response

August 26, 2020

Dear California City Leaders,

Earlier this month, U.S. Senators adjourned the legislative session through Labor Day and headed home for their annual summer recess, despite not coming to an agreement on the next coronavirus relief package. U.S. House members adjourned in late July, except for a brief return to Washington, D.C. last week, for a vote on emergency funding for the United States Postal Service.

While members of Congress take a break, California's cities and towns remain hard at work. City leaders are taking action to recover from a pandemic and safely reopen their local economies. They are supporting firefighters from both California and neighboring states as they work around the clock to protect our residents and contain wildfires raging across our state. And, as we read a new round of headlines about social unrest and systemic racism, city leaders are working to heal racial divisions and build more equitable communities.

As recess continues for some, city leaders remain on the front lines keeping our communities moving forward and maintaining services, ranging from public safety to street maintenance and inspections to permitting. California cities also face a \$7 billion revenue shortfall and are experiencing millions of dollars in unplanned expenses due to COVID-19.

Congress' failure to reach agreement on a new relief package that provides direct and flexible funding for cities will imperil cities' ability to maintain essential local services and force reductions in city workforces. We cannot let that happen, and cannot afford to wait any longer. That's why the League continues to send the message to federal lawmakers and the White House that cities nationwide need \$500 billion in assistance now to support local services and to offset the expenses associated with addressing COVID-19.

# League Weekly COVID-19 Update: Aug. 20-26

August 26, 2020

According to the [California State Controller's website](#), the second CARES Act payment was sent out to cities on Aug. 24. Cities can check online for their specific dollar amount.

On Aug. 26, the Governor announced that the state has entered a new contract with a private company to process up to an additional 150,000 COVID-19 diagnostic tests a day, with a contractual turnaround time of 24-48 hours. The goal is to stand up a laboratory facility and begin processing tens of thousands of additional tests by Nov. 1 and run at full capacity by no later than March 1, 2021.

The Governor stated that there will be new reopening guidelines later this week, and information regarding an economic stimulus plan, which will include eviction legislation, as jobs and economic growth and recovery remain a top priority.

As wildfires burn across the state, COVID-19 has presented additional challenges in combating the wildfires and protecting residents. Evacuation shelters now include health screening and assessments, mask requirements, social distancing guidelines, and air purifiers.

The Governor issued an [executive order](#) to address a variety of issues in response COVID-19 including increasing the income-eligibility threshold for the Community Service Block Grant program to support economic and community development efforts in response to the pandemic. The order also increases the availability of CLIA-waived COVID-19 testing, issuing waivers permitting pharmacists and pharmacy technicians to conduct CLIA-waived COVID-19 tests, which detect the presence of the virus.
