#### NOTICE OF APPLICATION OF SOUTHERN CALIFORNIA EDISON COMPANY TO INCREASE ELECTRIC RATES APPLICATION A.21-10-011

#### Why am I receiving this notice?

On October 29, 2021, Southern California Edison Company (SCE) filed its application with the California Public Utilities Commission (CPUC) requesting an expedited review and approval of its 2021 Energy Resource Recovery Account (ERRA) Revenue Requirement Trigger Mechanism Application (Application). The ERRA functions to recover the fuel and purchased power procurement costs SCE incurs to provide electric service to customers.

As of September 30, 2021, SCE was undercollected by \$698.726 million (Undercollection Amount) in recovering its actual procurement costs. SCE's Application is requesting to recover the Undercollection Amount concurrent with the implementation of SCE's 2022 ERRA Forecast rates, which are anticipated to go into effect on March 1, 2022.

#### Why is SCE requesting this rate increase?

Pursuant to CPUC rules and regulations, SCE is required to promptly increase rates to recover the Undercollection Amount. Rather than implement an immediate rate increase, SCE is requesting that the CPUC permit SCE to include the Undercollection Amount in rates concurrent with the implementation of SCE's 2022 ERRA Forecast rates, which are anticipated to go into effect on March 1, 2022.

#### How could this affect my monthly electric rates?

If the Undercollection Amount were to be put in rates today, the average residential monthly bill using 500 kWh per month would increase by approximately 2.8% (or \$3.85) per month for the average customer.

The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding are currently reviewing SCE's Application, including the Public Advocates Office of California, which is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. 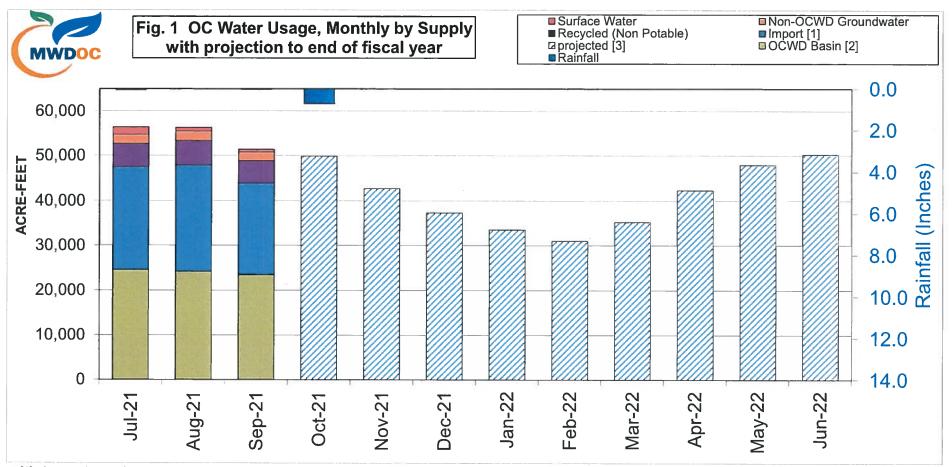
The attached figures show the recent trend of water consumption in Orange County (OC), an estimate of Imported Water Sales for MWDOC, and selected water supply information.

- OC Water Usage, Monthly by Supply in September.

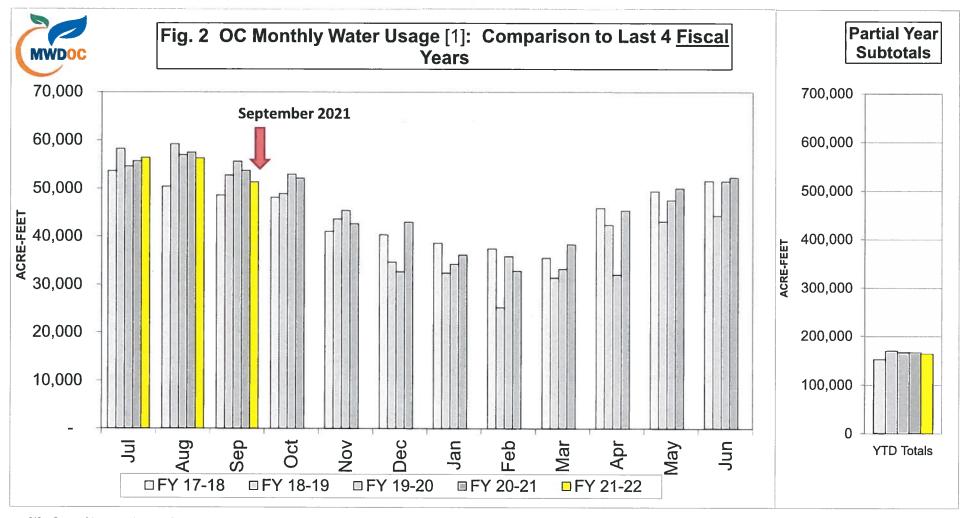
  OCWD Groundwater was the main supply in September.
- Estimated OC Water Usage, Monthly, Comparison to Previous Years Water usage in September 2021 was slightly below average compared to the last 5 years.
   We are projecting a slight decrease in overall water usage compared to FY 2020-21. On July 8<sup>th</sup> 2021, state officials have ask California residents to voluntary reduce their water usage by 15% compared to 2020 levels.
- Historical OC Water Consumption Orange County M & I water consumption is projected to be 534,000 AF in FY 2021-22 (this includes ~11 TAF of agricultural usage and non-retail water agency usage). This is about 26,000 AF less than FY 2020-21 and is about 2,000 AF more than FY 2019-20. Water usage per person is projected to be slightly lower in FY 2021-22 for Orange County at 151 gallons per day (This includes recycled water usage). Although OC population has increased 20% over the past two decades, water usage has not increased, on average. A long-term decrease in per-capita water usage is attributed mostly to Water Use Efficiency (water conservation) efforts. O.C. Water Usage for the period of Fiscal Years FY 2015-16 to FY 2019-20 was the lowest since the 1982-83 Fiscal Year (FY 1982-83 was the third wettest year on record). O.C. Water Usage in FY 2020-21 was the highest since FY 2010-11.

<u>Water Supply Information</u> Includes data on Rainfall in OC; the OCWD Basin overdraft; Northern California and Colorado River Basin hydrologic data; the State Water Project (SWP) Allocation, and regional storage volumes. The data have implications for the magnitude of supplies from the three watersheds that are the principal sources of water for OC. Note that a hydrologic year is Oct. 1st through Sept. 30th.

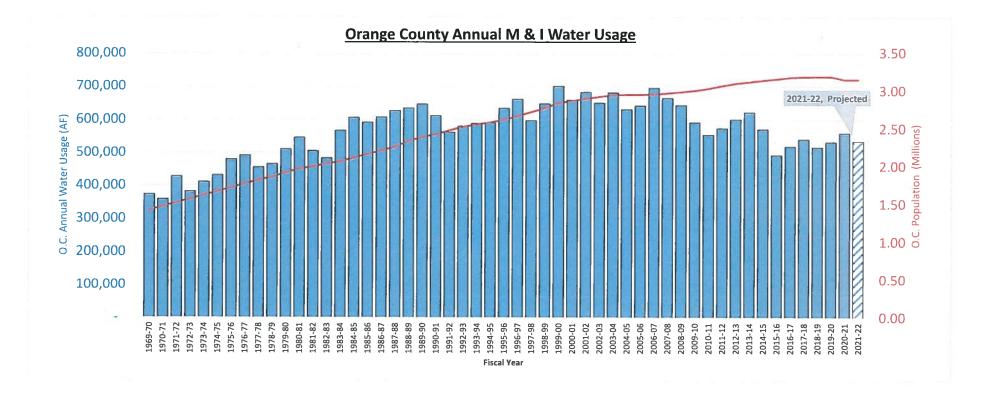
- Orange County's accumulated precipitation through *late October was* below average for this period. Water year to date rainfall in Orange County is *1.22 inches*, which is *222% of normal*.
- Northern California accumulated precipitation through late October was 416% of normal for this period. Water Year 2021 was 48% of normal while water year 2020 was 63% of normal. The Northern California snowpack was 66% as April 1st. As of late August, 100.00% of California is experiencing moderate to exceptional drought conditions while 100.00% of the state is experiencing abnormally dry conditions. The State Water Project Contractors Table A Allocation was lowered to 5% in March 2021.
- Colorado River Basin accumulated precipitation through late October was 138% of normal for this period. The Upper Colorado Basin snowpack was 74% of normal as of April 13<sup>th</sup>. Lake Mead and Lake Powell combined have about 45.0% of their average storage volume for this time of year and are at 32.1% of their total capacity. If Lake Mead's level falls below a "trigger" limit 1,075 ft. at the end of a calendar year, then a shortage will be declared by the US Bureau of Reclamation (USBR), impacting Colorado River water deliveries to the Lower Basin states. As of late August, Lake Mead levels were 8.36' BELOW the "trigger" limit. The USBR has declared a shortage on the Colorado River staring January 1st 2022. There is and a 97% chance of shortage continuing in 2023.

OC supervisors haggle over redistricting, should pick new map Nov. 22

Orange County supervisors still haven't picked a map that redraws their districts after three meetings on the subject, but on Tuesday they narrowed the choices down to two basic maps – one they'll consider as is when they meet next week, and four versions of a second map.

The maps the Board of Supervisors is considering appear to satisfy desires of voting rights advocates by putting residents in central Anaheim and parts of Orange, Garden Grove and Tustin together with Santa Ana to create a Latino-majority District 2. They also create a new District 1 that would shore up the influence of Asian American voters by keeping Westminster and Garden Grove together and adding Cypress, Los Alamitos, La Palma and Seal Beach along with part or all of Huntington Beach.

Representatives of activist groups such as the ACLU, Viet Rise and the Council on American-Islamic Relations continued Tuesday to urge the board to pick a version of a map originally submitted by the People's Redistricting Alliance – and one of the maps the board will consider next week is based on it.

Several South County officials including Laguna Niguel Mayor Fred Minegar asked the board to keep their communities in one district, and Airport Working Group President Mel Beale said John Wayne Airport should be in the same district as Newport Beach and other communities "most impacted by its operations."

District 3 Supervisor Don Wagner pushed back on those suggestions, arguing it could benefit South County communities to have two supervisors "attuned to their interests and responsive to them," and he said everyone in the county has an interest in the airport.

Several big issues still have to be decided: will Ladera Ranch and Rancho Mission Viejo be added to a new inland District 3, which includes Yorba Linda, Anaheim Hills, Lake Forest and Mission Viejo, or will they stay with coastal cities in a new District 5?

Irvine is currently split between District 3 and 5, and the new maps would do that too, but where to put a chunk of the city north of the 5 freeway is up for debate.

And where to put Costa Mesa is also in question. One map – which a majority of supervisors seem unlikely to choose, based on their comments Tuesday – keeps the city with Newport Beach and points south in a new District 5. Most variations of the other map move the city into a redrawn District 1, which generally stretches northwest from Fountain Valley.

District 2 Supervisor Katrina Foley objected to Costa Mesa being separated from Newport Beach (the cities share a K-12 school district) and being moved into a new District 1.

That change would put Foley (who won the District 2 seat in a March special election) in the same district as board Chairman Andrew Do; the two have publicly clashed at several board meetings. She's the only supervisor whose seat would be affected by any of the maps still under consideration.

"I've been here for six months and you're putting me in a district that is not up for reelection" until 2024, Foley said. "If you're trying to say it's not about political targeting, it's pretty obvious that it is."

Earlier in the meeting, Do responded to a resident's criticism of a map that draws a sitting supervisor out of their district by saying, "some of the consequences of map drawing is that sometimes it hurts some people."

The Board of Supervisors will meet to discuss redistricting and likely pick a final map at 1 p.m. Monday, Nov. 22, in the board hearing room at 333 W. Santa Ana Blvd., Santa Ana.

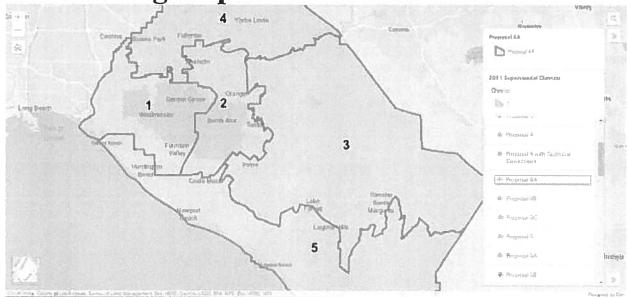

Brommer was taken to a local hospital for treatment but died from his injuries.

No description of the possible shooter was available, Carringer said.

OC Supervisors may make more changes to redistricting maps before final version chosen

The Orange County Board of Supervisors may have up to 14 map variations to choose from when it decides soon on new boundary lines for OC's five supervisorial districts.

The board is scheduled to meet Nov. 16 and Nov. 22 to consider proposed maps that incorporate the county's growth as recorded by the 2020 census. The boundaries supervisors choose now will remain in place until after the 2030 census.

While Los Angeles and San Diego counties are legally required by elections code to create independent redistricting commissions, how to run the process in Orange County is left to supervisors' discretion. Maps creating new districts were submitted by the public, but supervisors can move the lines around as they see fit, as long as the final product complies with the federal Voting Rights Act.

The board narrowed eight proposed maps down to three earlier this month, and then supervisors and their staffs tweaked the three proposals to create six more maps. Board Chairman Andrew Do told supervisors on Tuesday each can submit one more proposal with changes before they meet next week, for a potential total of 14 choices.

Each of the proposals so far would make fairly significant changes to existing supervisorial districts.

Santa Ana, Garden Grove and Westminster are currently grouped together in District 1. Most of the new proposals would carve out a Latino majority voting district including Santa Ana, part of Orange and the western portion of Anaheim.

Irvine is now split between two districts, something several people who spoke at Tuesday's board meeting wanted to see remedied. Several proposed maps would unite all of Irvine, with some grouping it with coastal cities Newport Beach and Laguna Beach, and one adding it to an inland South County district including Lake Forest, Mission Viejo and the unincorporated canyon communities.

Today OC's coastal cities from Newport Beach northward are in District 2, and from Laguna Beach southward are in District 5, which includes most of southern OC. One proposed map creates a district that runs the length of the county's coastline, minus Seal Beach, and another draws three districts that touch the sea.

Speakers on Tuesday again emphasized to the board they want a map that acknowledges the growth in the county's Latino population, now more than a third of OC residents, and one that doesn't split up or dilute the voting power of Asian American communities with shared political, social and economic interests.

Many commenters brought up the Voting Rights Act, which some said requires the county to create a Latino majority district. Senior Assistant County Counsel Nicole Walsh said that's not technically accurate – the law prohibits "practices that result in a denial or abridgement" of someone's right to vote based on race, so a map that appears to violate the law would be open to a legal challenge.

State elections code also requires that districts be contiguous (no islands cut off from their district), and that no more than 10 cities be split by the boundaries, Walsh said.

Any new maps supervisors may draw will be made public ahead of next week's meeting, when the board could make a decision or punt to the next meeting. Regardless, county officials hope to wrap up the process and see the board take a final vote on everything (including an ordinance that goes with the map) on Dec. 7.

## Congress passes \$1.2 trillion infrastructure bill: Here's what California cities can expect

Nov 10, 2021

After months of negotiation, Congress sent the massive \$1.2 trillion Infrastructure Investment and Jobs Act to President Joe Biden for his signature. The Act includes \$550 billion in new federal investments and will add an estimated two million jobs per year to the national economy. The legislation, which stalled in the U.S. House of Representatives after its passage in the Senate during the summer, ultimately passed with bipartisan support in both chambers.

Broadly speaking, the bill provides funding for the nation's roads, bridges, and public transportation infrastructure, with a strong focus on climate change mitigation, resilience, and equity. It also contains funding for a network of electric vehicle chargers, broadband internet, cybersecurity, clean water, and airports.

For years, California cities have called on the federal government to invest in local infrastructure. Although more funding is needed to fully repair the state's infrastructure, the measure will make significant investments in California, including:

- \$25.3 billion for federal-aid highway apportioned programs and \$4.2 billion for bridge replacement and repairs over five years
- \$9.45 billion over five years to improve public transportation options across the state
- \$384 million over five years to support the expansion of an electric vehicle charging network in the state and the opportunity to apply for \$2.5 billion in

grant funding dedicated to EV charging

- A minimum of \$100 million to help provide broadband coverage across the state
- \$84 million over five years to protect against wildfires and \$40 million to protect against cyberattacks
- \$3.5 billion over five years to improve water infrastructure across the state and ensure clean, safe drinking water for California communities
- \$1.5 billion for infrastructure development for airports over five years

Another bill working its way through Congress could provide additional support for cities. The Build Back Better Act includes nearly \$2 trillion in proposed funding for workforce development, climate resiliency, affordable housing, and other key city priorities. Negotiations on the Build Back Better Act are ongoing and an exact timeline for the bill's vote is still unclear.

## Parisian-café ambiance proliferates in Palm Desert with extension of patio dining permits initiated during pandemic

Nov 17, 2021

Nestled in California's famed Coachella Valley, Palm Desert has long been a popular retreat for "snowbirds" from colder climates. Many of its restaurants rely on a seasonal swell of tourists, which nearly doubles the city's population of 48,000 from October to May.

When the Governor issued his 2020 stay-at-home order to prevent the spread of COVID-19, Palm Desert officials feared that many of the city's restaurants would close for good. Moving quickly and in coordination with evolving public safety orders, they granted dozens of temporary permits to those wishing to operate dining decks in the public right-of-way or parking spaces.

The permits were a much-needed lifeline for many businesses, including the popular Grill-A-Burger. "It was an eyeopener," said owner Salima Nurani. "This is what California dining should have been all along. People were hungry to be at a restaurant, no pun intended. It was really a celebratory atmosphere."

Fulltime Palm Desert resident Terri Tallen agrees. "I love outdoor dining. It was so much fun to suddenly have so many options to eat outside," she said. "We have such fabulous weather here in Palm Desert. Outdoor dining is what this town should be all about."

Although the move was one borne out of financial necessity — both for the restaurateurs and the city — it was one that officials had long pondered.

"We were already having conversations about how to capture more space in certain parts of town, particularly our El Paseo Shopping District," said Eric Ceja, the city's deputy



director of development services. "How can we capture more pedestrian space, more public space? How can we make the streets seem livelier? The dining decks really made that happen."

El Paseo has long been the crown jewel of Palm Desert. The tree-lined boulevard is filled with public art, upscale stores, and boutiques — which visitors often missed due to its length and car-centricity. Expanded outdoor dining, combined with efforts to improve walkability, injected a new type of energy into the corridor. "It created the unique and desired effect we were looking for," said Ceja.

John and Marnie Parkes have been coming down to Palm Desert from Canada for years to escape the cold and enjoy the warm weather. They never understood why more restaurants didn't offer outside dining.

"Walking along El Paseo this week reminded me of being in Europe," said John Parkes. "With all of the people outside on the patios dining, it was much more lively, and created a much better ambiance. I'm really happy they plan to keep it like this."

Restaurants and residents have been supportive of the program. In June, the city council extended the permits an additional year for restaurants that bring their dining decks into compliance with a <a href="new set of design and safety rules">new set of design and safety rules</a> (https://www.cityofpalmdesert.org/home/showpublisheddocument/31266/6376386156488 30000), which were created in consultation with the city attorneys department, the California Joint Powers Insurance Authority, and city council.

To support still-struggling businesses, the city council also approved a matching grant program — up to \$5,000 — for dining deck improvements that adhere to the new design and safety guidelines. To date, 10 temporary permits have been reapproved, one-third of the total number issued in 2020.

Today, life has started to return to its pre-pandemic rhythm in many parts of the state. However, Palm Desert officials, residents, and restaurateurs hope the program can become a permanent city fixture. The project is good for the city, the restaurants, and the community noted Ceja. The restaurateurs and nearby shops enjoy more business, which increases the city's sales and tax revenue, and the quality of life increases for nearby residents and tourists.



"These dining decks have been out there for a year already.
They're going to be out there for an additional two years," stated Ceja. "Long-term, if they continue to be popular and we'll received, I think we start developing more permeant solutions with restaurants."

Grill-a-Burger, which sits outside the El Paseo area, is already

working with their landlord to develop a permanent outdoor dining space. "We're not truly out of the pandemic. Outdoor dining is no longer a bonus," said Nurani.

"It's becoming more of a requirement and our customers, staff — everybody — is really happy to have that. We hope that we'll have a permanent outdoor space that can carry on past COVID-19, if there is ever such a time."

"Creating spaces to eat outdoors made a big difference to restaurants during the pandemic and to people like me who wanted to get out and support our restaurants," Palm Desert resident Elaine Shannon said. "By maintaining outdoor patio dining, restaurants can serve more people and hopefully make up some of what they lost over the past couple of years. And personally, I like having the choice."

# A collective sigh of relief after CalPERS board votes to keep discount rate at 6.8% following compelling testimony by city officials

On Monday, Nov. 15 the California Public Employees' Retirement System (CalPERS) Board of Directors (https://www.calpers.ca.gov/page/newsroom/calpers-news/2021/calpers-board-new-asset-allocation-keeps-discount-rate-at-six-point-eight-percent?utm\_source=esubscriptions&utm\_medium=email&utm\_campaign=CalPERS-News) voted (https://www.calpers.ca.gov/page/newsroom/calpers-news/2021/calpers-board-new-asset-allocation-keeps-discount-rate-at-six-point-eight-percent?

utm\_source=esubscriptions&utm\_medium=email&utm\_campaign=CalPERS-News) to keep the discount rate — the long-term interest rate used to fund future pension benefits — at 6.8%. Several city officials, including League of California Cities President and Walnut Creek Council Member Cindy Silva, testified against lowering the discount rate due to the detrimental impact it would have on city budgets.

The discount rate had already been automatically lowered in July, from 7.0% to 6.8%, due to the CalPERS investment return for fiscal year 2020-21. While cities would have preferred the discount rate to return to 7.0%, the financial implications of further lowering the discount rate would have been disastrous for cities, making this an important win for local government.

During her testimony, President Silva, who helps lead a full-service city of 70,000 residents, noted that her city's 2021 pension payments are roughly 15% of their

\$87 million operating budget. "If you drop the discount rate by just a half-point, Walnut Creek's pension costs will jump by another three-quarter million — the equivalent of four fully-funded police officers," she stated.

Additionally, many cities are still reeling from the economic fallout of the pandemic. For Walnut Creek, the American Rescue Plan Act only covered 40% of their pandemic-related cuts to services and staffing. Officials from the cities of La Mesa, Sacramento, Pasadena, Hayward, and Rancho Cucamonga also pointed out that cities are still grappling with the financial pressures of the previous reduction of the discount rate in July.

"CalPERS has been struggling to catch up due to past decisions and the price is being paid by municipalities that did not have a say in those decisions," said La Mesa Director of Finance Tammi Royales. "Projects will have to be deferred due to lack of funding. As inflation starts to rise, we cannot ask our constituents to pay a price for past decisions."

Likewise, Sacramento Assistant City Manager Leyne Milstein stated, "Sacramento and many cities have struggled to keep pace with the pension contribution increases of 2016. This increased costs for the city of Sacramento by nearly \$67 million or more than 10% of our general fund, making pension costs 17% to 18% of our general fund budget."

City officials were also joined by Rural County Representatives of California, California Special Districts Association, California Schools Employee Association, Rancho Cucamonga Fire Protection District, and others, who shared many of their concerns. Monday's vote was a part of CalPERS <a href="https://www.calpers.ca.gov/page/about/organization/facts-at-a-glance/asset-liability-management">https://www.calpers.ca.gov/page/about/organization/facts-at-a-glance/asset-liability-management</a>) Asset Liability Management

(https://www.calpers.ca.gov/page/about/organization/facts-at-a-glance/asset-liability-management) process, a recurring, integrated review of its assets and liabilities with the intent of informing decisions designed to achieve a sustainable fund. During the proceedings, the CalPERS Board was presented with three investment portfolios, with discount rates of 6.5%, 6.8%, and 7.0%. Among the factors considered were the tolerance for market drawdown risk, acceptable volatility, and employers' ability to absorb different rate changes.

Cal Cities remains committed to working with CalPERS to find balanced solutions that safeguard retirement security while ensuring local governments have the resources needed to deliver essential services to our communities.

### Zero-emission fleet regulations coming to some cities in early 2024

The California Air Resources Board has (https://ww2.arb.ca.gov/our-work/programs/advanced-clean-fleets/advanced-clean-fleets-draft-regulation-and-comments) developed a series of new regulations (https://ww2.arb.ca.gov/our-work/programs/advanced-clean-fleets/advanced-clean-fleets-draft-regulation-and-comments) to accelerate the number of medium- and heavy-duty zero-emission vehicle purchases in order to achieve a full transition to zero emissions in California by 2045. These regulations will affect some cities as soon as Jan. 1, 2024.

On Jan. 1, 2024, city, county, special district, and state with more than 50 vehicles in their fleets will be required to take an inventory of their fleet. By March 1, 2024, they will be required to submit an inventory report to the Resources Board. Additionally, for applicable local authorities, 50% of all new motor vehicle purchases in each calendar year must be zero-emission starting Jan. 1, 2024. This number rises to 100% by January 2027 and includes all vehicle classifications, from class 2b to class 8.

The League of California Cities supports the overall goal to reduce emissions in the transportation sector and local cities are demonstrating tremendous leadership by facilitating transportation electrification in their local communities. However, the Resources Board's aggressive proposal heavily burdens cities, many of which are still struggling to recover from the economic impacts of COVID-19 and other large-scale emergencies, such as wildfires.

The current proposals ignore the time and resources needed to develop electric systems and storage facilities that support an electrified fleet of emergency, water, and sewer utility vehicles. For example, with existing city vehicles operating 8-12 hours a day and traveling 180+ miles to perform trash services, there is a dearth of available zero-emission vehicles that meet the needs of both a community and the state's regulations.

Regardless of the size, available resources, and existing infrastructure, every city in California will be impacted by these proposed regulations. Moreover, interruptions in supply chains and a lack of existing technology for heavy-duty vehicles, as well as reliance on city vehicles for essential services such as water, sewer, transportation, and stormwater — especially during emergencies — must be taken into consideration before such regulations are enacted.

On Monday, President Joe Biden signed the Infrastructure Investment and Jobs Act, which comprises billions in new federal investments in the nation's infrastructure, including more than \$25 billion for California to repair roads, bridges, and highways, and more than \$600 million to prepare transportation systems for extreme weather, drought, and wildfires. The details of the bill were summarized in a recent Cal Cities Advocate article (https://www.calcities.org/detail-pages/news/2021/11/10/congress-passes-1-2-trillion-infrastructure-bill-heres-what-california-cities-can-expect). League of California Cities Executive Director and CEO Carolyn Coleman also issued (https://www.calcities.org/detail-pages/news/2021/11/16/league-of-california-cities-applauds-the-signing-of-federal-landmark-infrastructure-bill) a statement (https://www.calcities.org/detail-pages/news/2021/11/16/league-of-california-cities-applauds-the-signing-of-federal-landmark-infrastructure-bill) in response to the bill's signing.

Additionally, reservations for the 2021 Main Street Small Business Tax Credit II, which provides (https://www.cdtfa.ca.gov/industry/main-street-small-business-tax-credit-II-AB150.htm#overview) COVID-19 financial relief for small businesses (https://www.cdtfa.ca.gov/industry/main-street-small-business-tax-credit-II-AB150.htm#overview), are currently available. Qualified small business employers may apply online to reserve \$1,000 per net increase in qualified employees — up to \$150,000 — to offset income, or sales and use taxes, when filing a return. Tax credits will be allocated on a first-come, first-served basis through Nov. 30 or until

the \$116 million in available credits runs out. Business employers who apply once all credits have been exhausted will be placed on a waiting list.

Finally, with the holidays approaching and concerns about a potential surge in COVID-19 cases, state health officials are urging cities to help boost the Vaccinate ALL 58 Campaign (VA58) this week. The goal is to prepare California families for celebrating safely this winter. With the addition of boosters for adults and vaccines for children 5-11, the VA58 campaign will deploy messaging that focuses on the "whole household."
