RESOLUTION AUTHORIZING EVICTION PROCEEDINGS AGAINST A TENANT HOLDING OVER ON AN EXPIRED LEASE OF CITY PROPERTY (12302 HARBOR BOULEVARD, 12511 TWINTREE LANE, 12531 TWINTREE LANE, GARDEN GROVE)
