LESSEE'S RELOCATION RELEASE AND WAIVER AGREEMENT AND SELLER'S INDEMNITY AGREEMENT WITH HARDIN HYUNDAI, INC., AND DAI R. LEE AND DEBBIE K. LEE; AND SITE AND BUILDING LEASE WITH HARDIN HYUNDAI, INC. REGARDING GARDEN GROVE HYUNDAI DEALERSHIP (F: A-55.333) (XR: A-116.7)

# REFINANCE OF EXISTING SECTION 108 HUD LOAN (F: 117.11)

This item was heard in conjunction with the Garden Grove City Council.

Staff report dated May 27, 2008, was introduced and reviewed by staff.

The 2008 HUD Refinancing facilitates the issuance of refunding certificates, with the proceeds used to defease the outstanding trust certificates associated with the original 1997 loan as replaced by the 1999 loan. The certificates are guaranteed under Section 108 of the Housing and Community Development Act of 1974. The interest rates for the upcoming public offering are expected to be significantly lower than those on the City's existing loan, ranging from 5.96 percent to 7.72 percent; to a projected interest rate range on the series HUD 2008-A certificates from 2.62 percent to 4.51 percent. Refinancing the loan would reduce the City's interest expense, resulting in a projected debt service savings of \$857,600 over the remaining life of the loan.
