## ACQUISITION OF REAL PROPERTY LOCATED AT 12252 HARBOR BOULEVARD (F: A-84.1) (XR: 43.4)

Staff report dated March 10, 2009, was introduced and reviewed by staff.

It was moved by Member Dalton, seconded by Member Nguyen, and carried by unanimous vote that the Agreement by and between the Garden Grove Agency for Community Development and Jerry L. Bowen and Sharon L. Bowen, and Thomas D. Bowen, for the acquisition of real property located at 12252 Harbor Boulevard, be and hereby is approved; the Agency Director and Secretary are authorized to execute the pertinent documents on behalf of the Agency; the Agency Director is authorized to waive the condition in the agreement for termination of the lease with the adjacent property owner; and the Finance Officer is authorized to draw a warrant in the amount of \$2,856,420 when appropriate to do so, and to fund \$15,000 for closing costs and environmental testing.
