AGREEMENT WITH GARDEN GROVE MXD, LLC, FOR ASSIGNMENT AND ASSUMPTION OF PURCHASE AGREEMENT FOR PARCEL APN 231-441-40 ON HARBOR BOULEVARD (F: A-55.346) (XR: A-116.6)

Staff report dated March 24, 2009, was introduced, and reviewed by staff.

It was moved by Member Jones, seconded by Member Do, and carried by unanimous vote that the Assignment Agreement by and between the Garden Grove Agency for Community Development and Garden Grove MXD, LLC, for the 10.3 acre site located at 12721 Harbor Boulevard, in the amount of \$2,250,000, be and hereby is approved; the Director and Secretary are authorized to execute the agreement and to do all actions and execute all additional documents necessary and appropriate to implement the Assignment Agreement on behalf of the Agency; and the Finance Officer is authorized to draw a warrant in the amount of \$100,000 to reimburse the Developer for the deposit immediately upon approval of the Assignment Agreement, and to draw a warrant in the amount of \$2,125,000, plus such other costs payable through escrow and pursuant to the Purchase Agreement, in order to close escrow for the purchase of the Property.

## MATTERS FROM AGENCY MEMBERS AND DIRECTOR

Chair/Council Member Broadwater responded to comments made during Oral Communications that the Police Chief and Fire Chief are kowtowing to the Mayor and City Council concerning the issue of fireworks.
