The Invocation was given by Keith Jones, Public Works Director. Council Member Jones led the Pledge of Allegiance to the Flag of the United States of America.

PUBLIC HEARING - AGREEMENT WITH THE COUNTY OF ORANGE FOR ACCEPTANCE OF JUSTICE ASSISTANCE GRANT FUNDS FOR \$267,655 TO SUPPORT THE PROACT PROGRAM AND THE PURCHASE OF AN AUTOMATED REPORT WRITING SYSTEM (F: 82.5) (XR: 82.15) (XR: 82.1)

Council Member Do stated that this Agreement does benefit the City and his dual role as a City Council Member and County Supervisor Nguyen's Chief of Staff does not prevent him from participating in this matter.

Mayor Dalton declared the Public Hearings open and asked if anyone wished to address the City Council on these matters.

Peggy Bergin questioned the function of the report writing system and whether it prints what is said. Staff responded that the system does not print what is recorded.

It was moved by Council Member Broadwater, seconded by Council Member Jones, and carried by unanimous vote, that the allocation of FY 2009-10 State Supplemental Law Enforcement Funds (SLESF) in the amount of \$165,000 for the purchase of an Automated Report Writing System (ARWS) and upgrades to the patrol vehicle In-Car Video Systems (IVS), be and hereby is approved.

It was moved by Council Member Broadwater, seconded by Council Member Jones, and carried by unanimous vote, that the Agreement by and between the County of Orange and the City of Garden Grove to transfer funds for the 2009 Recovery Act Edward Byrne Memorial Justice Assistance Grant (JAG) program to fund the PROACT program,

and allocate the remainder of the City's Assistance Grant in the amount of \$267,655 to complete the purchase of the automated report writing system (ARWS), be and hereby is approved; and the Mayor is authorized to execute the agreement.
