Commissioner Alejandro inquired about installing radar feed back signs; staff noted that flashing beacons could be installed with the curve warning signs.

It was moved and seconded to approve staff's recommendation (with a slight modification) to:

- Deny the request to install left turn pockets on Blackmer Street at Lampson Avenue.
- Deny the request to install rumble strips on Lampson Avenue, west of Blackmer Street, in advance of the roadway curve.
- Deny the request to convert the traffic signals at Lampson Avenue and Manley Street and Lampson Avenue and Blackmer Street to a 4-way flashing red operation.
- Install curve warning signs on Lampson Avenue, west of Blackmer Street with flashing beacons in advance of the roadway curve.
