PURCHASE AGREEMENT WITH WAYNE R. AND LYNN LOHSE FOR THE ACQUISITION OF REAL PROPERTY AT 12237 CHOISSER ROAD, GARDEN GROVE (F: A-84.1) (XR: A-116.15)

Staff report dated January 24, 2012, was introduced and reviewed by staff.

Lohse and Lynn Lohse, for the acquisition of real property located at 12237 Choisser Road, Garden Grove, be and hereby is approved; that the Agency and/or the City of Garden Grove as the Successor Agency to the Garden Grove Agency for Community Development, Agency Director/City Manager is hereby authorized to execute the pertinent documents and make minor modifications as needed; that the Secretary/City Clerk is hereby authorized to accept the Grant Deed on behalf of the Agency and/or the City of Garden Grove as the Successor Agency to the Garden Grove Agency for Community Development; that the Finance Director is authorized to draw a warrant in the amount of \$440,000, and funds necessary for the purchase price and for closing costs; that the Agency Director/City Manager is authorized to execute the Lease Agreement on an interim basis pending the disposition of the Subject Property, and to make modifications as needed; and that the Agency Director/City Manager is authorized to execute agreements for asbestos and lead-based paint testing, asbestos and lead-based paint abatement, and demolition at the lowest responsive bids.
