OBJECTIVE

For City Council to award a contract to R. J. Noble Company, for Project No. 7270 - Brookhurst Street Reconstruction from Chapman Avenue to Katella Avenue, Garden Grove.

BACKGROUND

The project consists of removal and reconstruction of bus pads, sidewalks, curbs and gutters, cross gutters, access ramps, and median curbs; roadway rehabilitation by full depth reclamation and pavement grinding, cement treatment of recycled base material, pavement cold milling; construction of asphalt concrete base course and surface course; adjustment of utility covers to finish surface; video detection system; traffic striping and traffic loop detectors; and other items required by the plans and specifications.

The proposed street reconstruction project will significantly improve ride, safety and appearance of this arterial street and reduce maintenance.

DISCUSSION

Staff solicited bids for this project pursuant to Municipal Code Section 2.50.100.

Six (6) qualified bids were received and opened in the City Clerk's office at 11:00 a.m., on August 14, 2014. The lowest qualified bidder is R. J. Noble Company, with a total bid of \$2,874,230.00. This bid is within the current project budget. The licenses and references of the contractor have been reviewed and verified by staff, and all other documentation is in order.

There is no financial impact to the General Fund. This improvement is included in the 2014-15, Capital Improvement Budget and is funded by Measure "M2" Local and Gas Tax funds in the amount of \$2,874,230.


RECOMMENDATION
