#### **OBJECTIVE**

For City Council to accept the above project as complete and authorize the City Manager to execute the Notice of Completion of Public Improvement and Work.

#### BACKGROUND/DISCUSSION

This Project consisted of the removal and reconstruction of street pavement, bus pads, and median curbs, installed new subsurface drip irrigation system with solar powered irrigation controllers for energy efficiency, and planted drought tolerant plants and shrubs, and replaced painted traffic striping, and traffic signal loops.

The contractor, Sully-Miller Contracting Company, has completed the improvements in accordance with the plans, specifications, and other contract documents.

## FINANCIAL IMPACT

There is no financial impact to the General Fund. The subject project was funded through Federal (Fund 281), CalRecycle (Fund 231), Gas Tax (Fund 061), Measure "M" local (Fund 421), and Measure "M2" local (Fund 422) funds and was completed within the project budget and schedule. The retention payment will be released after recordation of the Notice of Completion.

#### RECOMMENDATION

It is recommended that the City Council:

- Accept Project No. 7234 Valley View Street Reconstruction from SR22 Freeway to the northern City Limit as complete; and
- Authorize the City Manager to execute the Notice of Completion of Public Works Improvement and Work; and
- Authorize the Finance Director to release the retention payment when appropriate to do so.
