# **OBJECTIVE**

To request City Council approval for the acceptance of a street deed and an easement for public street and highway purposes in accordance with Precise Grading Plan G-1285 (the "Project"), for a portion of the real property located at 10062 Emerson Avenue, Garden Grove, owned by Peter H. Nguyen ("Owner").

### BACKGROUND/DISCUSSION

On September 25, 2013, the Owner submitted grading plans for the proposed two residential units on the property currently improved with a single-family home at 10062 Emerson Avenue, Garden Grove, and to dedicate 2.5 feet of right-of-way at the rear property line adjoining the existing alley to the City of Garden Grove for future widening improvements.
