OBJECTIVE

For the City Council to adopt a Resolution confirming that Regular City Council meetings will be held at the Courtyard Center, 12732 Main Street, Garden Grove, beginning with the regular meeting of August 25, 2015.

BACKGROUND/DISCUSSION

With the construction at the Community Meeting Center, the Regular City Council meetings have moved to the Courtyard Center beginning August 25, 2015. Section 2.04.010 of the Municipal Code provides that the Council establishes the place of its regular meetings by resolution. The attached Resolution formally confirms the regular meeting location change during the Community Meeting Center renovation project. Once the renovation project is complete and the City Council accepts the project as completed, the regular Council meetings will return to the Community Meeting Center and the attached resolution will automatically expire.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GARDEN GROVE
CONFIRMING THE TEMPORARY RELOCATION FOR REGULAR CITY COUNCIL
MEETINGS

Whereas, Section 2.04.010 of the Garden Grove Municipal Code provides that the City Council shall hold regular meetings on the second and fourth Tuesdays of each month at the hour and place as prescribed by City Council Resolution; and

Whereas, the City Council Manual of Procedure provides that regular meetings of the City Council shall be held at the Council Chambers located at the Community Meeting Center; and

Whereas, the Community Meeting Center and Council Chambers are currently undergoing renovations;

Whereas, commencing with its regular meeting of August 25, 2015, the City Council relocated its regular meetings to the Courtyard Center located at 12732 Main Street in the City of Garden Grove during the time that the Community Meeting Center is undergoing renovations.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GARDEN GROVE does hereby resolve that:

Section 1. The City Council hereby confirms that commencing with the regular meeting of August 25, 2015, the regular meetings of the City Council shall be held at the Courtyard Center located at 12732 Main Street, until the construction activities at the Council Chambers and Community Meeting Center have been completed and the work has been accepted by the City Council.

Section 2. The location of the City Council's regular meetings shall return to the Council Chambers at the Community Meeting Center commencing with the regular meeting following the meeting at which the City Council accepts and finds the Community Meeting Center renovation construction work completed, at which time this resolution shall automatically expire.
