OBJECTIVE

To request that the City Council adopt the attached Resolution requesting approval by Caltrans of the temporary closure of the State Route 22 (SR-22) offramp at Haster Street for the Disney Avengers Half Marathon on Sunday, November 15, 2015, between 5:30 a.m. and 10:00 a.m.

BACKGROUND/DISCUSSION

On June 23, 2015, City Council approved a three-year Agreement with Disney Sports Attractions to conduct the annual Avengers Half Marathon event and the annual Star Wars Half Marathon event on city streets. The Avengers Half Marathon event is scheduled for Sunday, November 15, 2015, with approximately 14,000 runners and walkers that will be participating in a 13.1 mile course. The course will go through the Disney theme parks and along city streets, including Haster Street where it meets with the SR-22. In order to conduct a safe course, the traffic plans require a four hour temporary closure of the SR-22 offramp at Haster Street.

The attached Resolution is requesting that Caltrans approve a four hour temporary closure of the SR-22 offramp at Haster Street on Sunday, November 15, 2015 on behalf of the City.

FINANCIAL IMPACT


There is no financial impact to the City's budget. As part of the Resolution, Disney Sports Attractions agrees to reimburse Caltrans for the cost of the traffic closures.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GARDEN GROVE
REQUESTING TEMPORARY CLOSURES TO CALTRANS SR-22 OFFRAMP TO HASTER
STREET FOR THE DISNEYLAND AVENGERS HALF MARATHON

WHEREAS, the Disneyland Avengers Half Marathon event is scheduled for Sunday, November 15, 2015;

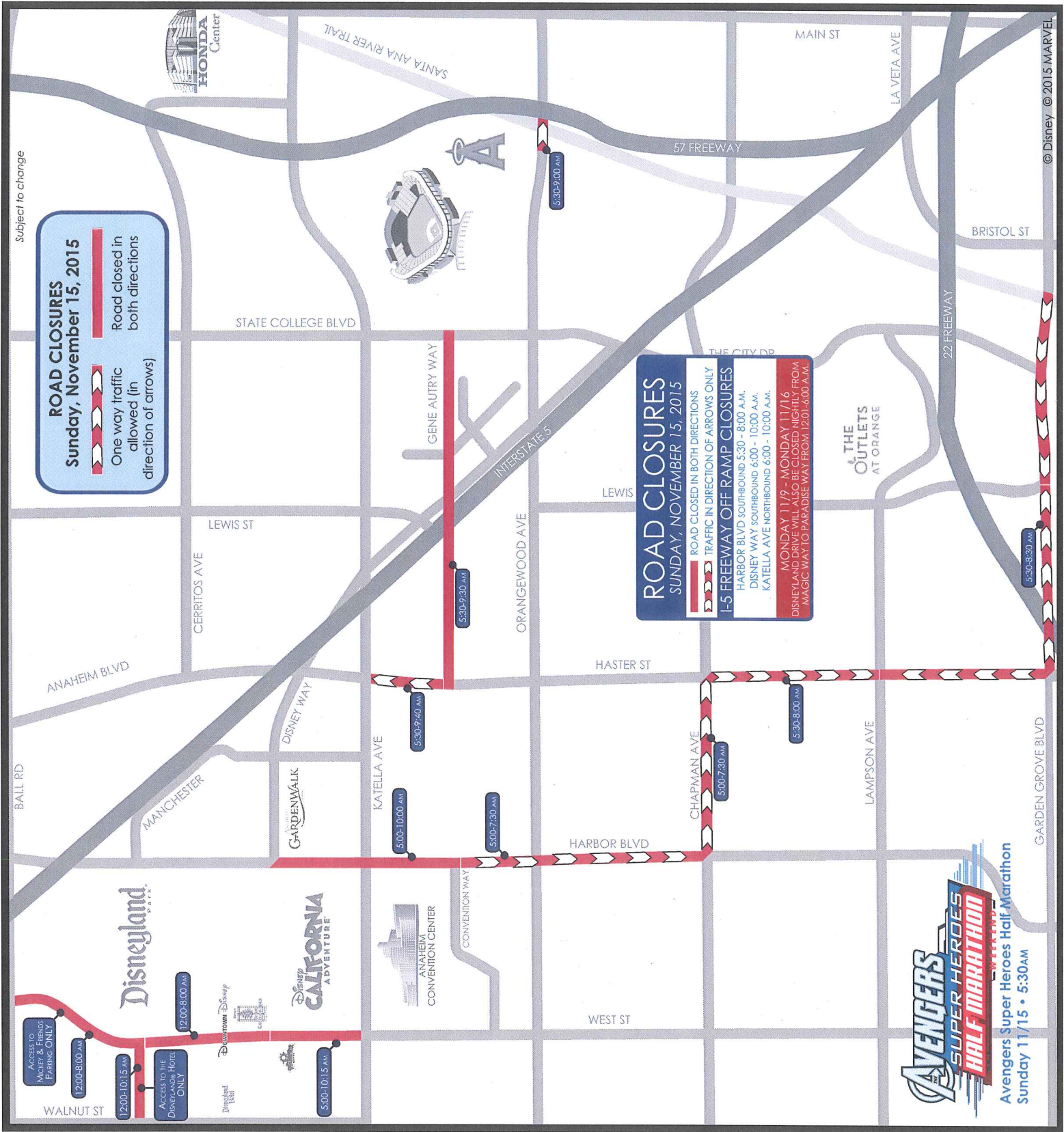
WHEREAS, 14,000 runners and walkers will participate in a 13.1 mile course through the Disney theme parks and along City streets passing the Haster Street and State Route 22 (SR-22);

WHEREAS, safety along the course will require an approximately four-hour temporary closure of SR-22 ramp in the City of Garden Grove at one location;

WHEREAS, traffic control plans have been prepared, and a certificate of insurance has be prepared to the satisfaction of Caltrans; and

WHEREAS, DISNEY agrees to reimburse Caltrans for the cost of the traffic closures.

NOW, THEREFORE, be it resolved by the City Council of the City of Garden Grove that the City requests temporary closures of up to four hours on November 15, 2015, between 5:30 a.m. and 10 a.m. at the SR-22 at Haster Street.
