OBJECTIVE

To request Garden Grove Sanitary District (GGSD) Board approve final payment in the amount of \$82,794.75 to the Midway City Sanitation District (MCSD).

BACKGROUND

GGSD entered into a joint use sewerage agreement with the MCSD on April 14, 1997 of which the terms and conditions were imposed by the Local Agency Formation Commission (LAFCO). The agreement requires that the GGSD participate with MCSD all shared costs of upgrading its sewerage system in exchange for capacity rights that allow for a portion of GGSD's sewer flows to pass through the MCSD sewer system.

DISCUSSION

On January 22, 2008, GGSD Board approved a deposit to be made to MCSD in the amount of \$755,958.23 for its proportional share of overall bid award of \$1,374,469.50 to the lowest responsive bidder, Charles King Company, Incorporated. The project replaced 3,881 linear feet of joint use sewer main to address capacity deficiencies located between shared pipelines along 15th Street and Westminster Avenue (Attachment 1). The final payment to MCSD of this construction represents GGSD proportionate share for cost of change orders and construction inspection of the project. A Notice of Completion was filed with the County of Orange on October 29, 2008 and the final payment to the contractor has been made.




