NEW BUSINESS

LEFT TURN ACCESS 9240 GARDEN GROVE BLVD

The staff report was introduced to consider a request to allow left turn access into 9240 Garden Grove Boulevard.

Michael Kim, Travis Do, and Mr. Joe Pak addressed the Commission regarding access to 9240 Garden Grove Boulevard.

Concerns:

- Difficulty in accessing the shopping center via Garden Grove Boulevard and driveway on Casa Linda
- Making u-turn at Magnolia Street
- Business Retention at the shopping center

Commissioner concerns:

- Criteria for keeping median intact
- Safety
- Documentation regarding business retention
- Funding/Cost
- Enough space to install access
- · Definition of major shopping center
- · Communication with business owner & residents

Commissioner Alejandro moved, seconded by Commissioner Cabral to accept staff's recommendation to receive public input and deny the request to allow left turn access into 9240 Garden Grove Boulevard.

OCTA PRESENTATION WEST COUNTY CONNECTORS PROJECTS

The Orange County Transportation Authority (OCTA), in partnership with the California Department of Transportation (Caltrans), started final design on the West County Connectors project. The project traverses the cities of Garden Grove, Westminster, Seal Beach, Los Alamitos and the community of Rossmoor.

It was initiated to link high occupancy vehicle (HOV) lanes/carpool lanes on the San Diego Freeway (I-405) with those on the Garden Grove Freeway (SR-22) and San Gabriel Freeway (I-605) to create a seamless HOV connection amongst the three freeways.

TRAFFIC ENGINEERING POLICY 66 ROADWAY STRIPING

The staff report was introduced to approve Traffic Engineering Policy 66 (Roadway Striping).
