ESTABLISHING SALARY RATES

FOR PUBLIC WORKS TRAINEES

OBJECTIVE

This memo is to request City Council approval for a resolution amending the salary range for Public Works Trainee.

BACKGROUND

The City has had a practice of resetting part-time salaries in conjunction with changes to other bargaining agreements and/or changes in the state or federal minimum wage. Other part-time classifications such as those in recreation and the Police Department were adjusted in 2006 and 2008 concomitant with increases in the state minimum wage. At those times, Public Works Trainee salaries were not increased because some thought was given to including this classification in the OCEA Employee's League, since Public Works Trainees are the training class for entry into the lowest League classification, Public Works Utility Worker.

During bargaining, the League indicated disinterest in including Public Works Trainees as unit members, mostly due to their part-time and transient nature. Because Public Works Trainees have not had their salary range adjusted since June 2, 2001, a separate action to increase the salary range is recommended.

DISCUSSION

Since 2001, the Public Works Trainee wage has remained flat while inflation has increased 22%. While better times might have allowed a larger increase, the recommendation at this time is to increase the range by an average of 11%. Though it is a training class with an expectation of "move up or move out," the hiring freeze has also meant average tenure in this class has risen significantly, making an increase in pay more urgent.
