OBJECTIVE

The purpose of this memorandum is for the District Board to review and adopt the attached Appropriations Limit Resolution for the Garden Grove Sanitary District setting the appropriations limit for Fiscal Year 2009-10.

BACKGROUND

In November 1979, the citizens of California passed Proposition 4 (Gann Initiative amending Article XIII B) which placed limitations on the finances of state and local governments. It also provided a method of calculating and adopting the limitations. The League of California Cities has developed guidelines from the legislation and Article XIII B for consistent statewide implementation. The District is utilizing these guidelines in the calculation process.

DISCUSSION

The Fiscal Year 2009-10 appropriations limit for the Garden Grove Sanitary District is \$9,811,957. The recommended budget appropriations subject-to-limit is \$2,259,000. The difference of \$7,552,957 is the "gap" from which additional appropriations can be made.

Section 7900 et seq. of the Government Code requires a local government to adopt a resolution setting the limitations at a regularly scheduled meeting or noticed special meeting. There is no requirement in the State Code for a public hearing prior to adoption of the resolution.

RESOLUTION NO.

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE GARDEN
GROVE SANITARY DISTRICT ESTABLISHING THE AMOUNT OF
INCREASE IN APPROPRIATIONS IN ACCORDANCE WITH
ARTICLE XIII B OF THE CALIFORNIA CONSTITUTION AS AMENDED BY
PROPOSITION 111

WHEREAS, Chapter 1205 statutes of 1980 became effective January 1, 1981;
and

WHEREAS, Article XIII B of the California Constitution was amended by
Proposition 111 to change the price and population factors that may be used by
local jurisdictions in setting their appropriations limit; and

WHEREAS, the amendments specify that the appropriations limit may
increase annually by a factor comprised of the change in population combined with
either the change in California per capita personal income or the change in the local
assessment roll due to local non-residential construction;

NOW, THEREFORE, BE IT HEREBY RESOLVED that the appropriations limit for
Fiscal Year 2009-10 in accordance with Exhibit "A" is \$9,811,957 excluding user
fees.

EXHIBIT "A"

ARTICLE XIII-B CALCULATIONS

2009-10 BUDGET

Per Capita Change = .62% (Personal Income)
Population Change = 1.02%

$$\text{Per Capita converted to a ratio:} \quad \frac{.62 + 100}{100} = 1.0062$$

$$\text{Population converted to a ratio:} \quad \frac{1.02 + 100}{100} = 1.0102$$

$$\text{Calculation of factor for FY 2009-10:} \quad 1.0062 \times 1.0102 = 1.01646$$

Conversion of the factor to a ratio eliminates minus numbers.

$$1.01646 \text{ converted to a \%} = 1.646\%$$

$$\$9,653,068 \times 1.646\% = \$158,889$$

$$\$158,889 + \$9,653,068 = \$9,811,957$$
