# **OBJECTIVE**

To hold a Public Hearing for receipt of objections to the Weed Abatement Notices mailed to parcel owners on September 9, 2009.

# **BACKGROUND**

On September 08, 2009, City Council adopted a resolution pursuant to Section 39500, et seq, of the State of California Government Code to declare that a nuisance exists in connection with the presence of weeds, rubbish, and debris on certain properties within the City of Garden Grove. A Public Hearing has been scheduled for November 10, 2009, to receive any objections to the Weed Abatement Notices.

Parcel owners had until October 14, 2009, to clear their properties. The City's Weed Abatement Official re-inspected these parcels on October 20, 2009; uncleared parcels are identified in the updated "Exhibit A."

### DISCUSSION

The City's contractor is to begin clearing privately owned properties that are not in compliance on November 11, 2009, with work slated for completion within 30 days.

### FINANCIAL IMPACT

There is no financial impact.

### COMMUNITY VISION IMPLEMENTATION

To protect the beauty and quality of life in Garden Grove by eliminating unsightly weeds and rubbish.

## **RECOMMENDATION**

- Uphold the objections and order individual properties to be removed from the scheduled abatement process; or

• If there are no objections, direct staff to proceed with the scheduled weed abatement.
