OBJECTIVE

For the Garden Grove Sanitary District (GGSD) Board to accept the above project as complete and authorize the District's General Manager to execute the Notice of Completion of Public Improvement and Work.

BACKGROUND

The project was awarded to Mike Prlich and Sons, Inc. on April 28, 2009. The total bid amount was \$758,133.00.

With the completion of this project, the GGSD has eliminated capacity deficiencies in the existing Lampson Avenue Sewer from Buaro Street to West Street and West Street Sewer from Lampson Avenue to Stanford Avenue. This allows the development or re-development of the area (known as the hub) bounded by Lampson Avenue, Buaro Street and Harbor Boulevard with a high-intensity use.

DISCUSSION

The contractor, Mike Prlich and Sons, Inc., has completed the improvements in accordance with the plans, specifications and other contract documents.

It is recommended that the GGSD Board:


- Accept the project as complete and authorize the General Manager to execute the Notice of Completion of Public Works Improvement and Work.

NOTICE IS HEREBY GIVEN that the Garden Grove Sanitary District, Orange County, California, has caused a public improvement, to wit:

to be constructed upon the property hereinafter described.
