#### **OBJECTIVE**

Adopt a current resolution to authorize the Public Works Director to execute Surface Transportation Program (STP) program master and supplemental agreements and to sign state and federal documents required for highway projects including street right-of-way certifications.

# **BACKGROUND**

On June 12, 2001, the City Council adopted Resolution No. 8356-01 allowing the Public Works Director to execute Surface Transportation Program (STP) program master and supplemental agreements and to sign state and federal documents required for highway projects including street right-of-way certifications. resolution streamlined the processes necessary for the City to receive state and federal funds.

## **DISCUSSION**

The City is currently processing a program supplement agreement with the State of California Department of Transportation in order to receive \$254,000.00 in grant funding for a new traffic signal at West Street and Wilken Way.

The State has deemed Resolution No. 8356-01 not current and is asking for an updated resolution before executing the program supplement agreement.

### FINANCIAL IMPACT

There will be no financial impact to the General Fund.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GARDEN GROVE AUTHORIZING THE PUBLIC WORKS DIRECTOR TO EXECUTE AND SIGN VARIOUS STATE AND FEDERAL DOCUMENTS REQUIRED FOR HIGHWAY PROJECTS

WHEREAS, the Federal Highway Administration (FHWA) has established funding programs, which may be used for highway construction that are classified as local or rural minor collectors;

WHEREAS, the State of California (Caltrans) will administer programs and assist local agencies to take advantage of the federally funded transportation programs that are consistent with the requirements of FHWA;

WHEREAS, and the City of Garden Grove (City) applies for funding through the Surface Transportation Program (STP);

WHEREAS, Caltrans accepted and may in the future accept more City arterial street projects for STP;

WHEREAS, the City desires to be reimbursed for the eligible federal funds for approved arterial streets projects;

WHEREAS, it is necessary to execute Program Master Agreements and Program Supplemental Agreements in order to implement said reimbursements; and

WHEREAS, certain documents including street right-of-way certifications required for federal funding of street and highway projects must be signed by a City Official authorized by the City Council to act on behalf of the City.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Garden Grove:

- 1. Hereby authorizes the Public Works Director of the City of Garden Grove to approve and execute the Program Master and Supplemental Agreements in conjunction with the Surface Transportation Program.
- 2. Hereby authorizes the Public Works Director of the City of Garden Grove to sign state and federal required documents for various highway projects, including but not limited to right-of-way certification.
