OBJECTIVE

For City Council to accept the above project as complete and authorize the Mayor to execute the Notice of Completion of Public Improvement and Work.

BACKGROUND

Trask Avenue Street Rehabilitation from Magnolia Street to Euclid Street project included the removal and reconstruction of failed pavement areas, crack sealing, pavement fabric, rubberized asphalt concrete overlay, traffic striping and raised pavement markers.

DISCUSSION

The contractor, Hardy & Harper, Inc., has completed the improvements in accordance with the plans, specifications and other contract documents. The project was funded through unencumbered Measure "M" local (Fund 421), Measure "M" regional (Fund 423) and California Integrated Waste Management Board (Fund 231) funds.

FINANCIAL IMPACT


There is no financial impact to the General Fund. The subject project was completed within the project budget and schedule. The retention payment will be released after recordation of the Notice of Completion.

OF PUBLIC IMPROVEMENT AND WORK**

NOTICE IS HEREBY GIVEN that the City of Garden Grove, Orange County, California, has caused a public improvement, to wit:


