FINANCIAL IMPACT



There will be no impact upon the General Fund.


RECOMMENDATION

- Authorize the City Manager to execute the amendment.





AMENDMENT NO. 3

Plan Check Services

This Amendment No. **3** to furnish **Plan Check Services** is made and entered into this 13th day of July 2010, by and between the **CITY OF GARDEN GROVE**, hereinafter referred to as "CITY", and **WILLDAN ENGINEERING**, hereinafter referred to as "CONTRACTOR".

WHEREAS, CONTRACTOR and CITY entered into Contract No. **08-2466**, dated **November 6, 2007** for Plan Check Services (the " Existing Contract").

WHEREAS, CONTRACTOR and CITY desire to amend the Existing Contract as provided herein.

Now, therefore, it is mutually agreed, by and between the parties as follows:

Section 1.0, Term and Termination of the Existing Contract, shall be amended as follows:

This Amendment No. **3** hereby extends the performance period to cover services rendered from **July 1, 2010** through **June 30, 2011**.

Section 3.0. COMPENSATION - shall be amended as follows:

Contractor shall be compensated in accordance with the hourly rates set forth in Exhibit C to Contract No. 08-2466. In no event shall compensation for the extended performance period exceed the total amount of **\$126,100**.

For the purposes of this Amendment No. 3 and Contract No. 08-2466, all prior references to "Willdan Corporation" shall be deemed to read "Willdan Engineering."

Except as expressly amended hereby, all of the terms and conditions in the Existing Contract remains in full force and effect as originally executed.

IN WITNESS WHEREOF, the parties have caused this Amendment No. 3 to the Existing Contract to be executed by their respective officers duly authorized on the date first written above.
