Change orders in the amount of \$94,350.51 were due to the project scope being increased to include Gilbert Street from Garden Grove Boulevard to Lampson Avenue. Additional striping plans were required by the City Traffic Engineer and the striping was changed from paint to thermal-plastic.

Credits in the amount of \$31,837.52 to the original contract consist of work that was not required.

#### FINANCIAL IMPACT


Funds for this project were allocated in the FY 2009/2010 Public Works budget. The funds are encumbered under Purchase Order Number 10-2710.

OF PUBLIC IMPROVEMENT AND WORK

NOTICE IS HEREBY GIVEN that the City of Garden Grove, Orange County, California, has caused a public improvement, to wit: PROP 1B CENTRAL GARDEN GROVE STREET REHABILITATION (OVERLAY) 2009/2010 to be constructed upon the property hereinafter described. The contract for furnishing of all plant, labor, services, materials, and equipment, and all utilities and transportation, including power, fuel, and water, and performing all work necessary to construct and complete, in a good and workmanlike manner in strict accordance with the specifications, plans, and drawings therefore on file in the office of the City Clerk of the City of Garden Grove, for the construction, installation, and completion of the above-described public improvement and work, was heretofore made and entered into with R.J. Noble Company., on the 28th day of June, 2010 and filed for record in the office of the City Clerk of the City of Garden Grove; that the work upon said public improvement has been completed, and that the Public Works Director, Keith G. 
