OBJECTIVE

To request City Council authorization to amend the Professional Service Agreement with American Ramp Company for upgraded designs and additional pre-casted ramp components for the West Haven Park Skate Spot project.

BACKGROUND/ANALYSIS

On March 9, 2010, the City of Garden Grove City Council approved the Professional Service Agreement with American Ramp Company for the design, construction documents and purchase of pre-casted ramps for Garden Grove Park and West Haven Park Skate Spots in the amount of \$75,880.31.

DISCUSSION

In March 2010, the City of Garden Grove entered into a Professional Service Agreement with American Ramp Company for the design, construction documents and purchase of pre-casted ramps for Garden Grove Park and West Haven Park Skate Spots. Due to the popularity of the first skate spot at Garden Grove Park, the community feedback called for a slightly larger design for West Haven Park. The original design was 988 square feet and it will be increasing to 3,010 square feet. The additional cost for design and pre-cast skate components amount to \$33,695.36.

FINANCIAL IMPACT

There is no financial impact to the General Fund for the additional design and precast ramp components cost for this project. The additional design and pre-cast ramp components cost of \$33,695.36 will be funded through Park Development Funds.

To: American Ramp Company. for Upgraded Design and Additional Pre-Casted Ramps.

This Amendment No. 2 to provide upgrade on design and additional pre-casted ramps for the West Haven Skate Spot project is made and entered into this ____ day of ____ 2010, by and between the CITY OF GARDEN GROVE, hereinafter referred to as "CITY", and American Ramp Company, hereinafter referred to as "CONTRACTOR".

WHEREAS, Contractor and CITY entered into the **Contract No. 10-2883**, effective **March 9, 2010**.

WHEREAS, Contractor and CITY desire to amend the Existing Contract as provided herein.

Now, therefore, it is mutually agreed, by and between the parties as follows:

Section 3.0, Compensation - shall be revised as follows:

The contract Price is hereby increased from \$75,880.31 to a new Firm Fixed Price of \$109,575.67. This is an increase of \$33,695.36 to cover upgraded design and additional pre-cast ramps as a result of modifications to the West Haven Skate Spot project. A copy of the revised design is attached hereto as Exhibit A.

Except as expressly amended hereby, the Existing Contract remains in full force and effect as originally executed.
