OBJECTIVE

For the Garden Grove City Council to accept the above project as complete and authorize the City Manager to execute the Notice of Completion of Public Improvement and Work.

BACKGROUND

This is to certify that R.J. Noble Company, contractor for the above project, has completed the project. The project was awarded to R.J. Noble Company on October 12, 2010. The total bid amount was \$645,411.33.

The work consisted of asphalt overlay on ten (10) residential streets representing 4.6 center lane miles. The project was funded from a grant made available through PROP 1B.

FINANCIAL IMPACT


Funds for this project were provided by a Proposition 1B Grant. The funds are encumbered under Purchase Order Number 11-2379.

OF PUBLIC IMPROVEMENT AND WORK

NOTICE IS HEREBY GIVEN that the City of Garden Grove, Orange County, California, has caused a public improvement, to wit: PROP 1B CENTRAL GARDEN GROVE STREET REHABILITATION (OVERLAY) PHASE II to be constructed upon the property hereinafter described. The contract for furnishing of all plant, labor, services, materials, and equipment, and all utilities and transportation, including power, fuel, and water, and performing all work necessary to construct and complete, in a good and workmanlike manner in strict accordance with the specifications, plans, and drawings therefore on file in the office of the City Clerk of the City of Garden Grove, for the construction, installation, and completion of the above-described public improvement and work, was heretofore made and entered into with R.J. Noble Company., on the 12th day of October, 2010 and filed for record in the office of the City Clerk of the City of Garden Grove; that the work upon said public improvement has been completed, and that the Public Works Director, Keith G. 
