PROP 69 FUNDS

OBJECTIVE

To gain City Council approval for the appropriation and use of the City's FY 2010-2011 allocation of \$104,701 in Prop 69 funding allocated by the County of Orange.

BACKGROUND

On February 8, 2011, the Orange County Board of Supervisors approved allocation of \$104,701 in Prop 69 funding to the Garden Grove Police Department toward the purchase of the DNA storage-related items (\$89,133), and for reimbursement related to the cost of DNA collections (\$15,568).

DISCUSSION

The Police Department is asking the City Council to approve \$104,701 in Prop 69 funding to fund a number of DNA-related equipment purchases, and to offset DNA collection-related costs. The equipment will be used to enhance DNA collection and storage capabilities.

FINANCIAL IMPACT

Prop 69 funds are specifically for law enforcement purposes only, and their use will have no negative impact on the City's General Fund.

RECOMMENDATION

It is recommended that the City Council:

 Approve the appropriation of Prop 69 funds in the amount of \$104,701 in Fund 179, and
