OBJECTIVE

For City Council to accept the above project as complete and authorize the Mayor to execute the Notice of Completion of Public Improvement and Work.

BACKGROUND/DISCUSSION

On June 8, 2010, City Council awarded the contract to R. J. Noble Company with a total bid of \$390,255.50. This project consisted of adding a right turn lane on northbound Brookhurst Avenue from its intersection with Emerson Avenue to Garden Grove Boulevard. The improvements also included the removal and relocation of existing curb, gutter, sidewalk, curb return, pull boxes, utilities, asphalt paving, traffic signal modification, and signing and striping.

The contractor, R. J. Noble Company, has completed the improvements in accordance with the plans, specifications, and other contract documents. The project was funded with Measure "M" Regional (Fund 423) and Local Turnback (Fund 421).

FINANCIAL IMPACT

There is no financial impact to the General Fund. The subject project was completed within the project budget. The retention payment will be released after recordation of the Notice of Completion.

NOTICE IS HEREBY GIVEN that the City of Garden Grove, Orange County, California, has caused a public improvement, to wit:


