OBJECTIVE

For City Council to accept the above project as complete and authorize the Mayor to execute the Notice of Completion of Public Improvement and Work.

BACKGROUND/ DISCUSSION

The project widened the west side of Fairview Street to its ultimate width to allow for three southbound through lanes. Additional improvements included construction of curb and gutter, sidewalk, driveway, wheel chair ramps, asphalt paving, fire hydrant, traffic signal modification, traffic striping, and adjusting utility valves and manholes to new finish grade.

The contractor, R. J. Noble Company, has completed the improvements in accordance with the plans, specifications and other contract documents. The project was funded through Measure "M" local (Fund 421), Measure "M" regional (Fund 423) and Gas Tax (fund 061) funds.

FINANCIAL IMPACT


There is no financial impact to the General Fund. The subject project was funded through Measure "M" local (fund 421) and Measure "M" regional (fund 423) and completed within the project budget and schedule. The retention payment will be released after recordation of the Notice of Completion.

RECOMMENDATION

It is recommended that the City Council:

- Accept the project as complete and authorize the Mayor to execute the Notice of Completion of Public Works Improvement and Work.
- Authorize the Finance Director to release the retention payment when appropriate to do so.

NOTICE IS HEREBY GIVEN that the City of Garden Grove, Orange County, California, has caused a public improvement, to wit:

The contract for furnishing of all plant, labor, services, materials, and equipment, and all utilities and transportation, including power, fuel, and water, and performing all work necessary to construct and complete, in a good and workmanlike manner in strict accordance with the specifications, plans, and drawings therefore on file in the office of the City Clerk of the City of Garden Grove, for the construction, installation and completion of the above-described public improvement and work, was heretofore made and entered into with , R.J.
