OBJECTIVE

To receive City Council acceptance of Project No. 7252 – Traffic Signal Installation at West Street and Wilken Way as complete, and authorize the City Manager to execute the Notice of Completion of Public Improvement and Work.

ANALYSIS

This is to certify that Pro Tech Engineering Corp., the contractor for Project No. 7252, has completed the project. The project consisted of installing a new traffic signal and traffic striping modifications with left-turn lanes at West Street and Wilken Way.
