OBJECTIVE

For the Garden Grove City Council to accept IFB No. 1059-A, Phase 2 Street Sign Replacement and Installation Project as complete and authorize the City Manager to execute the Notice of Completion of Public Improvement Work.

BACKGROUND

On August 24, 2010, the City Council awarded a contract to BC Rentals Inc. dba BC Traffic Specialist (BC Traffic) for Phase 2 Street Sign Replacement and Installation in the amount of \$341,864.08. This project brought street signs into compliance with current sign standards as established in the California edition of the Federal Highway Administration's Manual on Traffic Control Devices.

DISCUSSION

The contractor, BC Traffic, has completed all of the work as outlined in the scope of work.

FISCAL IMPACT

The funding for this project was within the Public Works FY 2010-2011 and FY 2011-2012 budget. The retention payment will be released after recordation of the Notice of Completion with the County of Orange.

RECOMMENDATION

It is recommended that the City Council:

- Accept IFB No. S-1059-A as complete and authorize the City Manager to execute the Notice of Completion of Public Improvement Work; and
- Authorize the Finance Director to release the retention payment of \$29,813.31 when appropriate to do
