PROJECT

OBJECTIVE

To obtain City Council approval of the plans and specifications for the Orange County Flood Control District's project to construct the Haster Retarding Basin, Pump Station, and Recreational Field Project (Project) in the City of Garden Grove per California Public Contract Code No. 21020.9.

BACKGROUND

The Project will improve the storage capacity of the Haster Retarding Basin within the East Garden Grove-Wintersburg Channel system. A new pump station and other pumps will be added to regulate and optimize the flow from the basin to the downstream channel. Improvements to the adjacent Twin Lakes Park will be constructed in conjunction with the new pump station. Recreational improvements will consist of filling a portion of the retarding basin for a new grass turf area, reconstruction of the basin perimeter multi-use path, and replacement of picnic tables and benches affected during construction.

DISCUSSION

On January 24, 2012, the Orange County Board of Supervisors approved the project for advertising, and authorized Orange County Public Works to submit Project Plans and Special Provisions for the city's approval. Engineering staff has reviewed and approved the subject plans and specifications accordingly. These plans and specifications are voluminous and therefore are available for review by the City Council and the public at the City Clerk's Office. Per California Public Contract Code No. 21020.9, the City Council must approve the plans and specifications before it is awarded for construction. The following is a proposed construction schedule:


