OBJECTIVE

For the Garden Grove Sanitary District (GGSD) Board to accept the above project as complete and authorize the District's General Manager to execute the Notice of Completion of Public Improvement and Work.

BACKGROUND

The Twintree Lane Sewer project included the installation of 8 to 15 inch extra strength vitrified clay pipe sewer line, manhole and sewer laterals from Volkwood Street to Haster Street and the Haster Street Sewer project included the installation of 10 to 15 inch extra strength vitrified clay pipe sewer line, manhole and sewer laterals from Twintree Lane to Allard Avenue and Garden Grove Boulevard to Blue Spruce Avenue. This work has eliminated capacity deficiencies in those areas.

DISCUSSION

The contractor, Nikola Corporation, has completed the improvements in accordance with the plans, specifications and other contract documents.

FINANCIAL IMPACT

The project was funded with Sewer Funds and completed within budget and schedule. The retention payment will be released after recordation of the Notice of Completion with the County of Orange.

RECOMMENDATION

It is recommended that the GGSD Board:

- Accept the project as complete and authorize the General Manager to execute the Notice of Completion of Public Works Improvement and Work.
- Authorize the Finance Director to release the retention payment when appropriate to do so.

NOTICE IS HEREBY GIVEN that the Garden Grove Sanitary District, Orange County, California, has caused a public improvement, to wit:

to be constructed upon the property hereinafter described. The contract for furnishing of all plant, labor, services, materials, and equipment, and all utilities and transportation, including power, fuel, and water, and performing all work necessary to construct and complete, in a good and workmanlike manner in strict accordance with the specifications, plans, and drawings therefore on file in the office of the City Clerk of the City of Garden Grove, for the construction, installation and completion of the above-described public improvement and work, was heretofore made and entered into with NIKOLA CORPORATION, on the 23RD day of August 2011, and filed for record in the office of the City Clerk of the City of Garden Grove; that the work upon said public improvement has been completed, and that the City Engineer has notified the Sanitary District that he has made and completed a final inspection of the materials furnished and installed and the work performed in the construction, installation, and completion of said public improvement hereinabove more particularly described and set forth, and has certified in writing to the Sanitary District that all the provisions of the contract and contract documents for the furnishing of all plant, labor, services, materials, and equipment, and the performing of all work necessary for the construction, installation, and completion of said public improvement above described have been fully complied with to his satisfaction as required by the contract document; that final acceptance of the construction, installation, and completion of said public improvement above described was made on the 22ND day of May 2012; that the nature of the title to said property of said Sanitary District is as follows: That is to say, it owns said public improvement in fee except the right-of-way upon which it is constructed, and that it owns an easement upon, over, and along said right-of-way for the purpose of the construction, installation, and completion of said public improvement hereinabove described and the use thereof after said completion; that the property hereinabove referred to and on which said public improvement is situated is described as follows, to wit:


