PROTEST HEARING ON WEED

ABATEMENT NOTICES

Date: October 23, 2012

OBJECTIVE

To hold a Public Hearing for receipt of objections to the Weed Abatement Notices mailed to parcel owners on September 12, 2012.

BACKGROUND

On September 11, 2012, City Council adopted a resolution pursuant to Section 39500, et seg, of the California Government Code to declare that a nuisance exists in connection with the presence of weeds, rubbish, and debris on certain properties within the City of Garden Grove. A Public Hearing has been scheduled for October 23, 2012, to receive any objections to the Weed Abatement Notices.

Parcel owners had until October 10, 2012, to clear their properties. The City's Weed Abatement Official re-inspected these parcels on October 11, 2012; uncleared parcels are identified in the updated "Exhibit A."

DISCUSSION

The City's contractor is to begin clearing privately owned properties that are not in compliance on October 24, 2012, with work slated for completion within 30 days.

FINANCIAL IMPACT

There is no financial impact.

RECOMMENDATION

It is recommended that the City Council hold a Public Hearing, receive testimony, and take one of the following actions:

- Uphold the objections and order individual properties to be removed from the scheduled abatement process; or
- Overrule the objections and direct staff to proceed with the scheduled weed abatement.
- If there are no objections, direct staff to proceed with the scheduled weed abatement.
